

ACV Dp 65 Nycodus Mehandi, personal register 1496-1503, later continued by his heir Cladius Crostel 1503-10, then in turn by Guilliermus, son of the late Cladius Crostel, 1513-1521.

One register containing various debts in favor of Nycodus Mehandi, notary of Payerne, with signatures and paraphes of the notaries who recorded these transactions. The first folio, apparently a sort of flyleaf, does not appear on the microfilm, and the first visible folio is numbered 2. The foliation is modern, in crayon.

This register contains many examples of the paraphes of various sizes used by the notaries of the period. One of these raises the suspicion that the register attributed to Petrus Ruerat (ACV Dp 92) is actually the work of Franciscus Ruerat. Are there any other contemporary mentions of the notary Petrus Ruerat? We know of none! The transactions recorded here helped us reach the conclusion that ACV Dp 92 is in the hand of Franciscus Ruerat.

On fol. 30, we learn that Nycodus Mean has died, sometime between 07 may and 04 sep 1503, and that his heir is Cladius Crostel. The little register was thus continued by Cladius Crostel (or Crostelli), until his death, sometime between 1510 and 04 sep 1513, and then in turn by Guilliermus, son of the the late Cladius Crostel. At the end of the register, there are additional notations from the period when the book was used by Nycodus Mehandi, then a final transaction from 1549 in which Noble Guilliaume Crostel leases property to Jehan Grivaz and Pierre Costaz.
