22 jan 1518, Nobilis Anthonius Malliar burgensis rotundimontis as guardian of his children by Ysabella his late wife, daughter and heir of Noble Jacobus de Billens, and also as usufructuarius of Ysabella's estate. Previously by Jacob de Billens and before that by Jean de Billens and his wife Agneta. Cites documents back to 1330's but genealogy not clearly stated.

25 sep 1520, magnifico viro Dyetrich de Anglisperg milite sculteto friburgi conjuntorio nomine eius uxoris filie quondam noblis et poteris viri _____ de Compesio domini de Vulpilliere et de Dignens, ac nobilis viri Zeybur de Patroromano burgensis friburgi conjuntorio nomine eius uxoris filie quondam spectabilis viri Petri Faulcon sculteti et militis friburgi ex alter, property in the parish of Corsiez, ac etiam Viviaci et de Sancto Simphoriano, that was previously recognized by Noble Karolo de Compesio domino de Vulgilliers (=Vulpilliers) et de Dignens et perpridem nobilibus de Blonay alias recognita sub dicto feudo nobili per nobilem vir Perretum de Blonay filium quondam domini Johannes de Blonay militis... 06 may 1313, et postea per dominam Margaretam relictam domini Johannis de Blonay militis, ... et deine per nobilie Aymonetum de Blonay filium dicti Nobilis Perreti de Blonay ... 1337, et etiam per eiusdem Aymonetum de Blonay 1341, et postea per Nobilem Petrum de Compesio filium quondam domini Guilliermi de Compesio militis conjuntorio nomine Nobilis Johannete eius uxoris filie dicti quondam nobilis AYmoneti de Bloney, et deinde per spectabilium dominum Adrianum de Boembert ad causam predictorum bonorum... contra nobiles viros Johannem, Petrum, et Ludovicum de Compesio 1444... 175 Nobilis Francesia relicta quondam discreti viri Arthaudi Papan, filie quondam Nobilis Anthonii de Franoz et nobilis Marie conjugum filie quondam nobili viri Petri de Subtusturri.

Monday after St. Martin, 1521, Francesia widow of Arthaud Papan. Property at Eschandens previously recognized by Stephanodus de Vuffliers, then purchased by nobles Henri and Pierre de Subtus Turri (=Dessousletour), then by succession to Marie, mother of Francesia.

177 Nobilis Bartholomeus de Pre dominus de Corsellis

(copied only to fol. 209, then skipped to last 2 pages to get date), 13 sep 1529, Noble Bartholomé de Prez son of the late Johannes de Prez of Lutry who was son of Guidonis de Prez (whose widow was Johanneta).
