

ACV Fh 122 Priory of Etoy, 1442-1451, commissaire Petrus Bally de Drailant.

The top of each page has been damaged by moisture, but most of the text is still legible. In a few cases, we were able to recover the names of the principals from the repertorium (also damaged, however) at the end of the volume. The inventory of the ACV indicates that this terrier is for “le prieuré d’Etoy, à cause de ses maisons de Pizy, Mont-Joux, et Trévelin que dépendent dudit prieuré.” The text specifies that the reconnaissances were made for the benefit of *Reverendus in Cristo Patris et Domini Dominus Johannes de Groler prepositus dominus pauperum hospitalis Sanctorum Nycolai et Bernardi Montisjovis*. All dates are specified as Style of the Nativity. The volume was previously known as 22 (on the spine of the volume).
