405 Communitas de Ballens

20 may 1506, Andreas Barberii et Johannes Aymonaz, sindici et gubernatores ville et communitatis de Ballens, with assistance of Michaelis Lamberti, Jacobi Mayor, Claugii Barberii, Nycodi Soudans, Petri du Russel, Petri et Anthonii Maenciz dicti loci de Ballens. Previously recognized by Gierardum Barberii, Glaudium filium quondam Bissonczii de Frigidavilla de Ballens (Eg. J. Vullieti). Originally back to November, 1299 (Eg. Aymonis Magneti for Abbot of monastery of St. Engendi (=St. Oyens). (These are the same parcels enumerated in Fg 159 for the commune of Ballens.)

408 Anthonius filius quondam Andree Mayencyz (=Mayenchie)

11 may 1506, Anthonius filius quondam Andree Mayencyz de Ballens, by succession and division with his brother Petrus. Previously (Eg. J. Vullieti) by Anthonius and his brother Petrus, and before that by their father Andreas. Mention jx heirs Glaudii Augier

410, 450 Petrus Maencyz (brother of Anthonius)

28 may 1506.

413 Johannes Aymonaz and his wife Maria filie quondam Glaudii filii quondam Bissenczonis de Frigidavilla, and her brother Pierre, also Andree filii quondam Petri filii dicti quondam Glaudii de Frigidavilla.

28 may 1506, previously (Nycodi Braserii) by the said late Glaudium de Frigidavilla, previously de bonis que dudum fuerunt Perrodi Rossetaz et Aymoneti eius filii Mermeteque filie dicti Aymoneti... Johannes received donation from his wife Maria. On fol. 415, one item is de bonis que per prius fuerunt Girardi fratris quondam Biczonzii de Ultra Juriam et Perrodi eius filii.

417 Nycodi filius quondam Hugueti Soudans, his guardian for the prior reconnaissance was Petrus Mayor (Eg. J. Vullieti)

28 may 1506, one property en la Palaz jx que fuit **Johanneti Figoen** a vento (fol. 418), and pratum Johannis de Frigidavilla quod fuit **Petri Cygoen** a borea. Another jx **heredum Mondeti Mayor**. Another jx **Petrus Mayor junior**, fol. 419v.

421 Anthonius de Verney alias Mayor (son of Michel son of Anthoine). Michel had brother Pierre, they recognized this property under Eg. Nycod Brasier. Another relative Jacobo de Vernay alias Mayor – 08 may 1506. Michel and Pierre are also referred to as Mayor. The properties are: in Aubonne, en Chivrajon (Chevrajon? See FH 153 fol. 318, 411, and 704; also see below 436); also in Yens, sus Villaz.

Description of the parties and their property at Chivrajon:

(421) ... Anthonius filius quondam Michaelis filii que quondam Anthonii de Vernay alias Mayor de Ballens, property previously recognized (in manibus providi viri Nycodi Braseri) by dictum quondam Michaellem de Vernay alias Mayor et Petrum eius fratrem... (421v) ex succession dicti eius quondam patris acque divisionibus inter ipsum confitentem cum Jacobo de Vernay alias Mayor eius consanguineo... videlicet medietatem pro indiviso cum dicto Jacobo de Vernay alias Mayor eius consanguineo pro alia medietate duarum posarum vinee situm in territorio Albone loco dicto en Chevarjoz juxta terram heredum Mermete uxoris Ansermi de Ponpaploz quam alias tenebat Nycodus Balli a vento terram liberorum Petri Challeti de Bougier Sancti Martini a borea et juria et terram seu planchiam Johannis Jaquier que fuit Johannis Reymondi et quam alias tenebat Johannes Gay a lacu, pro qua medietate ut supra recognita debere confitetur dictus confitens pro se et suis predictis prefato domino comiti et suis jandictis, videlicet medietatem decimeocto denariorum gebennenses census anno quolibet termino festi Beati Michaelis pro solvit ... dudum recognitorum **per Aymonetum Mayor predecessorem dicti confitentis**. (Thus, while the property is traced back to Michel and Pierre Mayor/du Verney, the original “cense” is traced back to Aymonet Mayor, presumably the one who is also the source of the Monod family. The corresponding section for Jaques Mayor is silent on this point, see below fol. 436v. The division of the property into two halves is traced to a partage between Antoine son of Michel and Jaques son of Pierre, for which see below, fol. 436.)

422 Andreas Barberii filius Girardi filii que Johanneti Barberii de Ballens

30 oct 1506, Andreas filius quondam Girardi filii que quondam Johanneti Barberii de Ballens, property previously recognized by the said Girardi, and from estate of Vuilliermete, daughter of the late Enardi Mathez of Ballens (=Mathey), wife of the said Johanneti Barberii. Et per pruis from Johannete filie quondam Tournoberti (Tornoberti) Bland, wife of Perreti dicti Grant (Grand) de Ballens. Divided with Claudius brother of Andreas. Tournoberti also had son Johannodi?

30 oct 1507, Michael filius quondam Petri filii quondam Michaelis Lamberti de Ballens, previously by said Pierre (Eg. J. Vullieti), ... 433v : Francisce uxoris Andree Aribloz was daughter of the late Mermeti Mathet of Ballens. Many dated sales to Lambert from neighboring families are noted! Fol. 432v, jx bonatenens Rolete uxoris Girardi Figuens (!) a borea. Mention Petri "Matel", presumably = Mathey! A number of parcels leased from Louis de Gruyere (D. Nycodum Braserii) 14 jan 1493. Mention fol. 433v – not understood completely – Nycodum Augier de Ballens and Jacobi eius filii, quem ab ipso? Nycodo suscepit Glaudia eius quondam uxor filia quondam Jacobi de Plathea ... Fol. 435 has item previously by Mondetum filium quondam Aymoneti Mayor, Petrum Mayor, Petrum Lambert de Ballens, et Johannem Reymondi de Sancto Liberio (J. Vullieti), que per pruis fuerunt Aymoneti et Francisci fratrem filiorum quondam Aymonodi Reymondi de Sancto Liberio et Amonete et Cecillione uxorum suarum filiarum quondam Jaquetii dicti Fol de Ballens, ex cussessione dicti eius quondam patris... (at Ballens, en Muratellet).

Jacobus Mayor filius quondam Petri Mayor.

22 oct 1507. He had brother Humberti, they were children of said Petri and of Nycollete daughter of Aymoneti Soudans. Another daughter of Aymoneti Soudans was Peronete, wife of Mermeti Solliardi, who son Nycolleti Solliardi was thus "germani filii" of Jacob and Humbert. Mention of property from? Mondetus filius quondam Aymoneti Mayor and others. Most likely explanation for Antoine and Jaques: They were cousins, children of the said Michel and Pierre, brothers, both sons of the original Antoine. (Previous reconnaissance was rec. by Eg. J. Vullieti, Petrus Mayor in the name of Jacobus and Humbertus his children by his late? wife Nycolleta daughter of Aymonetus Soudan.)

Second property, fol. 437, is unam posam cum dimidia, in Prato Durant alias Champs Rambor, jx heirs of Nycod Soudan que fuit Mermeti de Eschagnens de joux, Nycod Soudan de bize, confessant and Nycod Soudan de vent, no specification for the side de lac. This is the property later described as en Pra Durand alias Champ Rampbert soit en la Planche du Boz à Soudan.

Description of the parties and their property at Chivrajon:

Problem for the section on Ballens : analysis of the names Cigoen, Agoen, etc., was there just one Girard Cigoen cited in prior terriers, whose name was sometimes read incorrectly as Girard Agoen, or was there also a separate person called Girard Agoen, in addition to the one called Cigoen? The mentions we found are clear, we found only Cigoen here (although at least once as Figoen, with the same wife Rolete), even though the other names found in FH 175 supposedly derive from this terrier and from the intermediate one FH 153.
