

Fh 17 Gimel for the nobles de la Porta 1552, commissaries Nicolas and Bartolomé Tripod.

The seigneur is identified as noble Jaques de la Porte, son of the late noble Claude de la Porte and the late noble Pernette his wife daughter of the late noble Guillaume Marchand of Aubonne. A notation on fol. 29 indicates the information was later copied into a "grosse", possibly the terrier now identified as Fh 18. The writing in the copy is at times very widely spaced and heavily annotated, apparently in order to serve as the basis for a later revision. Among other things, the annotations in Fh 18 give the subsequent history of the properties down to about 1600 (and possibly for the preparation the terrier Fh 63?). Corresponding folio numbers for the section of Fh 18 pertaining to Gimel are indicated in brackets, along with some of the significant notations regarding later ownership. Fh 63 (1680, for Benjamin son of Pierre Valier) cites this terrier frequently.

5 [9v] Pierre Mexieux (=Messieux) [Fh 18 : Ledict Pierre Messieux est decedé et a laissé Claude Messieux son filz qui tient »]

15 dec 1552, Pierre Mexieux de Gimel comme conjointe personne de Jehanne saz femme fillie de feu Jehan de Vers. Witnesses include Eg. Michel Collat notaire et bourgeois d'Aulbonne.

6 [12] Bernard Champion, Claude Champion, et Pernon fille de feu Claude Champion [Fh 18 : « Ledict Bernard est mort et a laissé Anthone Champion vivant ; Claude Champion est mort sans enfans ; la Pernon est decedée et a laissé Claude Baud vivant »]

15 dec 1552, Bernard for ½, Claude for ¼, and Pernon for ¼, relationships not stated. Apparently they are descendants of a Nycollet Champion and of a Jaquet Champion.

8 [16] Bernard Champion

15 dec 1552, Bernard Champion, as a result of a partage with the other 2.

8 [18] Aymé Mochel (=Mochet) [Fh 18 : « tient Pierre Moschet filz d'Aymé Moschet et de Jaqueme G... » (illegible)]

15 dec 1552, Aymé Mochet conjointe personne de Jaqueme sa femme fillie de feu

9 [20] Mauris de la Fougé [Fh 18 : « ledict Maurys est mort et a laissé Rolet son filz vivant »]

20 dec 1552, Mauris filz de feu Jehan de la Fougiz, 1/3 of a house, purchased by his father in 1543.

10 [22v] Jean Begney

14 jan 1553, Jehan Begney de Gimel tant a son nom que comme tuteur de Bernarde et Jenon fillies de feuz Claude Begney et de Pierre Rosset de Saint Livre comme administrateur de Claude son filz et de feu Mye sa premiere femme qu'estoit fillie de feuz Amyed Begney en son vivant dudict Gimel, previously by George et Louys Begney freres

11 [25] le susnommé Jean Beney

14 jan 1553, similar to above. Father of George and Louys Begney was Pierre. Property anciennement by Jehan Favre habitateur de Gimel et depuis de Pierre Passiez, and purchased by feuz Pierre Begney from him.

12 [28] Legier Bolley

22 dec 1553, Legier Bolley filz de feu Louys Bolley de Gimel. Previously by Claude Bolley and before that by Jehan Bolley.

14 [31v] Jaques Fillietaz [Fh 18 : Ledict Jaques est mort est a laissé Thivent Claude et Paule Fillietaz ses filz qui ont partagé »]

29 aug 1554, Jaques Fillietaz de Gimel, various.

14 [33v] Bernarde et Claude Malliez, represented by their mother Claude, widow of Claude Malliez of Gimel.

29 aug 1554.

15 [35v] Anthoine de Genevve [Fh 18, for one of the parcels : « Tient François de la Foge la quarte partie ; tient Discret David Favre les autres trois parts », another parcel was held by all three brothers, Discret David, Michiel, and Bernard Favre]

12 dec 1554, Anthoine filz de feu Pierre de Genevve autrement Billiard de Gimel. Abbergement to said Pierre by nobles Claude de la Porte and his wife Pernelle, and recognized by the said Pierre to them 24 mar 1501 (Nycod Brasier, notaire). Another property had been purchased by Louis de Geneve, grandfather of Anthoine from George Savariod 27 sep 1496 (provide Jaques de la Foge) as well as a donation to the said late Pierre de Geneve by Anthoine Savariod (Eg. Guill. Billiard notaire de Montherod 14 jul 1529). Some properties are next to Jaques de Geneve dict Favre, no relationship stated. Perhaps they are half-brothers, sons of different mothers?

18 [43v] « le susnommé Jaques de Genevve » autrement Billiard filz de feu Pierre de Genevve de Gimel.

12 dec 1554, Jaques filz de feu Pierre de Genefvve aultrement Billiard. Diesme on one parcel, no relationships stated, but one of the witnesses was Anthoine de Geneve.

19 [45] François Jannin [Fh 18 : « ledict François est mort et est heritier Benjamin Jannyn »]

12 dec 1554, François Jannyn de Gimel.

20 [47v] Louys Bolliet habitant a Gimel

12 dec 1554, Louys Bolliet residant a Gimel.

20 [49], 22 [54] Pierre de la Fougé [Fh 18 : « Tient Thivent et Michiel de la Fougé freres filz de feu Perrod de la Fougé »]

12 dec 1554, purchased from Pierre Vacherand le jeune in 1537. The second reconnaissance on fol. 22, 23 nov 1556, calls him Perrod de la Fougé.

31 dec 1557.

24 [58] Nycolas Gagnerat

31 dec 1557, Nycolas Gagnierat de Gimel.

19 aug 1554, Claude filz de feu Claude Billiard de Exertines, anciennement par feu Jehan Clert predecesseur dudict confessant 25 mar 1437 (J. Fonjalé).

19 aug 1554, Claude Clert de Exertynes. By succession and partage with André.

26 André Clerc

19 aug 1554, similar to above.

27 François Mamburier

15 dec 1552, François Mamburier ... purchased 01 may 1544 from Mauris filz de Anthoine de Leysel aultrement Cristin.

28 Maurys, Thivent et Maurise enfans de feu Anthoyne de Leysel

12 dec 1554, Mauris filz de feu Anthoine Cristin alias de Leysel agissant tant a son nom propre que au nom de Thivent Cristin son frere absent... et François filz de François Mamburier agissant

au nom et comme personne conjointe de Maurise sa femme fillie dudict feu Anthoine Cristin et seur desdictz Mauris et Thivent absente. Anciennement by Nycollet Cristin. Et dempuis par Jehan Cristin (Nycod Brasier).

15 dec 1552, George filz de feu Jehan filz de Jenod Chambat de Saint George. Wife of Jenod was Jaqueme fillie de feu Claude Georget. Indivis with Jehan Regnaud aultrement Chambat filz de feu Loys Chambat.

30 Jean Chambat

15 dec 1552, Jehan filz de feu Louys filz de Jenod Chambat de Saint George, similar to above.

31 Jaques Angeloz

15 dec 1552, Jaques Angeloz residant a Gimel, previously by Pierre et Collet Gagnerat... mention Nycollas Martyn alias Gagnerat.

32 Pernon Gagnerat relicte of Jehan Saioz (? Sajoz = Sage ?) – in the reconnaissance of Pierre Bichet, fol. 37, she is revealed to be the daughter of Jaquemoz Martyn (alias of Gagnerat).

Longerodz

33 Jean Biondet and his wife Claude fillie de feu Claude Girod de Longerod son of Ansonnet Girod. Claude, wife of Jean Biondet, made partage with her sisters Louise and Theodole, and with Eustace and Anthoine enfans d'ung aultre Claude Girod (?).

34 Legier de la Muraz and his wife Anthoine fillie de feu Claude Girod (another ?) son of Ansonnet Girod.

35 Eustace Girod filz de feu Claude Girod, son of Ansonnet. Claude father of the wife of Jean Biondet is the uncle of Eustace, proving that Ansonnet had two sons named Claude.

36 Pierre Guddet and his wife Françoise daughter of Loys Gervex.

37 Thivent Besson filz de Jehan aultrement Archet
