

ACV Fh 199 Extracts of transactions for the Confrérie du Saint Esprit de Gimel

The volume is damaged, but enough of the first folio remains to discern that it begins a section containing transactions recorded by Jacobus de Fogia, apparently the same collection that was copied into Fh 200. The entries on the last few pages appear to be only summaries of the original documents.

2 Johannes Maruglerii, 16 ?? 14?6, sells to Confrérie represented by Nycolletus Champion and Georgius Savariod (see Fh 200, fol. 9)

2v Petrus Gagnierat prior of the Confrérie leases to Johannes Huguettaz de Albona faber, a house juxta viam publicam tendens de ecclesia versus domum Ludovici de Gebennis a vento... (see Fh 200, fol. 10)

4 Stephanus filius quondam Petri Montouz de Gimel, 20 ?? 1469 donates? to Confrérie represented by Petrus Mariglerii as prior. (see Fh 200, fol. 11)

5 Johannes Maliez alias Ja..., 20 may 1485, donates? to Confrérie represented by Ludovico de Gebennis and Georgio filio Petri Benedicti, priors. (see Fh 200, fol. 12)

5v Franciscus Huguettaz alias Alamand, to Ludovicus de Gebennis and Georgius Benedicti as priors, 15 jun 1485. (see Fh 200, fol. 13)

6v Glaudius filius quondam Johannis Magniglerii, 05 mar 1482, to Petrus Gagnierat as prior, witnesses Petro de Bonavilla, Ludovico de Gebennis. (see Fh 200, fol. 14)

7v Glaudius douz Bugnion, 17 jun 1482, to Glaudius Bolley as prior (see Fh 200, fol. 15)

8 Johannes Malliez alias Janet, 17 jun 1482, to Glaudius Bolley as prior (see Fh 200, fol. 16)

9 Glaudius Bolley as prior, 17 dec 1498, leases to Ludovicus de Gebennis alias Billiard (see Fh 200, fol. 17)

10v Petrus Gagnierat de Gimel as prior, , assisted by Nycolletus Champion, Petrus de Gebennis, Petrus Champion senioris, et Glaudius Bolley de Gimel, 13 may 1493, lease to Nycolletus douz Bugnion (see Fh 200, fol. 19, where the date seems to be 03 may 1493)

11 Johannes et Benedictus Maniglerii, brothers, 27 apr 1520, sell to Glaudius Malliez as prior (see Fh 200, fol. 20, where the date seems to be 27 apr 1511)

12 Johannes et Benedictus Maniglerii, brothers, 29 may 1499, sell to Petrus de Gebennis alias Billiard de Gimel (see Fh 200, fol. 20, second sale)

12v Franciscus et Anthonius Huguettaz alias Alamand de Gimel, brothers, 03 feb 1479, sell to Claude Bolley as prior.

14v Peroneta relicta Petri Andree alias Bergier de Gimel, 28 jun 1441, sells to Petrus du Bugnionz et Petrus Billiard priors, references to other documents prior to 1410 and to other parties.

16 Stephanus de Volactaz de Gimel and Johannes Malliez dicti loci, 28 may 1458, sell to Nycolletus douz Bugnion et Petrus filius Perrodi de Rosseys dicti loci de Gimel as priors, oche in villa de Gimel next to house of Petrus douz Bugnion , adjoining curtine of Petri et Girardi douz Bugnion.

17 Perrodus Rossey de Gimel et Petrus eius filius, 22 may 1447, sell to Girardus Martini et Petrus Genedicti de Gimel as priors.

17v Petrus et Jaquetus fratres dicti du Bugnion de Gimel, 24 jun 1434, sell to Petrus Fillietaz and Johannes Maniglerii de Gimel as priors.

18v Davit (=David) douz Bugnyonz de Gimel, 11 jun 1434, sells to Johannes Maniglerii de Gimel and Petrus douz Bugnion dicti loci as priors

19 Johannes Maniglerii de Gimel, 1444, testament, donation of property to the confrérie, universal heirs Johannetam uxorem Nycolleti Champion de Gimel et Peronetam uxorem Peroneti de Peys de Burtigniez filias suas.

20v Johannes et Nycolaus fratres dicti Champion de Gimel, 1439, sell to Petrus dou Bugnion and Petrus Villiard de Gimel as priors

21 Johannes Collon de Gimel, 20 mar 1429, sell to Petrus Fillietaz and Petrus dou Bugnionz de Gimel as prior

22 1441, transaction between Johannes de Crosa alias de Gollion cappellanus morans apud Gime, and Johannes Bolleys de Gimel as prior

27v Johannes Maniglerey, 15 feb 1429, recognizes obligation to Perrodo Pallioz de Gimel prior of the Confratrie Sancti Spiritus de Gimel, witnesses Domino Johanne Baczans cappellano et Johannodi dou Bugnion.

28 Jaquetus dictus Achola (or perhaps Athola? – heading says Antallaz), 23 may 1389, sells to Perrodus dictus Pallioz as prior.

29 Petrus Billiard de Gimel et Ludovicus de Gebennis morans apud Gimel, 26 jun 1468, sell to Nycolletus Champion de Gimel as prior

29v Lia relicta Johannis Sutoris de Gimel [et] Thoma ipsius conjugum filius, 24 jun 1388, sell to Johannodus Palloz ipsius loci as prior, jx Johanneta filia quondam Peroneti Hugueti, witnesses Perrodo Andree de Sancto Georgio et Richardo Veyri de Gimel.

30v Petrus Joffrey alias douz Mex de Gimel, 31 jul 1481, settlement with Nycolletus Championus and Ludovicus de Gebennis alias Billiard as priors

32v Johannes Bolley de Gimel, 1477 et die ultima mensis, settlement with Girardus Gagnierat as prior regarding previous transaction of 03 apr 1464 in which Petrus Palliez filisu quondam Johannis dicti loci de Gimel sold to the same Johannes Bolleys tunc presenti.

33v 30 may 1469, relating to a prior transaction of 09 mul 1426, involves property from the late Mermetus d'Alamand and his wife Johanneta

34v Petrus Geneveys de Gimel, 28 may 1458, sells to Nycolletus douz Bugnion et Petrus filius Perrodi du Roseys de Gimel.

34bis v Petrus Gagnierat de Gimel, 06 jun 1503, sells to Colletus Gagnierat and Glaudius Malliez as priors

35 Petrus Ganyerat and Ludovicus Beney alias Michie de Gimel as rectors of the confrérie de Gimel, 22 mar 1498, reconnaissance for the priory of Romainmôtier (Eg. Aymonet Pollens), mentions various adjoining parties including Johanneta uxoris Petri Vacherand.

39v Johanneta relicta Petri Magnyn, 12 jun 1470, sells to Nycoletus Champion et Glaudius douz Bugnyon as priors

40 Johannes Tienturies alias Perier (or Pererii), 16 nov 1489, sells to Petrus Benedicti and Glaudius Bolley de Gimel as priors.

40v Johannes Tienturis, 03 mar 1477, donates to Ludovico de Gebennis et Petro Maniglerii as priors.

41v Johanneta filia quondam Perrodi Jaugnet? (heading: Jannet or Jaunet) de Saubraz, 04 jul 1451, donates to Johannes Bolleis de Gimel as prior, based on previous donation of Roletus de Saubraz nutritus domini Ansermi quondam curati de Saubra who donated pro remedio anime sue et suorum predecessorum to Nycodo de Gimel notario tunc morantis Albone as prior.

42 Anthonius Huguetat (heading: Huguetaz) alias Alamand habitator de Saubraz, obligation to Ludovico de Gebennis et Georgio filio Petri Benedicti as priors, relating to bequest of Johannetam uxorem Johannis Rendu de Saubraz pro remedio anime ipsius Johannete.

43 Roletus filius quondam Petri de Crosa (heading: de Crousaz) de Saubraz, 22 nov 1502, sells to Colletus Gagneraz and Glaudius Malliez as priors.

43v Petrus de Crosa de Saubraz, 06 mar 1477?, donation to Ludovico de Gebennis and Petro Maniglerii as priors, witnesses includ Nycolletto filio quondam Girardi douz Bugnyon.

44 Johanneta filia quondam Perrodi Jannet de Saubraz, 04 jul 1451, donation to Johannes Bolleys de Gimel as prior (see above, fol. 41v, for related document).

45 Glaudius de Crosa de Saubraz, 20 may 1490, sells to Petro filio Ludovici Billiard et Petro Champion as priors.

45v Stephanuz de Crosa de Saubraz, 01 may 1480, sells to Petrus Maniglerii and Nycolletus douz Bugnyon as priors, witnesses include Ludovico de Gebennis.

46v Mermetus dictus Perier morans apud Saubraz et Beatrix eius uxor filia quondam Richardi dicti Jannet de Beria, 12 jul 1455, donate to Glaudius douz Bugnyon et Ludovicus de Gebennis morans apud Gimel as priors, relating to previously bequest of Roletus de Saubraz nutritus domini Ansermi curati de Saubraz, see above, fol. 41v.

48 Petrus dictus Gimel de Platea de Germagniez, 23 jun 1390, donation pro remedio anime sue Stephanete uxorem sue et animarum predecessorum suorum.

48v Roletus Choumont? de Mont, 22 feb 1339, sells to Petrus douz Bugniouz et Petrus Billiard de Gimel as priors.

49 Johannes Reymondi alias Charveyron de Germagniez, 07 mar 1458, donation to Nycolletus filius Jaqueti Champion de Gimel as prior.

49v Perroneta filia quondam Perrodi douz Sancouz (= douz Santouz) de Sancto Engendo de Roctires nunc uxor Johannis Ruphi de Bougier Million, et Francesia filia quondam Richardi douz Sanctouz nunc uxor de Veteri Grangia(evidently the given name of her husband has been omitted), 18 oct 1319, obligation to Guiliermus de Gimello as prior.

51 Johannes Fagesii (Fugesii ? Frigesii ?) habitator Sancti Engendi et Anthonius douz Sanctouz de eodem, 02 apr 1509, sell to Guiliermo Ghampionis et Johanni douz Bugnion as priors.

51v Johannes Andree alias Bullet de Sancto Georgio, 14 mar 1502, sells to Ludovicus Benedicti et Colletus douz Bugnion alias Janyn de Gimel as priors, witnesses includ Petro de Gebennis.

54v Johannes et Benedictus Magniglerii fratres, 27 apr 1511, sell to the confratrie.
