Acquired by Guillaumaz by succession from her father.

21 feb 1617 D. Bernard Favre fils de feu Eg. Estienne Favre b. de A with his condiviseurs. Previously to Humbert son of the late Jehan Malliez of Gimel 13 jun 1516 and before that by the said Jehan Malliez. (several pieces, apparently purchased from others at Gimel by Estienne Favre.)

Before that by Claude fils de feu Pierre Bergier and by Pierre and Perrot Bergier, and before that by the prenommez Claude et Perrod Bergier. One parcel purchased by Egrege Jean Huguet father of Claude (?) 05 nov 1566 receu Eg. Baudin.

505 Hugue and Rodolph sons of the late Eg. Urbain Burnier viv. Chat. De Biere by their tuteur Michel Gros

23 mar 1615 Michel Gros as tuteur for Discretz Hugue and Rodolphe freres filz de feuz Eg. Urbain Burnier... Previously by D. Pierre son of the late Nycod Morel de Feschiez acting also for his brother Antoine Morel 16 jan 1580, previously by Matthey Burssiner, and preceding that by Jacquet Burssins and his mother Aymonette. Exchanged with late Urbain Burnier by the late Anthoine Morel, Eg. Cl Huguet notr., 21 jul 1592. De cinq parties les deux par indivis avecq Discret Samuel Burnier leur frere pour les aultres trois cinquiemes parties d'une maison... que fust desdictz Morel

Another acquired by Benoitte from discussion of biens of Jehan Robert dict Gadel receu Jehan Barbier 14 jan 1587
