

ACV P de Mestral I 1500: Rotulus for Noble Jean (IV) d'Aubonne, fief dit de Rochefort, by Jacobus de Bissingio, 1342-1349, and ACV Fh 69, the last seven membranes of the same rotulus.

Rotulus over 21 meters in length, evidently for the fief known as “Rochefort”. Some of the membranes are badly faded, but the script remains largely legible. The individual membranes bore small Roman numerals at the top left corners, but some of those numbers are too faded to read. There is also a modern numbering of “views”, in pencil. Further, there is an old (17th or 18th Century?) numbering of some of the individual items, associated with the French equivalents of the names of the reconnaissants in the left margin, in ink. One addition is found, dated 01 aug 1349, by the notary Jaquetus de Exertines.

There are also some interruptions in the rotulus, identified by (17th Century?) notations to the effect that material had been removed and forwarded to other seigneurs, after which the remaining pieces were sewn back together. In fact, these notations may eventually lead to the identification and recovery of copies of the missing sections. The nature and extent of the breaks can also be verified from what remains of the original sequence numbers of the individual membranes, most of which are still legible.

The rotulus was originally somewhat longer. The sequence number on the final membrane is still legible, xli. The original joints between membranes were ornamented with a sort of large paraphe that extended across the joint, so that it would always be possible to verify the integrity of the rotulus. The paraphe at the end of the final membrane is incomplete, demonstrating that at least one membrane has been lost. The missing section at the end turns out to have survived as ACV Fh 69, consisting of membranes xlii-xlviii, with a final subscription and paraphe at the end. The available images of Fh 69 are not as good as we would like, but sufficient to make out most of the text, and we elected to add it to the present analysis.

The final tally: The original rotulus had 48 membranes. The last surviving membrane of P de Mestral I 1500 bears the original number xli, and shows clear evidence that at least one membrane was previously attached to it at the bottom. In addition to whatever was lost at the end of the rotulus, the following membranes have been removed: bottom of xvii, all of xviii and xix, top of xx, all of xxii, xxiii, xxiv, xxv, and xxvi, and the top of xxvii. The missing membranes concerned, according to the notations found at the places where these removals occurred, Reverolle, Pampigny, Sivirier, and Cottens. Membranes xlii-xlviii are now Fh 69.

From these notations, also, we suspect that ACV P de Mestral I 1501 (not yet examined) may be a copy of the entire (?) rotulus made by Guillaumus Berardi around 1488, potentially yielding better readings and additional material. Another terrier by Berardi is P de Mestral I 1507, with dates mainly 1483-1506, but containing a section consisting of a copy of additional material by

Jacobus de Bissingio for Aubonne etc., that is not part of P de Mestral I 1500, but which was clearly intended as part of the same project for Johannes (IV) coseigneur d'Aubonne.

In the analysis below, we show both the original membrane numbers, where they can be discerned or [inferred], as well as the (modern “view” numbers), and selected items in full.

(It is tempting to see in this item that Stephanetus must have been a relative of Roletus Voucheret, but as both of their fathers are named, we think that the actual sequence of events was (1) that Roletus held the properties, whatever they were, under certain conditions, (2) Roletus died without a successor under the terms of his lease, (3) the dominus used his discretion to confiscate and then lease the properties to Stephanetus under the same terms that had originally applied to the family of Roletus.)

By our count, four membranes xxiii through xxvi, and the top part of membrane xxvii, were removed at this time, although the removal may actually have occurred in two steps, see the old notation at the bottom of membrane xxxvi, below.)

(Section for Ballens begins at FamilySearch image 41, modern “view” number 36. The connecting paraphe is incomplete, the lower part that should have been at the top of membrane xxvii is lost, and that tells us the top of that membrane has

been cut away, presumably part of the missing section for Pampigni, Severier, et Cottens, see above. The properties and individuals who are the subject of these reconnaissances represent only the part of Ballens that was subject to the fief of Rochefort. Other parts of Ballens were under the jurisdiction of the priory of Romainmôtier – for which separate reconnaissances exist, such as ACV Fg 2 – and possibly other entities as well.)

This rotulus fragment is described by the ACV as being very fragile and in poor condition. It seems to have been examined for possible digitization in 2010, but it is not part of the series of digitized terriers that have been posted on the FamilySearch.org web site. It would probably be identified there as Image Group 101660642, which falls between the digitized files for Fh 68 and Fh 70.

We have photographs from microfilm. The outside of the rotulus bears a clear title, probably from the 18th Century, “Rouleau de reconnoissances passées à Aubonne au mois d’Avril 1344 devant le Chateau ez mains de Jaques de Bissinges en faveur de Jean, Seigneur d’Aubonne riere Aubonne, Monterod, Reverlola, et dont le commencement manque”. There is also a notation, N°:227^o, reflecting its provenance as part of the Inventaire Blanc, layette 290.

This piece of the original rotulus contains membranes numbered (in small roman numerals, but likely later than the text itself) [xlii] through xlvi. There is significant damage to the first membrane, and parts of the text are not clearly legible in the available images due to the quality of the microfilm. Most of the membranes that should form the beginning of this rotulus,

membranes i-xli, are identifiable as the rotulus ACV P de Mestral I 1500, although the latter contains notations indicating that several membranes were removed and forwarded to other seigneurs.

The microfilm exposures for these seven membranes are rather dark, and some passages are too dim to read with any certainty. There appear to be no other significant notations or numbering schemes, but the large paraphe that overlaps the joints between membranes in this fragment is the same as those found in the first part of the rotulus, and the dates, script, general plan, and the identity of the commissaire all verify that these two fragments belong together.
