Grosse for fiefs of the heirs of Rolet Gachet of Villars-en-Vully, commissaire **Petrus de Molendino** clericus et burgensis Staviaci Lacus, introduction (“Narratio”) dated 14 oct 1516.

The Gachet heirs are listed in detail in the introduction:

- Margarete uxoris providi viri Johannis Jaccolleti burgensis Staviaci, Jaquete uxoris Discreti viri Guydonis filii Girardi Jaccollet de Autavoulx, et Glaude uxoris egregii viri Goddofredi Griseti burgensis Staviaci filie honesti viri Petri Jaccollet et quondam Glaudie eius conjugis (see fol. 5, eius prime uxoris) sororum filiarum quondam Bartholomei filii quondam Roleti Gachet de Villard en Vuilliez pro meditate bonorum et censium sequentum, necnon
- Nycolleti filii quondam Aymonis filii quondam vita functi Johannis filii defunct Roleti Gachet de Villard en Vuilliez et fratrum suorum pro quarte parte alteris medietate dictorum bonorum, ac
- Honesti viri Glaudii filii Nycoleti Gachet morantis in Constantina pro una quarta parte alternis medietatis, acque
- Johannis filii quondam Roleti Gachet residens apud Agnes (=Agnens) pro una alia quarta parte dicte medietatis, necnon
- Johannis Gachet et Johannete eius sororis uxoris Stephani Mathey burgensis de Grandcord liberorum quondam Johannis Gachet de Grandcord pro reliqua quarta parte dicte ultime medietatis eorumdem bonorum,

Heredum et bona tenentium quondam Bartholomei et Johannis Gachet fratrum filorum et heredum quondam Roleti Gachet de Villard en Vuilliez.

Evidently the first group, holding a one-half interest, are the descendants of Bartholomeus son of Roletus, and all the rest, comprising the other one-half interest, are the descendants of Johannes, the other son of Roletus. The details revealed in the text of the reconnaissances clarify the relationships. Some of the same parties are mentioned in other terriers at the ACV, especially Fl 402, fol. 588.

Previous terriers cited:

Petrus Garineti of Cudrefin (fol. 98v, during lifetime of Bartholomeus Gachet)

Andreas de Arsina of Estavayer (fol. 98v, during lifetime of Bartholomeus Gachet, and after Petrus Garineti; also fol. 120v; 122v with implied dated after June, 1482)

Regarding property held by Petrus Gachet of Payerne, “**recognite per predictores suos et predecessores dictorum Gachet venerabilibus religiosis conventus ville Staviaci**” (fol. 105v), implying that some of the property was subject to the convent of the Dominicans in Estavayer. The corresponding terriers might be AEF Grosses Dominicains 1, 1462, and Grosses Dominicains 30, 1467.)

4v Johannes de Sibor alias Grassod filii quondam Francisci de Siborg alias Grassod et quoneam Girarde ficti Francisci uxoris filie quondam Johannis Roumont dicti loci de Villard en Vuilliez, 09 dec 1516.

By maternal succession from Girarda mater mea, recognitis olim per dictum quondam Bartholomeum Gachet acquisitis a quondam Jaqueto Roumont de Villard en Vuilliez, unum morsellum terre continentem circa duas posas terre cum dimidia situm in territorio de Villard loco dicto en Evoulx (? or Sevoux ?) juxta terram mis dicti confitentis a parte venti rivum de Cornaulx a parte boree et affrontat eis contors terrarum Petri Gacheti clerici Paterniaci que fuit Petri Hugoneti et terre Francisci Mongney quam tenet a Jacobo Preletaz alias Escophey ab oriente et terre mis dicti confitentis ab occidente. Property previously recognized by quondam Reynaudus Barbey de Villard, also property previously recognized by Amedeus Barbey, and jx terram Petri Gachet notarii Paterniaci. Also property previously recognized by quondam Johannes Vuillieomet alias Chautemps ex acquisitione facta per quondam Bartholomeum Gachet de censu ibidem subscripto a Johanne et Girardo Marischet fratribus, jx terra mis dicti Vuilliermi confitentis quan teneo a dictis Gachet de Landerono, also property previously recognized by quondam Glaudii Gillion de Villard vigore adquisicionis facte per dictum quondam Bartholomeum Gachet ab Henrico Pictet de censu subscripto, jx terre heredum quondam Johannis Gachet de Landerono.

22 Petrus Vouchi (Vouchy) alias Cousandey dicti loci de Villard en Vuilliez, 24 nov 1516.

Previously recognized by Reyaudus Barbey de Villard en Vuilliez by maternal succession and indivis with Johannes Barbey.

24v Nycodus Musy filius quondam Jacobi Musy dicti loci de Villard, 24 nov 1516.

Causam et titulum habens a Nobili Johanne de Monte de Paterniaco, de bonis et recognitione quondam Henrici Pictet alias Gary ex empto pro me mabito a Johanne Gary..., at Delley.

26 Hugoninus Sansonyn alias Senturaz residens apud Villard en Vuilliez, 02 dec 1516.

Ex acquisitione per me facta a Roletto Barbey...,

27v Gladius filius quondam Roleti Gillion dicti loci de Villard en Vuilliez, 26 nov 1516, not history given.

29 Petrus Musy alias Collaud saltore dicti loci de Villard, 26 dec 1516, no history given.

30v Nycodus Gillion alias Masalley filius quondam Glaudii Gillion dicti loci de Villard en Vuilliez, 01 dec 1516.

Previously recognized by Gladius Gillion, by paternal succession.

33 Johannes Bardet alias Billiard faber de Villard en Vuilliez filius quondam Johannis Bardet alias Billiard fabri antenati de Villard en Vuilliez, tam meo que aliorum fratrum meorum nominibus, 05 feb 1516.

De bonis et regonitione dicti Johannis Bardet antenati patris mei, one property jx terre Petri Gachet notarii Paterniaci, another property ex accensation made by Bartholomeus Gachet to his father at Delley.

36 Vuilliermus Jannyn alias Gammel de Villard en Vuilliez, 20 nov 1516.

Previously recognized by Henricus Pictet alias Gari.

37v Johanneta uxor Vuilliermi Jannyn alias Gammel filie quondam Petri de Bellarippa et quondam Anthonie dicti quondam Petri de Bellarippa uxor filie quondam Johannis Mongney de

Villard , et Nycolleta uxor Henrici Cristinaz filie quondam Francisci Mongney de Villard en Vuilliez, 03 jan 1516.

Vigore certe adquisicionis per quondam Bartholomeum Gachet facte a Johanne de Viveis alias Ramuz de Sallavoulx, et nostris legitimis sucessionibus, videlicet mis dicte Johannete ex successione materna et mis dicte Nycollete paterna.

39v Henricus Cristinaz, 03 jan 1516.

Previously recognized by Glaudius Gillion, jx Petri Gachet notarii Paterniaci, property was abandoned to (?) Bartholomeus Gachet who made accensation to Cristinaz,

42 Nycodus Broncod et Johannes Broncod eius nepotis filius quondam Petri Broncod de Villard en Vuilliez, 25 nov 1516.

Previously recognized by Johanneta uxor Petri Broncod de Villard, the other half of the first property is subject to Petrus Gachet notarius Paterniaci. Another de bonis alias dicto Bartholomeo Gachet recognitis per Petrum filium quondam Jacobi Broncod vigore eiumdam acquisitione per dictum quondam Bartholomeum Gachet facte a Nobile Johanne de Mont de Paterniaci, videlicet unam posam terre sitam in territorio de Villard loco dicto en Praz Mosset de longitudine terre Othonii Mongney notarii ab oriente terre Michaelis Mongney ab occidente affrontat terre Johannete uxoris Vuilliermi Jannyn quadam via intermedate a vento et terre Johannis Barbey a borea.

44v Jacobus Preletaz alias Escophey (=Escoffier) filius quondam Vuilliermi Preletaz alias Escophey dicti loci de Villard en Vuilliez, 12 jan 1516.

Que cum Vuilliermus Preletaz quondam pater meus vendidevit et divisevit (?) perpetue pro se et suis heredibus universis quondam Bartholomeo Gachet de Villard en Vuilliez et suis heredibus tres solidos lausannensibus bonorum census precio sixaginta solidorum lausannensibus bonorum per dictum patrem meum a dicto Bartholomeo Gachet haberei confessatorum, assigned on property jx vineam Petri Gachet notarii Paterniaci, rec. **Johannes de Molendino clericus Staviaci 17 nov 1489**, also another cense rec. **Jacobus Mongyey notarius 17 may (or mar?) 1490**, and another at Delley, rec. **Jacobus Mongney 23 jan 1490**, and yet another rec. **Petrus Gacheti notarius Paterniaci**, no date given.

49 Glaudius filius quondam Francisci de Molendino alias Camus et Girardus de Molendino alias Camuz de Villard en Vuilliez, 08 nov 1516.

Glaudius filius Francisci de Molendino alias Camus tam me que fratrum meorum nominibus, et Girardus de Molendino alias Camus de Villard en Vuilliez, previously recognized by Jaquetus de Molendino filius Johannis de Molendino.

51v **Comunitas de Villard**, 01 jan 1516, no genealogical details, but previous reconnaissance(s) by Johannes Gachet mentioned, in manibus Jacobi Bellin notarii Paterniaci.

54v **Eadem**, 01 jan 1516, based on sale by Bartholomeus Gachet to the community of Villars, and then a reconnaissance by Bernardus Vignetaz de Villard.

65 Johannes Perrier for one half, et domini Jacobi capellani and Othonini et Michaelis Mongney for the other half, 07 sep 1518.

Previously recognized by quondam Petrus et Johannes Perrier dicti loci de Villard, ex nostris legitimus successioneibus tam paternis quam maternis, Primo medietatem indivisam cum Petru Gachet notario Paterniaci unius morselli prati situm in finagio dicti loci de Villard loco dicto en Sancte Maris dictum eis Andens de longitudine parti Johannete uxoris Vuilliermi Jannyn et Nycollete uxoris Henrici Cristinaz a jorano pratum Glaudii de Delley et Francisci Mongney ab auberreria affrontat eis contors pratorum a vento et borea, other properties also held ½ by Petrus Gachet (medietatem... parcientem ut supra).

68v Johanneta uxor Vuilliermi Jannyn Nycolleta uxor Henrici Cristinaz pro medietate, et venerabilis dominus Jacobus Mongney capellanus, Franciscus, Othoninus et Michael Mongney de Villard pro alia medietate, 07 sep 1518.

Previously recognized by quondam Girardi Criblet de Sancto Albino facte quondam Bartholomeo Gachet pro medietate et Girardo Hugoneti de Staviaco pro alia medietate, de una posa terre sita ouz Genevre quam tenemus nos dicti confitenum a Discreto viro Petro Gacheti de Paterniaco sub censu ... in quibus dicti Gachet percipere debent medietatem et dictus Petrus Gachet percipere debet medietatem ceusns subscribe, other properties with apparently the same arrangement.

71 Domini Jacobi, Octoneti, Francisci, et Michaelis Mongney de Villard, 07 sep 1518.

Property « que antiguitus fuerat de bonis Johannis Symont », at St. Aubin.

86v Andrea relicta quondam Humberti Gari alias Pictet et Adrineta dictorum conjugum filie uxor Guilliermi Reis residentem in dicto loco de Villard les Friques, 20 nov 1516.

Previously recognized by quondam Henricus Pictet alias Gari, at Delley and St. Aubin,

89v Petrus Bouzanet alias Marion de Villard les Friques, 20 nov 1516.

Previously recognized by quondam Johannes Pictet alias Gari, at St. Aubin.

91 Johannes et Petrus Marion alias Bouzanet, 20 nov 1516.

Petrus Bouzanet alias Marion et Johannes Bouzanet alias Marion de Villard les Friques, Primo unum morsellum terre situm in territorio de Villard loco dicto en Terruz juxta terram Johannis de Siborg quam tenet a Johanne Gachet de Grancord et Johanneta eius uxoris... (this may be an error !).

93 Idem Johannes Bouzanet alias Marion dicti loci de Villard les Friques, 16 nov 1516.

No history, but property is medietatem pro indiviso cum Petro Gacheti notario Paterniaci, unius pecie terre site in territorio Sancti Albinus loco dicto en Plain juxta terram Johannis Billiard terram Margarete uxoris Johannis Rusti ex auberreria et terram Vuilliermi Rusti a vento affrontat terre mis dicti confitentis a borea,

95v Glaudius filius quondam Glaudii Bardet filii quondam Johannis Bardet antenati fabri de Villard les Friques maior natu quatuordecim annorum, de laude Johannis Bardet alias Billiard fratris mei tutorisque et gubernatoris, 25 nov 1516.

Previously recognized by Johannes Bardet antenatus nomine dicti Glaudii eius filii et quondam Johannete eius prime uxoris (that is, recognized by Johannes Bardet the elder, son of Claude Bardet and Johannete his first wife), property at St. Aubin.

97 Glaudius filius quondam Johannis Bardet junioris de Villard les Friques, 20 nov 1516.

Ex empto per ipsum habito a Johanne filio quondam Johannis Gari alias Pictet hodie laudato confirmato pro dictos Gachet, property at St. Aubin, no further history.

98v Anthonius, Glaudius, et Mermetus Bardet alias Villan fratres de Villard les Friques filii quondam Johannis Bardet junioris et Andrinete Mossu eius uxoris, 05 feb 1516.

Property previously recognized by their father Johannes Bardet junior, and antiquitus recognitas per quondam Johannetam uxoris Roleti Taccoroz alias Gardiam (?) de Villard et successive per Johannem Bardet antenatum fabrum et dictum Johannem Bardet juniorum patrem nostrum dictorum confitentes, also property previously recognized by their father Johannes Bardet junior, also property antiquitus recognitis per quondam Petrum Rusguet de Villard, also property de bonis olim recognitis per Nycodum Rusguet alias Bertaz et successive per Andrinetam Mossu matrem nostrum dictorum confitentum, also (fol. 101) **de bonis alias dicto Bartholomeo Gachet in manibus Petri Garineti notarii Cudriffini recognitis per Johannem Bardet et successive eidem Bartholomeo recognitis per Johannem Bardet patrem nostrum dictorum confitentes recognitis in manibus Andree de Arsina notarii Staviaci.**

No history, medietatem unius morselli terre continentis circa duas posas terre sitas in territorio Sancti Albinus loco dicto eis Combes alias Taponeres juxta et longitudine terre Johannis Marion quodam rivo appellata de Lermetajoz (?) intermedio a borea terre heredum Andrinete Mossu filie quondam Mermeti Mossu uxorisque Johannis Bardet junioris a vento affrontat terre seu rape Anthonii Bardet que fuit Nycodi Bectaz ab oriente et rivum de Tombey ab occidente, et

est sciendum que Petrus Gachet de Paterniaco percipit super alia medietate dictarum duarum posarum terre prelimitatarum totidem census eo que dicte due pose terre prelimitate reponitur (abbreviation ?) fuiss et **recognite per predictores suos et predecessores dictorum Gachet venerabilibus religiosis conventus ville Staviaci**... (The last part of this appears to say that the property had previously been subject to the convent of Estavayer, so it might be useful to check for any “grosses” for this convent at the AEF that include property at St. Aubin: These would be AEF Grosses Dominicains 1, 1462, and Grosses Dominicains 30, 1467.)

De bonis et recognitione Anthonii Raspard dicti loci de Villard les Friques, property at St. Aubin, one property is sujet half to the heirs of Bartholomei Gachet, and the other half to Petrus Gachet notarius Paterniaci.

111v Vuilliermus et Johannes Rusti de Sancto Albino en Vuilliez, 22 nov 1516.
Que cum Bartholomeur Rusti antenatus filius quondam Johannis Rusti gratis et sponte pro se et suis heredibus vendiderit Bartholomeo Gachet de Villard en Vuilliez videlicet quinque solidos et sex denarios lausannensibus bonorum census, assigned suer uno morcello vinee sito in vinoglio de Bellarippa loco dicto retro Furnum de Sallavaulx inper suos confines quam vineam presenci aliter tenet Girardus Morel de Constantina...
