1 Franciscus Criblier filius quondam Girardi Criblier et Agnetis conjugum filie quondam Girardi de Sibor de Sancto Albino en Vuilliez, with approval of his mother Agnes, previously recognized by his said mother Agenes (rec. quondam Stephanus Catellani), and before that by Girardus de Sibor (rec. Guionetus de Tretorens), et eadem mater mee ex legitima successionem paterna, properties at St. Aubin and Agnens, also property previously recognized (Guionetus de Tretorens) by Johannes filius quondam Hugueti de Sibor, another previously recognized by Bartholomeus Rolandi and his wife Francesia and then by Nobilis Girardus de Bruello, et quam ab eodem nobili Girardo tenebat Petrus filius quondam Johannes filii quondam Hugueti de Sibor, with separate approval by Agnes, 22 nov 1482, and for Agnes, 13 dec 1483.

4 Bartholomeus Verdon alias Alix filius quondam Johannis Verdon alias Alix de Sancto Albino en Vuilliez, cense, no history, 22 nov 1482. (This reconnaissance is for the small general censuses owed by all citizens for the privilege of residing at St. Aubin, in addition to censuses they might owe as tenants of specific properties.)

5 Bartholomeus filius quondam Johannis Rusty de Sancto Albino in Vuilliez, previously recognized by Vuilliermus de Rippa alias Rusty (rec. Guionetus de Tretorens) and then by my father the said late Johannes Rusty (rec. Stephanus Catellani), en laz Rochetaz de longitudine terre Gladii de Grandes alias Soutier?, others, 22 nov 1482.

6v Humbertus filius quondam Johannis Ramux antenati de Sancto Albino en Vuilliez, previously recognized by his father, by Jaquetus Ramux, and by Johannes Ramux junior (rec. Guionetus de Tretorens), and then (rec. Stephanetus Catellani) by his said father, others, 23 feb 1483.

8v Peroneta (Perneta) filia quondam Johannis Ramux junioris de Sancto Albino en Vuilliez uxor Johannes Jauminez, previously recognized (Guionetus de Tretorens) by Petrus de Sibor, and then (Stephanus Catellani) by me the said Perneta confitens, others, 24 feb 1483.

11 Bartholomeus de Rippa alias Rusty de Sancto Albino en Vuilliez filius quondam Vuilliermi de Rippa alias Rusty dicti loci Sancti Albini, previously recognized by himself (Stephanus Catellani), others, 06 feb 1482.

13v Uldrisetus Perriard de Sancto Albino en Vuilliez filius quondam Johannis Perriard de Paterniaco et quondam Anthonie conjugum filie quondam Jaqueti Ramux dicti loci Sancti

Albini, previously recognized (Guionetus de Tretorens) by dictuus quondam Jaquetus Ramux, Johannes Ramux antenatus et Johannes Ramux junior fratres, also property previously recognized (Stephanus Catellani) by dictus quondam Jaquetus Ramux avum meum maternum, 23 feb 1483.

15v Johannes filius quondam Conodi Braczod dicti loci Sancti Albini et Johannete quondam conjugum, previously recognized (Stephanus Catellani) by his mother, 23 feb 1483.

16v Glaudius Soutier alias de Granges filius quondam Jaqueti de Granges et Marguerete quondam conjugum filie quondam Petri Soutier de Sancto Albino en Vuilliez, previously recognized (Guionetus de Tretorens) by predictus quondam Petrus Soutier avum meum maternum, etc., 01 aug 1485.

19 Bartholomeus de Sibor filus quondam Vuilliermi de Sibor de Sancto Albino en Vuilliez cosanderius, cense, 24 feb 1485.

19v Petrus filius quondam Johannis Nirgoz alias Blan de Sancto Albino en Vuilliez, nomine meo proprio ac eciam nomine et ad opus Johannis Nirgoz alias Blan dilecti fratris mei, previously recognized by their father, many properties, 24 feb 1483,

21v Jaquetus de Sibor alias Uldriod de Sancto Albino en Vuilliez, cense, 24 jan 1483.

22v Vuilliermus Verdon alias Alix de Sancto Albino en Vuilliez, previously recognized (Guionetus de Tretorens) by his father, 24 feb 1485.

24v Petrus Clerc filius quondam Jaqueti Clerc de Sancto Albino en Vuilliez, cense owed by Nobilis Bonus de Bruello (in other words, Clerc is tenant of de Bruello, who is tenant of de Anglisi ?), 24 feb 1483.

25 Nobilis Bonus filius quondam Nobilis Girardi de Bruello et Nobilis Ambrosie conjugum, with approval of his mother Ambrosia, and his paternal brother Franciscus de Bruello capellanus, and in the name of his absent brother Nobilis Andreas de Bruello, previously recognized (Guionetus de Tretorens) by quondam Bartholomeus Rolandi et Francesia eius uxor, and then by the said Girardus his father (Stephanus Catellani), many properties, most with censiers named but not extracted here, except middle of fol. 30v: Item, terciam partem duarum partum duarum seytoratarum prati sitarum ouz Grant Bryt quam nunc tenet Bartholomeus Gaschet de Villar et ab ipsum tenet Johannes Marion dicti loci de Villar sitas in longitudine prati Francisci Grassod a vento et prati eis Gardian a borea et affrontat ab oriente super pascuam publicam et super carreriam publicam ab occidente, 10 mar 1483.

37 Uldristeus Perriard, Humbertus Verdon, Johannes Braczod, Franciscus et Johannes Collaux, Petrus Ramux antenatus, Petrus Ramux junior suo et aliorum fratrem suorum nominibus, Bartholomeus Rusti antenatus, Petrus Nirgoz, Franciscus Gardiam, Vuilliermus Verdon alias Alix, Franciscus Cribliet, Bartholomeus Michon, Perneta uxor Johannis Jauminiez with approval of her husband, Bartholomeus de Rippa alias Rusty, Humbertus Ramux, Henricus

Pictet alias Gary, Andrineta (or Andriveta?) uxor Johannes Bardet junioris with approval of her husband, all approve the above item, 16 aug 1485.

37v Franciscus de Sibor alias Grassod de Sancto Albino en Vuilliez nunc morans apud Villarium en Vuilliez, previously recognized by Johannes filius quondam Uldriodi de Sibor, 10 mar 1483.

38v Marguereta relictā Johannis de Sibor alias Grassod de Sancto Albino en Vuilliez, cense, same date.

39v Petrus Bossiez burgensis Paterniaci filius quondam Girardi Bossiez, previously recognized by quondam Petrus Bossiez (rec. Gionetus de Tretorens), ex legitima succession paterna deventas, with approval of Jaquetus de Sibor alias Uldriod and Bartholomeus de Rippa alias Rusty (censiers), 15 nov 1484.

41 Franciscus Panchiviaz alias Gardian de Sancto Albino en Vuilliez filius quondam Richardi Panchiviaz alias Gardian, in his own name as well as that of Johannes Panchiviaz alias Gardian antenatus frater dicti quondam Richardi patris mei, et Johannes Panchiviaz alias Gardian filius quondam Girardi Panchiviaz alias Gardian eciam fratris dicti quondam Richardi patris mei, previously recognized by Perrussona aviam meam matrem dictorum fratrum (rec. Guionetus de Tretorens), et inde (rec. Stephanus Catellani) per eadem Perrussonam, various properties, 11 may 1485.

45v Jaqueta relictā Petri Michon alias Bossaton de Sancto Albino en Vuilliez tanquam usufructuaria in bonis dicti quondam Petri viri mei, et tanquam tutrix sive administratrix meorum et dicti quondam Petri Michon viri mei liberorum, previously recognized (Guionetus de Tretorens) by the said Petri Michon, 11 may 1484.

46v Petrus Verdon alias Gary de Sancto Albino en Vuilliez filius quondam Petri Verdon, cense, -7 feb 1482.

47v Petrus Ramux antenatus filius quondam Mermeti Ramux de Sancto Albino, et Petrus Ramux junior eius nepos filius quondam Bartholomei Ramux fratris dicti Petri, previously recognized by the said late Mermetus Ramux (Guionetus de Tretorens), and then by the said late Bartholomeus (Stephanus Catellani), various others, 18 jan 1484.

51v Petrus Ramux junior superius nominatus filius quondam Bartholomei Ramux, similar to above, 13 jun 1485.

52v Petrus Ramux antenatus superius nominatus morans Paterniaci filius quondam Mermeti Ramux, similar to above, same date.

54 Girardus filius quondam Johannis Ramux junioris de Sancto Albino en Vuilliez, previously recognized by the late previously mentioned Jaquetus Ramux et Johannes Ramux fratres (Guionetus de Tretorens), 19 feb 1485.

56 Petrus Hugonet Staviaci burgensis, previously recognized by Vuilliermus de Rippa alias Galey (Guionetus de Tretorens), another previously by Vuilliermus de Rippa alias Rusty, 30 jun 1485.

58 Franciscus filius quondam Bartholomei Bergier alias Collaux de Sancto Albino en Vuilliez, and for his brother Johannes as well, previously recognized by their father Bartholomeus Collaux (rec. Stephanus Catellani), and before that (Guionetus de Tretorens) by Richardus Escuyer, various others, including properties on which pension is owed to Bartholomeus Gaschet de Villario (fol. 59v), 09 jul 1485.

61 Petrus filius quondam Jaqueti Verdon de Sancto Albino, cense, 19 feb 1484.

61v Petrus Verdon superius nominatus et Humbertus Verdon fratres filii quondam Jaqueti Verdon et Perrussone quondam conjugum filie quondam Jaqueti Tachy alias Charbona de Sancto Albino en Vuilliez, previously recognized (Guionetus de Tretorens) by dictus quondam Jaquetus Tachy (Tachi), etc., 19 feb 1484, and for Humbertus, 10 aug 1485.

63v Communitatis : Bartholomeus Rusty filius quondam Johannis Rusty, Franciscus Panchiviaz alias Gardian filius quondam Richardi Panchiviaz alias Gardian de Sancto Albino en Vuilliez sindici procuratores et gubernatores tocus ville et communitatis dicti loci Sancti Albini, with counsel and consent of Petrus Ramux antenatus, Petrus Ramux junior, Johannes Nirgoz alias Blan, Uldrisetus Perriard, Bartholomeus Verdon alias Alix, Bartholomeus de Sibor cosanderius, Jaquetus de Sibor alias Uldriod, Bartholomeus de Rippa, Humberti Ramux, Johannes Braczod, et Petrus Verdon dicti loci Sancti Albini, various properties, 09 jul 1485.

67v Glaudius de Montagniaco filius quondam Mermeti de Montagniaco de Dompnopetro Parvo, also for his newpew Humbertus filius quondam Jaqueti de Montagniaco fratris mei, previously recognized (Guionetus de Tretorens) by Ruydus Braczod and by dictus quondam Jaquetus de Montagniaco, 21 aug 1485.

69 Glaudius de Montagniaco superius nominatus, Ayma uxor Glaudii Hostam de Font, et Katherina eius soror filie quondam Roleti de Montagniaco de Dompnopetro Parvo, ego Glaudius pro medietate nomine meo et dicti Humberti filii quondam Jaqueti de Montagniaco pro medietate, et nos dicte Ayma et Katherina nominibus nostris et Johannete sororis nostre uxor Bonifacii Alamand burgensis Rotondimonte pro alia medietate, previously recognied (Guionetus de Tretorens) by dicti quondam Jaquetus et Roletus de Montagniaco et eciam Ruydus Braczod, mention Girardus filius quondam Ruydi Braczo et Johanneta eius soror uxor Jaqueti Rochat ? fabri, 21 aug 1485.

71 Petrus Cuanyer filius quondam Francisci Cuanyer de Deller, previously recognized by himself (Guionetus de Tretorens), 21 aug 1485.

72v Missilliararia Sancti Albini : Franciscus Cribliet et Humbertus Ramux de Sancto Albino en Vuilliez sindici et procuratores acque commendatores dicti loci Sancti Albini et communitatis eiusdem, with list of others giving consent, scilecet totam missilliarariam dicti loci de Sancto Albino en Vuilliez prout ipsa missilliararia se extendit in longum et in latum... (this appears to be

an error for *macellarius*, a meat market; the butchers had to pay a “cense” for the privilege of working in the village of St. Aubin), 05 may 1484.

Agnens

75 Janna filia quondam Perrodi Guenard de Sancto Albino en Vuilliez uxor Glaudii Monet morans apud dictum Sanctum Albinum, previously recognized (Guionetus de Tretorens, and later by Stephanus Catellani) by her father, several properties, many names, 10 may 1484, and by censiers Johannes de Curia and Huguetus Guenard 16 aug 1485..

77 Glaudius Monet predictus morans apud Sanctum Albinum en Vuilliez, cense, 10 may 1484.

78 Huguetus Guenard dei Missiez filius quondam Petri filii quondam Perrodi Guenard de Agnens, and also for Johannes Guenard his nephew filius quondam Jaqueti Guenard frater mei, previously recognized by his father (Guionetus de Tretorens), jx Jaqueta filia quondam Glaudii Melleir alias Abbes uxor Nicodi Chevrodi et Johanneta soror sua uxor Petri Donzel, 10 aug 1485.

79v Jaqueta filia quondam Glaudii Abbes alias Melleir de Agnens uxor Nicodi Chevrod a dicto loco absentis (she seems to be making this reconnaissance on his behalf?), previously recognized (Guionetus de Tretorens) by the late Jaquetus Abbes, also on behalf of all the “missillariam” dicti loci de Agnens, and for all “habitants in dicto loco de Agnens”, 11 jun 1485, Petrus Ramux junior filius quondam Bartholomei Ramux also appears in this reconnaissance.

Villar

84 Henricus Pictet alias Gary de Villar en Vuilliez le Pictet, previously recognized (Guionetus de Tretorens) by Jaquetus de Crousaz, and then (Stephanus Catellani) by « dictus quondam pater meus » (not named, however), 04 dec 1484.

85v Communitatis : Henricus Pictet alias Gary, Johannes Bardet antenatus faber, Johannes Bardet junior, Jaquetus Bouczanet, et Anthonius Raspard dicti loci de Villario le Pictet, previously recognized (Guionetus de Tretorens) bu Nicolletus Fricaz alias Marion, Johannes Fricas alias Pictet, Mermetus Mossu, Johannes Marion alias Fricaz, Nicodus Ruquet, Nicolletus Raspar, Jaquetus et Roletus de Crousaz dicti loci de Villar en Vuilliez, pasturage etc., note parcels on fol. 86 ff : unum morsellum pascue situm eis Marest subtus Villar de longitudine pascuarum communitatis de Villar ultra carreriam a parte boree et pascuam Sancti Albini a parte venti, et affrontat supra dominium Adventhice a parte oriente et supra prata de Villar et supra certas terras que solebat esse prata a parte occidente..., de quo vero morsello pascue sura limitato a dicta communitate tenent Petrus et Nicodus Broucoz de Magno Villario sub censu annuali duorum solidorum... quatuor seytoratam sitas de longitudine prati nostrum confitentem de dictorum pascuis ab oriente et prati Petri et Johannis Perriard dictis pascuis ab occidente, et affrontat pascuis illorum de Sancto Albino a vento et prati heredes Jaqueti filii Roleti de Molendino a borea et tenent ipsi Broucoz duas a vento et alias duas a borea tenent dicti Broucoz de dictis pascuis et ab ipsis ipsas tenet ipse rehempcionis perpetue Bartholomeus Gaschet dicti

loci de Villar de cuius laude et oluntate fecit ? presens recognitio. Item Petrus et Johannes Perrier de dicto Villario tenent a nobis dictis confitentis nomine quo supra dicte communitatis sub censu duorum solidorum, quatuor seytoratas sitas ibiem prope de longitudine prati dictorum Broucoz supra limitati ab oriente et prati Bartholomei et Jonannis Gachet de Landerono et Johannis Marion ab occidente et affrontat mareschie sive pascue Sancti Albini a vento et pascue communitatis de Villario a borea. Item Johannes Bouczanet alias Marion de Villario loz Pictet predictus et Johannes Gachet de Landerono tenent de dict communitatis quatuor seytoratas prati sitas ibidem de longitudine prati supra limitatis dictorum Perrier ab oriente et prati Henrici Pictet ab occidente et affrontat pascue Sancti Albini a vento et pascue de Villar a borea... There are several mentions of a Johannes Gachet not qualified as « de Landerono », but it is not clear if this is intended to refer to a different person. Dated for Petrus et Johannes Perrier “die et anno quibus supra” (=04 dec 1484, date of the preceding reconnaissance), and for the said Bartholomeus Gaschet et Johannes Gaschet de Landerono 21 aug 1485 (thus implying that there is only one Johannes Gachet involved here, and he is from Le Landeron).

87 Andrineta filia quondam Mermeti Mossu de Villar le Pictet alias les Friques uxor Johannis Bardet junioris, previously recognized by her father, and purchased from Petrus de Sibor, 18 jun 1485.

90 Henricus Pictet alias Gary de Villario le Pictet alias les Friques syndicus et procurator sive commendator dicti Villarii et communitatis eiusdem, ex nova accensatione, 16 aug 1485.
