Terrier for Anthonius de Anglisi, commissaire Guionetus de Tretorens de Melduno, 1446-1449. (Another terrier by the same commissaire, dated to about 1448, is ACV Fl 5, a fragment of a « grosse » for Louis de Savoie, in approximately the same area.) This is a predecessor to the terrier for a younger Anthonius de Anglisi, commissaire Andreas de Arsini, 1482-1485, AEF Grosses de St. Aubin 23. The immediate predecessor of Grosses St. Aubin 23, compiled by Stephanus Catellani, is apparently lost.

10v Vuilliermus de Ryvaz alias Gallex de Sancto Albino en Vuilliez, tanquam usufructuarius Mermete filie quondam Mermeti Mischon alias Cuanet de dicto Sancto Albino, from her dowry (but it does not seem to be stated explicitly that she was his wife), 26 oct 1448, witnesses Petrus de Sybor et Mermetus Ramuz de Sancto Albino.

11v Girardus filius quondam Vuilliermi de Sybor de Sancto Albino in Vuilliez, by paternal succession, de bonis et recognicionem quondam Humberti Dagnens, also by succession of Uldrودي de Sybor, also by paternal succession of property previously recognized by quondam Girardus Prior, 27 oct 1448, witnesses Mermetus Ramuz et Vuilliermus Rusti dicti loci Sancti Albini.

13 Petrus de Sybor de Sancto Albino en Vuilliez, de bonis quondam Perrodi Falliez..., property purchased from Johannes filius quondam Hugueti de Sybor, 27 oct 1448, witnesses Mermetus Ramuz et Johannes Nirgo de dicto Sancto Albino.

14v Johannes Nirgoz alias Blam filius quondam Vuilliermi Nirgoz de Sancto Albino en Vuilliez, by paternal succession, de bonis et tenemento Aymoneti Nirgoz, de bonis Perrussone filie quondam Reynaldi de Vuanges, de bonis et recognicionem quondam Girardi Prior de dicto Sancto Albino, ex bonis et recognicionem quondam Jaqueti Cristinier, 28 oct 1448, witnesses Mermetus Ramuz et Johannes Ramuz antenatus.

17 Perrussona filia quondam Roleti Escuer de Sancto Albino en Vuilliez relictique quondam Jaqueti Panchivia dicti loci, by a division made with her sister Nicoleta relictia Perriardi Curtallioz de Grancor, 03 nov 1447, witnesses Mermetus Ramuz et Roletus Verdon de Sancto Albino.

18 Johannes Verdon de Sancto Albino en Vuilliez, de bonis et recognicionem quondam Girardi filii Johanneti Monner de Villar en Vuilliez, ex bonis Perrussete Reynauldiz alias ? per Francesiam filiam quondam Jaqueti Rivat ? , de bonis et recognicionem Jaqueti Cristinier, 04 nov 1447, witnesses Petrus de Sybor et Vuilliermus Rusty.

20 Johannes filius quondam Nicoleti Jordyer dictus Bovet (Bonet ? Lionet ?) de Lovatens, de bonis quondam Agnellete filie quondam Jaqueti Ranat eius quondam matris, 04 nov 1447, witnesses Mermetus Ramuz et Aymonetus Ponat.

21 Petrus filius quondam Michaelis Bossaton de Sancto Albino en Vuilliez, de bonis et tenemento Jaquete filie quondam Girardi Ryolat, also property previously recognized by quondam Girardus Escuer de dicto Sancto Albino, also property purchased from Aymonetus Nirgoz, de bonis et recognicionem Jaqueti Cristinier, 06 nov 1447, witnesses Petrus Cler et Girardus Panchivia (written Pa^{ch}ivia) de Sancto Albino predicto.

22v Johannes filius quondam Hugueti de Sybor de Sancto Albino en Vuilliez dictus Bovet (or Bonet ?), by maternal inheritance, de bonis et recognicionem Hugonodi filii quondam Buomondi Gobier (clear !), ex bonis et regonicionem Jaqueti Cristinier, de bonis et recognicionem Perrussone filie quondam Roleti Escuer, de bonis Girardi Cristinier, 06 nov 1447, witnesses Petrus de Sybor et Johannes Nirgo de dicto Sancto Albino.

24v Vuilliermus de Ripvaz (=de Rive) alias Rusty de Sancto Albino en Vuilliez, by purchase from Mermetus dictus Cuanet de Sancto Albino, which was from the property and reconnaissance of dictorum Gobyer (clear), also by purchase from Bartholomeus et Petrus Collaux from property previously recognized by Perrusseta filia quondam Reynaldi de Fonte, property de bonis et recognicionem Hugonodi filii quondam Buomondi Gobier, de bonis et recognicionem Girardi Prior, property on which Katherina filia quondam Vuilliermi Marie de Adventhica uxor Hugueti Chemoz ? de Corcellis collects 10 deniers annual pension, also de bonis et recognicionem Jaqueti Tachy, Girardi Prior, and Hugonodus filius quondam Buomondi Gobier, 07 nov 1447, witnesses Mermetus Ramuz et Petrus Bossaton de dicto Sancto Albino.

26v Petrus filius Francisci Cuanier de Delley with approval of his father, nomine suo et Mermeti eius fratris, by maternal succession de bonis et recognicionem Francesie filie quondam Girardi Ranat eorum matris, de bonis et recognicionem Hugonodi filii quondam Buomondi Gobier, de bonis et recognicionem Buomondi Gobier, 07 nov 1447, witnesses Mermetus Ramuz de dicto Sancto Albino et Aymonetus Penar ? de Cudriffino.

27v Johannes Jacoz de Delley filius quondam Perrodi Jacoz dicti loci, by purchase from Johannes Bergie alias Collaux de Sancto Albino de bonis et recognicionem Perrussete filie quondam Reynaldi de Fonte, also property purchased from Mermetus Raspars, to whom an annual pension of 6 deniers is owed, 08 nov 1447, witnesses Vuilliermus Rusty et Roletus de Montagniaco clericus.

28v Mermetus Ramuz de Sancto Albino en Vuilliez, de bonis et recognicionem Jaqueti Ranat de dicto Sancto Albino, de bonis et recognicionem quondam Aymoneti Nirgoz que fuerunt de bonis Perrussete filie quondam Reynaldi de Vuanges, also nomine et ad opus Petri et Bartholomei liberorum suorum by Ysabella filia quondam Jaqueti Fontanel, also property purchased from Girardus dictus Prior, de bonis et recognicionem Perrussete Reynauldiz (perhaps Regnauldiz), de bonis et recognicionem Jaqueti Cristinier, 08 nov 1447, witnesses Petrus de Sybor et Johannes Nirgoz de dicto Sancto Albino.

31 Richardus et Girardus fratres filii quondam Jaqueti Panchivia de Sancto Albino en Vuilliez, previously recognized by Girardus dictus Prior, also de bonis et recognicionem Perrussone filie quondam Roleti Escuer eorum matris, de bonis et recognicionem Jaqueti Cristinier, 08 nov 1447, witnesses Jaquetus Verdon et Aymonetus dictus Pruar ?

33 Bartholomeus et Petrus fratres (*et Petrus fratres* is written twice) filii quondam Johannis Bergiez alias Collaux de Sancto Albino en Vuilliez, de bonis et recognicionem Perrodi Falliez, also property purchased from Girardus Escuer, de bonis et recognicionem Jaqueti Cristinier, 08 nov 1447, witnesses Mermetus Ramuz et Richardus Escuer.

34v Johannes filius quondam Uldriodi de Sybor de Sancto Albino en Vuilliez nomine suo et Nicolete eius sororis uxoris Johannis Perragoz, de bonis et recognicionem Girardi Cristinier, wife of the confessant is Johanneta filia quondam Vuilliermi Soutier, de bonis et recognicionem Girardi Ryolat, ex bonis et recognicionem Vuilliermi Bosso que fuerunt de bonis Agnetis filie quondam Girardi Rovat ? , 12 nov 1447, witnesses Petrus Soutier et Bartholomeus Collaux.

36 Ruydinus Brassod (Brasso) de Sancto Albino en Vuillye, from accensation to his predecessors by Jaquetus et Mermetus de Montagniaco de Dompnopetro Parvo, 12 nov 1447, witnesses Petrus Collaux et Girardus Panchivia.

37v Conodus Brasso de Sancto Albino en Vuilliez, property previously recognized by Buomondus Gobier, de bonis et recognicionem Girardi Prior, de bonis Mermeti Cristinier, additional pension owed by Jaquetus filius dicti quondam Mermeti de Montagniaco, 12 nov 1447, witnesses Petrus de Sybor et Johannes Nirgo.

38v Jaquetus filius quondam Mermeti de Montagniaco de Dompnopetro Parvo, the above pension, de bonis et recognicionem Hugonodi filii quondam Buomondi Gobier et quam acquisit ? idem quondam Mermetus de Montagniaco, same date and witnesses.

39 Petrus Cler de Sancto Albino en Vuilliez, de bonis et recognicionem Reynaldi Thachy, de bonis et recognicionem Jaqueti Cristinier, 12 nov 1447, witnesses Petrus de Sybor et Johannes Nirgoz.

40 Bartholmeus Rolandi morans apud Sanctum Albinum en Vuilliez et Francesia filia quondam Johannis filii quondam Girardi Ramuz de Sancto Albino en Vuillie with the approval of the said Bartholomeus (eius uxor, according to the index and many other passages, but we found only one mention here, fol. 42, when they are called “conjugibus”), by inheritance, reconnaissances, and from the estate of the said late Girardus Ramuz, de bonis re recognicionem Johannis Grasso, de bonis et recognicionem Jaqueti filii quondam Girardi Ranat, de bonis et recognicionem Henrici Rolom ?, de bonis et recognicionem Hugonodi filii quondam Buomondi Gobier, de bonis et recognicionem Girardi Prior (written p^{or}), de bonis et recognicionem Reynaldi Tachy, de bonis et recognicionem Perrodi Falliez, property purchased by the predecessors of the said Francesia as well as those of the said Bartholomeus de bonis et recognicionem Jaqueti Cristinier, many small censes owed to them by others (many names), de bonis et recognicionem Buomondi Gobier, de bonis et recognicionem Johnnes filii quondam Vuilliermi Nirgoz, 10 jan 1446, witnesses Mermetus Ramuz de dicto Sancto Albino et Aymonetus Penar ? (but see elsewhere, Penar ?) de Cudriffino.

47 Petrus filius quondam Johannis Brulliot de Missiez, by paternal succession, de bonis et recognicionem quondam Jaqueti Cristinier, same date and witnesses.

47v Richardus dictus Escuer de Sancto Albino en Vuilliez, de bonis et recognicionem quondam Vuilliermi Nirgoz, property purchased from Mermetus Cuanet de bonis et recognicionem Perrodi Falliez, 12 jan 1449, witnesses Petrus Bossaton et Petrus Collaux de dicto Sancto Albino.

48v Prenominatus Richardus Escuer et Perrussona filia quondam Johannodi de Champmartin relict a quondam Johannis Escuer de Sancto Albino predicto as usufruct of the said Johannes her late husband, and also in the name of their minor son Petrus Escuer, de bonis et recognicionem quondam Jaqueti Cristinier, same date.

50 Nicoleta filia quondam Girardi filii quondam Uldriodi de Sybor de Sancto Albino en Vuilliez nunc uxor Johannis Perragoz de Cudriffino, by paternal succession, de bonis et recognicionem Jaqueti Cristinier, same date.

50v Jaquetus Ramuz, Johannes antenatus et Johannes junior fratres filii quondam Nicodi Ramuz de Sancto Albino en Vuilliez, de bonis quondam Johannodi Grasso, de bonis et recognicionem Girardi Prior, de bonis et recognicionem Perrusete filie quondam Reynaldi de Fonte, 14 jan 1449, witnesses Aymonetus Pemar ? et Nicodus Rusquet.

51v Bartholomeus et Petrus fratres filii quondam Mermeti Ramuz de Sancto Albino en Vuilliez, by inheritance and succession from Ysabella filia quondam Jaqueti Fontanel eorum matris, same date and witnesses.

52 Johannes junior filius quondam Nicodi Ramuz de Sancto Albino en Vuilliez, ex bonis et recognicionem Michaelis Bossatom ? , de bonis et recognicionem Johannis Mestraul, dictis bonis ex adquisicionem per ipsum facta a Petro filio quondam Vuilliermi Soutier, ex bonis et recognicionem Bartholomei et Petri Bergiez alias Collaux, 14 jan 1449, witnesses Vuilliermus Rusty et Jaquetus Verdon de dicto Sancto Albino.

53v Johannes Ramuz filius quondam Nicodi Ramuz de Sancto Albino en Vuilliez antenatus (index : Johannes antenatus filius quondam Nicodi Ramuz), by purchase from Mermetus Cuanet de dicto Sancto Albino de bonis et recognicionem Jaqueti Tachy, de bonis et recognicionem Buomondi Gobier, de bonis et recognicionem Jaqueti Cristinier, 18 jan 1449, witnesses Johannes Perragoz et Johannes Verdon.

55 Roletus dictus Cuestron (Cuestrom) de Missiez, ex bonis et recognicionem Jaqueti Cristinier (described in the reconnaissance of Johannes Ramuz antenatus), same date and witnesses.

55v Jaquetus Ramuz de Sancto Albino en Vuilliez, by purchase from Mermetus Cuanet, de bonis et recognicionem quondam Jaqueti Cristinier, 18 jan 1449, witnesses Petrus Collaux et Girardus Panchivia.

57 Johannes filius quondam Johannis Brulliot de Missiez, pension owed by Jaquetus, Johannes antenatus, and Johannes junior fratres filii quondam Nicodi Ramuz de Sancto Albino en Vuilliez, same date and witnesses.

57v Petrus Bossiez de Sancto Albino en Vuilliez morans Paterniaci, de bonis et recognicionem Agnetis filie quondam Girardi Ranat, de bonis et recognicionem Jaquete filie quondam Girardi Ryolat, de bonis et recognicionem Girardi Prior, 18 jan 1449, witnesses Aymonetus Penar ? de Cudriffino et Johannes Perragoz morans in Sancto Albino predicto.

59 Roletus filius quondam Jaqueti de Montagniaco et Jaquetus filius quondam Mermeti de Montagniaco de Dompnopetro Parvo, pension owed by Vuilliermus et Petrus dicti Bossiez, ex bonis et recognicionem Girardi Prior de dicto Sancto Albino already delimited in the reconnaissance of Ruydinus Brasso de dicto Sancto Albino, same date and witnesses.

59v Petrus de Sybor de Sancto Albino en Vuillie superius nominatus, by exchange made with Bartholomeus Rolandi, que fuit ex bonis et recognicionem Mermeti filii quondam Girardi de Sybor, de bonis et recognicionem Jaqueti Cristinier, same date and witnesses.

60v Vuilliermus Marchiam morans in Sancto Albino en Vuilliez, ex bonis et recognicionem quondam Girardi Prior, de bonis et recognicionem Jaqueti Cristinier, same date and witnesses.

61 Johanneta filia quondam Mermeti Mischon alias Cuanet de Sancto Albino en Vuilliez uxor Mermeti dicti Roliquin (written Roliqn), de bonis et recognicionem Jaqueti Cristinier, same date and witnesses.

61v Jaquetus Verdon de Monmagnyel morans in Sancto Albino en Vuilliez, ex bonis et recognicionem quondam Jaqueti Cristinier videlicet ex adquisicionem per ipsum facta a Johanneta filia quondam Mermeti Cuanet de dicto Sancto Albino, 22 jan 1449, witnesses Jaquetus Ramuz et Petrus de Sybor de dicto Sancto Albino.

62v Johannes Friccaz alias Pictet de Villar en Vuilliez, by exchange with Bartholomeus Rolandi de bonis et recognicionem Jaqueti Cristinier, same date and witnesses.

63v Alexia filia quondam Uldriodi Martigniez de Dompnopetro Parvo uxor Jaqueti filii quondam Mermeti Ramuz de Sancto Albino en Vuillie, pension owed by Jaquetus Ramuz de Sancto Albino en Vuilliez, same date and witnesses.

64v Communitas de Sancto Albino : Johannes Nirgoz et Girardus Panchivia de Sancto Albino en Vuilliez syndici procuratores et gubernatores tocus ville et communitatis dicti loci Sancti Albini, descriptions of various pastures and fields on which cense is owed, mention of a cense owed to Dompnus Johannes Cantin ? tanquam rector et desservitor altarum beatorum Georgii et Katherine martirorum fondatum in ecclesia parrochiali beate Marie Virginis de Russudens, dudum legaros ut asseritur per dominos quondam de Grandissono domino pro tempore dicti loci Sancti Albini, mention of convention made by the late Domicellus Petrus de Grandissono dominus Bellimontis dated September 1323, and another dated 01 sep 1330, et est sciendum quod spectabilis et potens dominus Humbertus bastardus de Sabaudia predictum census obligavit Bartholomeo Rolandi in contractu matrimonium inter ipsum et Francesiam filiam quondam Johannis filii quondam Girardi Ramuz de Sancto Albino predicto celebrati precio ducentorum florinum auri..., dictum matrimonium recepta per Reymondum Bonedie (=Bonjour) 01 mar 1405, dated at Cudrefin 20 feb 1449, witnesses Ludovicus de Tretorens clericus et Aymonetus Penar ?

67 Mermetus Raspar (Raspars ?), Perrissona relictia Johannis Escuer, Mermetus Roliquin, Jaquetus Mestre (Meistrez), Johannes Perragoz, Johannes Grasso, Roletus Verdon, Bartholomeus Verdon, Agnexia relictia Vuilliermi de Rivaz alias Rusty morantes in Sancto Albino en Vuilliez, these all owe the small censes of flour etc. assessed to all the residents, and apparently no other rents, 23 feb 1449, witnesses Aymonetus Penar ? et Jaquetus de Montagniac.

68 Perrodus filius quondam Johannis Guenar de Agnens morans in Sancto Albino en Vuilliez, various properties at Agnens ?, but their source not indicated, 05 mar 1446, witnesses Johannes Perragoz et Johannes Uldrioz.

69 Petrus Guenar d'Agnens morans apud Missiez, by donation made by quondam Girardus Jacaud d'Agnens, ex bonis et tenemento antiquo Vuilliermi Gras de Pans ? , 05 mar 1446, witnesses Johannes Nirgo et Petrus de Sybor de dicto Sancto Albino.

(Fol. 69v is followed by fol. 80, evidently a numbering error.)

80 Communitas d'Agnens : Jaquetus Abbes filius quondam Stephani Abbes d'Agnens et Alixona Rend ? relicta Girardi Jacaud d'Agnens for themselves and all the other inhabitants of the said Agnens, various pastures, etc., by accensation from quondam bone memorie dominus Petrus de Grandissono, die Veneris post festum Apostolorum Petri et Pauli 1335, also the cense collected by Dompnus Johannes Cantin (clear) tanquam rector et desservitor altarum beatorum Georgii et Katherine fondatum in ecclesia parrochiali beate Marie Virginis de Ressudens by a legacy from the Grandissono family, and mention of Humbertus bastard of Savoie but no date for the latter obligation, 20 feb 1449, witnesses Mermetus Mossu de Villar et Johannes Perragoz.

Villar le Pictyt

82 Jaquetus de Crousa (Crousaz) de Villar en Vuilliez le Pictyt, from a division made with Nicodus Rasperd de bonis et recognicionem Girardi Monnet de antiquo tenemento quondam Girardi de Dompnodesiderio (=Domdidier), datum et actum apud Villar en Vuilliez in domo habitationis Girardi Hugoneti 02 mar 1446, witnesses Discretus Girardus Hugoneti clericus et Jaquetus de Molendino de dicto Villario.

83 Johannes Fricaz (Friccaz) filius quondam Mermeti Frycaz de Villar en Vuilliez, by accensation made by the late Johannes de Constantina tunc castellanus Grandiscurie, datum et actum Cudriffini 20 feb 1449, witnesses Aymonetus Penar ? et Johannes Perragoz.

84 Communitas de Villar le Pictyt : Nicoletus Fricaz alias Marion, Johannes Fricaz alias Pictet, Mermetus Mossus, Johannes Marion alias Fricaz antenatus, Nicodus Rusquet, Nicoletus Rasperd alias Larjoz, Jaquetus et Roletus de Crousaz de Villar en Vuilliez le Pictyt nominibus ipsorum tocius communitatis ac omnii habitatorum in dicto Villario le Pictet, various pastures, no mention of sources of these obligations, same date and witnesses.

At the end of the volume, part of a parchment used for the binding is visible, but the date is lost. It was probably an accensation or lease by a religious institution. Only the names Johannes et Jaquetus predicti and "nos religiosi" are visible.
