

AEF Grosses Estavayer 117, for Rodulphus de Vuippens, commissaires Johannodus and Petrus Rosseli, 1446-1461.

Abstracts prepared by John W. McCoy (RealMac@aol.com) © 2014.

The first few pages of the index are lost, what remains begins with the index entry for fol. 64. The remainder of the volume appears intact. The introduction on fol. 1 indicates that the volume was compiled by the late Johannodus Rossel clericus Staviaci, and completed by his son Petrus Rosseli de Staviaco clericus, the final text of the introduction dated 22 nov 1446, with signature and paraphe of Petrus Rossel. The volume was compiled, according to the text in some of the reconnaissances, for Nobilis Rodulphus de Vuippens condominus ipsius loci de Vuippens filius quondam Nobilis Petri de Vuippens. AEF Grosses Estavayer 116, dating from 1463, is probably the successor to this volume.

One peculiarity of grammar and spelling should be mentioned here. Like most of the Swiss notaries of the period, Rossel writes *comparcionarius* rather than *compartitionarius*, meaning a partner, one who shares ownership of an asset. But in the case where someone “happens to be” such a partner, he always writes *comparcionarius deventarius* rather than the expected *compartitionarius deventus* (using the passive perfect participle of *devenio*), apparently for no other reason than to make the endings the same. The underlying verb should be *devenio*, but there seems to be no evidence for a participle similar to *deventarius*.
