

## **AEF Grosses Fille Dieu 2, notary Aymonetus Ponel, 1479-1488.**

There is an index, but it is bound between fols. 68 and 69. The cover indicates “Romont, Arruffens, Billens, Préz, par le Commissaire Ponel, 1481.” The volume was compiled for the « monasterium Domus de Filia Dei subtus Rotundumontem Cistercensis ordine Lausanne diocesis », by Aymonetus Ponel (the exact spelling of his name is somewhat doubtful, and his signature and paraphe appears instead to say Ay. Ponel), public notary of the duchy of Savoie. The abbess (*Abbatissa*) of the convent was Domina Catherina de Billens. The text mentions that two previous terriers were compiled by Anthonius Comititis (=Conte), notary. However, these two terriers appear to be lost. The next earlier terrier known to exist for this convent is AEF Grosses Fille Dieu 1, dating from about 1327.

13 Petrus Rod filius quondam Aymoneti Rod burgensis Rotundimontis, by accensation for the late Glaudius Villar burgensis Rotundimontis (previously by the late Roletus Perosat? ) ... in manibus quondam Anthonii Comitis notarii recognitis, 29 may 1481.

14v Anthonius Octionyn burgensis Rotundimontis, previously recognied (Anthonius Comitis, notary) by Nycodus Carnilliaux, Petrus Bollens, and Johannes Octionini late father of Anthonius, 27 jun 1481.

16 Petrus Brayel carpentator et burgensis Rotundimontis, previously recognized (Anthonius Comitis, notary) by Dominus Aymonetus Praz cappellanus Rotundimontis quondam, 27 jun 1481.

17v Petrus filius quondam Petri Bellens burgensis Rotundimontis, by accensation previously recorded by Dominus Petrus Martinodi cappellanus, previously recognized by the late Petrus Bellens father of the said reconnaissant in manibus Anthonii Comitis notarii, 11 aug 1481.

18v Johannes Malliar de Rotundomonte facta nomine ac liberorum quondam Glaudii de Sancto Bernardo eciam de Rotundomonte, ex adquisito per quondam Glaudium de Sancto Bernardo a Petro Regis domicello facto (Aymonetus Crespaz ? notarius 03 oct 1464), also property previously recognied (Anthonius Comitis, notary) by Humbertus Ovrem ex adquisito per dicyum Glaudium de Sancto Bernardo a Johanne filio dicti Humberti Ovren quondam facto (sale recorded by Glaudius de Barracherti ? 24 nov 1463), 28 aug 1482.

20v Nobilis Jacobus Regis filius quondam Nobilis Petrus Regis de Rotundomonte, with approval of Petrus de Ferro ? , by maternal succession, previously recognized (Anthonius Comitis, notary) by Petrus Mauloz burgensis Rotundimontis, same date (there are large blank spaces in this reconnaissance, as if it were expctected that more information would be added at a later date).

Glaudius Ouvry alias Jaquier senior (antenatus) de Prez parrochie de Sivririer, quod cum Vuillermus de Villarsel filius quondam Nobilis Petri de Villarsel teneretur venerabilibus religiosus duabus morsellibus Monasterii Domus de Filia Dei subtus Rotundummontem..., for 40 livres for a pension for honesta religiosa Domina Alixia Lucinaz filia quondam Nobilis Petri Lucens of the said monastery, assigned on various property, mention former Abbess Ysabella de Illens, cense owed then by Johannes Ouvrey de Prez, Jaquetus et Rodulphus fratres filii dicti Johannes Ouvrey, mention document to this effect recorded 03 apr 1443 by Anthonius Comitis notary, now the said Glaudius owes cense on many properties, 19 apr 1482.

69 Girardus Gautier alias Moneir filius Vuilliermi Gautier ac Anthonius filius quondam Aymonis Thorimbert de Grangetes, quod cum Nobilis Franciscus de Syoneveis de Corberiis sold to the monastery for 40 livres, in support (for a prebend) of Nobilis Agnes filia Nobilis Rodulphi filii dicti Nobilis Francisci de Syoneveis of the said monastery, assigned on various properties, on which Jaquetus Thorimbert de Grangetis et Hudricus eius filius owed cense, from sale recorded 18 jul 1433 by Johannes Lombardi de Montagniaco clericus, and another dated 16 nov 1433 recorded by Johannes Alamandi de Rotundomonte notarius, now the said reconnaissants recognize their obligations, Gautier for 30 sols and Thorimbert for 10 sols annual cense, 24 feb 1480.

71 Nobilis Jaquema filia quondam Nobilis Johannis de Billens de Orsonens uxor Johannes Malliardo de Rota, quod cum Nobilis Guillermus de Billens quondam eius frater in suo ultimo testamento (recorded by Richardus Chassot de Orsonens, notarius) bequeathed to the said convent to celebrate mass on the anniversary of his death, 20 livres, now the said Jaquema as universal heir of Guillermus her brother recognizes the obligation of 20 sols cense, 12 may 1481 and approved by her husband on 31 aug 1481.

72v Johannes et Perretus Magnyens filii quondam Girardi Magnyens de Bocterens parrochie de Broch ?, based on sale by them to the monastery of a debt recorded by Jacobus de Balmis clericus, 11 jun 1481.

74v Mermetus de Fonte alias douz Fey loci et parrochie de Broch, from a debt he sold to the monastery, recorded 14 aug 1470 by Bonisfacius Alamandi notarius, 15 nov 1471.

75v Nobilis Ysabella filia quondam Nycoleti de Sancto Martino uxor Nobilis Johannis de Fallerant de Burgondia, based on sale of debt sold to the former Abbess Briancia Fauresse by Nobilis Catherina relictia Nobilis Nicodi de Sancto Martino, recorded 14 jun 1463 by Bonisfacius Alamandi notarius, cense of 110 sols, 03 dec 1481.

80v Petrus filius Anthonii Pisczon (=Pischon ? or possibly intended as Pistzon) et Anthonius filius quondam Johannis Caschyn de Treffayes parrochie de Sales, regarding a donation by the late Ysabella relictia Francisci de Vuisternens domicelli to the monastery ?, approved by Nobilis Agnes relictia Nobilis Rodulphi de Illens militis, mention legacy by Johannes de Vuisternens domicellus grandfather of the said Agnes ? and father ? of the said Franciscus, mention transaction recorded 20 aug 1382 by Roletus Charmes (or conceivably Charvier ?) de Rotundomonte clericus, and the said debt later recognized by Nobilis Petrus Mayor, and later ? by Johannes Vionet and Octioninus his brother (Anthonius Comitibus, notary), now the said reconnaissants recognize the debt owed to Nobilis Nicodus Maior son of the said Nobilis Petrus Mayor (Maioris), 04 jul 1471 and 15 aug 1471.

Nycodus Mocket de Hennyze parrochie Curtilie, by accensation, de bonis et recognicione Petri de Mediavilla, by whom they were previously recognized (Anthonius Comitibus), 26 jun 1486.
