

AEF Grosses Surpierre 56, for Humbertus de Glannaz, commissaire Franciscus Catthyn, 1437-1440.

Abstracts prepared by John W. McCoy (RealMac@aol.com) © 2014.

Many of the reconnaissances indicate that the properties were part of a “tenementum” of someone in the past, but the script is sometimes quite messy, and we have not yet attempted to decipher all of the former holders of these “tenements”. It is not completely clear how old these “tenements” were, but from the names listed, at least some of them seem to date back to the grandparents of the current reconnaissants.

The text was written by two distinct scribes, one with a very clear round hand, the other, possibly the commissaire himself, with a much faster, smaller, and far less distinct cursive script. They seem to have collaborated, as there are reconnaissances where the first scribe begins and the other continues, and vice versa, but the second scribe may have had the last word, as most of the items that appear to have been added after the main text was established, are in his hand.

There is some possibility that the scribes wrote “Conay” as an abbreviation for the family name “Cossonay”. This possibility seems to be raised in the index, but in the text itself, we found both names, with no indication that the two different spellings actually refer to the same person in any instance.
