Following the répertoire, there are 7 folios containing a repertoire to a much later terrier compiled by Mauritz Plainchain (or Plamcham), dated 1575 at the end, and indicating that various pages are missing. These notations (not analyzed here) appear to carry some of the local families forward almost a century. The present volume appears to be collated incorrectly. Fols. 1-17 (preceded by the introduction, which gives the names of the members of the convent at an unspecified date) were found after fol. 59, and followed by fol. 68.

23 Esteveninus Balliot (Balliod) residens Staviaci, from a bequest to the convent by the late Johannes Brunaulx alias Burqui, 11 mar 1463.

25 Franciscus Borgonyon burgensis Staviaci, de bonis alias recognitis per Mermerius Rignaul de Luliez ex empto per ipsum confitentem a dicto quondam Mermerio facto, this purchase recorded by Girardus Hugoneti Staviaci notarius 06 dec 1438, 23 may 1463.
