

# **AVL C 318 Prieuré de Lutry 1538, commissaire Jean Gignilliat, copied by Nicolas Bulet**

This volume appears to be a complete and careful copy of an original terrier that also appears to have given rise to ACV Ff 76bis, which is now incomplete. Ff 76bis and C 318 agree up to the end of the first section, for Savuit. After that point, Ff 76bis contains only 3 reconnaissances. AVL C 318 has the additional advantage of being perfectly legible and perfectly preserved.

**1 Nobles Claude et Estienne Dutruyct filz de feuz Noble Jehan dou Truyct de Saint Pol [=Paul], oultre le lac, 12 oct 1538.** Previously recognized (Jean Vullieti) by Noble Pierre de Saint Amour, and next (Pierre Marchand) by the said noble Jehan Dutruyct pere desdict nobles reconnoissants, et par succession legitime desdict nobles reconnoissants devenue de part Noble Pernette leur mere fillie dudit noble Pierre de Saint Amour, property at Savuyt, some of it en Gravesses. One jx vignes of Marguerite fillie de Mycollet de Mexieres aultrement Piccot relexée de feuz Discret Jehan Croserens. Large number of parcels, but no further history.

10 Jehan Baulx de Oulens, 12 oct 1538. Previously recognized (Pierre Marchand) by Pierre Amiguet, et par institucion testamentaire faicte par Regnyer Amyguet frere maternel dudit recognoissant, a house in the village of Lustrier, jx house of Noble Guilliaume femme de Spectable Girard Grand, fille de feu Glaude Corserens devers vent.

13 Jehan Arenzoz filz de feuz François Arenzoz de Savuyt, 12 oct 1538. Previously recognized (Pierre Marchand) by his father François Arenzoz, by paternal succession. Divided with his brother Jaques.

16 Jaques Arenzoz filz de feu François Arenzoz de Savuyt, 12 oct 1538. Similar to above.

**20v Jehan filz de Estivent Justivel (=Jossevel) de Bussy aupres de Mouldon, 12 oct 1538.** Previously recognized (Pierre Marchand) by his father.

22v Glaude Cloyez aultrement Sauffaultaz de Lustrier comme conjointe personne de Françoise saz femme (fillie de Jehan Gronard bourgeois de Lustrier), 04 jan 1539. Previously recognized (Pierre Marchand) by her father.

25 Glaude Jaquier de Lustrier comment conjointe personne de Pernette saz femme (fillie de Jehan Gronard bourgeois de Lustrier), 04 jan 1539. Previously recognized (Pierre Marchand) by her father.

27v Girard Lanciz de Sales comment conjointe personne de Clemence saz femme (fillie de feu Pierre douz Boys), 25 jan 1539. Previously recognized (Pierre Marchand) by Pierre Cerjat,

and sold by the prieurs and the confrerie of Lustry to her father Pierre douz Boys (rec. D. Jehan Croserens).

31 Nycod Guillaume filz de feuz Nycod Guillaume aultrement de la Ruaz de Savuyt, 30 jan 1539. Previously recognized (Pierre Marchand) by his father.

33v Jehan Sechaux bourgeois de Lustrier, 02 feb 1539. Previously recognized (Pierre Marchand) by Pierre Collet aultresfois demourant en Arans, and sold by him to the said recognoissant (rec. D. Jehan Clavel).

36v Françoise relexée de Guillaume Clavel bourgeois de Lausanne, 28 mar 1541. Previously recognized (D. Pierre Quercu) by Pierre Berod, and next (Pierre Marchand) by Noble Jaques Mayor de Escleppens and after that by Noble Jaqueme de Montfort widow of the said noble Jaques Mayor, and sold by the late Noble Jaques Mayor to Spectable Estienne Loys, and by rehemption faicte dudit Estienne Loys par Messy Baptiste de Aycardis et par donation faicte par ledict Messy Baptiste à ladice Françoise recognoissante.

**39 Noble Girard Mestraulx advoier de Payerne (addition de recognoissance,** implying that C 318 was preceded by another terrier), le Mardy après festes de pasques 1541. Previously recognized (Pierre Marchand) by Bastian Lucens, whose son Pierre sold the property to the said recognoissant. Also in the name of his wife Noble Perrisson fillie de feuz Pierre Crostel, previously recognized (Pierre Marchand) by Pierre filz de Jehan Tornier, and sold to the late Pierre Crostel by Discret Jehan Croserens.

**41 Noble Jehan Chalon filz de feuz Noble Pierre Chalon de Cullie tant à son nom command de ses aultres freres avec luy indivis, 21 may 1541.** Previously recognized (Pierre de Quercu) by noble François de Lustrier aultrement Biougie command et conste par recognoissance levée et signée par Nycod Gavod commissaire des registres dudit Pierre de Quercu, et puys apres (Pierre Marchand) by Pierre Biougie.

43 Pernette fillie de feu Discret Pierre Croserens de Lustrier femme de Discret François Daulx de Lausanne (Pierre is son of Jehan Croserens and Marguerite fillie de Nycollet de Mexieres aultrement Piccot de Savuyt), 02 aug 1541. Previously recognized (Pierre Marchand) by Nycollet de Mexieres aultrement Piccot de Savuyt, and by succession to the said Pernette from her father Pierre Croserens son of Marguerite, fillie dudit Nycollet de Mexieres. Some of it indivis ½ with the saons of the late D. Jehan Croserens. Some properties had come from Discret Jehan Croserens, father of both Discret Pierre and Discret Jehan and grandfather of the said Pernette. Also property previously recognized (Pierre Marchand) by Glaude et Bernard Liardet, and paravant par Humbert Marsens, et par tilter d'acquisition faicte de Glaude Baucion pour le pris de 19 florins (rec. D. Glaude Planallet). Also property previously recognized (Pierre Marchand) by Jehan et Thiebaud de laz Cuaz de Belmont.

50v Catherine fillie de Michel Grand de Lustrier (addition de recognoissance) (she is a sister of Pernette Croserens, above), however the text first says Catherinen fillie de Michiel Blan, rather than Grand, as specified in the title, but later says Grand, 02 aug 1541. Previously recognized (Pierre Marchand) by Nycollet de Mexieres aultrement Piccot, then sold by Discret

Jehan Croserens and his wife Marguerite daughter of the said Niccollet, to Michel Grand, father of the said recognoissant.

52v Pierre filz de feu Discret Jehan Croserens de Lustrie (his tuteur is Noble Pierre Malliardo de Grandvaulx) (he is the brother of Pernette and Catherine, above), 15 sep 1541. Previously recognized (Pierre Marchand) by Nycollet de Mexieres aultrement Piccot de Savuyt et par institucion testamentaire faicte par feuz Marguerite fillie dudict feuz Nycollet de Mexieres aultrement Piccot audict Jehan Croserens père dudict Pierre recognoissant, indivis avec Pernette fillie de feuz Discret Pierre Croserens femme de Discret François Daulx. Fol. 54, Jehan, grandfather of the said Pierre recognoissant, was the son of Blaise Croserens.

59 Estivent Ogier de Lustrier, 22 sep 1541. Previously recognized (Pierre Marchand) by Jaquet Baucion, and then (by the said commissaire Jehan Gigniliat) by Pierre Gillion...

61v Spectable Joffrey de Fabrica (from his uncle François de Fabrica), 18 oct 1541. Previously recognized (Pierre de Quercu) par Pierre Berod de Bossieres homme talliable dudict prioré et pui apres es mains de Discret homme Humbert de Myvillaz par noble Anthoine Mayor auquel noble Anthoine les biens dudict Pierre Berod et tenement furent affranché et redduict à hommage liege par messy George de laz Rochette pour alors administrateur dudict prioré du consentement de tout le couvent et religieux dudict prioré commandant et conste en laz lettre de affranchement rechue et signé par Discret homme Humbert de Myvillaz datée au chapitre dudict prioré de Lustrier le vingt six jour du mois de may l'an notre seigneur Jesuchrist mille quatre cent soixante quatre, et aussi puis apres recogneu es mains de Discret homme Pierre Marchiand poru alors aussi commissaire dudict prioré par noble Jaqueme de Montfort relexée de noble Jaques Mayor de Esclippens et par acquisition aultresfois faicte par messy François de Fabrica oncle dudict recognoissant de Noble Jehan Mayor et par institucion testamentaire faicte par ledict messy François de Fabrica audict messy Joffrey recognoissant. Previously recognized (Pierre Marchand) by the said noble Jehan de Villarsel père de ladict Aymé[e] et par exequution de passement obtenus par ledict noble recognoissant au nom de sadict femme dessus les biens de feuz noble Guilliaume de Villarsel son frere, ½ indivis with Noble Jehan de Villarsel frere de ladict noble Aymé[e].

67v Aymé Albyn, 26 nov 1541. Previously recognized (Pierre Marchand) by Jehan Gronsar, and before that (Jehan Vullieti) by noble Jaques Gru.

69v Noble Jehan Gru (Gruz) bourgeois de Lustrier, represented by Discret Jehan Ruffy de Grandvaulx his procureur, 04 feb 1542. Previously recognized (Pierre de Quercu) by Pierre Berod de Bossieres, and after that (Humbert de Myvillaz) by Notle Anthoine Mayor (see above etc.), followed by the teneur of the procure, Noble Jehan Gruz donzel de Lustrier faict scavoir etc. 28 jan 1542.

74 Jehan Rosche bourgeois et lieutenant de Lausanne, appothecaire, 28 dec 1546. This reconnaissance is in a different hand from the others, but it is still signed by Gigniliat.

Previously recognized (Pierre de Quercu) by Pierre Berod, and then by Marguerite fille de Johannod Vyonnyer de Savuyt relaissée de Vuilliesme Marquix, and after that (Pierre Vullieti) by Jehan Rosche bourgeois et appothecaire de Lausanne... Also fol. 76, property previously recognized (Pierre Vullieti) by Alix femme de Barthollomey de la comba femme de Discret Humbert Marsens.

76 Anthoine Gillieron de Servion, 09 nov 1538. Previously recognized (Pierre Marchand) by Aymé de Gard ? and by remission faicte audict recognoissant par messy Pierre Morelli abbé d'Haultcrest.

79 Glaude Cottet demourant sus le Mont de Lustrier, 09 nov 1538. Previously recognized (Pierre Marchand) by Jehan Baucion de Belmont, sold by him to the recognoissant (rec. Clement Gilliard).

80v Jaques et Pierre Lisod demourans en laz Forel sus Lustrier, 09 nov 1538. Previously recognized (Pierre Marchand) by Jehan Baucion de Belmont, sold to the recognoissant by Pierre de Vaulx aultrement Bechet (rec. Hugonyn Thorenche).

82v Anthoyne (de) Bordon aultrement Mathiot nepveux de feuz Michiel Mathiot et Pierre Mathiot alias Berdon (adotifz dudict feuz Michiel Mathiot), 09 nov 1538. Previously recognized (Pierre Marchand) by Jehan Baucion.

85 Pierre Abicel de Belmont, 05 feb 1540. Previously recognized (Pierre Marchand) by Jehan Vaulet aultrement Pattolyz, and before that gy Glaude Abicel père dudict recognoissant. Also property previously recognized (Pierre Marchand) by Glaude[,] Bernard et Pierre Liardet, sold by Pierre Lyardet to the recognoissant, etc.

89 Jehan Baucion de Belmont, 05 feb 1540. Previously recognized by Glaude Baucion filz de Janod Baucion et consequemment par ledict Jehan Baucion recognoissant.

92 Pierre Liardet de Belmont, 07 feb 1540. Previously recognize (Jehan Vullieti) by Glaude Liardet, and then (Pierre Marchand) by Glaude et Bernard Liardet. Some shared ½ with Jehan Liardet.

96v Jehan filz de Thiebaud de laz Cuaz de Belmont, 07 feb 1540. Previously recognized (Pierre Marchand) by his father. Also property previously recognized (Pierre Marchand) by Jehan de laz Cuaz filz de Michel de laz Cuaz moitié avec Girard de laz Cuaz.

100 Girard de laz Cuaz filz de Thiebaud de la Cuaz, 20 nov 1540. Previously recognized (Pierre Marchand) by his father.

102v Guilliaume Vacherin de Lustrier, 09 dec 1540. Previously recognized (Pierre Marchand) by Pierre Appostelloz and his brother Domp Anthoine Appostelloz.

104 Jehan douz Bugnyon de Belmont, 09 dec 1540. Previously recognized (Pierre Marchand) by his father Pierre du Bugnyon, and before that by Glaude Baucion.

109 Jehan Favre de Gumuens, 10 dec 1540. Previously recognized (Pierre Marchand) by Nycollet de Mexieres aultrement Piccot, and by sale by Glaude de Fossaulx to feuz domp Pierre Favre, and by institucion testamentaire faicte au dict recognoissant par ledict Domp Pierre Favre.

111 Anthoine Gavet bourgeois et marchand de Lausanne, 10 dec 1540. Previously recognized (Pierre Marchand) by Jehan Baucion...

113 Pierre Borgonyon alias Guillaumaz de Lustrier, 15 sep 1541. Previously recognized (Pierre Marchand) tant par Jehan de laz Cuaz command par Thiebaud de laz Cuaz de Belmont, and sale to the recognoissant by Jehan and Girard de laz Cuaz (rec. Pierre Croserens).

115 Lois Ravey de Belmont, 08 oct 1541. Previously recognized (Pierre Marchand), party not named.

117 Pierre Jordan gendre de feuz Jaques Tanod, 08 oct 1541. Previously recognized (Pierre Marchand) by Jehan Baucion and by Glaude et Bernard Liardet.

119 Nycod filz de Aymé Pon, 19 jan 1542. Previously recognized by Glaude filz de Janod Baucion, and then (Pierre Marchand) by the said Aymé Pon. Property in Belmont en laz Fonjallaz aultrement en Macherel jx Gaspard de laz Planchiz de Lustrier devers laz bize.

120v Messy George de Pré prieur de Provalley, 19 jan 1542. Previously recognized (Pierre Marchand) by Jehan de laz Maz.

121v Noble Jehan de Villarsel Seigneur de Delley, 19 jan 1542. Previously recognized (Pierre Marchand) by his father noble Jehan de Villarsel.

122 Anthoynne Guyset demorant à Lustrier, 19 jan 1542. Previously recognized (Pierre Marchand) by Anthoynne de Castelloz.

Previously recognized (Pierre Marchand) by Domp Jehan Muvilliod chapellain de Lausanne et par institucion testamentaire faicte audict reconnoissant par Janne saz femme fillie de feuz Jehan Perret. Jx Pernette relexée de feuz Discret Saturnyn Ruffy que fust de Glaude relexée de feuz Pierre du Crest devers occident.

132 François Chemyn filz de feuz Jehan Chemyn de Cort dessoub Lausanne, 20 jul 1539. Previously recognized (Pierre Marchand) by the said Jehan Chemyn père dudit reconnoissant.

134 Pernette relexée de Pierre Milliex tutresse de ses enfans, 20 jul 1539. Previously recognized (Pierre Marchand) by her husband.

136 Pernette relexée de Discret Saturnyn Ruffy bourgeois et notaire de Lausanne, 12 jan 1540. Previously recognized (Pierre Marchand) by Glaude relexée de Pierre douz Crest fillie de feuz Jehan Pachod, and before that (Discret Mermet Loys) by Mermod Muvilliod, by legitimate succession.

138 Jehan filz de Jaques Balliod clerc et bourgeois de Lausanne, 12 jan 1540. Previously recognized (Pierre Marchand) by Pierre Balliod cordannier et bourgeois de Lausanne, and before that (Pierre Vullieti) by Jehan Villard. Another property previously recognized (Pierre Marchand) by the said Pierre Balliod, and before that (Pierre Vullieti) by Lois de Mex.

140v Collette relexée de Discret Jehan Tissot (Tissoti) fillie de feuz Discret Jehan Vauderrey aultrement Charvet bourgeois de Lausanne, 02 jun 1540. Previously recognized (Pierre Marchand) by her father. 149 \_\_\_\_\_ filz de Pierre Versel sallier de Lausanne (his tuteur is Bonaventure Frontonay bourgeois de Lausanne), 05 oct 1540. Previously recognized (Pierre Marchand) by Jaques Vincter apothicaire de Lausanne, and sold by him to the said late Pierre Versel.

152 Jehan Borgeis (Borgey) bourgeois de Lausanne, 31 aug 1541. Previously recognized (Discret Arthaud Loys) by Jehan et Estienne Borgeis, and after that (Discret Jehan Villieti) by Pernette relexée de Lois Clavel, and then (Pierre Marchand) by Aymé Clavel, and then by donation of all his estate by the said Aymé Clavel to the said reconnoissant.

154 Françoise fillie de feuz Pierre de laz Chaulx femme de François Marlinjoz bourgeois de Lausanne, 31 aug 1541. Previously recognized (Pierre Marchand) by her father. Also property previously recognized (Pierre Marchand) by Girard Clerjat, then sold to the late Glaude Guyon, and after that by remission to the said reconnoissant by the heirs of the said Glaude Guyon.

Previously recognized (Discret Arthaud Lois) by Jaques de Chastel, and then (Pierre Villiencii) by Pierre Blescheret, and then (Pierre Marchand) by Henry de laz Praz monneyer de Lausanne, and sold by Francois son of the said Henry de laz Pra to Maistre Guillaume Guyot masson et bourgeois de Lausanne (rec. Discret Jehan Benedicti, levé et signé par Discret Jehan François), then by remission by Guyot to Jehan Perret aultrement de Leiderrey de Penthaz by right of proximity (rec. Discret Jehan Chevalleri), and then by sale by \_\_\_\_\_ Perret aultrement de Leiderrey to noble Aulbert Loys frère dudit recognoissant (rec. Jehan Chevalleri). 172 Marguerite fillie de Estienne Gratilliet de Cort demourant en Martherey avec Blaise Lavandey, 08 nov 1541. Previously recognized (Pierre Marchand) by the said Marguerite.
