1 08 feb 1608, Partage, Gaspard Dutoit bourgeois et marchand de Moudon and his brother Egrege Jaques Dutoit notaire, sons of the late Jaques du They vivant marchand et bourgeois de Moudon, many properties. Some at le Plan, some from the Mestraulx family, one from the “discussion” of the estate of the late Discret Daniel Demierre, also, Item, le champ de dessoubz le Devens de leur bien paternal, partissant d’avecq celuy d’Egrege Balthazard Duthoict”, witnesses include Pierre fils de feu Jean Duthey de Chavannes.

4 0-5 feb 1607, Exchange, Philippe fils de feu Noble François Cerjat et Balthazard Decristaz notaire et bourgeois de Moudon.

5 30 jul 1611, Partage, Jaques Berthod bourgeois de Moudon, Jerominaz Berthod sa soeur wife of Jean Frossard bourgeois de Moudon, and the other children of the late Louis Berthod vivant bourgeois de Moudon, witnesses include Guillaume Frossard bourgeois de Moudon and his wife Thievenaz mere desdits partissantz, Claude and Vuille Berthod their uncles, and Jean Frossard et Jean son fils mari de ladite Jeronymaz.

6v 19 jun 1606, Marriage, Daniel Jaulnier cousturier bourgeois de Moudon, to Antheine fille de feu Claude Beroz de Romainssin ? represented by Pierre Dutoit son oncle et Daniel et Abraham [Dutoit ?] ses cousins, settlement includes her part of the estate of her late cousin, apparently not named, who was the daughter of the late Anthoine Dutoit bourgeois de Vevey.

08 nov 1606, Anthoine Dutruict bourgeois de Moudon sells to Jean Dutoit bourgeois de Moudon pelletier.

11 04 feb 1611, Prononciation, Jean fils de feu Pierre Porchet bourgeois de Moudon contre Philippe Porchet son cousin residant en la grange de Belflori, regarding the partage of their properties held jointly.

12v 27 nov 1611, Testament au cour de Moudon, Hanns Thievauld Decrevel notaire vidompne dudit lieu tenant la cour ordinaire, Pernon Chaneaz femme de Jean Cavin died a little more than three weeks ago, apparently her entire estate goes to her husband.

13v 03 oct 1611, Testament, before Balthazard Dutoit, notaire, vidomne de Moudon tenant la cour extraordinaire, Jaques Potterat de Syens died a little over a month ago, his widow is Catherine Milliard.

14v 04 jul 1611, Testament, before Balthazard Dutoit notaire and vidomne, Benoit Vuagnieres vivant bourgeois et officier de Moudon died about six weeks ago, his widow is Genon, witnesses Emoz (=Aimé) Dutoit and François Cresinel bourgeois de Moudon.

15 02 jan 1612, Marriage, Samuel Dutoit regent d'eschole de Moudon fils de Spectable Pierre Dutoit, to Catherine fille de Guillaume Frossard bourgeois de Moudon. Catherine has a brother Anthoine, and a sister who is already married, Pernelle, with quittance.

17 12 may 1612, Marriage, Humbert Trolliet fils de feu Anthoine Trolliet de Martherenges, to Evaz fille d'Egrege Michel Frossard notaire, with quittance.

19 30 mar 1609, Marriage, François fils de feu François Buttex de Granges, to François fille de feu Egrege Bettex (once written Betthex) curial de Lucens, witnesses include Jaques et Abraham Buttex brothers of the groom, and Andrey et Jaques Bettex, brothers of the bride., with quittance.

22 13 oct 1611, Marriage, Vulliesme Trolliet de Seigneulx fils de feu Claude Trolliet, to Marie fille d'Egrege François Bettex notaire et curial de Lucens, with quittance.

24v 13 oct 1611, Marriage, Pierre fils de feu Claude Trolliet de Segneux, to Jeanne fille d'Egrege François Bettex, with quittance.

27v 28 feb 1611, Marriage, Bastian fils d'Egrege François Bettex, secretaire de Lucens (above, François is the curial of Lucens), to Claudinaz sister of Egrege Anthoine Dutoit notaire et bourgeois de Moudon, the settlement stated to be similar to that of her sister Elizabeth, who is the wife of Daniel Fornier.

30v 28 feb 1611, Marriage, Jean fils d'Egrege François Bettex secretaire de Lucens to Jannaz or Jehannaz Dutoit, sister of Egrege Anthoine Dutoit, with quittance.

32v 23 feb 1611, Partage, George, Benoit, et Jean Besenson freres, their mother is Pernelle Richard, their cousin in Pierre Richard.

35 05 oct 1610, Arrest, Spectable Abraham Demierre for his brothers Jaques, Isaac, et Daniel, contre Jean Demierre their other brother, their mother was probably the late Françoise de Veriez, Spectable Jonas Merle is their brother-in-law whose wife is Françoise Demierre, and Spectable Jacob Gaillard is their brother-in-law.

37v (no date), Anthoine Dutruict sells to Jean Duthey pelletier, incomplete.

(At this point, there are two sets of folio numbers. The one positioned below the other at the top of the page is apparently the correct one.)

38 28 oct 1611, Marriage, Abraham fils de Jean Ansonnet masson et bourgeois de Moudon, to Anthoine fille de feu Pierre Costerd bourgeois de Moudon with her mother François and with her brothers Michel et Benoict Bosson.

40 03 dec 1614, Marriage, Abraham Buttex de Granges to Susanne fille d'Egrege François Bettex notaire et bourgeois de Lucens, her mother was the late Jeanne Cen[t]livres, and his brothers are Philibert and François Buttex, with quittance.

43 13 jan 1610, Exchange, Aymé Dutoit et Jost Buttin fils de Collet Bussin, a house at Neyruz that Aymé had purchased from Collet Buttin.

44 10 aug 1613, Marriage, Claude file de feu Noble Abraham Claval (=Clavel ?) bourgeois de Culliez et de Louise du Mur, to Noble Barbille fille de feu Noble François de Villarzel vivant seigneur du Delley et chatelain de Lucens et de Susanne de Graffenried. The bride's brothers are Jean and François de Villarzel, with quittance.

47v 28 feb 1616, Whereas a donation was made, for Daniel and David Dutoit, brothers, of Chavannes. Michel Frossard notaire et metral, tenant cour à l'ordinaire, by Alexandre Veyre leur parent, ne se pouvant de son mesme regir et conduire pour cause de son infirmité et viellesse, recorded 27 dec 1615 by Discret Jaques Jayet, now it is noted that Veyre died about 14 days ago. The donation of 27 dec 1615 is found in surviving registers of Jaques Jayet, DL 57/1, fol. 124v.

48v 03 dec 1615, Martin Meystre de Thierrens as guardian of Anne fille de feu Abraham Meystre de Thierrens, sells to Jaques et Jean Meystre sons of the late Claude Meystre of Thierrens.

50v 03 dec 1615, nine additional sales by or concerning Martin Meystre, to various parties: to Humbert Chevalley de Thierrens; to Jean Piot, hoste; to Jean Mottaz residant à Thierrens; to Gerard Meystre; to Discret Jean Favre de Thierrens; to Martin Meystre for his wife Jeanne Piot; to Jaques fils de Pierre Berzin; to Pierre Clot residant à Thierrens; to Bernard Pahuz, Gerard Meystre, et Pierre Clot.

54v 10 jun 1615, Marie Estoppey relaissée de feu Michel Frossard de Brenles bourgeois de Moudon for her children, accompanied by Jaques Frossard her "coadjuteur" and Guillaume Frossard her beaufrere, sells to Mauris Coster chatelain d'Oron, with mention of an inheritance from feu Egrege Jaques Doges d'Oron.

56 31 may 1615, Marriage, Noble George François Charriere seigneur de May et seigneur de Pentaz, to Noble Anne Joffrey relaissée de feu Noble Jean Mestral bourgeois de Payerne, coseigneur de Combremont le Petit, witnesses include Claude Andrey Charriere, son of the groom, and Michel Besson, "parent" (i.e., relative).

- 57v 26 mar 1617, Testament, before Jaques Frossard vidomne tenant cour à l'ordinaire, Benete Oguex has died, relaissée de feu Thomas Braliard de Sottens, aunt of Pierre et Jaques Badoz de Cremin, about 8 dyas ago.
- 59 12 feb 1617, Testament, before the cour ordinaire, Marie Pasche relaissée de feu Jaques Dutoit de Chavannes has died, about 14 days ago, her verbal testament presented at the request of Nicolas du Fourt, Pierre Chappuis, and Pierre Rospraz, testimony by the witness Jean fils de Pierre Dutoit de Chavannes, whose daughter Jenon is the wife of Pierre Chappuis.
- 60v 20 sep 1615, Abraham Bize conseiller et bourgeois de Moudon sells to Egrege Gaspard Jossevel notaire et conseiller de Moudon.
- 61v 25 nov 1615, Exchange, Abraham Bize conseiller et Pierre Buttet bourgeois de Moudon.
- 63v 11 oct 1617, Testament verbal, Noel Fauchierres died three weeks ago, presented by his brothers Pierre, Jean, and Jaques Fauchierres and by Jaques Jordan for his wife, who is a sister of these brothers. The heirs are the three brothers.
- 64v 10 apr 1616, Abraham Bize conseiller selle to Pierre Dutoit officier et bourgeois de Moudon.
- 66 04 dec 1616, Testament verbal, Balthazard Fauchierres died three weeks ago, brother of Jean Fauchierres de Bussy, and his mother is Anthoine Trolliet.
- 67 21 jan 1618, Testament, Anthoine Lymat died about eight days ago, heirs his daughter Françoisse, daughter Anthoine, and son Philibert.
- 68 27 feb 1618, Daniel Riguet officier et bourgeois de Moudon sells to Claude Guex bourgeois de Moudon.
- 69v 16 may 1617, Jaques Jayet conseiller et bourgeois de Moudon sells to Jeannaz Ansonnet relaissée de feu Anthoine Myevillaz vivant bourgeois de Moudon.

- 75v 09 nov 1617, Magdelaine relaissée de feu George Folliet marchand acting for her son Jaques, owes Claudaz Greppaz marchande à Moudon.

- 77 26 feb 1618, Jaques Jordan tuteur testamentaire for the heirs of the late Jaques Fauchierres de Bussy sells to Jaques Frossard conseiller.
- 79 20 jun 1615, Guillaume Frossard sells to Mauris Costerd chatelain d'Oron.
- 80 29 nov 1619, Pierre Rechoz bourgeois de Moudon owes Jean Fauchierres as guardian of Catherine Bocharde sa belle-mere.
- 81v 16 feb 1620, Testament verbal, François Martin de Borinaux, his widow is Pernon Trolliet, he died about six weeks ago.
- 83 12 mar 1620, Pitius (=Sulpicius) de[s] Borines bourgeois de Moudon acting as guardian of Rosaz fille de feu Pierre fils de feu Bernard Gilliand vivant bourgeois de Moudon, sells to François Gillieron de Peyres bourgeois de Moudon.
- 84v 12 mar 1620, Pitius de[s] Borines bourgeois de Moudon sells to the heirs of the late Bernard Gilliand.
- 85 02 dec 1612, Prononciation, Henry Wagnieux contre Anthoine Wagnieux.
- 86 19 feb 1615, François Baudet bourgeois d'Orbe as guardian of Catherine fille de feu Jaques Decristaz and for Charlotte sa femme aussi fille d'icelluy, sells to Egrege Denis Pyvart notaire et bourgeois de Moudon.
- 88 03 jul 1616, Gabriel de Blonay sells to Denis Pyvart secretaire et bourgeois de Moudon.
- 90 02 jun 1610, Exchange, Egrege Anthoine Dutoit conseiller contre Jean Dutoit de Chavannes.
- 91v 02 jun 1610, Exchange, Egrege Anthoine Dutoit contre Elie Dutoit.
- 92 (no date or title), Dispute, Jonas Jaquemet hoste demurant à Moudon contre Jaques Bourgeois bourgeois de Grandson, incomplete.
- 93 25 feb 1615, Henri de Praromand seigneur de Cheyres sells to Jaques Jayet.
- 94 16 jun 1618, Marriage, Jean Yanaz de Granges sus Vevey, to Françoise fille de Daniel Demond bourgeois de Moudon et de sa mere George.
- 96 13 oct 1610, Susanne Socquet with her husband Samuel Monney (she is the daughter of the late Gustin Socquet bourgeois de Moudon) sells to Claude Chappuis favre et bourgeois de Moudon.
- 96v 25 jan 1620, Prononciation, Spectable Anthoine Aygre bourgeois de Moudon diacre à Lucens, with his brother Pierre Aygre, contre Jean Mestraulx cordonnier et bourgeois de Moudon son beaupere. Mestraulx has married Marie Gerbaz, the mother of these two brothers.

- 99 29 apr 1620, Divestiture, regarding the estate of Jaques de Garzel bourgeois de Moudon, whose daughter Catherine had married François Borel and then died, leaving issue. Catherine's mother was Alix Demierre.
- 101 18 jun 1620, Jaques Jayet conseiller as guardian for the estate of feu Egrege Jaques Dutoit notaire et bourgeois de Moudon, sells to Claude Guex.
- 102v 17 aug 1620, Guillaume Demierre owes Guillaume Frossard.
- 103v 15 mar 1620, Adam Monachon for 1/4 and his brother Pierre Monachon for 3/4 owe Balthazard Jayet.
- 104v 13 mar 1625, François Meystre sells to Christoffer Favre de Thierrens, subhastations, with similar transactions for Jaques fils de Claude Meystre and Pierre Chevalley dict à Jenon to Jean Cuagniez.
- 107 12 may 1621, Daniel fils de François Dutoit de Chavannes bourgeois de Moudon owes Egrege Anthoine Dutoit notaire.
- 107v 28 may 1612, Prononciation, Egrege Hanns Thibaud Decrevel contre Gaspard Dutoit bourgeois de Moudon.
- 109v 28 feb 1620, Jean et Abraham Martin, debt to Pierre Martin de Neyruz resident à Berne.
- 110v 28 jan 1621, Egrege Jaques Jayet as guardian of Sara fille de feu Egrege Jaques Duthey notaire sells to Sara Nycod relaissée de feu Gaspard Dutoit vivant conseiller.
- 112v 17 aug 1617, Exchange, George Dubrit and the commune of Sottens.
- 115 21 may 1621, Magdelaine relaissée de feu George Folliet with her son Jaques sells to Jean Gagnieres dit Bernard de Sarzens, with letter of cense.
- 117 11 oct 1617, Testament verbal, Jaques Fauchierres, presented by his widow Marie Trolliet, he died about 14 days ago, heir his daughter Esther wife of Abraham Gatavin.
- 118v 18 apr 1618, Testament verbal, Susanne sister of Jaques Trolliet died about 14 days ago, she was the widow of Thyvent Pidoux de Forel, leaving a daughter Jeanne and a sister Jeannaz.
- 119v 10 may 1620, Testament verbal, Martin du Boz de l'Abbaye de Rossinges died about six weeks ago, his heirs are his sons François and Jaques du Boz.
- 120v 18 apr 1621, Testament verbal, Jaquemas Gerard wife of François Braliard of Sottens has died, heir her son Daniel Porchet.

(Fol. 120v is followed by fol. 130, a numbering error not uncommon at this period.)

131 07 feb 1621, Testament verbal, Louis Jacquier de la Raspaz has died, leaving a widow Louise Mestraulx.

132v 07 jul 1621, Testament verbal, Magdelaine Brochon wife of Claude du Franoz has died.

133v 09 jul 1621, Testament verbal, Anthoine Buttet de Ferlens has died, leaving a brother Andrey Buttet. The heirs named are his brother Daniel, and Daniel's daughters who are nieces of Anthoine, his brother Pierre, and the heirs of his late brother Rod Buttet.

135 05 may 1621, Testament verbal, Jean Nycod vivant conseiller et bourgeois de Moudon died about three weeks ago, leaving a widow Magdelaine Moriset, heirs his sons and daughters in equal portions.

136 12 sep 1621, Pierre Nycod fils de feu Jean Nycod vivant conseiller, acting for his brothers and sister, with their mother Magdelaine Moriset, sell to Pierre Dutoit jadis officier de Moudon.

137v 13 dec 1621, Prononciation, Elie Dutoit contre Petter Ott and his wife Estiennaz Forinat ? , regarding the division of a house.

139 11 oct 1621, Exchange, Jean Borrel tisserand, contre François fils de Jaques Dutoit.

140 08 nov 1616, Testament verbal, Noble Philippe Cerjat, leaving a widow Jaqueline Joffrey, and Guillaume Buttet was his beaufre.

143v 12 mar 1619, Testament verbal, Bernard Gilliand bourgeois de Moudon died about one month ago, heir his brother Claude Gilliand bourgeois de Moudon, but the document is incomplete.

145 06 jan 1616, Testament verbal, Jaques Porchet, his heir is his cousin François Porchet.

146 19 jan 1620, Testament verbal, Bernard Martin tisserand residant à Moudon, his widow Barbraz Vaulruz.

148 25 feb 1622, Philibert Limat sells to Louis Limat.

149 25 feb 1622, Cense for the above transaction.

149v 20 feb 1622, Testament verbal, David fils de feu Jaques Forestey de Thierrens, presented by his sister Pernon Forestey widow of the late François Wagnierres d'Orgens, heirs his brother Anthoine and sister Marie.

151 04 feb 1621, Andrey et Pierre Buttet freres de Ferlens, debt to Susanne fille de feu Abraham Charles.

- 151v 04 feb 1621, Pierre fils de feu Anthoine Gillieron, debt to Andrey Buttet.
- 152 04 feb 1621, Claude Favre, debt to Susanne Charles.
- 153 22 apr 1622, Jean fils de Benoit Martin de Neyruz, debt to Pierre Martin demeurant à Berne.
- 153v 04 jan 1620, Bernard Bastian, debt to Susanne Charles, and a series of additional debts to Susanne Charles involving others, with dates from 21 jun 1620 to 04 feb 1621, continuing through fol. 169v.

- 170v 18 jul 1618, Jean fils d'Anthoine Pidoux de Forel as guardian of the heirs of Estienne et Pierre Pidoux sells to Jean fils de Rod Pidoux.
- 171v 05 may 1619, Pierre Berod demeurant à Vevey acting for his sister Anthoine Berod femme de Claude Andrey Preneloup de Cossonay residant à Moudon, relaissée en premiere noces de feu Daniel Jaulnin vivant bourgeois de Moudon, sells to Egrege Anthoine Dutoit conseiller et bourgeois de Moudon.
- 172 28 may 1620, Marriage, Guillaume fils de Daniel Demond (=Demont) bourgeois de Moudon, to Sara fille de feu Daniel Poyterlin vivant bourgeois de Lausanne, with her mother Anne Malingre and her step-father (Anne's present husband), Spectable Pierre Jenin professeur à Lausanne.
- 173 05 jun 1620, Benoit Corday de Chappelle Vaudanne residant à St. Saphorin sells to Jaques fils d'Anthoine Pache de Chappelle Vaudanne.
- 173v 01 oct 1620, Anthoine Veyre cordonnier et bourgeois de Moudon sells to Abraham Jaquery cordonnier et bourgeois de Moudon, with cense for this transaction.
- 175 09 oc 1620, Ellie Dutoit hoste et bourgeois de Moudon sells to Jaques Dutoit tisserand et bourgeois de Moudon, with cense for this transaction.
- 176, 20 jan 1621, Daniel fils de feu Louis du Boz de Rossenges owes Elizabeth Dutoit relaissée de feu Egrege Abraham Chomel vivant diacre à Moudon, and after that wife of the late Daniel Fornier.
- 177v 02 may 1621, Philibert Lymat de Sottens sells to Pierre Vulruz acting for his brother.
- 178v 11 may 1622, Testament verbal, Noble Jeanne Charmet, widow of the late Noble Anthoine Cerjat bourgeois de Moudon, died about six weeks ago. Witnesses testifying were Balthazard Decristaz, Jaques Jayet with his wife Claudine daughter of Jaques Frossard, and Catherine Frossard wife of Anthoine Pidoux. The deceased Jeanne Charmet was the "belle mere grand" of Jaques Jayet, and also the grandmere of Claudine Frossard.

180 03 jul 1627 ? (or possibly 1617, the script is not clear), Anthoine Vucherens cedes to Pettremand Chastellanaz 125 floins that was owed to him by Colletaz widow of the late Anthoine Vucherens his uncle, for “refecture de sa mayson gastée par le feu”.

181 14 aug 1622, Pierre Pictet bourgeois de Moudon acting as guardian of Anne et Esthyvenaz, daughters of the late Jaques Bectens bourgeois de Moudon and of Nicolas Puret ? his beaufiles (not otherwise explained), sells to Benoitte Demierre widow of the late Jean Duret ? (the script is not clear as to whether the name should be Duret or Puret) bourgeois de Moudon.

182v 07 mar 1617, Marriage, Pierre Connet bourgeois de Moudon with his father Anthoine Connet, to Jeanne fille de feu Spectable François Monnery vivant bourgeois de Moudon et ministre à Constantine, with Noble George de Glannaz her mother.

184 07 may 1617, Daniel Riguet officier et bourgeois de Moudon owes Samuel Zachender bourgeois de Bern et ancien baillif de Moudon. (Samuel Zehender was bailli de Moudon 1616-1621.)

185 22, dec 1625, Jean fils de Pierre Jenet de Thierrens sells to Jaques fils de Claude Meistre.

185v 15 mar 1624, François fils de Jaques Meistre sells to the above Jaques Meistre.

186 15 mar 1624, Anthoine Meistre acting for his brother Jean Meistre sells to David Pahu, metral de Thierrens.

187 20 jul 1617, Dispute, François Vauruz bourgeois de Moudon acting for his daughter Anthoëne relaissée en premieres noces de feu Bernard de[s] Borines, contre Pitius (= Sulpicius) de[s] Borines brother and heir of the said Bernard.

189 16 jan 1605, Dispute, Guillaume Frossard bourgeois de Moudon contre Michel Frossard de Brenles his brother, regarding their partage.

193 21 jun 1622, Dispute, communes of Servion and Ferlens, regarding pasquerage, apparently incomplete, and possibly a draft of the next item.

194 20 jul 1622, Dispute, communes of Servion and Ferlens.

197 28 apr 1623, Prononciation, Jean Borel tisserand contre François Cherpillod bourgeois de Moudon, regarding property rights.

198 (Possibly a continuation or annex for the items on fols. 193 and 194 ?)

200 30 nov 1623, Sales of several properties “excheutte” des hoirs de Jaques Meistre de Thierrens.

205 10 aug 1623, George Cavin lieutenant de Vuillens as guardian of Jeanne, Marie, et Judith filles de feu Daniel Cavin de Vucherens with consent of Pierre fils de Jean Dutoit de Chavannes, who is the husband of Jeanne Cavin, sale to Anthoine Vuagniaux de Vucherens.

208 20 aug 1623, Pierre fils de Jean fils de feu Rod Duthey de Chavannes with his wife Jeanne fille de feu Daniel Cavyn de Vucherens, and George Cavyn as guardian for Jeanne's sisters Marie and Judith, sell to Balthazard Decristaz notaire et conseiller de Moudon comme plus offrant, with another, similar transaction, on fol. 208v, same date.

209 20 aug 1623, Heirs of Daniel Cavin sell to Anthoine Cavin metral de Vucherens, and a series of similar sales, including notably on fol. 216v, a sale by the heirs to Rod Dutoit dit Billet, fils de Jean Dutoit, with a notation dated 28 aug 1624 that Rod Dutoit has died, and that his brother Pierre Dutoit now holds the property. These transaction suggest that this Rod Dutoit dit Billet was the brother of Pierre fils de Jean fils de feu Rod Duthey.

219v 13 apr 1624, Anthoine et Pierre Connet pere et fils sell to Pierre fils de feu Jean Duthoiet dit Billiet de Chavannes bourgeois de Moudon acting for his unnamed brother and sisters (who, presumably, must include the younger Rod Dutoit who figures in the transactions beginning on fol. 218).

220v 30 mar 1625, Testament verbal, Pierre fils de Louis Belaz bourgeois de Moudon presents the verbal testament of his uncle Pierre Bastiand, witnessed by Andrey Wagnierre, Jaques Porchet, and Anthoine Trolliet on 12 mar 1624, heirs named as his daughter Magdelaine Bastiand, beaufils Piere Callin, sister Marguerite Bastiand, and Claude Gessenay nephew.

222v 26 nov 1624, Pierre Canon de Villard Mendraz sells to Pierre Mojoniez.

223 16 mar 1624, Michel Jayet d'Hermenges bourgeois de Moudon sells to Jaques Guy.

223v 24 may 1624, Claude Charpilliod acting in his own name and that of his brother Pierre, acknowledges receipt from the late Jean Cavin represented ? by Jean Cavin for his wife Myaz Cavin relicte dudit Cavin sa fille... (the text is likely in error, the relationships as stated appear contradictory).

224 14 mar 1624, Bastian Vuagnierres bourgeois de Moudon as guardian of the heirs of the late Guillaume Berthoz (=Berthod) bourgeois de Moudon sells to François Burnan[d] bourgeois de Moudon, witnesses include Pierre Bertoz fils dudit Guillaume.

224v 19 oct 1625, Testament verbal, Annelle fille de feu Jaques Badoutz (=Badoux, possibly Baddoz), all of her estate to go to her mother Michere and to her siblings, including her brother Jean Badoutz.

- 226 23 jul 1625, Prononciation, Anthoine Peytregnet de Mollondens with his wife Catherine Mottaz, contre François Mottaz and his sister Barbille Mottaz, regarding the estate of their brother “Muris” (=Mauris) Mottaz and his wife George.
- 227 29 aug 1624, François Forestey de Thierrens sells to Jaques Favre comme plus offrant, with several similar sales.
- 231 22 mar 1634, Settlement, Jaques Frossard conseiller et juge, contre Philippe des Borines, with letter of cense.
- 234 25 jun 1626, Benoit Bosson bourgeois de Moudon charge ayant de Jaques Grimmoz sells to Daniel Le Grand his beaupere bourgeois de Moudon.
- 235 08 may 1626, Jaques fils d’Anthoine Piot de Thierrens sells to Jaques fils de Claude Meistre.
- 236 (date uncertain), Dispute, Jean Mestreaux conseiller et bourgeois de Moudon contre Louis Place residant à Lausanne.
- 237 12 nov 1622, Dispute, Pierre Chappuis de Vucherent demeurant sus le mont de Villette, contre Jean Chappuis son frere, regarding the estate of their brother Jaques Chappuis.

- 243 15 jan 1623, Testament verbal, Jenon Piot wife of Anthoine Porchet died several days ago, heirs are her sister Françoise and Jaques son of her brother Anthoine Piot.
- 244 29 jun 1622, Passage à clos ?
- 245v 29 mar 1623, François Meistre sells to Jean Grebot.
- 246v 19 sep ? 1625, Jaques fils de François Cavin owes the heirs of the late Daniel Cavin.

247 09 may 165, Daniel Mestreaux d'Hermenges sells to Pierre fils de Claude Mestreaux.

248 26 sep 1624, Pierre Canon sells to Pierre Mojony.

248v 16 mar 1624, Michel Jayet d'Hermenges sells to Jaques Gex d'Hermenges.

249 24 jun 1624, Guillaume fils de feu Anthoine Sougnon de Domp martin acting for his wife Andreez fille de feu Thyvent Millyard de Bressonnaz dessus, sells to Baltazard Decristaz, property acquired by partage from her brother François Millyard, with ratification by Andreez.

251 08 oct 1629, Dispute, Marguerite Menoz relaissée de feu Pierre Dutey vivant hoste et bourgeois de Moudon, contre Gaspard et Marguerite ses enfants heuz de Catherine Socquet sa premiere femme, and acting for them, Elie Dutey brother of Pierre their father. Marguerite vouloit et pretendoit retirer à soy tous les biens par elle apportez en la maison dudict [Pierre] Dutey son mary, tout en or que argent monnoye, vasselle d'argent, que autres meubles, and the property includes the "maison et logis de la Croix Blanche, rue Granardiaz, avecq les places, curtilz, grange, et estableries y adjacentz". The real properties go to his children Gaspard et Marguerite Dutoit, the meubles go to Marguerite Menoz. 256 (date uncertain, incomplete), possibly this is the end of the document that begins on fol. 256v ?

256v 25 feb 1615, Henri de Praromand cedes to Aymé Dutey tisserand bourgeois de Moudon, a clos that was originally held by Collet Buttin.

257 02 mar 1615, apparently the end of a document regarding Jonas Jaquemet and his wife, with a later substertption, incomplete.

257v 27 jun 1617, Pierre fils de Jean Huguet chappuis, parts of the text are lost in the binding, it appears Pierre has a brother Jaques Huguet and a sister Marguerite Huguet.

12 mar 1620, 18 mar 1620, etc., several acknowledgements of debts.

258 19 dec 1621, Elye Dutey with the authorization of the justice de Moudon sells to François Chevalley, Abraham _____ (surname uncertain), Pierre Boudin, Hubert Chevalley, all ? consors de Claude Boudin, part of a wood lot (bois).

16 jan 1622, Elye Dutey releases ? Pierre Myevillaz chappuis and his brother Jaques from the 1/4th part of some property, not clearly legible.

258v (uncertain, apparently miscellaneous notations)

[259] (folio not numbered) 15 mar 1619, Gaspard Bichelex cedes to François Myevillaz and his brother Jaques.

260 17 jul 16... (date not clearly legible), Jaques Frossard, regarding subhastations for Jean Demierre.

261 (illegible).

DL 52/2 **Livre de memoyres de moy Jaques Jaqueri**, a minotaire, lacks folio numbers. Only the items that include significant history or relationships are extracted here.

31 dec 1609, Testament, Anthoine Myevillaz bourgeois de Moudon, naming his children Jaques, Daniel, and Clement, and his wife Jeannaz.

21 may 1610, Jean Frossard sells to Wolfgang Frossard his brother.

30 jul 1610, Sara relaissée de feu François Gillan, grants procure (power of attorney) to Abraham Jaqueri her brother.

25 sep 1610, Esve (=Eve) widow of the late Egrege Claude Panchaud, subject uncertain.

11 feb 1611, Anthoine Connet and his son Pierre Connet sell to Jaques fils de feu François Duthey de Chavannes.

28 may 1611, Estienne Marceau regent d'escholle à Moudon, a donné, comme par cestes donne presente charge et procuration generale à honorable Daniel Demont bourgeois de Moudon son beaufils, to collect monies owed to him.

1612, note mention of Claude Janet *dict Centlivres*.

11 jul 1613, Marriage, Pettreman Busigniez de Vuillens, accompanied by his father Pierre, to Françoise fille de Daniel Demont cordonnier et bourgeois Moudon et de George sa mere.

02 dec 1613, Marguerite femme de Bastian Malherbe owes to Jean Nycati de Combremont le Petit.

19 jan 1614, Anthoine Dutoit et Felix son fils owe to Bastian Malherbe and his wife Marguerite Menoz, for loan of 1000 florins. (See above, **DL 52/1**, fol. 251, where in 1629 the same Marguerite was now the widow of Pierre Dutoit, hoste de la Croix Blanche de Moudon.)
