113v 20 apr 1607, Testament, Pierre Monachon de Martherenges, naming his sons Pierre, François, Jean, et Balthazard, and his wife Marye.

114v 31 jul 1607, Testament, Pierre Gilliand favre et bourgeois de Moudon, naming his son Claude and his wife Claudaz.

115v 22 oct 1607, Testament, François Fouchierres de Bussy bourgeois de Moudon, naming his sons Pierre and Noel by his first wife (mention of “Trabaccoz”, not clear whether this is a place name or a personal name), and his sons Jean and Jaques by his current wife, and daughters Eve and another unnamed daughter who is the wife of Jaques Vuagnierres, wife Marye, brother Jaques, and his sister Marie is the wife of Pierre Dutoit.

118v 08 nov 1607, Anthoine Pollat cordonnier et bourgeois de Moudon sells to Anthoine fils de feu Egrege Jaques Veyres cordonnier et bourgeois de Moudon, et Abraham fils de feu Egrege Bernard Jaquery de Demort.

119v 02 nov 1607, Claude Rojoz bourgeois de Lausanne and his wife Bastiennaz Viollet sell to Louis Rosset d’Ollens, property at Ollens.

120 18 mar 1607, Accord between Maistre Estienne Marseaux beschellier (=bachellier) en l’escholle de Moudon for his wife Marye Cornaz, contre Jean et Daniel Demont freres bourgeois de Moudon, fils de feu Jean Demont and of the said Marye. The marriage contract of the latter couple (Jean Demont and Marye Cornaz) was recorded 08 dec 1564 by Jean Jaquery (however, this contract, in a minutaire of Jean Jaquery, DL 53/4, gives Marie’s surname as Cheyre or Cheyres).

121v 27 may 1607, Dispute, concerning a claim by Jaques Frossard bourgeois de Moudon charge ayant de George Dutoit bourgeois de Vevey son beaupere, regarding the sum of 29 ecus (chacun vaillant 5 florins) owed to him by Gabriel Bourgeois de Courtilles. Now appears Spectable Pierre Dutoit charge ayant des hoirs dudit feuz George Dutoit son frere...

123 15 dec 1607, Exchange, Estievent Hugoniez lieutenant de Carrojoz, contre Anthoine Chappuis de Corrojoz.

125 01 dec 1607, Marriage, Abraham fils de feu Jaques Vouthey de Bussy, to Esther fille de Jaques Fouchierres. Jaques had a brother the late François Fouchierres whose daughter is now the wife of Jaques Vuagnierres alias Jordan, witnesses Jean Margueron, Pierre Riguet, Pierre et Jean Guimat, et plusieurs autres, with quittance.

128 27 dec 1607, Marriage, Balthazard Besat de Berchier to Claudaz fille de feu Claude Besson, represented by her brother anthoine Besson, with quittance.

131 23 apr 1605, Jaques Pasche mestral de Chappelle Vaudanne sells to Anthoine Pasche de Chappelle Vaudanne.

132 06 may 1608, François fils de feu Bettrand Monnery bourgeois de Moudon sells to Balthazard Dutoit tisserant et bourgeois de Moudon.

133v 23 feb 1608, Jaques Clot de Prevondens with his wife Aymaz fille de feu Bernard Argaulx sells to Daniel Pappoux cordonnier et bourgeois de Moudon.

134v 29 feb 1608, Exchange, Jean Wagnierres hoste et bourgeois de Moudon contre Abraham Caney et Claude fils de feu François Dubriect tous deux de Sottens.

136 18 nov 1607, Anthoin Pasche de Chappelle Vaudanne with his wife Claudaz Place sell to Pierre fils de feu Jean Place de Saint Cierge.

137 27 dec 1607, Quittance between Claude et Jean fils de Anthoine Forestey de Thierrens.

137v 20 mar 1608, Egrege Gaspard Jossevel bourgeois de Moudon charge ayant de son onble François Jossevel de Bussy sells to Abraham Bize conseiller et bourgeois de Moudon.

139 06 feb 1608, Jaques Jossevel de Bussy bourgeois de Moudon sells to Egrege Gaspard Jossevel.

141 05 may 1608, Marriage, Andrey fils de feu Claude Vuagnierres de Bussy bourgeois de Moudon, to Françoise fille de feu Bettrand Monnier vivant bourgeois de Moudon.

143 02 may 1608, Exchange, Estievent Monaschon de Martherenges contre Pierre et Balthazard Monachon freres.

144v 09 aut 1604, Quittance, Jean fils de feu Egrege Humbert Demierre bourgeois de Moudon contre Spectable Abraham Demierre ministre à Oron et Jaques fils de feu Humbert Demierre freres, also representing their other brothers Isaac et Daniel Demierres. The widow of the late Humbert Demierre is Françoise de Veyrie.

145v 03 jun 1608, Claude Rojoz bourgeois de Lausanne and his wife Bastiennaz Violet sells to Louis et Jaques Rosset d'Ollens.

146v 06 jun 1608, Abraham Trolliet de Seignieux sells to Humbert Rod de Henneyez, property indivis with the purchaser, tiltre ayant de Anthoine Troillet frere dudit vendeur.

147v 21 jun 1608, Jean Demierre bourgeois de Moudon sells to Bastiennaz vefve de feu Jean Vuagnieres vivant hoste et bourgeois de Moudon acting as guardian of her children by the said Vuagnieres.

148v 08 jul 1608, Anthoine Bize bourgeois de Moudon, lettre de cense payable to Anthoine Tillier de Berne represented by Jaques Frossard conseiller et bourgeois de Moudon, the obligation secured by sums due to the said Bize by Jaques Dumont de Dynizié et Pierre son fils, plus an amount due from Jeannod et Jaques Martin pere et fils de Neyruz.

150 24 apr 1608, Agreement, Catherine Monnod relaissée en dernier nopces de feu Egrege Jacob Mottet vivant bourgeois et chastellain d'Avenches, sale to Gabriel Bourgeois de Curtilles residant à la grange de Challabruz with his wife Suzanne, and to Stoffel Blanc bourgeois d'Avenches with his wife Jeanne, both daughters of the late Spectable Guillaume Guinand ? vivant ministre à Curtilles (and these two women are the daughters of the said Catherine), and also to her son Daniel Mottet, and also mentioning Jean fils de Claude Gueri whose wife Sarraz is also apparently another daughter of Guillaume Guinand, witnesses include François Burnand favre et bourgeois de Moudon.

151v 13 sep 1608, Jaques Frossard conseiller et bourgeois de Moudon sells to Jean Rojoz habitant à Moudon.

152v 03 oct 1608, David Guex bourgeois de Moudon sells to his uncle Pierre Guex de Bollens, and David also has a brother Jaques Guex.

153 25 jul 1608, Anthoine Bize bourgeois de Moudon sells to Thomas Limat de Chappelle Vaudanne.

154 24 aug 1608, Pernon vefve de feu Claude Metraulx, et Pierre fils dudit Claude Mestraulx d'Hermenges, acting for the other children of the said Claude Mestraulx, sell to Anthoine Metraulx d'Hermenges.

155v 20 nov 1608, Guillaume fils de feu Pierre Gallot de Chardonnaz sells to Gaspard Duthey marchand et bourgeois de Moudon, regarding the rachept de certaines vignes à Corsier.

163 17 mar 1608, Subhastations, François Diaconaz contre Pierre Bastian tisserant, the original debts were for Claude Gilliard.

164v 14 mar 1608, Jaques Fauchierres de Bussy bourgeois de Moudon leases to Anthoine Porchet, witnesses François Burnand favre bourgeois de Moudon and Jean Burnand de Vulliens.

165 13 ? dec 1608, Antheyne vefve de feu Abraham Fouchierres comme mere tutrice, sells to François Vuagnierres alias Jordan bourgeois de Moudon.

166 21 dec 1608, Settlement, Egrege Pierre George conseiller et bourgeois de Moudon for his wife Catherine Frossard, contre Guillaume Frossard and the heirs of the late Michel Frossard, regarding for their accounts for their inheritance from their uncle Jaques Doge d'Oron. Catherine is the sister of Guillaume and Michel Frossard, and Estienne Michod, notaire, is the brother-in-law of Guillaume Frossard.

168 27 jan 1608 (but should this be 1609 ?), Partage, François, Catherine, et Françoise, enfants de feu Bettrand Monery bourgeois de Moudon.

169v 30 jan 1609, Marguerite relaissée de feu Jean Brayoux de Lucens comme mere tutrice, sells to Jean Pidoux de Forel.

09 apr 1610, Jean fils de feu Claude Duthey cousturier de Chavannes bourgeois de Moudon acting for Claudine Sauvagat sa femme, sells to Jaques fils de feu Guillaume Dutoit tisserant, mentioning a partage previously made between the seller and his unnamed partissants. Witnesses Bernard des Borines and Elie Dutoit, with ratification by Claudine Sauvagat.

18 jan 1610, Settlement before Hanns Rodollff d'Erlach baillif de Moudon, regarding a property dispute, Noble Gabriel de Blonay seigneur de Moudon et de St. Legier, à present seigneur de Carrojoz, with his brother George de Blonay, and his cousin Noble Hannes Rodullff Masset, contre Noble Hanns Meyer advoyer de la ville de Fribourg, et Noble Marie de Brandebourg relaissée de noble Nicollas Meyer de Fribourg tutrice de ses enfants and acting for them and their compartissnats, Noble Niclus Meyer and Egrege François des Granges, generals dudit Fribourg, and with Spectable Hanns Gottraulx de Fribourg.

29 jul 1610, Hanns Rudollff d'Erlach baillif de Moudon sells to Jaques Cavin metral de Carrojoz, une pose de terre à Vucherens, "à nosdits seigneurs excheutte par l'execution faicte de François Hugoniez".

30 sep 1610, François Guex monnier à Ollens bourgeois de Moudon sells to Gaspard Dutoit marchand.

19 feb 1610, Edict in favor of Claude de Praromand seigneur de Regnens et Chappelle Vaudanne, regarding the "discution" de Jaques Pasche. Also a series of similar "edicts", same date, for Jeanne de Praromand widow of the late Jean Seigneux; for Egrege Gaspard Jossevel notaire et bourgeois de Moudon; for Philippe Cerjat; for George Gilliand conseiller de Moudon; for Daniel Trolliet de Martherenges; for Jean Forney; for Jean Nycod bourgeois de Moudon; for Discret Pierre Pasche notaire demeurant à Lausanne contre Jaques Pasche son pere.

18 mar 1610, Jenon Pechon relaissée de feu Maurys Gonel vivant residant à Moudon sells to Michel Brideri bourgeois de Moudon.

23 mar 1610, Bernard Rodz de Villard Mendraz sells to Bernard des Borines bourgeois de Moudon.

25 mar 1610, Guillaume et Abraham Burnand pere et fils de Vulliens, and acting also for Moyse son of the said Guillaume, sell property at Vulliens to François Burnand favre et bourgeois de Moudon. Some of the property is adjacent to Esthievent, another son of Guillaume Burnand, and there is a different Estievent Burnand in the same vicinity, apparently not the son of Guillaume. Also in the area, a Humbert Burnand, a Jean Burnand, as well as Jean Burnand le jeune.

13 may 1610, Exchange, Claude Dubryt bourgeois de Moudon contre Jenon fille de feu Anthoine Dubryt de Sottens. Jenon has brothers Claude Dubryt and Pierre Dubryt.

08 may 1609, François Chevalley notaire de Thierrens sells to François Vaulruz bourgeois de Moudon, vignes à Lutry indivis avec Pierre Chevalley.

18 jun 1610, Exchange, Anthoine Bize bourgeois de Moudon contre Claude Guex bourgeois de Moudon.

22 jul 1610, Spectable François Monneir (=Monnery etc.) ministre à Constantine sells to Pettermard Corbet tisseran habitant à Moudon.

28 jan 1610, Settlement, Guillaume Demierre conseiller de Moudon contre les hoirs de feu Egrege Humbert Demierre, refers to a period when Guillaume was living at Basle, and his expenses while he was there (however, we were unable to locate Guillaume in the Livre du recteur for the university at Basel). Guillaume has a frere maternel, Jaques de Jouvier, and there is a reference to a deposition reçu par Anthoine Pidoux, dated 07 sep 1609.

09 aug 1610, Exchange, Benoict Bosson bourgeois de Moudon contre Claude Guex.

12 nov 1609, Anthoine Chambaz de Villar Tiercelin leases to Jean and Daniel Chambaz his nephews.
