

## ACV Ab 3 Inventory of documents relating to noble fiefs, date uncertain, apparently 1530's.

At least some sections are organized by noble family, with citations to Balay (mentioning at least volumes "A" through "H") and other sources, often intermixed. An earlier, apparently original foliation is sometimes visible, intermixed with folios added later, some not numbered. There is a "repertorium" for sections relating to the principal locations, corresponding with the original foliation.

A section at the end gives the contents and folio numbers for the four volumes of the grosses of 1403-1409 compiled by Johannes Balay and his deputies, plus a volume from 1432-1436 compiled by Mermetus Cristine. As the first volume ("A") is now apparently lost, known only from partial copies, the list of contents included here is an important reference in establishing which sections may still exist as copies, whether in dedicated volumes such as AEF Grosses Quernet 140 and 142, or in other terriers whose origins are not clear. There are also scattered citations in Ab 3 for "Balay" volumes "E", "F", "G", "H", and possibly even "J" and "K", about which nothing else seems to be known. However, occasional mentions in Ab 3 suggest these volumes might be extracts or later "renovations" (notably by Mermetus Cristine) based on the first four volumes.

(The standard analysis until now has been the table of reconnaissances in the Introduction of Philippe Champoud's "Les droits seigneuriaux dans le Pays de Vaud", *Bibliothèque historique vaudoise* 36, 1963. There appears to be some confusion in his table, pp. 17-22, in the citations of the reconnaissances that were copied from the "A" volume into AEF Grosses Quernet 140 and 142. A number of reconnaissances were in fact copied into both of these quernets, but Champoud only cites 140 when the reconnaissance is not found in 142.)

Also to be reviewed, **ACV Fb 9, part B**, "nomina nobilium totius ballivatus Vuaudi, d'après les extentes reçues par Jehan Balay et [Jehan] Chalvin" (the inventory of the ACV is in error here, indicating that this item is found in part M of this volume; the list of nobles begins with the heading "In libro quarto ab extra cum aquila et leone", referring to the design on the cover, and the list covers the first two volumes, in order, but omitting duplicate names; see images 8-11, [image group 101669580](#)); **ACV Fi 1**, "copie des extentes relevées par Jehan Balay de Saint-Julien au diocèse de Maurienne, notaire public dépendant d'Amédée de Savoie", [image group 101669619](#); **ACV Fk 514**, reconnaissances from 1405, not noble fiefs, compiled by Jean Chalvin, [image group 101685710](#); **ACV Fk 232**, fiefs dépendant du château d'Yverdon, 1403, not noble fiefs, Jehan Chalvin; **ACV Fk 6**, Corcelles-sur-Chavornay, Jehan Chalvin, 1406, not noble fiefs; and **ACV Fn 9**, fiefs dépendant de la châtellenie de Moudon et du mandement du Rue, Johannes de Corveto and Johannes Chalvini, not noble fiefs.

(**ACV Fb 9** needs further study. It is all in the same 19<sup>th</sup> Century hand, a series of notes or correspondence originally separate but now bound together, relating to certain dîmes and other

rights in the area around Rolle. The identity of the author is not known. The inventory of the ACV places it after 1754, but there is a notation on fol. L1v, dated 20 aug 1786, in which the author says he has examined records of the “affaire de Mr. du Rosey” at the residence of Mr. Desaillaux. The author was clearly a scholar of the history of the Pays de Vaud, and he had access to some sources that were later destroyed in the Bourla-Papey episode of 1802, such as the terrier of Aymonetus Robert. The identity of this person seems to be revealed on fol. D1v (image 19), the end of a letter dated at Genollier 21 dec 1787, signed “Votre très humble et très obeïssant serviteur, Aneth”, possibly the notary François-Frédéric Aneth, whose notarial registers survive (Dm 1), or more likely a relative, since the full signature appears to be Aneth, Ch. F. The signature of François-Frédéric Aneth in his own notarial registers, ACV Dm 1, differs significantly. The family name is also found as Anet. Genolier was an annex of the parish of Vich during this period. However, another reading might be that this was the Châtellain (Marc-Elie ?) Aneth. Further, the notary François-Frédéric Aneth also served as secrétaire baillival de Nyon 1758-1795. So far, we have not indentified the individual Ch. F. Aneth.)

3      Copy of reconnaissance of Anthonius Brevaudz de Melduno, “dicta die”, no further date, has mention of the Gres family of Bressonnaz, from AEF Grosses Quernet 136, fol. 275v.

3v      Copy of reconnaissance of Johannes Bercherii de Eschagnens, “dicta die, no further date, from AEF Grosses Quernet 136, fol. 275.

4      Copy of reconnaissance of Bernardus de Glereir ? condominus de Bayoes, 28 oct 1405, from AEF Grosses Quernet 141, fol. 1v.

(Inserted at this point, a single sheet listing several properties held by Roletus and Hugonetus filii Johannodi Hermin subject to the noble domina de Bayoes, but the word Bernardo is also found at the top of the text.)

5 Copy of reconnaissance of Nycoleta filia quondam Petri de Castillione condominus de Font domicellus uxor Vuiberti Malleti de Paterniaci eciam domicelli, anno et indicione quibus supra die xiii mensis Novembris (13 nov 1405), from AEF Grosses Quernet 141, fol. 3, with an additional paragraph dated 03 aug 1406 listing additional items, no other source listed.

6 Copy of reconnaissance of Aymonetus Macellarii burgensis Montagniaci nomine Francesie uxoris sue filie quondam Roleti Paviotti de Cletis domicelli, et Petri Pavioti fratris dicte Francesie existentis ad partes Lombardie arma presequendo, 17 nov 1405, from AEF Grosses Quernet 141, fol. 3v.

6v Copy of brief reconnaissance of Nycodus filius Guilliermi Arthodi suo nomine et Jacobi sui fratris, no date listed, this is from AEF Grosses Quernet 141, fol. 3v, dated 17 nov 1405.

6v Copy of reconnaissance of Perrodus Lombardi de Rances, no date listed, this is from AEF Grosses Quernet 141, fol. 5, dated 17 nov 1405.

7 Copy of reconnaissance of Johannes Bastardi de Gland, no date listed, this is from AEF Grosses Quernet 141, fol. 5, dated 17 nov 1405.

7 Copy of brief reconnaissance of Roletus de Rivo nomine suo pro medietate, Anthonius Posiour filius quondam Johannis Posiour nomine suo et suorum fratrum pro alia medietate et pro indiviso, no date listed, this is from AEF Grosses Quernet 141, fol. 4v, dated 17 nov 1405.

7v Copy of brief reconnaissance of Anthonius filius Johannis Posiour nomine suo et fratrum suorum, no date listed, this is from AEF Grosses Quernet 141, fol. 5v, dated 17 nov 1405.

8 (In a very different hand) Copy of reconnaissance of Rodulphus de Boulo (Boulo) domicellus, no date listed, this is from AEF Grosses Quernet 141, fol. 6, dated 12 dec 1405.

10 Another copy (in the first hand) of reconnaissance of Rodulphus de Boulo, 12 dec 1405.

10v Copy of reconnaissance of Anthonius filius quondam Girardi de Corberia, date 01 apr 1406 is lined out, no other date found, this is from AEF Grosses Quernet 141, fol. 8v, dated 12 dec 1405.

11v Copy of reconnaissance of Johannes Porterii filii quondam Anthonii Porterii de Yverduno domicellus, 30 may 1406, this is from AEF Grosses Quernet 141, fol. 103.

12v Copy of reconnaissance of Georgius de Bonovillario domicellus nomine filii sui minoris etatis, 01 jun 1406, Georgius homine administratorio filii qui et Nycolete uxoris sue omnis minorum etatis (not named), this is from AEF Grosses Quernet 141, fol. 103v.

13v Copy of brief reconnaissance of Johannes filius Johannis de Forez domicellus, 01 aug 1406, habitator de Forez, this is from AEF Grosses Quernet 141, fol. 104.

14 Another copy of the same reconnaissance, at length, Johannes filius Johannis de Forez domicellus, with considerably more history and detail, 01 aug 1406, see preceding item.

15 Copy of reconnaissance of Johannes de Disy domicellus, 07 oct 1406, this is from AEF Grosses Quernet 141, fol. 105, with a final undated item (fol. 17v) possibly from a second reconnaissance in AEF Grosses Quernet 141, fol. 162, dated 08 oct 1406.

18 Copy of reconnaissance of Girardus filii Johannis de Disi domicellus, no date listed, this is from AEF Grosses Quernet 141, fol. 107, dated 07 oct 1406. It is not yet known if this copy includes the second reconnaissance in AEF Grosses Quernet 141, fol. 163, dated 08 oct 1406.

22 Copy of reconnaissance of Octho et Guilliernus pupilli liberii quondam Nycodi filii Petri de Adventhica junioris, 28 feb 1407, this is from AEF Grosses Quernet 141, fol. 109v.

25 Copy of reconnaissance of Johannes de Chenens burgensis Friburgo, no date listed, this is from AEF Grosses Quernet 141, fol. 111v, dated 28 feb 1407.

(Fols. 27-28v are blank.)

29 **New section, a “Repertorium nobilium, tenementariorum, et recognoscere deberi patrie Vuaudi”**, The text is heavily altered, most entries lined out. Was this a list of nobles who needed to make a reconnaissance at some point, each entry lined out as this task was accomplished ? Much of the text is not clear enough to read.

29v A completely different subject, apparently a summary inventory of reconnaissances for Vuycherens (the title is badly faded), with folio number references to two volumes, mainly the “A” volume of Balay. However, some of the folio numbers exceed the 302 folios cited elsewhere for the “A” volume, suggesting that they might be based on a copy of the “A” volume in the smaller, more standard format, hence with more than 302 folios. The marginal notations, poorly legible, seem to concern details and possibly further developments, but lack dates and folio references, not transcribed here:

(Possibly from “C” volume, AEF Grosses Quernet 136, fol. 27, dated 21 jul 1403 ?)

Dominus Johannes de Blonay miles pro Domina Katherina eius uxore recognovit inter cetera sub reacheto partem dicte Domine Katherine continentem in decima de Vuycherens quam tenet nunc Dominus de Blonay ut libro Ballay ? (inserted and altered ? , original text was predicto) A Nobilium Rote et Rotondimontis Melduni et plurium locorum, fol. 153 (or 154, the end of the numeral is partly hidden in the binding, vii<sup>xx</sup> xiii or vii<sup>xx</sup> xiiii), et similiter in manibus Jacobi Magnyni ut libro plurium Nobilium Melduni Morgie, fol. 304.

Dominus Jacobus Sallamyn de Melduno cappellanus nomine suo Gyrardi eius fratris recognovit inter cetera quam tenet Nobilis de Glana partem suam decime de Vuycherens, de Sarrandens, et de laz Raspaz cum aliis suis condisoribus, scilicet cum Domina Ysabella filie quondam Domini Anthonii de Vulliens, Vuilliermo Chatrerii, et heredibus Rodulphi Pallyery octo cupas bladi medii frumenti medii avene ad mensuram Melduni ut libro Ballay A Nobilium Rote, Rotondimontis, Melduni, et plurium locorum, fol. 268. (Perhaps the same reconnaissance listed below on fol. 75 of the “A” volume ?)

30 In a different hand, apparently a record of fractional parts of a dîme, possibly one jointly held by Noble Mayor, the Dominus de Vallardyn, the Dominus de Blonay, and the Dominus de Denysy.

30v “De totu decime de Vuycherens...”, nearly illegible, perhaps summarizing what is found on fol. 30. In the lower left corner of the page, inverted and in a different ink, xxiiii, suggesting that this folio once had a different purpose.

31 (Image 304, misplaced in the images on FamilySearch because it is in fact an old repertorium to parts of the present volume.)

**Image 304 is a repertorium corresponding with the OLD folio numbers for the sections, still to be reconciled with the current (new) numbers. This folio has a modern number 31 lined out, then R1 at the bottom. In other words, this repertorium belongs here, at fol. 31, and it references an old set of numbers:**

Comparison of the entries in this repertorium with the old and new folio numbers throughout this section of the volume, from fol. 42 (the section for Moudon) through the end of the section for Nyon, fol. 144v, revealed the following irregularities of the old and new foliations:

New fols. 42-50v, no old numbers visible, although fol. 42 was apparently intended as old folio number 1.  
 New fols. 51-54, old numbers 2-5.  
 New fols. 55-58, no old numbers.  
 New fols. 59-66, old numbers 6-13.  
 New fol. 67, no old number.  
 New fol. 69-77, old numbers 14, 15 primo, 15 2°, 15, 16, 17, 17 2°, 17 3°, 18.  
 New fol. 78-88, no old numbers.  
 New fol. 96-97, old numbers 19-20.  
 New fol. 98, no old number.  
 New fol. 100-108, old number 21-29.  
 New fol. 110, old number uncertain, should be 30, but page shows vii with an abbreviation mark followed by an uncertain character, possibly a 2.  
 New fol. 112-119, old numbers 31-34, 35 primo, 36 primo, 37, 38.  
 New fol. 120, no old number.  
 New fol. 124-133, old numbers 41-50.  
 New fol. 134-138, old numbers 35 2°, 36, 37, 38, 39.  
 New fol. 140-144, old numbers 41-45.

These irregularities show that the volume was expanded several times before reaching its current state.

31v Confines Joracti: 30 apr 1510, in loco Melduni. Glaudius Brouchon de eodem et Philippus de Mediavilla dixerunt quod circa quinquaginta octo anni (i.e., about 1452) quod ipsi fuerunt in nemore Joracti cum Magnifico Domino Francisco de Grueria comite Gruerie marescallo Sabaudie, Egregio Mermeto Cristini tunc secretario Vuaudi, et pluribus aliis dominis et personis de diversis locis prelimictando dictam Joractam et bene sciunt quod tunc posuerunt certos limictes lapideos in dicto nemore, videlicet unum in loco dicto en laz Rochetaz ultra villagium de Servion tendendo contra laz Douczaz... Datum pro copia premissorum existens et scriptorum in quodam libro registrarum veterum ... , with signature and paraphe of Machard ?

32 Apparently a list of reconnaissances, mostly lined out, without distinct citations, commissaires, or citations of folio numbers.

(Fol. 32v is apparently blank. The inventory of the ACV shows fol. 32 is blank, but its image is clear, image 66.)

33v (In a different hand from fol. 33) Memorie aliorum duorum librorum per *nos Ludovicum Challeti et Jaquetum Gaudini* feudorum nobilium redditorum in camera ducale, scilicet quarti et quinti per me Gaudini die vii<sup>a</sup> Jullii anno domini millesimo quingentesimo trigesimo secundo (07 jul 1532), et in eodem quarto libro continentur recognitiones sequentes: (From this brief notation, it could be surmised that Challet and Gaudin compiled much of Ab 3. A comparison of the various scripts found in this volume would be useful. These commissaires compiled a terrier Fn 63, circa 1528, a fragment consisting of fols. 414-653; Fn 68, circa 1531, 545 folios; Fn 65, circa 1531, 278 folios; and several fragments of terriers, but none of these seem to be the volumes described here. The preceding page, fol. 33, indicates that Challet and Gaudin also

extracted or copied two volumes of noble fiefs originally prepared by Michael Quisard, which remain unidentified.)

(In other words, this section specifies some folio numbers and reconnaissances in the “A” volume of Balay – the volume is described as noble fiefs for Rote and Rotundimontis – but with folio numbers well beyond the documented total of 302.)

The list of nobles in Fb 9 is likely definitive, and the reconnaissance for the fief of Isabelle de Vulliens may well have been subsumed under one of the Blonay fiefs, assuming the citation of fol. 139 refers instead to a later copy of the “A” volume in a more standard format, and therefore with proportionally higher folio numbers.

The volume contains later indexes, still in Latin, but in a much later hand, including one index referencing a “B” volume by Chalvin with folio numbers well beyond 140, but the original repertorium, in a very neat 15<sup>th</sup> Century hand with some later and much later notations, appears to correspond to the contents reported below, ending at fol. 140. Was additional material from the “Balay” project added to the “Quarto Libro” at a later date, as suggested by the discrepancy between the original repertorium and the later indexes, or is the list of contents in Ab 3 simply incomplete, but coincidentally ending at fol. 140?)

(End of the list of contents for the “D” volume of Balay, AEF Grosses Quernet 141, and the original repertorium of that volume ends at this point as well. However, the later indexes fond in AEF Grosses Quernet 141 show additional items extending to fol. 196. These seem to be indexes to some other volume! It may be that these are the lists of contents for a series of separate volumes of extracts for the various districts (Rotundimontis, Montagniaci, Rue, Staviaci – Molliere, Bellegarde, Surpierre, Vuycens, Attalens, Chastel St. Denis, Vuarens, Pont, Illens, Vuyppens, Corbieres, Grueyere, Morat, Grandson, and Echallens).

(These pages are followed in AEF Grosses Quernet 141 by a slip of paper with 20<sup>th</sup> Century French script, “Seigneurie de Surpierre / Reconnaissances faites à noble Jean de Montjovet (Challant!)”, and two lists: one, a loose slip of paper entitled Chalvin, with place names and scattered folio numbers as high as 196, and the second, a folio apparently bound in the volume, “Repertoire des fiefs qui sont dans le terroire et souveraineté de la ville de Fribourg, compris dans le present cvolume intitulé ‘Divers fiefs N° B per Jean Chalvini A° 1405’ ” (a lists of fiefs and the pages where they occur, as high as 190, not naming the nobles themselves, even though the “présent volume” is not now considered the “B” volume, and some of the fiefs, such as the porteria of Montagnier, seem not to be mentioned at all in the analysis of the four Balay volumes reported here in Ab 3. However, there seem to be some points of comparison that suggest these two items are in fact lists of some of the fiefs and the pages where they are mentioned in the “D” volume.)
