

ACV Af 10 Register of debts payable to the Crostel family of Payerne, 1449-1539.

Abstracts prepared by John W. McCoy (RealMac@aol.com) © 2020.

This small register contains copies of reconnaissances or acknowledgements of debts to members of the Crostel family, in many different hands. Most of these are in the hands and over the signatures and paraphes of the notaries who recorded them, thus providing an excellent tool for the identification of signatures and paraphes found in other documents. Many of the items in this volume have been crossed out, presumably indicating that the obligation had been fulfilled, superseded, or transferred.

The pagination starts with 1 on the verso of the first folio, then the second folio containing pages 2 and 3 has apparently been lost (however, see below, pages 11-12). The next folio contains pages 4 and 5.

Fiat licteram quod Johannem Canevaz ? confitetur debere pro se etc. Johanni Crostel decem solidos Lausannenses nomine et ex causa empacionis unius falcatis.

8 Henricus Curtilliard burgensis Paterniaci nunc morans Corcellis, debt to Petrus Moroni clero tanquam tutore et gubernatore liberorum quondam Johannis filii Hugueti Crostel, 28 mar 1463.

10 Petrus filius Johannis Chapuis de Corcellis, debt to Petrus Moroni tanquam tutore liberorum quondam Johannis filii quondam Hugueti Crostel et Francesie quondam conjugum, 03 sep 1462, with signature and paraphe in a different ink, of Johannes de Vallangen.

Jaketus Bertho, debt to Petrus Moroni tanquam tutore Nycodi et Johannis liberorum quondam Johannis filii quondam Hugueti Crostel, 23 sep 1463, with signature and paraphe of Claudius Advoye.

11 Memento quod Huguetus Crostel ... (uncertain, text is faded and abbreviated, and the paper is stained).

(At this point there is about 1 cm of another folio protruding from the binding between pp. 11 and 12, possibly the remainder of the missing second folio, see above.)

12 Petrus Bossier, lease for 9 years, debt to Petrus Moroni tanquam tutore liberorum quondam Johannis filii quondam Hugueti Crostel, 16 may 1462, no signature or paraphe.

Petrus et Franciscus Maior fratres, lease for 9 years, debt to prefatus Petrus Moroni etc., no signature or paraphe.

13 Vuillermus dou Ru, debt to Francesia relicita Hugueti Crostel, 02 feb 1461.

Petrus Chiviliar alias Bonyn ? de Corcellis, lease for 9 years, debt to Petrus Moroni etc., 09 may 1462, signature and paraphe in a different ink of Petrus Lombardi.

14 Johannes Vuilliomet, lease for 3 years, debt to Petrus Moroni etc., 08 jul 1470.

(In a very awkward hand) Memento quod die et anno subdictis prefatum Petrus Chivilliard, lease for 3 years, debt to Petrus Moroni etc., 02 jun ? 1464. In a different ink below this transaction, the name Petrus de Mediavilla, but likely not the signature of that notary.

Crostel.

21 Claudius Ruerat filius quondam Anthonii Ruerat de Corcellis, debt to Francesia filia quondam Mermeti Pictet Warbet (clear) uxore Hugueti Crostel burgensis Paternaci, 12 feb 1450, with signature and paraphe of Petrus Lombardi.

23 Petrus Ruerat filius quondam Glaudii Ruerat de Corcellis, debt to Glaudia filia quondam Johannis Crostel nunc uxor Glaudii Michiez (inserted above the line : junioris) burgensis Paternaci, 10 mar 1491, with signature and paraphe of Petrus de Mediavilla.

24 Jacobus Mellet burgensis Paternaci sells to Johannes filius Hugueti Crostel, 21 oct 1453, with signature and paraphe of Jacobus Bellin. (This transaction is not found in the surviving records of Jacobus Bellin, Dp 8.)

25 Henricus Berroux et Girardus Berroux eius nepos de Corcellis , debt to Petrus Moroni clericus tanquam tute Nicodi et Johannis liberorum quondam Johannis Crostel burgensis Paternaci, 15 mar 1469, with signature and paraphe of Petrus Lombardi in a different ink.

26 Henricus Berroux filius quondam Octheti Berroux de Corcellis reprehendit de morte et obitu quondam Nicodi Crostel filii quondam Johannis Crostel Paternaci burgensis, die veneris post festum Purificationis Beate Marie Virginis 1477, with signature and paraphe of Jaquetus Requimadens.

- 34 Roletus Mocet nunc morans Paternaci, lease for 6 years, debt to Johannes filius quondam Johannis Crostel burgensis Paternaci, several gaps in the text, incomplete, day and month left blank at the end, dated in 1473, no signature or paraphe.
- Petrus Mocet antenatus de Paterniaco, lease for 6 years, debt to dictus Johannes Crostel, incomplete, date left blank, no signature or paraphe.
- 35 Mermetus Alamant ? morans Paternaci, lease for 3 years, debt to prefatus Johannes Crostel, gaps in the text, incomplete, day and month left blank at the end, dated in 1473, no signature or paraphe.
- Johannes Vuion ? burgensis Paternaci, lease for 3 years, debt to predictus Johannes Crostel, incomplete, date left blank, no signature or paraphe.
- 36 Oliverius Fisicani (or Fisicam) de Corcellis, lease for 6 years, debt to jamdictus Johannes Crostel, incomplete, date left blank, no signature or paraphe.

37 Prefatus Nicodus Maringo, lease for 3 years, debt to dictus Johannes Crostel, incomplete, date left blank, no signature or paraphe.

Johannes Chavanton ? de Paterniaco, lease for 6 years, debt to dictus Johannes Crostel, incomplete, date left blank, no signature or paraphe.

38 Nycolleta relicta quondam Johannis Chapuis burgensis Paterniaci tanquam tutrix et administratrix liberorum suorum et dicti quondam Johannis viri sui et eciā tanquam ususfructuaria et titulum habens in bonis dicte quondam Johannis, lease for 9 years, debt to Petrus Moroni tanquam tutor et gubernator Glaudie filie quondam Johannis Crostel filii quondam Johannis Crostel, 16 may 1490, with signature and paraphe of Franciscus Ruerati. (This transaction is not found in the surviving register of Franciscus Ruerat, Dp 92.)

39 Ludovicus dou Mulin burgensis Paterniaci, lease for 6 years, debt to Petrus Moroni nomine quo supra, datum die et anno quibus supra (=16 may 1490 ?, with signature and paraphe of Glaudius ? Banquetaz. (This transaction is not found in the surviving register of this notary, Dp 5.)

40 Guigo Cartier corderius Paternaci, lease for 3 years, other party not named, 06 mar 1492, no signature or paraphe, but P. Moroni written in left margin at the end of the text. (This transaction is not found in the surviving register of this notary, Dp 72.)

41 Nycodus Givel de Paterniaco, debt to Glaudia filia quondam Johannis Crostel nunc uxor Glaudii Michiez junioris, 12 apr 1496, with signature and paraphe of Petrus de Mediavilla.

42 Bartholomeus Nybloz burgensis Paternaci, debt to Glaudia filla quondam Johannis Crostel nunc uxor Glaudii Michie junioris, 04 dec 1497, with signature and paraphe of Petrus de Mediavilla.

43 Petrus Uldry filius quondam Johannis Uldry burgensis Paternaci, debt to Glaudia filia quondam Johannis Crostel nunc uxor Glaudii Michie junioris, 20 jun 1495, no signature or paraphe, but G. (=Glaudius, Claudius) Banquetaz written in left margin at the end of the text. (This transaction is not found in the surviving register of this notary, Dp 72.)

44 Girardus Pillet de Montet, debt to Glaudia filia quondam Johannis Crostel nunc uxor Glaudii Michie junioris, 05 apr 1498, with signature and paraphe of Petrus de Mediavilla.

45 Nycodus Vouchy burgensis Paternaci, debt to debt to Glaudia filia quondam Johannis Crostel nunc uxor Glaudii Michie junioris, 26 apr 1498, with signature and paraphe of Petrus de Mediavilla.

46 Glaudius Marmand alias Chuard filius quondam Johannis Marmand alias Chuard de Cugie, debt to Glaudia filia quondam Johannis Crostel nunc uxor Glaudii Michie junioris, 25 apr 1498, with signature and paraphe of Petrus de Mediavilla.

47 Petrus Givel et Glaudius filius (inserted : quondam) Guionis ? Givel, debt to Glaudia filia quondam Johannis Crostel nunc uxor Glaudii Michie junioris, 21 jun 1500, with signature and paraphe of Petrus de Mediavilla.

Ruerati written in the left margin at the bottom of the text. (This transaction is not found in the surviving register of Franciscus Ruerat, Dp 92.)

50 Guigo de Stabulo de Paternaco, debt to Johannes Michie junior velut tutor et gubernator liberorum quondam Glaudii Michie eius fratri, incomplete, no date, not signed.

51 Johannes Ruerat filius quondam Johannis Ruerat de Biternaz de Corcellis, debt to Johannes Michie burgensis Paternaci tanquam tutor et tutorio nomine liberorum quondam Claudii Michie eius fratri titulum habentes in bonis quondam Glaudie filie quondam Johannis Crostel, 20 jan 1518, with signature and paraphe of Petrus Chuardi. (This transaction is not found in the surviving registers of Petrus Chuardi, Dp 16 and Dp 109/3.)

(This transaction is not found in the surviving registers of Petrus Chuardi, Dp 16 and Dp 109/3.)

[72] Petrus et Jaquetus Rossel alias Jacaux de Montagniaco, have satisfied a debt ? to Johannes Crostel burgensis Paternaci, die dominica de Judicame 1473, no signature or paraphe. (The above item lined out, and very likely not intended as part of this volume. Rather, the blank space on the remainder of this page seems to have been used for a record of receipts from various persons, but the script is badly faded and not very legible. The list does not seem to include a date.)

[73] (This is the verso of the preceding page. The text is badly faded and only partly legible.) Richardus ? Brulliod de Missie, debt to prefatus Johannes ? Crostel, date partially obscured or illegible, January... septimo, no signature or paraphe.

Johannes Ansel tutor nunc morans Paternaci, lease for 9 years, debt to dictus Johannes Crostel, no date, no signature or paraphe.
