

ACV Bib 140, « Registre premier d'homologuations et decretations de Testamens, assignaux, hostages et subhastations judicialement à Aubonne, »

The register covers 17 jan 1713 to 23 jan 1725.

« Il est deffendu à chacun de barbouiller la couverture des registres et autres livres à peine de payer 5 mains de mesme papier. »

Foliation/pagination is irregular. Foliation runs from 1 to 249, but numbers 148, 149, and 192 are skipped. From 249 to the end, each side is numbered (pagination), but 255 is skipped, and the 4 pages after 289 are lined out (numbered 290, 291, 192, 193, presented below in this order), then pagination resumes with 290. Folios 107v-108, 116v-117, 118v-119, 121v-122, 145v, 193v-194 were not photographed.

Summary:

1 Testament de Pernette Reynaud, femme de Jacob Humbert de Marchissy She died 25 dec 1712, testament recorded by Eg. Gedeon Mayor 21 nov 1712. Letters sent to relatives Jean Renaud (hors du pays), David Reynaud frère de la deffunte. Testament names niece Pernette, daughter of testator's brother David Reynaud of Gimel. Residual heir her husband. Probated 17 jan 1713.

2v Assignal en faveur de demoiselle Françoise Robert femme du Sieur Benjamin Coinsin d'Aubonne, 17 jan 1713. Benjamin Coinsins bourgeois d'Aubonne has received from his wife 7000 florins etc., attested by her brother le justicier Robert. Coinsins pledges various properties at Aubonne, Montherod, and La Vaux. Benjamin's parents are Gamaliel Coinsin and Louyse Valier. (See fol. 164, below, where she is called Jeanne Françoise Robert and a further assignal is recorded, the one here on fol. 2v having been found to be insufficient.)

5 Blank, but with marginal notation, « Testament de Mr. Marquis en faveur de Jacob Bertod et sa femme, lequel a en main Mr. l'ancien curial Mayor qui ne l'a voulu rendre pour l'enregistrer en pretences l'emolument. »

7 Hostage Vautier Dufour, 28 feb 1713. Mr. le chastellain Vautier de Nion contre le Sieur Anthoine Dufour de Burtigny, dispute about payment for various properties.

8 Assignal pour honneste Jeanne Françoise fille de feu Pierre Benay fait par honneste Pierre Rochat de Saubraz son mary, 28 feb 1713. A copy was made 12 jul 1752 for the daughters of the said Rochat. To secure proceeds of sale of various properties belonging to his wife, Rochat pledges other properties at Saubraz.

9 Assignal pour demoiselle Susanne Olive femme du Sieur Jean Valier bourgeois d'Aubonne, 21 mar 1713. Susanne Olive, assisté du Sieur Secretaire Balival Valier, « expose qu'ayant soit la dame sa mere remis audit Sieur son mary » various sums granted to them by the marriage contract here produced dated 11 dec 1706 (Eg. Demontricher), requests assignal. The said Sieur Valier acknowledges receipt of the said sums amounting to 9145 florins and pledges as security property at Saubraz that came from his late father.

10 Verbal testament of Françoise Liardon vefve de Gamaliel Berthollet, dictated to witnesses 17 mar 1713. Probate requested by her nephew Jean Pierre Liardon demeurant riere Biere, and by her sister Susanne Liardon wife of Isaac Challet of Pampigny. All to her nephew, whose late father (her brother) had given her assistance in the past. Her sister excluded, had married against her wishes. Probated 28 mar 1713.

11v Hostage en faveur de Spectable et Scavant George François Hollard ministre à Lussy, contre Louys de Bonneville de Gimel, 09 may 1713. Hollard represented by Eg. Gedeon Mayor of Aubonne. Dispute over payment for various properties.

13 Investiture et homologuation d'hostage en faveur du Sieur Jean Valier bourgeois d'Aubonne demeurant à Saubraz, contre les hoirs de Jaques Rochat dudit Saubraz, 16 may 1713. Pierre Valier, father of Jean, had obtained the rights to a letter of rent in favor of the commune of Saubraz against the late Jaques Rochat and his sons Salomon and Pierre Rochat. Property granted to Valier for lack of payment by the Rochat heirs.

14v Investiture pour monsieur Imbert de Beausobre bourgeois de Morges, 13 jun 1713, against Salomon Pampigny (incomplete).

16 Testament of Benjamin Chenevard vivant de St. Livre, 06 mar 1712, recorded by Marc Anthoine Basset bourgeois de Morges, notaire. Chenevard estant en dessein et mesme en chemin pour aller voyager par les pays estrangers. Half of his house at St. Livre to Jaques Bovard for his services and friendship. Bequest to Jeanne Cristin his godchild and niece, daughter of Pierre Cristin his brother-in-law. Residual heirs the children of his sisters Jeanne Chenevard (wife of the said Pierre Cristin) and Ester Chenevard (wife of Abel Anselme of L'Isle, but after the death of his beloved uncle Jean Pierre Chenevard). He died while traveling abroad. Probated 20 jun 1713.

17b Subhastation pour honorable Pierre Badel de Saubraz contre Jean Jaques Dumartherey de Feschy, 20 jun 1713. Pierre Baddel regeant d'eschole à Saubraz requests sale of Dumartherey's property to pay debts.

18v Testament of Pierre Dumartherey of Montherod. Discret Pierre fils de Discret Jonas Dumartherey de Montherod died while out of the country and had made a testament before his departure (Eg. Fivaz, 11 feb 1711), probate requested by the said Jonas and by his son Isaac and also by the two daughters of the said Jonas. Pierre was « desirant de voyager par les pays Estrangers et estant mesme enroollé par permission de LL. EE. de Berne pour le service de Leurs Hautes Puissance les Estats d'Hollande. » Bequests to his sisters Benigne and Claudine.

Residual heir his brother Isaac, reversible to his sisters. Benigne is now wife of Isaac Ninet, and Claudine is the wife of Gaspard Barbier. Probated 04 jul 1713.

20 Investiture pour Demoiselle Catherine Vouchy femme de François Louys Duthon le fils, contre Pierre Monnay d'Aubonne, 11 jul 1713.

21v Investiture et homologation d'hostage pour le Sieur Jean Jacob Plantin citoyen de Lausanne contre Jaques David Jotterand de St. Livre, 26 sep 1713.

23 Investiture et corroboration d'hostage pour la noble hoirie de Pampigny contre les honnorables Benjamin, Gedeon, Criste, et Isaac Wist (Vuist), 28 nov 1713.

25v Investiture et subhastations pour honnable Nicolas Chansson de Cuarnens, contre les Sieurs François, Jean François, et Jean Jaques Jacquier, freres, de Feschy, 05 dec 1713, regarding debt from the father of these brothers 12 jul 1689 (Eg. DeRibeaupierre). Chansson obtained this debt by inheritance from his aunt the late Madame la vefve Aguet.

27 Investiture et subhastation pour les Sieurs Goncerut de Nion contre les honnorables Jean François et André Granjon frères de Longirod, 05 dec 1713.

28 Assignal pour Françoise Bachellard femme d'Abraham Croisier d'Aubonne, à elle fait par ledit Croisier son mari, 16 jan 1714. Presents inventory of her property and personal effects, pledges property for security.

29 Testament of Benjamin Valier chastellain de Gimel et bourgeois d'Aubonne, 27 feb 1713. Probate requested by Foelix Baptiste Vallier, assisted by Assesseur Ballival Henry Begoz, Chastellain [Baptiste] Valier de Rolle, and Secretaire [Imbert Estienne] Valier of Aubonne. Felix, son of the deceased, has sisters Jeanne Louyse (wife of Foelix Messieux) and Jeanne Françoise. Late wife Jeanne Françoise Begoz, mention bequest of his (or her?) late brother Isaac to said late wife, who herself had died intestate. Late second wife Helene Grivel had left a bequest to his son (that testament probated at Gimel 25 sep 1705 (?), pronunciation faite par Messieurs Rochmondet et Morsier). Residual heirs son Baptiste Foelix Vallier, daughter Jeanne Louyse wife of Foelix Messieux, and daughter Jeanne Françoise. Henry Begoz assesseur ballival, Baptiste Valier chastellain de Rolle, and Imbert Estienne Vallier secretaire ballival, tous mes proches parents, have kindly accepted his request to act as Conseilliers Tuthellaires for his unmarried children. Probated 30 jan 1714.

32 Subhastations et investiture pour le Sieur Chastellain Margel de Gilly contre Anthoine Delamuraz de Longirod, 20 feb 1714. Marie Meylan is wife of Delamuraz, objects that some of the property has already been pledged to her by assignal.

35 Testament of Estiennaz Besson de Marchissy, 04 dec 1711 (Eg. Sr. Curial Champion). Probate requested by her brothers Jean Pierre Besson and Hugues Besson (for his sons Jaques and Daniel), and her sister Marguerite Besson, and also Jean Borgey for his children by [the late] Marie Besson [another sister]. Residual heirs nephews Jaques et Daniel Besson. Probated 13 mar 1714.

36v Testament of Jean Jaques Mariaz of La Chaux, habitant à Aubonne, 13 dec 1700 (Eg. Billiard). Probate requested by his son Jean Pierre Mariaz, habitant at Aubonne, and by his daughter Marie Mariaz, wife of Jean Pierre Delasarraz. Residual heirs his son and daughter Jean Pierre and Marie Mariaz, and his wife Madgelaine Durand. Probated 13 mar 1714.

38v Homologation de subhastation en faveur de Monsr. Henry Louys Begoz assesseur ballival et bourgeois d'Aubonne, contre Discret Estienne fils de feu Claude Ninet dudit lieu, 29 may 1714.

39v Donation of the late Pierre Pellet of St. Livre, 01 dec 1708 in favor of Elizabeth Collon his widow and their daughter Helaine Pellet. Pellet died a few days before 05 jun 1714. His widow requests judicial homologation of the donation. Other parties include Marguerite Pellet wife of Isaac Bugnaux demeurant à Rolle, and Jean Pierre Pellet, children of the said late Pellet, as well as Jeanne Elizabeth, and Marie Helaine Pellet, fils et fille dudit defunct de son premier mariage. Text of donation is included, names Jeanne Elizabeth and Helaine Pellet his daughters, but only after death of Elizabeth Collom their mother and step-mother. Probated 05 jun 1714.

41 Testament of Daniel Grenier of Burtigny, son of the late Estienne Grenier of Burtigny, dans un aage fort avancé, 14 may 1714 (Eg. Feignoux). Probate requested by le sieur justicier Feignoux representing Grenier's widow Nicolarde Favre, and their children Benjamin, Nicolas, Daniel, Claudine, Jeanne, Marie, and Elizabeth (no commas between the names of the first three daughters, but he refers to his *sept enfans*). Probated 19 jun 1714.

43 Subhastation pour maistre Paul Goyrand mareschal à Begnin, contre Jean Jaques Badel de Longirod, 03 jul 1714.

44 Acquis judicial pour Mtre. Benjamin Piguet masson demeurant en Plens, fait des hoirs de feu Discret Pierre Riss vivant officier ballival d'Aubonne, 03 jul 1714, resulting from public sale of property of said Riss. Jean Jaques Ogy is uncle and tutheur of the said heirs.

45 Acquis judicial pour Mtre. Gabriel Mauraz bourgeois d'Aubonne fait des hoirs de Discret Pierre Riss vivant officier ballival dudit lieu, 03 jul 1714.

46 Testament of Jeanne Estienne Gautier wife of Jaques Machard demeurant à Feschy, 04 aug 1713. Names husband Jaques Machard, nephew Jean Jaques Fazan, nieces Jeanne Estienne and Pernette Ginier, sisters Michere and Marie Fazan, brothers Jean Jaques and François Fazan, others named but relationships not given. Recorded by Is. Robert. Probated 17 jul 1714.

48 Investiture et subhastation pour Monsr. l'Intendant Thorman bourgeois de Berne contre honnorable Jacob Humbert de Marchissy, 11 sep 1714.

49 Acquis judicial pour honneste Isaac Dubosson de St. Livre fait des hoirs de Nicolas Abrezol de [St. Livre], 25 sep 1714.

50 Subhastation pour les Sieurs hoirs de Spectable et Sçavant Jean François Colladon d'Aubonne contre Jean Jaques du Martheray de Feschy, 02 oct 1714. Regarding obligation signed Eg. Jean George Maryo 26 mar 1700.

51v Testament of Gabrielle Chavanaz, 10 jun 1707 (Eg. Billiard), died 5 weeks prior to 19 nov 1714. Gabrielle Chavanaz vefve en dernieres nopces du Sieur Lieutenant Christin de Lavigny estant detenue de maladie... Residual heir her son Jean Estienne Ninet à présent hors du pays, reversible to Jaques Chavanaz, relationship not stated. Probated 20 nov 1714.

53v Subhastation en faveur de Noble et Genereux Jean de Gingins capitaine demeurant à Rolle, tant à son nom que de la Dame sa femme, contre les hoirs d'honneste Jaques Phillibert Prodhom de Montherod, 20 nov 1714. The Dame in question was the daughter of the late Banderet Vouchy.

55v Investiture et subhastation en faveur de Monsieur le Lieutenant [Jean Isaac] Grivel d'Aubonne contre honorable Benjamin François Pellet de St. Livre, 20 nov 1714.

57 Subhastation pour Noble Henry de Martines capitaine bourgeois de Morges, contre honnorable George Jacquier de Feschy, 04 dec 1714.

59 Homologation d'hostage ou subhastation en faveur de Monsr. le Proposant Robin de Lausanne, contre Andrianne Mayor (fille de feu Jean Baptiste Mayor) femme de Jean George Goy de Ballens, 04 dec 1714.

60 Subhastation pour Noble et Genereux Jean Rodolph de Wlliermin seigneur de Gumoens et Daillens, contre les hoirs d'honnorable Estienne Delasarraz habitant en cette ville, 15 jan 1715.

61v Subhastation en faveur d'Eg. et Prudent David Margel Chatelain de Gilly, contre honneste Claude Rennaud de Longirod, 29 jan 1715.

63 Lettre de rente pour vert. Imbert Debausobre bourgeois de Morges, contre le Sieur Salomon Pampigny et Marie Tornier conjoints demeurant à St. Livre, 12 feb 1715. Marie Tornier had previously married to the late Eg. Gabriel Vionnet of St. Livres. Debts are from Vionnet, sale of property to discharge these debts.

66 Assignal pour honoree Elizabeth Fusay femme de Jaques David Jotterand de St. Livre à elle fait par ledit Jotterand son mary, 12 feb 1715. With list of the sums or properties of Fusay. Transaction appears to be incomplete, 67v-68 mostly blank.

68v Subhastation en faveur de maistre Anthoine Pelat demeurant à Rolle, contre Jean George Jacquier de Feschy, 19 feb 1715.

70 Testament of Esaye Wagnon bourgeois d'Aubonne, 03 may 1712 (Eg. Boinod), died about 5 weeks prior to 12 mar 1715. Joint testament with his wife Suzanne Gauthey. Residual heirs their daughter Françoise Wagnon, and Louise Françoise and Ursule Marie, daughters of

their late son Gedeon Wagnon, and in case Jean Marc Wagnon, the eldest son of the said testators, dehors du pays dès longtemps, should return, he will have 1/3. Probated 12 mar 1715.

73 Investiture pour le Noble et Genereux Seigneur d'Estoy au nom des pauvres dudit lieu, contre Jean Pierre Cathelaz de Longirod, 19 mar 1715. Relates to an obligation originally in favor of Sp. Jules Charles Fevot, minister at Etoy, 03 apr 1708 (Eg. Mayor).

74v Confession et assignal pour Demoiselle Magdelaine Jeanne Bory femme du Sieur Samuel Isaac Grivel de St. Livre (Capitaine au service de sa majesté le Roy de France), faite par ledit Sieur son mary, 19 mar 1715. Bory is the daughter of the late Isaac François Bory of Bussy, vivant Sieur Chastelain de Yens, and her property resulted from a partage among his heirs, valued at 16166 florins, 8 sols, 9 deniers. Bory has unnamed sisters.

77v Acquis judiciel pour Vertueux et Prudent François Louys Duthon bourgeois d'Yverdun, fait des hoirs de Spectable et Sçavant Jean François Colladon bourgeois d'Aubonne, 26 mar 1715. Colladon was minister at Coppet.

78v Acquis judiciel pour Monsieur le Lieutenant Collonel Lect de Geneve, fait des Sieurs hoirs de Spectable et Sçavant Jean François Collant (=Colladon), vivant bourgeois d'Aubonne et ministre à Copet, 26 mar 1715.

79v Acquis judiciel pour Noble et Genereux Jean de Sacconex seigneur de Bursinel et Monsieur Papam (Papan) assesseur balival de Morges, fait des sieurs hoirs de feu Spectable et Sçavant Jean François Colladon vivant bourgeois d'Aubonne et ministre à Copet, 26 mar 1715.

80v Acquis judiciel pour Monsieur Nicolas Pappam (Papan) assesseur ballival et bourgeois de Morges, fait des Sieurs hoirs de Spectable Jean François Colladon vivant bourgeois d'Aubonne et ministre à Copet, 26 mar 1715.

82 Investiture pour la noble bourgeoisie et charitable hospital d'Aubonne, contre le Sieur Salomon Pampigny et les hoirs d'Egrege Gabriel Vionnet de St. Livre, 02 apr 1715.

84v Subhastations de fonds et prises pour le Sieur Chastellain (Jeremie) Warnier de Montricher contre le Sieur (Jean) Salomon Pampigny et Marie Tornier sa femme, 18 jun 1715.

87 Investiture pour le Sieur Jonas Anthoine bourgeois d'Aubonne contre Pierre Barbier dudit lieu, 18 jun 1715.

88 Testament of Gabriel Dumartheray of Montherod, 27 feb 1715 (rec. Eg. Feignoux), died 25 may 1715. Wife Jeanne Estheinnaz Josseron, sons Matthieu and George Dumartheray. Residual heirs these children plus additional children Enoch, Esthienne, sons, and Jeanne Esthennaz and Jeanne, daughters, and also Jacob son of Jean Court and the late Elizabeth Dumartheray his daughter. Probated 02 jul 1715.

89v Testament of Pernette Mauraz wife of Isaac Josseron of Montherod, 19 may 1715. Probate requested by her brother Esthienne Mauraz of Aubonne. She died 15 days ago today 17

sep 1715. Requested also by her brother Gabriel Mauraz, and Anthoinaz Mauraz her sister widow of the late Reimond Mouty. Niece Judith daughter of Discret Jean Esthienne Mauraz her brother. Additional children of Jean Esthienne Mauraz: Hugues, Marc Isaac. Residual heirs her two brothers, substituting their children. Rec. Croutaz. Probated 17 sep 1715.

91 Assignal pour dame Jeanne Françoise Roy vefve de feu Spectable et Sçavant Jean François Colladon bourgeois d'Aubonne et ministre à Coppet, 15 oct 1715. Her brother Monsieur Roy is professeur at Lausanne, who has purchased her paternal and maternal rights.

92 Testament of Enoch Chometton bourgeois d'Aubonne, 10 oct 1715 (Eg. Mayor). Mother Judith Neyroud, substituting Judith Anselme daughter of the late Henry Anselme, his maternal sister. Others named in proceedings. Probated 26 nov 1715.

93v Subhastation pour monsieur l'assesseur ballival Rolaz de Morges, contre la vefve de feu Pierre Jacquier de Feschy, 10 dec 1715.

94v Testament of Miaz Cour vefve de feu Jonas Chavanaz d'Aubonne, 07 aug 1709. Son Isaac Gabriel Chavanaz. Daughters Louyse et Magdelaine Chavanaz. Probated 21 jan 1716.

96 Investiture pour Noble Theobal de Watteville seigneur ballif du Rougemont (and his unnamed indivis), contre Noble Benjamin Dallinge dit Bocquis de Saubraz et les hoirs de Wille Henguer dudit lieu, 21 jan 1716. Represented by Eg. Gedeon Mayor of Aubonne.

97 Testament of Elizabeth Prenleloup de Cossonay, 29 nov 1715. Daughter Louyse Marie Richard. She had already made distributions to her other (unnamed) children. Probated 28 jan 1716.

98v Investiture pour les Sieurs hoirs de feu Monsieur le Banderet Vouchy bourgeois d'Aubonne, contre Pierre Jaques Larpin demeurant à Bursinel, 28 jan 1716.

100 Confession et assignal pour honnorée Anne Claudine Lagnel de Saubraz femme d'honorables George Benjamin Prodhom de Montherod, fait par ledit Prodhom son mary, 25 feb 1716.

101 Subhastation pour les hoirs de feu le Sieur Jean Dumartherey de Montherod, contre honnorable Jonas Dumartherey dudit Montherod, 10 mar 1716.

103 Testament of Anne Marie Machard en son vivant femme d'André Granjon de Longirod, 02 mar 1716 (Eg. Barret). She died one month ago today, 12 may 1716. Residual heirs her daughters Danielle and Susanne Granger. Probated 12 may 1716. The proceedings give a partial explanation: Jaques, Salomon, and Jean Granger, demeurants à Esin were brothers-in-law of the deceased. Daniel Granger, demeurant aussy audit Esin, is guardian of Danielle and Susanne Machard, daughters of the said deceased, and Jean Pierre Maïntonnet of Burssin and Discret Moyse Baupan of Loin are her cousins. Danielle Maïntonnet is now wife of Claudy Burnet of Burtigny. The deceased had been the wife of "feu ledit Granger", but his name is not actually given. It appears that Danielle and Susanne should not have been called Machard, but rather

Granger (as cited in the testament). Is Danielle “Mâintonnet” the same person as Danielle Granger/Machard?

104v Investiture pour la dame vefve et hoirs de feu Mr. le ministre Gandillon de Begnin, contre honnoragle Pierre Jaques Larpin de Feschy, 19 nov 1716. (Date first listed as 19 nov 1715, but at the end of the record it is stated as 19 nov 1716.)

106 Acquis pour honorable Claudy Chauvy de la Fiougere, fait des hoirs de feu Pierre Michel Chauvy dudit lieu, order issued 19 nov 1715. The guardian of the heirs is Gedeon Chauvy of La Fiougere, and Pierre François André is their uncle. Further proceedings reported, the final settlement 28 jul 1716.

107 Acquis pour honnable Jean Issac Montoux de Yens, fait des hoirs de feu Pierre Michel Chauvy de La Fiougere, 28 jul 1716.

119v [end of testament of _____ Grivel of St. Livre, recorded by Eg. G. (=Gedeon) Mayor, probated 27 oct 1716. His mother was Eve Buclin, and he had a brother Jean David and sister Jeanne Imberte.

[Notation at the bottom of 119v indicates that several subhastations and acquis were omitted in error, and that they are recorded on fols 151v, 152v, and 173v.]

166v Testament de Noble Imbert Marquis bourgeois d'Aubonne, 28 jan 1718 (Eg. Martinet). Nephew Jean Jaques Marquis of Aubonne. Codicil 02 oct 1718 (Eg. Chaubert), in case Jean Jaques Marquis, now in the service of his Britannic Majesty, should die, estate reverts to the children of the sister of Jean Jaques, Françoise Marquis, wife of Jacob Berthoud. Mention of late Louyse Marquis, sister of Jean Jaques. Probated 15 nov 1718.
