

ACV C VIIa 410 Romainmôtier, properties subject to the priory and château de Brussins (modern Bursins), early 14th Century.

Abstracts prepared by John W. McCoy (RealMac@aol.com) © 2017.

The manuscript is a scroll consisting of several membranes sewn together, but the beginning has been lost. There are no folio numbers or other landmarks, so we used the file numbers of our photographic images (for the first image in which the beginning of each item is clearly visible) for navigation. The text is related to ACV Ad 24, a terrier for approximately the same properties compiled by Jacobus de Sancto Raginberto or de Sancto Ramberto in 1337. However, in many places, C VII a 410 appears to refer to an earlier period, such that the reconnaissants are often one generation earlier than those mentioned in Ad 24. Of 102 reconnaissants where we could find sufficient information in both terriers, 59 had evidently died and were succeeded in Ad 24 by someone else, and 43 had survived and continued in their tenancies.

A notation at the beginning of the scroll (possibly an old file card, now pasted to the first surviving membrane) indicates that it was noted as missing from the ACV as of August, 1929, but was “repatriated” from the communal archives of Moudon on 24 nov 1990.

692 Curatus de Brussins (Ad 24, fol. 12v, Dompnus Berthodus curatus de Brussins) debet domino pro casali domus sue sito super cimiterium, xii denarios. (This is likely the parcel involved in the enlargement of the church and cemetery in 1472, see Fj 70, fol. 97, where the associated house is said to have been the house of the curatus, but later belonged to the Confrérie. The house itself seems never to have been specifically subject to a cense in this series of terriers, not even when it was occupied by the Confrérie, perhaps because it was originally part of the precinct of the church itself.)

In compacionem ? (uncertain reading, perhaps an attempt at *cambiendum*, or a very strangely written *mustacionem*) but the amount matches that to be paid for each « mutation » or change of the curatus, in Ad 24, fol. 12v) curati pro placito x solidos.
