

ACV Dc 31bis, Nycodus de Planchia, 1484-1490.

Abstracts prepared by John W. McCoy (RealMac@aol.com) © 2013.

One register, probably a fragment. Almost every item bears the paraphe of Nycodus Planchia, in a few cases plausibly interpreted as Nycodus *de* Planchia. The important question is whether he is the same Nicodus de la Planchia from Corcelles-près-Payerne who is also known to have been associated with Lutry, and who was also a citizen of Fribourg, and if so, whether that fact in any way illuminates his history.

Marginal notations indicate that many items were later copied by A[nthonius] Perrin, a notary from the district of Avenches. The folio numbers are modern, and at the end, there is a group of “pages” that are much smaller than the rest, suggesting that this is an artificial register, not originally intended to be bound together.

The microfilm includes an image of the inside of the front cover, an old parchment, apparently a testament. However, since only the left half of the parchment is visible, it happens that neither the full name of the testator (Johannes) nor the date of the testament is visible. There are mentions in this testament of Bartholomeus Dancit, a late brother of the testator, and the place names Aran and Lutry. The best that can be said is that this was the testament of Johannes Dancit, probably of Lutry, in the 15th Century.

One of the small slips of paper bound at the end of the register (numbered as fol. 39) is clearly dated 1475 and appears to involve people at Aran, so it is possible that the cover and the stray item from 1475 are relics from the earlier career of Nicodus de la Planchia, who was an officer for the Bishop of Lausanne at Lutry around 1480.

The surname de Vineis or de Viveis appears several times. Historians seem to be about equally divided as to which possible interpretation is correct. The two names are indistinguishable in the script of the time, because the small n, u, and v are usually identical.

(Fols. 27v and 28 apparently were not photographed on the microfilm. However, the next frame on the microfilm appears to be a loose piece of paper, possibly the top of a folio from the present register, with a marginal notation that a copy was made by A[nthonius] Perrin: Vuilliermus Patri residens in Bellarippa has received from Johanneta filia quondam Johannis Cuschad ? de Montet his wife 40 livres, dowry, assignal ? , 04 ??? 1489 or possibly 1490, with paraphe of Nicod Planchia.

They are plausibly all in the same hand, but only a few bear the paraphe of this notary. Unless otherwise noted, they are written on only one side.)

Johannes Perisset de Lunouroz antenatus ? leases from Vuilliermus et Glaudius Cler de Pegrant fratres, 24 feb 1487.

... ? (later in the text, this party seems to be identified as Johannes Rossallat) and Perrissona his wife sell to Johannes Roguinet ? de Pegrant, 25 oct 1485, with other provisions. (This item, with its additional provisions, extends to fol. 43, the end of this fragmentary register. The tops of fols. 42, 42v, and 43 are damaged and stained. However, the parties seem to be those mentioned on fol. 40. See fol. 7, where it appears that the husband of this Perrissona is Johannes Nebely or similar.)
