

ACV Dc 32bis Mermet de Montet, 1464-1500

One register, originally unnumbered, with modern foliation in pencil. There is no cover, and it seems likely this register is a fragment. There is no direct evidence for the attribution of this register to Mermet de Montet (the inscription that includes his name on the first folio is modern), and the list of acts that someone had copied “from the registers and protocols of Mermet de Montet”, on fols. 46-47v, makes us wonder if this register actually pertained to a successor, who was entrusted with his registers and “protocols” after his death. There are occasional mentions of Mermet de Montet in the text, again suggesting that the present register may be the work of a contemporary who survived him and later had custody of his registers. There is a gap of more than a decade between the material before fol. 46 and that beginning on fol. 47v, and the script of this later section is possibly from a different hand as well.

The modern notations on the first page note the presence of inscriptions mentioning Thomas Guisan, notary. However, there are other notaries cited as well. On fol. 1v, there are three places where notations indicate copies were made by Petrus Cuaneti commissus (in other words, a notary Petrus Cuaneti was instructed or “commissioned” to make copies). The same Petrus Cuaneti is mentioned in the marginalia on fol. 2v-4, and continuing until fol. 45v. The hand of this Petrus Cuaneti appears indistinguishable from the main text, so we are inclined to think that fols. 1-45 are in fact a register of acts recorded by Petrus Cuaneti, and not Mermetus de Montet. On fols. 33v, 34v, 35, and 38v there are notations such as “levata est per me G. de Dompnopetro commissum”, with a small paraphe. On fols. 46-47v, there is a list of acts that someone copied from the first four registers of Mermetus de Montet, but this list might be in a different hand. The script from fol. 47v to the end is noticeably more irregular and careless than that of the first section, and the dates jump at this point from 1469 to 1481. On fol. 48, we find the first notation that a copy was made by the notary Thomas “Guisani” or “Guysani”. Similar notations are found on fols. 51v, 57, 58v, 59, 62, 62v, 64, 65, and 66v. The script of these marginalia seems similar to that found in the main text on fols 47v-69v. On fol. 50v, there is a notation “levata per me Claudii (?) Cuaneti commissus”, the only instance of this name.

The simplest explanation for the genesis of this register, then, would be that the first section, up to fol. 45v, was the work of Petrus Cuaneti. A transaction in the registers of Nicodus Bonjor (ACV Dc 45/1a, fol. 24v, 26 may 1458) shows that Petrus Cuaneti, clericus et burgensis Adventhica, was the son-in-law of Mermetus de Montet, having married Ludovica, daughter of Mermetus de Montet, notarius de Mostier. As the notary’s son-in-law, and a notary himself, Cuaneti would have been the logical custodian for de Montet’s records. The next pages were used by someone, possibly not Cuaneti, to maintain a list of the items that had been copied from four registers of Mermetus de Montet, of which this unknown notary had custody. The remaining pages were probably the work of Thomas Guisan, and at some point G. de Dompnopetro and probably Claudius Cuaneti (it is known that Mermetus had a son of this name) also had custody of this register. If any of the transactions recorded here can be matched with copies in other sources that give the name of the original notary, it might be possible to prove the authorship of one or both sections of the present register.

The dates range from 1464 to 1500 (but with a gap between 1469 and 1481), but we found one item dated 1508 (fol. 66v) and another from 1517 (fol. 62), probably later additions, and possibly related to the other items on those pages.
