

ACV Dc 45 Nicodus Bonjour, notary at Avenches, 1447-1459.

Abstracts prepared by John W. McCoy (RealMac@aol.com) © 2013.

Fragments of two registers covering the years 1447-1453 (Dc 45/1b) and 1457-1459 (Dc 45/1a). Some pages are now reduced to small fragments, like the Dead Sea Scrolls, and it is not clear that these fragments are collated correctly. The first intact folio of the part of this register marked "A" (this is actually Dc 45/1b, according to the labels on the Family History Library microfilm) appears to be 10, followed by folios 11 to 130 (written C30). The other fragment, Dc 45/1a, contains folios 1 through 56. The dates in these registers seem to have confused earlier scholars. The year 1450 is sometimes written by this notary as m^o iiij^c lmo, the last part representing "quingesimo", but probably interpreted by more than one reader as liii^o, thus leading to the incorrect reading 1453. In any case, the dates in these fragments do not seem to match the inventory of the Archives Cantonales Vaudoise (ACV). Further, the Family History Library catalogue and microfilm #865765 incorrectly place these fragments in the 17th Century instead of the 15th!

The two fragments are presented here in their logical order, the earlier Dc 45/1b (1447-1453) first, followed by Dc 45/1a (1457-1459).

After this incipit, the first item concerns Franciscus, no more of the name is visible. The name on the next item is not visible at all. This fragment may be all that remains of a (first) register beginning in 1443, and if that is true, the present register consisting of fols. 10-130 must be the "second" register of this notary. Dc 45/1a would then have to be the "fourth" register, covering 1457-1459, and a "third" register covering 1454-1456 has evidently been entirely lost.

This fragment is bound with a parchment bearing an "assignal" by Petrus Vissin filius Petri Vissin, for his wife Marguereta filia Nychodi..., dated 1455, for a dowry of 50 livres. Only the left half of this assignal is visible, as the parchment was folded around the rest of the register, and the other half, which functioned as the back cover for the register, is apparently lost. There are 57 numbered folios, 1 to 10, another 10, and then 11-56.

The front cover bears sundry notations, mostly illegible, as well as a small attached slip of paper that says, "Vieu livre Latin qui paroît Carnet, dont le Comencement et la fin sont déchirés, et tous les articles y contenus raîés" (in registers of this period, it was apparently customary to draw a diagonal line or an x across the text when its terms had been fulfilled).
