Second register of the notary Pierre Gachet, secretary of the city of Payerne. His first register is lost, and there was likely a third register as well, also lost. The “Hußbuchli” of his son Niklaus Gatschet, who had a long career in Bern, tells us that Pierre died 21 mar 1528 (Burgerbibliothek Bern, Mss.h.h. XVII.276, no. 19). A few folios appear to be missing, and there are a few irregularities in the folio numbers. Some folios also bear other numbers, generally lined out, as if paper for the present register had been scavenged from another register that was already numbered, but otherwise unused.

There is only one item from 1503, and a few from 1504. The bulk of the items are from the years 1505-1513, with a few later additions to those items. Thus, the first register of this notary would have covered the years up to about the beginning of 1505, style of the Annunciation. The transactions are not in strict chronological order. As was the practice of other notaries as well, it appears loose documents were copied into the register at irregular intervals, after only very rough sorting. As a result, dates are sometimes uncertain, when the notary writes “anno quo supra” but the day and month would place the date in a different year, a few days before or after the Annunciation. (There is no evidence that this notary ever used the style of the Nativity in computing the year, except for a few acts concerning the cloister of the Abbey of Payerne at the beginning of 1513.)

It took some time to understand this, but the present notary writes *prenominantus* instead of *prenominatus*, using the present active participle in place of the present perfect participle, but with the endings expected for the latter.

[Marguereta] uxoris relictique quondam dicti quondam Petri Roberti (the other party), dispute, the said brothers claim half of the property from the said late Petrus Roberti that came from his first wife Margareta, et hoc vigore testamenti per eiusdem quondam Petrum Roberti facti, but Dompnus Petrus de Expagniaco claims that the property, or some of it, came from Janna, second wife of the said Petrus Roberti, arbiters Discretus Aymo de Torculari et Franciscus Ruerati clerici et burgenses Paterniaci parte dictorum Johannis et Georgii..., et Frater Philippus de Bruello cantor conventus Paterniaci et Nobilis Claudius de Foucignye de Paterniaci on behalf of the other party, settlement requires payment of considerable rents, some at Corserey, to the said

brothers, 25 feb 1504. (There is a poorly legible notation in large letters at the bottom of folio 1, “Die xxiii mensis januarii dies Mercurii ... millesimo v^C nona ab annunciatione...”, the rest illegible.)

Claudius Ruerat de Corcellis, testament, burial in the parish church of Corcelles, universal heir his son Anthonius, bequests to his daughters Loysa et Margareta, bequests to church, remainder of the testament in very small script, much of it badly stained and faded, and thus largely illegible, date not found.
