

ACV Dp 5 Claudius Banquetaz, notary 1486-1493.

One register with répertoire. 14 unnumbered + 210 numbered folios, 13 oct 1486 - 23 jun 1493, but the last of the unnumbered folios at the beginning of the register, with writing only on the verso, dated 25 or 26 mar 1486, may have come from another register.

The title of the répertoire is not clearly legible due to staining, but it appears to say “Repertorum primi registri...” The entries in the repertoire have been incorporated into the digest of the register, indicated in *italics*. Not all items in this register are noted in the répertoire – such items are noted below. The various items are frequently recorded out of chronological order, as if they were copied at irregular intervals from various loose papers. As a result, it is possible that some of the dates might be questioned, when the year is given as “anno quo supra”.

Volly (Wolly) de Villaret de Curtypit ? has received from Olliverius Ruerat de Corcellis 20 livres of Friburg that he owes for cows, 24 may 1486.

Glaudius Brunet filius quondam Ansermi Brunet owes cense to Petrus de Aumond de Bussy filius Anthonii de Aumond by agreement made between them concerning a debt of 12 livres that Glaudius owed to the said Anthonius because of the marriage (“*causam matris monii*” !) of the late Johanneta, sister (*suroris mee*) of Glaudius, daughter of the late Ansermi Brunet late father of Glaudius, 24 oct 1486.

Dompnus Johannes Banquetaz cappellanus Paterniaci curatus de Corcellis prope Paterniaci filius quondam Johannes Banquetaz dicti loci Paterniaci filiusque Perronete filie quondam Michaelis Merquy (=Marquis) alias Lonbart de Albona et filie quondam Bone filie nobilis _____ de Gallera de Lignyrolaz prope Orbe Lausannensis diocesis, sells to Johannes de Vallera (Vallere ?, but the V is clear, the name is not written de Gallera) domicellus Cletaris ? (=Clées ?), cense, nomine dotis sive assignacione « matrismonii » dicte Bone matris dicte Perronete (inserted : et dicte Janne) matris dicti Johannes Banquetaz venditoris heredis dicti _____ de Gallera domicelli, die Jovis ante festum beati Martini Yemalis 1486. Marginal notation says that Bona had another daughter Janna, now widow of the late Gabriel Mestreaux, with whom the inheritance is shared.

(In the genealogies of Hubert de Vevey, there is a notation in the de Gallera genealogy that « Bonne bâtarde de N.N. de Gallera de Lignerolle épousa N.N. Marquis d'Aubonne, dont la petite fille Perronète Marquis était en 1456 la femme de Claude Banqueta de Payerne (communication d'Arnold Gachet de Bioley-Orjulaz) » . From the entry here, it appears Arnold Gachet was mistaken. No source is given for his version of this family, and there is no other mention by de Vevey of any of the other people mentioned here.)
