

ACV Dp 64 Nicodus Mareschet, notary from the district of Payerne, 1431-1439.

Genealogical information from entries marked **M** (marriages), **A** (assignaux), **T** (testaments), or **P** (partages) has been added to the Dutoit database at www.rootsweb.com/~chevaud/dutoit.

Many items in this register bear notations “Levata est per me Ja. (Jacobus) Bellin ex commissione” or a similar one by Ay. (Aymonetus) Pictet, indicating that these notaries, working in Payerne, later had custody of this register. However, Nicodus Mareschet himself seems to have worked, at least for these years, mainly in the Vully area, and perhaps as far afield as the city of Neuchâtel.

There are many transactions in this register involving the small community of Jews in the city of Neuchâtel. This aspect of the register of Nicodus Mareschet seems to have escaped notice. A detailed study of this community has been published from sources at the archives of Neuchâtel: Achille Nordmann, 1922-1923, *Les Juifs de Neuchâtel*, *Musée neuchâtelois*, 1922 Nos. 4, 5, 6, and 1923, Nos. 1, 2 (internet copy at: http://www.pdfarchive.info/pdf/N/No/Nordmann_Achille_-_Les_juifs_dans_le_pays_de_Neuchatel.pdf). The main source for the published information appears to be the register of the notary Bourcard de Sonceboz, before 1430. The register of Nicodus Mareschet contains information that significantly extends this information, at least 78 separate transactions involving the Jews of Neuchâtel, the first on fol. 8v (12 nov 1432), the last on fol. 184v (14 sep 1438).

Summary of the Jews of Neuchâtel mentioned in this register:

- Abraham dou Puget (8v), wife Ester (42v) occasionally called Stella (29).
- Abraham de Souroz or Souvroz, son Gaudetus (Gaviletus?) (29), Bella his widow (39v); Abraham and his widow, as well as a son Isaac who left the area, are mentioned by Nordmann.
- Joseph de Berno (Bernod) (33) ; his son Isaac appears in the register of Jacobus Bellin (ACV Dp 8).
- Abraham de Luam (34), wife Ester (46v) ; Abraham de Luam dit Velyns, 1451, mentioned by Nordmann.
- Lionetus, judeus, residing at Aubonne (Albona) (66), later (184v) of Porrentruy and residing at Novumcastrum; mentioned as “Lion” by Nordmann.

While we transcribe the abbreviation  as “alias”, this scribe frequently uses an abbreviated form of “aliter” (written ) , and never “alias” when listing alternate names, except for the very last entry in the register, where “alias” is written out in full.

Marguereta relictā Anthonii Capitam de Villar en Vuilliez nunc uxor Jaqueti de Groler de Costantina owes cense to Roletus filius Huguetus Soutier dicti loci de Costantina, same date, with other provisions, and another similar act for the same parties, same date.

Johannes Boular filius Reynaldi Boular de Charbuens quitclaims to Jaquetus de Molendino de Villar en Vuilliez, debt owed by Johannes in connection with the marriage of his wife Johanneta sister of the said Jaquetus, 8 livres, same date.

Johannes Crostel clericus filius quondam Jaqueti Crostel de Paterniaci quitclaims to Jaquetus Ramux de Sancto Albino en Vujilliez, cense (rec. Vuilliermus Mareschet), same date.

Fol. 231v :

Jaquetus Charbona alias Tachyt de Sancto Albino en Vuilliez owes Johannes Montet nunc residens in dicta villa Sancti Albini, same date.

Dictus Johannes Montet de Cudriffino has received from Vuilliermus Rucy de Sancto Albino en Vuilliez 4 livres in deduction from 7 livres debt, same date.

Johannes Perragoz de Cudriffino nomine Jaquete uxoris sue, et Huguetus Soutier (Soncier ?) de Costantina ?, dispute, main statement of the issue badly stained and blurred by moisture, related to a transaction between the late Nicodus Pagiez and the said Huguetus, recorded by Petrus Gachet, settlement, 03 feb 1439.

Johannes de Tombey de Bellarippa with approval of Humbertus his son sells to Petrus Tissot de Salavuax, 04 feb 1439.

Fol. 232v:

Prefatus Johannes de Tombey de Bellarippa sells to Petrus Jaunyn dicti loci, same date, with other provisions.

Johannes Ramux junior de Sancto Albino en Vuilliez owes Dompnus Jacobus Lamberti curatus Bellarippa, same date.

Fol. 233 :

Nicodus Bel alias de Montet de Chessaz with approval of Aymonetus Nochet sells to Dompnus Bartholomeus Clerici (written out, =Cler) alias Rolier de Lietherens, 10 feb 1439.

Johannes Trevaul clericus tanquam tutor et gubernator liberorum quondam Johannes de Praromant de Friburgo has received from Jaquetus Ramux de Sancto Albino en Vuilliez..., (badly stained), same date.

Johannes Trevaul as above has received from Johannes Bergier alias Collaud de Sancto Albino en Vuilliez, cense, same date.

Nicodus Charbuens filius quondam Girardi Charbuens de Missiez owes cense? to Johannes Trevaul clericus Paterniaci as tutor etc. for children of the late Johannes de Praromant, same date.

Fol. 234:

Nobilis Bartholomeus Rolandi has received from Johannes Trevaul clericus et burgensis Paterniaci, same date.

Uldriodus Saugit de Sancto Albino en Vuilliez owes Perrinus Lardy, 12 feb 1439.

Marguereta relicta quondam Roleti de Tombey de Bellarippa owes Jaquetus Geneveis dicti loci, 15 livres for a barrel of wine, 10 feb 1439.

Jaquetus Soutier ? de Costantina et Jacobus Perlectaz de Villar en Vuilliez accensation ? for Johannes deis Coster ? (edge of page is badly stained) burgensis de Novocastro, 15 feb 1439, with other provisions.

Johannes Perrier alias Verdom (=Verdon) de Vallon sells to Dompnus Jacobus Tabusset et Humbertus eius frater de Dompnopetro en Vuilliez, 20 feb 1439, with other provisions.

Fol. 236 :

Johannes Perrier de Vallon sells to the same parties (but badly stained and blurred by moisture), same date, with other provisions.

Roletus Gillion de Villar en Vuilliez owes Johannes Perrier filius quondam Roleti Perrier morans in villa Sancti Albini en Vuilliez, same date.

Stephanus dou Vuax de Missiez donation to his son Johannes dou Vuax nunc morans apud Lietherens, nomine partagii, various properties, but parts are badly stained and illegible, 04 mar 1439.

Fol. 236v:

Johannes Collaud *alias* (written out, the only such passage found in the entire register!) Bergier de Sancto Albino with approval of his sons Bartholomeus and Petrus, owes Johannes Trevaul Paterniaci clericus, same date.

A small slip of paper is inserted here, “Billet pour François (?) Jaquet Jan de l’an 1571”, apparently a list of days (“journées) spent on his behalf for various tasks, and apparently listing crops at specific locations, “somme du byllet vii florins”.
