Aymo de Torculari clericus et burgensis Paterniaci tanquam rector et gubernator ville Paterniaci with approval of (list of city councilors), accensation for 3 years to Glaudius Banqueta clericus et burgensis Paterniaci, videlicet hospitale Paterniaci cum omnibus terriis pratis censibus redditibus ... (in other words, he is to manage the assets of the hospital), with various conditions for the execution of these duties, die Veneris ante festum Sancti Andree Apostolis 1500, with other provisions, the said Glaudius and his wife Jauna making guarantees 30 nov 1500, and a marginal notation indicating that Georgius filius dicti Claudii Banquetaz in plenis consilio ville Paterniaci paid in the name of the hospital for all that the said Claudius held in trust?

Glaudius Banqueta clericus et burgensis paterniaci with approval of his wife Janna sells to Johannes Grisso burgensis paterniaci, octo posas terre juxta terram heredum quondam Jaqueti Meam ab oriente et pratum heredum Poncete filie quondam Girardi Uldriar ab occidente et affrontat a parte venti supra pratum heredum Francesie filie quondam Johannis Fabri et a parte boree super plures contors, 13 jan 1500, with other provisions.

Francesia relict a quondam Jacobi Bellin clericus burgensis Paterniaci, donation to Francesia relict a quondam Nicolleti Bossie filia quondam Petri Periar eius neptis, description of the property is incomplete, 14 jan 1500, with other provisions, and a marginal notation that a copy was made by Aymo de Torculari.
