

ACV Dp 74 Nicod Olivier, notary at Payerne, circa 1509-1512

Fragment of a register, fols. 2-49v, with separate index running at least to fol. 259 (parts of the index that are most clearly legible are transcribed at the end of this document). The index is also incomplete. It is organized by the first name of the first party, apparently, and begins in the letter "G", but any "G" entries for fols. 1-14 have been torn away, with some loss also on the other side of the same sheet. From the part of the index that survives for the folios in the present fragment, it is seen that the index notes only some of the items, presumably the most important ones.
