

ACV Dp 79 Nicodus Probi, 1465-1481.

Abstracts prepared by John W. McCoy (RealMac@aol.com) © 2013.

The catalogue of the ACV and the associated inventories identify the author of the register Dp 79 as Jean Proux (or in Latin, Johannes Probi), but the cover is clearly labeled in a later hand (17th-18th Century?) as Nicod Probi, and there are several signatures (fol. 10 and elsewhere) in this register, with a paraphe that appears to say N. Probi. The notary Nicodus Probi or Proudon is mentioned in several places, but there is no mention of anyone else with that family name.

The catalogue further lists the inclusive dates as 1471-1473, but the contents are not in chronological order and cover at least the dates 1465-1478, plus one item dated 1481, along with a few later annotations or insertions that need not be from the hand of the present notary. There are also copies of at least three earlier documents, see fols. 80-84v.

In the copy registers of the Inventaire Blanc, ACV Aa 12, we find a number of documents where the notary is from the Probi family:

No. S203, 14 oct 1450, transaction involving Isabella relictā quondam Johannes Proudon (=Probi), not identified as a notary.

No. 549, 14 sep 1466, notary Nycodus Probi.

No. 538, accensation for Nycodus Probi de Paterniaci, no occupation noted, 21 jul 1475.

No. 1218, final part, 04 feb 1477, notary Nicodus Probi.

No. 549, another part, accensation for Nycodus Probi, 26 sep 1477.

No. 629, 23 apr 1478, notary Nicodus Probi.

No. 600, 17 jan 1478, notary Nicodus Probi.

No. 611, 05 feb 1478, notary Nicodus Probi.

No. 458, 05 mar 1478, notary Nicodus Probi.

No. 612, 06 may 1479, notary Nicodus Probi.

No. 615, 06 may 1479, notary Nycodus Probi.

No. 630, 29 jan 1479, notary Nicodus Probi.

No. 507, 02 nov 1480, notary Nicodus Probi.

No. 508, 02 nov 1480, notary Nycodus Probi.

No. 628, 26 nov 1480, notary “Nicodus Paterniaci”, probably a transcription error for Nicodus Probi.

No. 509, 14 jan 1480, notary Nycodus Probi.

No. S162, second part, 16 apr 1481, notary Nycodus Probi.

No. 459, 24 aug 1481, notary Nicodus Probi.

No. 1186, 07 aug 1519, notary Nicodus Probi (this is the younger notary of this name, ACV Dp 80).

No. 1208, 1532, notary Nicodus Probi.

From these citations, we see that the elder Nicodus Probi served as a notary from at least 1466 until 1481, but we found no evidence in any source for a notary Johannes Probi at any time.

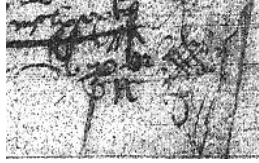
Now, the younger notary in Dp 80 clearly identifies himself as the son of a Nycodus Probi, but it is not clear whether his father was the notary of Dp 79. The earliest known date for the younger man is 1512, more than 30 years after the latest document recorded by the notary of Dp 79. It may be that the younger notary is the grandson of the first Nicodus.

The elder notary Nicodus Probi is also mentioned in the registers of the other notaries of the period in Payerne. One citation is especially interesting: In the second register of Petrus Moroni (père) (ACV Dp 71/1, fol. 107v, dated 24 sep 1469), there is mention of property on which *Nycodus Probi clericus Grandissoni nunc residens Paterniaci* owes a “cense”. Thus, this Nicodus came from Grandson, and so is likely not related to the Preux/Probi family of Vevey who are mentioned occasionally by other notaries of Payerne. (The same origin is stated in the subscription to the item on fol 75, below.)

This Nicodus married Perroneta, daughter of Jacobus Meller and Perroneta daughter of Johannes Borcard, all of Payerne. After the death of Nicodus, Perroneta Meller next married Johannes de Rippe, contract dated 20 jan 1482 (Petrus Moroni père, notary, Dp 71/3, fol. 42).

As further evidence, the **signature** and paraphe that could only be that of Nicodus Probi the elder is found on fol. 78 of the register Dp 71/2, dated 24 may 1479 :

This is the same paraphe found on fol. 10 of the present register, though obscured by the text and by dark stains:



The paraphes are clearly the same, even though the name, N. Probi, is not spelled out in full.

Some of the acts attributed to Nicodus Probi in the copy registers Aa 12 were copied after his death by Dionysius de Torniac (Denis de Tournay), another notary at Payerne. A document that appears to relate to this situation (and apparently misread when the inventory was compiled) is ACV C IV 586 bis, « L'évêque Benoît de Montferrand confie au notaire Denis de Tournay, clerc de Payerne, le registre de feu Michel Proux dont il lèvera les actes de l'oeuvre du prieuré de Payerne, 18 oct 1482. »

The present register is artificial, in the sense that it is composed of separate leaves, many of which were originally folded in various ways. Further, there is evidence that several leaves were later torn out or otherwise lost, and there are several additional leaves that have been attached or inserted.

Philipus de Compesio vicarius generalis etc., accensation for Nycodus Probi, clericus Paterniaci (poorly legible, dark stains), 30 jun 1471, the name of the notary "subscriptus" is not given, possibly because this is a copy of the original made by Nicodus Probi himself

Fol.2

Quod cum Humbertus Rappinat quondam burgensis Paterniaci made a bequest in his testament to the capella beate Marie Virginis, now Othtoninus ... (illegible, elsewhere in this register he is Othtoninus de Yverduno) prior claustralis (list of other members of the abbey), concession to Johannes Chappuis?, 02 apr 1471.

Jaqueti Daumont de Missiez owes Girardus Morel, 26 mar 1471 ?

Fol. 2v

Frater Stephanus? de Expagnie camerarius abbacie Paterniaci leases? to Petrus Meandi burgensis Paterniaci, 10 sep 1470, with other provisions, including one dated 05 jul 1474.

Fol. 3

Frater Petrus d'Espagnyaco sacrista et tanquam vicarius generalis..., with approval of the monks of the abbey (list of names), accensation ? for Johannes Perryn et Nycolletus de Missiez alias Miridam? et Oddetus eiusdem Nycolleti filius residentes in grangia de ...?, 08 oct 1473, with other provisions.

Fol. 5

Illegible, mentions Dompnus Ludovicus _____ capellanus, Petrus de Expagnye, witnesses Dompnus Vuilliermus Tabbuset capellanus, Henricus Nyquilly, 29 jun 1471 ?, with other provisions scarcely more legible.

Fol. 5v

Another item poorly legible, 04 jul 1471.

Petrus Yblet nomine uxoris sue leases? from? Johannes Bovat?, 25 jul 1471.

Fol. 6

Girardus Berroux filius quondam Petri Berroux de Corcellis sells to Henricus Charbuens filius quondam Johannis Charbuens de Corcellis, 18 may 1469.

Philippus de Compesio ? ... prothonotarius vicarius generalis ... abbacie monasterii Paterniaci, quod cum Henrici Charbuens filius quondam Johannis Charbuens de Corcellis purchased from Girardus Berroux filius quondam Petri Berroux de Corcellis..., approves sale ? , date left blank.

~~Nos Nycodi Benedicti prior prioratus de Perruys order of St. Benedict~~ Nos frater Petrus d'Espagnyaco sacrista et vicarius generalis et admodiarius abbacie monasterii Paterniaci, quod cum Anthonius Contoz ? burgensis Paterniaci nunc residens in grangia de Corgy purchased property from Franciscus Ambrenn... ? nunc residens in molendino de Ressudens, ... 27 jun 1475.

Frater Petrus d'Espagnyaco sacrista..., lease ? for Dompnus Jacobus Richardi capellanus, Petrus Richardi eius pater, et Girardus Richardi eius filius (that is, Girardus son of Petrus, and thus brother of Dompnus Jacobus – this reading is confirmed later in the text, Jacobus Richardi et Girardus eius frater), 15 feb 1473, and also approved by Johannes Richardi (another brother?) 17 jun 1474, with other provisions.

Fol. 9

Philippus de Compesio sancte sedis apostolice prothonotarius ..., lease ? for Dompnus Nycolaus Rebus curatus parrochie ecclesie de Chiertiest, text not very clear, this document continues on Fol. 11, dated 10 jun 1466.

Fol. 10

Apparently another copy or version of the preceding item, inserted between the leaves of the latter, 10 jun 1466, text difficult and not very clear, but with paraphe of N. Probi.

Nobilis Johannes de Calcibus receptor generalis acque firmarius abbacie monasterii Paterniaci..., lease ? for Nobilis Richardus Rossel de Mureto, at Chiertiest, 21 jun 1472, and fidejussores signed 01 jul 1472.

Fol. 12v

Frater Petrus d'Espagniaci sacrista... lease for 2 years to Nobilis Richardus Rossel de Mureto, 11 jun 1473, with other provisions.

Fol. 13

Quod cum Nobilis Johannes de Leschaulx olim receptor generalis, lease for 3 years to Dompnus Andreas Richardi monachus de Balmis, Petrus Richardi, et Glaudius Richardi fratres, now Frater Petrus d'Espagniaci leases to dictus prioratus de Balmis, 13 jun 1473, with other provisions.

Frater Petrus d'Espagniaci sacrista tanquam firmarius abbacie Paterniaci..., lease for 3 years to Nobilis Richardus Rossel de Mureto, 05 jun 1475, with other provisions dated 14 jun 1475.

Johannes de Trevaul clericus et burgensis Paterniaci, accensation for Johannes Savari filius quondam Johannes Savari de Corcellis, all his vacant tenements en laz Fredivillaz, 29 jun 1475, with other provisions.

Fol. 14v

Prefatus Johannes Savari owes cense to Mermeta relicta quondam dicti Johannis de Trevaul, 02 ? sep 1477, with notation that a copy was made for Mermeta 22 feb 1490.

Fol. 15

Johannes Jaumynyer residens in Sancto Albino et Stephanus de Mediavilla? burgensis Paterniaci tanquam tutores et gubernatores Bartholomei, Oliverii, Isabelle, et Basthienne ? liberorum quondam Vuilliermi Jauminyer, owe? to Johannes Savari de Corcellis, 17 jan 1473.

Fol. 15v

Frater Stephanus d’Espagniaco camerarius abbacie Paterniaci, lease to Jaquetus Chevro filius quondam Nycoleti Chevro de Corcellis?, relates to a mill, die Veneris ante festum purificationis beate Marie Virginis 1476.

Instrumentus possessionis ecclesie parrochialis de Martrant?, 27 jun 1477, 7 A.M., at the request of Dompnus Stephanus Rubato ? presbiter de Castellione in Nuchallia Gebennensis diocesis, Dompnus Otho Grux? capellanus olim rector predictae parrochialis ecclesie de Martrant, text not clear, “ita fuit per me” with paraphe of N. Probi.

Daniel? Budallon? owes Dompnus Glaudius de Grelliaco, 06 nov 1476.

Vuilliermus de Octrat ? de Missiez owes ? Nycodus Benedicti prior de Perruys vicarius abbacie Paterniaci, die Lune post ?

Die Lune ante festum nativitatis beate Marie Virginis, mention Roletis Gardia ? de Sancto Albino en Vuillie, text not clear.

Fol. 18

Johannes Gumens notarius Paterniaci nomine Ludovici filii quondam Johannis Gumens eius filii, and nobilis Guigo de Loex ? (later clearly written Loys) nomine Ysabelle alupmne seu nutrite Fratris Petri de Expagnye sacriste abbacie Paterniaci, marriage, 26 aug 1469.

Fol. 18v

Ludovicus Gumens burgensis Paterniaci has received from Frater Petrus d’Espagniaco sacrista for dowry of Ysabella his wife 35 florins, assignal, 20? mar 1474.

Fol. 19

Ludovicus Gumuens filius quondam Johannis Gumuens filii quondam Johannis Gumuens notarii et burgensis Paterniaci, donation to his wife Ysabella, in effect a testament, bequests to the church, mentions chapel founded in the abbey by his grandfather Johannes Gumuens in honor of saints Fabian et Sebastian martyrs, 10 oct 1474 ? (last digit of year uncertain, written over a fold on fol. 20v and obscured by stains).

Ysabella relicta quondam Ludovici Gumens uxor nobilis Ludovici Fervuerg de Friburgo, testament, poorly legible, die Lune post Magdelanem 1477.

Die 10 mensis septembris 1478 prefata Ysabella tanquam sciens etc. de auctoritate Ludovici eius viri renounces and annuls the preceding testament.

Same date, the said Ysabella had made a donation recorded by Dyonisius de Tornayo clericus, now with approval of her husband, she renounces? that donation.

Fol. 22

20 mar 1478, nobilis ...? _____ uxor spectabilis viri dompnus _____ dompnus de _____, donation? to Dompnus Glaudius de Grelliaco, poorly legible, followed by several more notations apparently relating to the same item, even less legible.

Fol. 23

Nobilis Jacobus de Expagnyaco diocesis Gebennensis and Ysabella relicta quondam Ludovici Gumens de Paterniaco nunc uxor nobilis Ludovici Ferwert de Friburgo, dispute, relates to a testament of the said Ludovicus Gumens recorded by Jordanus Regis, notary of Geneva, Ysabella denies this, arbiters Dompnus Amedeus Mistralis prior prioatus Montisricherii vicarius generalis abbacie Paterniaci, and nobilis Henrici de Praromant de Friburgo, resolution not very clear, but it appears Jacobus prevails, 14 jan 1476, with paraphe of N. Probi.

Fol. 25v

(Mostly blank, but a heavily edited item at the bottom, dated 11 feb 1477, names of parties possibly lined out, now illegible.)

Fol. 26

Aymonetus Loctaz? respondit de laude Johannis Fabri, to Frater Rodolphus de Barra procurator conventus abbacie Paterniaci?, de qua responsionem dictus Johannes Perroctet ..., 31 dec 1471, several other similar items, all nearly illegible.

(Fol. 26v is blank.)

Fol. 27

Johanneta filia quondam Nycodi Crostel de Paterniaci uxor Stephani filii Johannis de Yverduno burgensis civis Lausanne, with approval of her husband and of her mother Henrieta relictā prefacti Nycodi Crostel uxoris dicti Johannis de Yverduno, sells to Jaquetus Estoppey filius quondam Nicodi Estoppey morans in grangia subtus Trey, 10 feb 1474.

Fol. 28v

Frater Amedeus Mistralis prior prioratus Montisricherii vicarius generalis abbacie Paterniaci, lease for one year to Dompnus Jacobus Richardi capellanus de Balmis et Girardus Richardi eius frater, 20 dec 1476?, another approval 14 jan 1476, per me Ny. Probi levata, marginal notation appears to be dated 1477, with other provisions.

“Excambia”

Johanneta filia quondam Nycodi Crostel de Paterniaci uxor Stephani filii Johannis de Yverduno burgensis et mercatoris Lausanne, exchange with Oddetus de Rippa burgensis Paterniaci, 18 mar 1474, with other provisions, including one mentioning that Oddetus has received from Petrus Bonet tanquam gubernator liberorum quondam Johannes Crostel in 1477, other notations mostly illegible.

Fol. 31

Frater Petrus de Expagnye sacrista abbacie Paterniaci, quod cum Johannes Aygoz owed?..., 21 may 1472 ?, most of this is illegible, very messy script, heavily abbreviated.

Another illegible item, naming Frater Rodulphus de Bera tanquam procurator dicti conventus, same date, followed by an apparently related item naming prefatus Petrus Remuffin?, same date, the first item possibly concerning Petrus Remuffin as well.

Fol. 31v

Frater Petrus de Expagniaco sacrista, accensation? for Jaquetus ? B... ?, mostly illegible, 19 may 1473, with other provisions.

Fol. 32

Johannes Gumens notarius Paterniaci sells to Humbertus de Montet alias Cudriffin de Missiez (with approval of his – meaning of Humbertus – brother Bartholomeus), duas astas prati sitas in finagio de Missiez eis Recerbet? juxta pratum Johannis Gaschet de Villard a vento et pratum Girardi Escuer alias Gardiam et suorum comparticionarii a borea et affrontat..., 27 apr 1471.

Prelibatus ? Humbertus sells to frater Rodulphus de Barra procurator..., 09 aug 1471, with other provisions.

Fol. 32v

Idem Humbertus de Montet alias Cudriffin cedes to Bartholomeus de Montet alias Cudriffin eius frater, same date.

Dictus Johannes Gumuens sells to Johannes Brulliod filius quondam Girardi Brulliod de Russier, property at Missy, same date.

Fol. 33

Johannes Brulliod filius quondam Girardi Brulliod sells to frater Rodulphus de Barraz procurator dicti conventus, mention of Alexia wife of the said Johannes, 09 aug 1473, with other provisions.

Fol. 33v

Petrus Crostel filius quondam Mermeti Crostel clerici et burgensis Paterniaci sells to frater Rodulphus de Barraz procurator..., cense at Payerne, mention Johannes Crostel clericus filius quondam Jaqueti Crostel, 19 dec 1473, with other provisions.

Johannes Charbuens de Missiez et Johanneta filia Alexie filie quondam Johannis Brulliod antenati relictia Jaqueti Guerraz de laude dicti Johannis eius viri sell to frater Rodulphus de Barraz procurator et procuratorio nomine venerabili conventus abbacie monasterii Paterniaci, cense assigned on properties at Missy, 25 feb 1473, with other provisions.

Frater Petrus de Espagnyaco sacrista quitclaims to Johannes Charbuens de Missiez, same date.

Fol. 35

Johannes Grissod filius Petrus Grissod borralerius Paterniaci sells to fratres Octho de Yverduno prior claustralis, Jaquetus Gallery decanus ?, Petrus de Espagnyaco sacrista, Stephanus de Espagnyaco camerarius, Petrus de Grandemonte, Georgius de Villiaco ?, Johannes de Tretorens, Rodulphus de Barraz procurator, Johannes Maioris monaches, Glaudius de Monte ?, Humbertus Verneti, et Henricus de Grelliaco monaculi ?, cense ? formerly owed ? to the said convent by quondam dompnus Galcherius Grissodi capellanus, assigned on properties (descriptions mostly

illegible), one jx domus quondam dompni Galcherii Grissodi et Petri Grissodi eius fratris cum que partitur, 30 apr 1474, with other provisions, and marginal notations that copies were made by Petrus de Mediavilla.

Fol. 37

Andreas Ame, Johannes Ame junior, et Petrus Loctaz, debt? to Rodulphus de Barra, poorly legible, subject uncertain, 31 dec 1471.

Fol. 37v

Similar to the preceding item, mentions Petrus Chouczey? (possibly Chonczey?), Johannes de Trevaul burgensis Paterniaci, and frater Rodulphus de Barra, same date.

Fol. 38

Johannes de Trevaul clericus et burgensis Paterniaci filius quondam Petri de Trevaul clerici et burgensis Paterniaci, testament, burial in ecclesiam monasterii Paterniaci in Galilea cum predecessores meis, universal heirs Ludovicus filius quondam Petri dou Mulin et Ludovicus filius quondam Johannes dou Mulin filii dicti quondam Petri dou Mulin in equal portions, mention wife Mermeta filia quondam Jaqueti Crostel, mention a house (domus) at Fribourg, bequests to church, censures due annually from the following persons: Jacobus Bonet burgensis Paterniaci 14 sols cense recorded by? Jacobus Bellin clericus Paterniaci, Petrus Contoz alias Jarey de Vissin, censures recorded by? Petrus de Mediavilla, the heirs of the late Johannes Crostel filius quondam Jaqueti Crostel burgensis Paterniaci from dowry of the late Johanneta relicta dicti quondam Jaqueti Crostel matrisque dicte Mermete uxoris mee, Petrus Hensily et Cuanodus de Cuestron de Missie, the heirs of the late Glaudius de Agnens, Anthonius Perrin, and various other properties, bequest to Jacobus Meller burgensis Paterniaci et Petrus Meller eius filius pro multis gratis serviciis per ipsos michi factis post decessum dicte Mermete uxoris mee, bequest to Petrus et Anthonius Chaucy fratres et heredes quondam Berrardi Chaucy, bequest to Nycolleta (uxor? quondam?) Johannis Yod de Friburgo soror mea to be paid by the said Mermeta annually, bequest to Johanneta filia quondam Johannis Yod uxor Johannis Bellin de Friburgo apothecarii, bequest to Guigo Ansel filius quondam Ansermi Ansel, 09 dec 1475, with paraphes of N. Probi (identical to the others in Dp 79 and elsewhere) and Petrus Moroni, and additional notations carrying over to fol. 41.

Fol. 42

Johannes Heremant mistralis de Stabulo, personally appeared before me Nycolleta relicta Anthonii Charbonner dicti loci de Stabulo nunc uxor Johannes ... de Paterniaco materque Johannes et Ysabella liberorum dicti quondam Anthonii Charbuens ac etiam nonnulli parentes consanguinei agnati et cognati ipsorum liberorum ... Aymonetus Charbonne et Johannes Perrin

dicentis et proponentis... (corner of page is lost, ends of first 7 lines are missing), Aymonetus and Johannes are appointed guardians for the children. Item ends as follows: In cuius rei testimonies Ego frater Stephanus camararius sigillum meum pro me et ad presentes et requisicionis omnium procuratorum quorum interest per Nicodum Probi Paterniaci clericum juratum presens instrumentum scribe et in hanc formam redigi feci ac sigilli mei una cum signo et subscriptionem dicti jurati appensione muniri ad utilitatem dictorum liberorum vel quorum interest aut interesse poterit in futurum, 06 jun 1475. From this, it seems certain that the notary is in fact Nicodus Probi, and not Johannes Probi.

Octhoninus de Yverduno prior claustralis abbacie monasterii Paterniaci, Amedeus Mistralis prior prioratus Montisricherii et elemosinarius predicti monasterii Paterniaci, Petrus de Expagnye sacrista, Petrus de Villiaco prior aye infirmarius, Jacobus Gallerii ..., Johannes de Palusviridi? Fol. 52

Johannes Jam antenatus burgensis Paterniaci, donation to the abbey? – text very difficult to read because ink has bled through from the other side of the page, 25 jan? 1472.

Fol. 53

Dompnus Petrus de Expagnye sacrista and Petrus Bonet, dispute?, very poorly legible, ?? oct 1472, followed by settlement? of same, 30 nov 1472.

Fol. 54

Philippus de Compesio prothonotarius, accensation? for Anthonius Chabonyer de Estrabloz, mostly illegible, 17 sep 1471.

Fol. 55

Johannes de Leschaux domicellus vicarius generalis for the abbey, appointment of Glaudius Richard de Balmis as châtelain of Balmes, 13 oct 1471.

Fol. 56

This notation presumably refers to the act that follows, and it implies that this is the original, of which the notary intended to make a copy in a separate register, which, if it ever existed, was apparently already lost at the time the papers of the notary were assembled into the present artificial register.

Also, the lists were certainly compiled by some earlier notary, and must have been copied in the 15th Century for some unknown purpose. Further analysis of these items is needed. There are several mentions of Berthodus and Mermetus Mander in the last half of the 14th Century in the copy registers of the Inventaire Blanc, Aa 12.)

(Note that the existence of this item confirms that we are not looking at the formal register kept by Nicodus Probi, in which such a copy should not appear. Rather, the present “register” is simply a collection of loose papers from this notary.)

Frater Glaudius de Grelliaco and Girardus Uldriard, dispute, whereas nobilis Guiliermus Maioris ... mention Guigo de Loyes, frater Petrus de Expagnye sacrista, 17 oct 1465, this item mostly illegible, followed by apparently related items, 18 oct 1465 and 10 nov 1465, the latter indicating that the said frater Glaudius had received something (illegible, obscured by stains, and the writing very bad in any case) from Girardus Uldriard, and a notation at the bottom of the page relating to a debt of 15 livres that Girardus owed to the camerarius, of which he is acquitted.
