

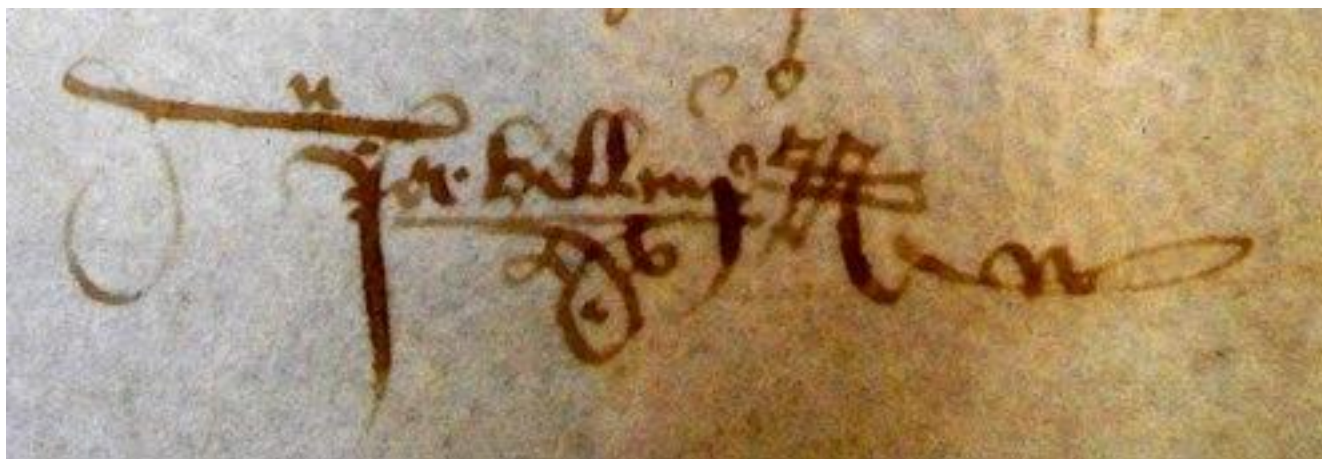
ACV Dp 8, Jacobus (?) Bellin, notary, 1438?-1459.

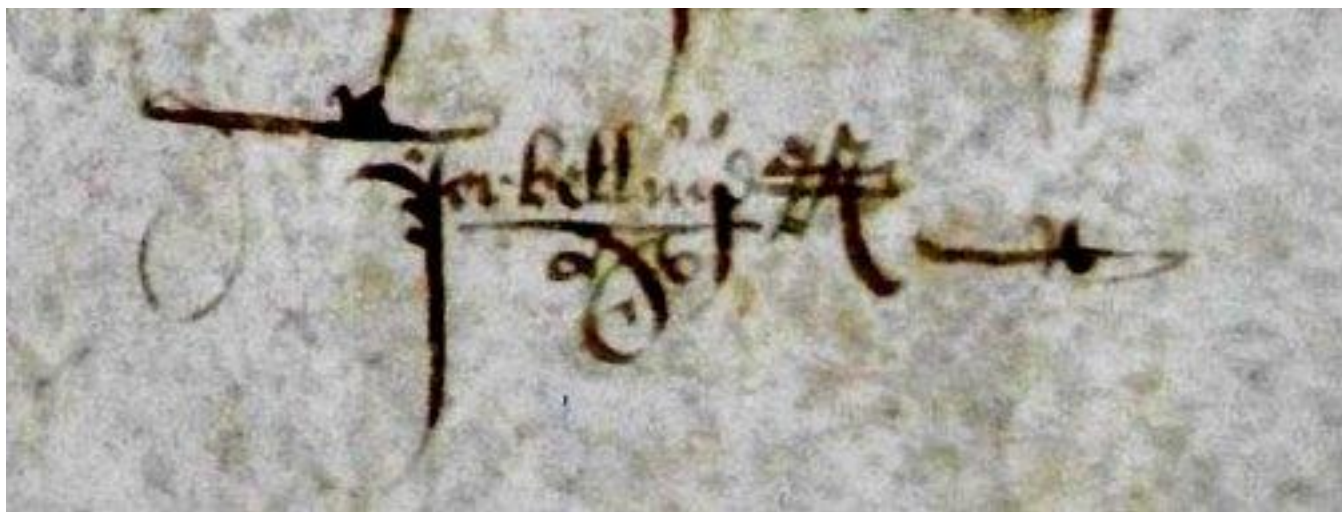
The surviving register is badly damaged by mice and moisture, and more than 50 folios (in two separate sections) are missing. The second (?) folio has apparently disintegrated completely.

The name of the notary is uncertain. On the first folio of this register, there is an inscription that once gave the name of the notary to which it belonged, but only the first three letters of his name remain, Jac – the rest was nibbled away by mice! There are several acts signed Ja. Bellin or Bellini (notably fol. 92), with paraphe, but the paraphe is not the same as the one that appears on the other items that are not signed. However, the paraphe that appears under the other acts follows “Laudatus est”, and so need not be that of Bellin himself. In one document the notary Jacobus Bellin mentioned as being present (fol. 17, 1440), and on fol. 152v, we find a transaction involving Francesia, wife of the notary Jaquetus Bellin. (At least once, no. 611 in the Aa 12 copy register volumes, she appears as the widow of *Jacobus* Bellin – 05 feb 1478 –, suggesting that Jacobus was occasionally called Jaquetus, or vice versa.) We found one item in the copy registers of the “Inventaire Blanc” that might solve this question. In ACV Aa 12/4, no. 574, there is a transaction involving Oddetus de Rippa as tutor for the children of Vaulterius Cordeir dated 05 jan 1452, recorded by Jacobus Bellin. However, the entire year 1452 is missing from the present register, due to the loss of fols. 101-128. The next opportunity to solve the problem is ACV Aa 12/3, no. 523, a “reconnaissance” by Nycodus Girard alias Morens, recorded by Jacobus Bellin and dated 10 jun 1453. This transaction, too, falls in the same gap in the present register. There may still be other transactions that bear on this question in Aa 12/7, a supplement volume, not yet explored. However, the original documents corresponding to these two items in the copy registers have been located (ACV CC VII b 1802 and 1810), and they show the name of the notary written out in full in the text as Jacobus Bellin, and the identical paraphe of “Ja. Bellin” found in Dp 8 at fol. 92 and in other notaries’ registers that were at one time in the custody of Bellin (especially the register of Nicodus Mareschet, Dp 64). Proof that the notary is in fact Jacobus Bellin was finally located in Dp 71/1, a register by the notary Roletus de Montagniac, who in a dispute among the heirs of Roletus Chaucy of Montagny (fol. 54v), dated 09 mar 1462, cites the testament of the said Roletus, recorded by Jacobus Bellin clericus et notarius de Paterniac, which is found in the present register at fol. 95v, dated 12 sep 1451.

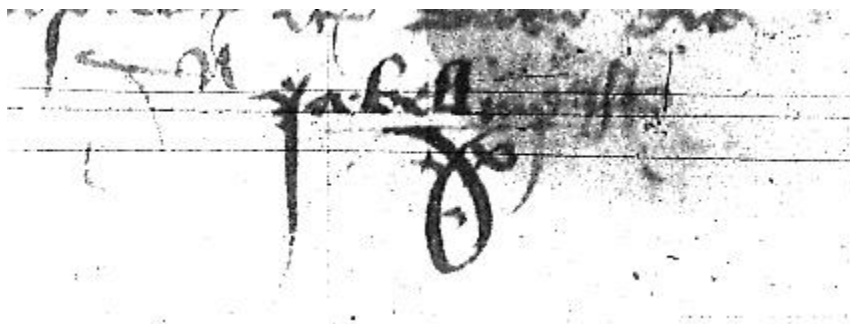
Paraphe of Jacobus Bellin from C VII b 108:



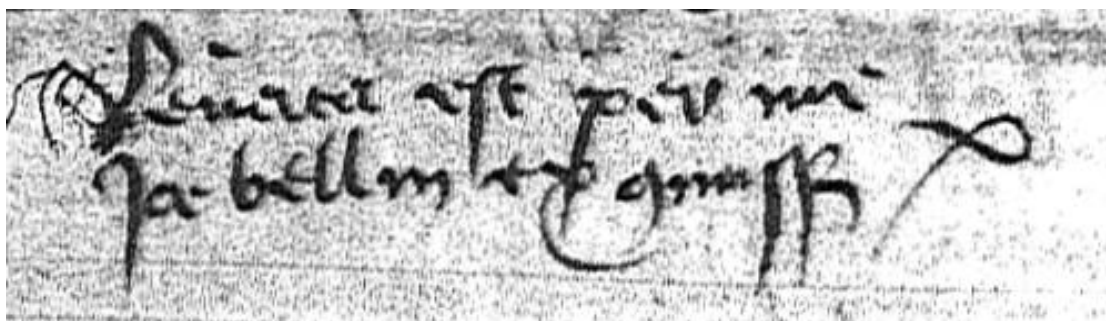
C VII b 1810:

² The construction of this *Item* is apparently to be understood as follows: Subject, *ego Nicoletus Gachet*; verbs, *petebam et exigebam*; object, *platheam* (accusative case), serving then as the “subject” for what appear to be passive infinitives *dimieti*, *partiffice*, *et relinqui*, these actions to be taken by (*per*) *Roletum* and directed toward or in favor of *michi* (*dicti Nicoleti*). Thus, *I claimed and required a “plathea” to be marked off, partitioned, and relinquished by Roletus to me, the said Nicoletus*. *Relinqui* is the passive infinitive of *relinquo*, but the other two “infinitives” are more difficult to confirm. Could *partiffice* be a variant of the active perfect infinitive *partivisse* (from *partio*), or perhaps an attempt at the passive perfect infinitive, traditionally *partitum esse*? Could *dimieti* (in both places where this word occurs, it is very tiny and therefore the spelling is not clear) be from *demetior*?

³ Nicoletus appears to be requesting half of the property and half of the accumulated rents in arrears for the 20 years that have elapsed (“*omnes ipsorum habandum fluxorum*”) since the property, once held by the predecessors of Nicoletus and Roletus, was abandoned to Roletus Gachet by Nicodus Ramus or his heirs. We can therefore date this event to about 1430. Nicoletus is claiming half of the property and its rents because, after it was released by Ramus or his heirs, it should have reverted to the Gachet heirs in common, and not only to Roletus. However, this interpretation depends on difficult text. *Dimieti* is evidently the same word that was used in the previous item, and it is equally uncertain. *Censusque* is lined out, and also difficult to read. To replace the obliterated *censusque*, abbreviated words are inserted above, appearing something like *q med reteta*..., possibly *cum medio retentorum*, but the use of *medius* as a noun is unusual – it might be *medietate*, but everywhere else that word occurs in this text, it is in a form that includes at least one *t*. Also, the word shown as *viginti* is abbreviated *vigin* with an indistinct abbreviation mark at the end, and all the remaining words in this sentence are abbreviated as well. Finally, the word *habandum*, in both places written clearly but with the ending abbreviated, is probably a mistake for *habendum*, perhaps arising from confusion with the misleadingly similar *habandonatus*.

⁴ The construction here is difficult to explain, but the word rendered as *quantitatem* is composed of an elaborate compound sign based on the letter *q*, followed by the letters *-tit-* and ending with the sigla that generally signifies *-is*. There may be an indistinct mark above the end of this word. There are two other occurrences of this word, similarly abbreviated, one with an extra syllable (*-titat-* instead of *-tit-*), in the next-to-last line of fol. 83, where it is clearly in the genitive case: *medietatem dicte quantitatis*. The text in question is apparently intended to mean, “which quantity I request to be restored to me ...”.

⁵*De maiori quantitate* is defective, the word that is very clearly written *maiori* should be in the ablative case, not the dative: *de maiore quantitate*. The abbreviated word that we render as *quantitate* is very similar to the first occurrence of the same word at the end of the fourth line from the top of the same page, but with the letter *e* added at the end. The phrase might be translated as “from a larger sum”.

⁶ The construction of this item is confusing. The two or three words following *nonnullis* are not clear, but it seems logical that they should indicate the property that Nicoletus wants restored to him, that was formerly (*alias*) a vineyard owned by Roletus. Whatever these words might be, they are in the ablative or dative case, and it is the dative that we expect after *petebam*, indicating the thing that was requested. The thing in question is evidently a plural noun of the third, fourth, or fifth declension, probably followed by an adjective of the third declension or a participle used as such. Further, the part that follows *in quibus* seems to lack a subject for *habebam*, if that is in fact the verb (abbreviated *hebam*, with a stroke over the *e*). Tentative translation: “Item, I request as above to be restored to me for a certain sum, for ... (property) formerly set out in vines of the said Roletus, of which a part has been destroyed and extirpated by the same Roletus or by his accomplices, 100 livres good money of Lausanne.” If the word indicating the type of property does in fact begin with *arbo-*, it is not *arboretum*, a stand of trees, because that does not have a form ending with *-bus*. Could it be some other agricultural term based on *arbor*? Could it be as simple as *arboribus existentibus alias in vineis*, currently trees, formerly set out in vines?

⁷ The word *magne* is reasonably clear in the best images, but the word that follows it is obscured by heavy staining. The missing word clearly ends with *-is*, probably *-tris*, and the next word is clearly *mee*. The only logical reading would seem to be *magne matris mee*, my grandmother, which is in fact what is expected from the text at the top of the page, where Perrussona is described as the wife of Johannes Gachet, grandfather of the plaintiff Nicoletus. While this is a literal translation of the French “grandmère”, this usage is not standard Latin.

⁸ Interesting symbol here, possibly intended as a prefix for the word (?) rendered here as causis. The symbol consists of a dot, a small diagonal stroke, and another dot, surmounted by a long diagonal stroke that combines with the following letter, apparently an e. However, the first "dot" is faintly connected by a sinuous line to the top of the long diagonal stroke. If the intent was a "dot", it is tempting to see in this a form of the abbreviation for one half. The sense of the symbol should be "many" or "numerous". This might be something like "dimidiam mille causis", half a thousand arguments, which would be interpreted figuratively as "countless arguments". Another possibility: could this symbol be an A? If it is, what is the meaning of the passage? Or possibly a D? In that case, the part that appears to be "causis" might in fact be part of an abbreviation, or perhaps it is simply "de causis"?

These names are faintly visible in the main transaction, but their relationships have not been deciphered.

Johanneta uxor Mermeti Jam de Corcellis quitclaim to Mermetus Vuilliermin filius quondam Johannis Vuilliermin eius filius, she is apparently usufructuaria of the late Johannes, ?? aug 1459, extremely faded, followed by related items, only slightly clearer.

Vuilliermus Corgeron? filius quondam Petri Corgeron? de ... sells to Aymonet Pictet clericus tanquam rector hospitalis, some names faintly visible, apparently in description of property, datum ut retro.

Fol. 166v:

(Four items, extremely faded and stained, most of the text almost invisible, but mentioning Oddetus de Rippa, the first one possibly dated 18 aug 1459.)

Fol. 167:

Jaquetus Bertho filius quondam Johannes Berthod burgensis Paterniaci with approval of his wife Ysabella filia quondam Petri de Calestria, owes to Francisci Chavanton burgensis Paterniaci tanquam tutor et gubernator Johannes et Francesie impuberum liberorum ipius quondam Petri de Calestria, 50 livres, secured by property at Payerne, 29 sep 1459, with further provisions.

Fol. 167v:

Dispute between Aymonetus Pictet rector hospitalis and Johannes Chevre? (Chevrey) antenatus et Johannes Chevre? junior de Paterniaco, regarding bequest by their father Petrus Chevrey?, only the year 1459 is visible in the date, this settlement badly stained and faded, and with some loss of paper at the margins.

Fol. 168:

Oddetus de Rippa filius quondam Jaqueti de Rippa burgensis Paterniaci ... has received from Jaquetus Bertin et Agnelleta (see next item) eius uxore burgensis Paterniaci ... nomine et ad opus Ysabella uxoris sui dicti Oddeti filie dictorum conjugum, 23 oct 1459, badly faded and stained, and with loss of paper at the margins and some tears and small losses in the body of the document, followed by related item in which the names "Jaquetus et Agnelleta conjuges" are clearly visible, apparently continuing onto fol. 168v, where the text is badly torn, stained, and faded (in this item Jaquetus and Agnelleta quitclaim property to Oddetus).

Fol. 169:

(with many tears and some loss of paper at the margins, stained and faded)... Quod cum Aymo Musard burgensis Staviaci had sold to [Johannes] de Trevaux [clericus] burgensis Paterniaci..., probably dated 12 oct 1459.

Petrus Favernier? alias Sappin burgensis Paterniaci owes? Petrus Chappuis de ... (torn, stained, and extremely faded, date apparently in June, 1460, much of the text nearly invisible), followed by related item between the said Petrus Chappuis de Corcelles and the said Petrus Favernier, datum ut supra.

[Richar]dus Mareschet clericus et burgensis Paterniaci with approval of Marguereta ? his wife, owes Jaquetus Bovet (Bonet?) filius quondam Nicodi Bovet (Bonet?) burgensis Paterniaci, 30 livres, possibly a debt owed to the late Nicodus as rector of the city of Payerne, 10 sep 1459, with related item in which Marguereta, uxor dicti Richardi gives her approval, same date.

... Bosonet burgensis Paterniaci owes ... (no date visible).
