

ACV Dp 80 Nicodus Probi, 1516-1534

Abstracts prepared by John W. McCoy (RealMac@aol.com) © 2013.

One register, in fairly good condition, about 222 folios, the second register of this notary, the first now lost. The first few items were recorded by other notaries (but all in the same fine hand, dated 1512-1513), one by Johannes de Turiaco, and then several by Johannes Banquetaz. It may be that this register was first intended as a record of “censes” owed to the convent of Payerne, then reused by Nicodus Probi (whose script is fast and rather messy, not at all like the preceding items). This notary was the son of another Nicodus Probi (fol. 4), but the text does not indicate, at least not unambiguously, that his father was also a notary. Since the first Nicodus Probi (ACV Dp 79) is known to have died about 1481, it seems improbable that the author of Dp 80 was his son, unless he was an infant when his father died, and that his first register, now lost, began around 1500. But this scenario is still plausible. We found no mention of a Nicodus Probi younger than the notary of Dp 79, apart from the author of the present register. When the first Nicodus Probi died, his registers, or at least a register that he kept for transactions concerning the “Prieuré de Payerne”, were entrusted to Dionysius de Torniaco, another notary at Payerne. If a son of the elder Nicodus Probi had been old enough to serve as a notary (possibly as young as 18) in 1482, the son would likely have undertaken this duty himself (or, if not yet of the age of majority, then under the supervision of another notary).

There are a number of marginal notations in the present register indicating that copies were made later by Johannes Amedeus Probi, probably the son of this Nicodus. It may be possible to confirm this identification from the registers of other notaries who were active after 1534, when the present register ends. The dates of the items recorded by Nicodus Probi range from 1516 until 1534, but they are not in chronological order, as if they were copied from loose papers at irregular intervals. There are also a few earlier or later dates that may or may not be from his hand: three items from 1506-1509 on folios 123v, 134, and 148v; two from 1541 (folios 246 and 247v); and two inserted items from other notaries (folios 102 and 139).

The register appears intact up to fol. 208, though with some numbering errors. Fol. 208 is followed by fol. 210 (possibly this is simply a numbering error, as there is no evidence of a discontinuity in the text), which in turn is followed by (loose?) folios numbered 245 to 254.

(All of the succeeding items are in a different, much faster hand than the preceding items. This notary sometimes uses the “style of the Nativity”, beginning the year on December 25 or January 1, rather than on March 25, “style of the Annunciation”, as was customary for the earlier notaries of Payerne.)

Nobilis Bartholomea de Billens relicita quondam Andreani de Raquineri?, testament (but marginal notation appears to say that this testament « non habuit locum », replaced by another testament ?), burial in cappelle parochialis ecclesie Paternaci in a chapel founded in honor of St. Nycollaus, in the tomb of the late Ludovicus de Mollendino her late husband, universal heirs her daughters Colleta et Barbila (by her late husband Andreiani de Raquier?), substituting her son Benedictus de Mollendino filius quondam Ludovici de Mollendino, 5 sols to brother Franciscus de Billens, another brother Petrus, bequests to church, 19 sep 1519, with other provisions.

Johanneta filia quondam Petri Gavaret de grangia de la Bretoneri antenata (apparently agreeing with Johnanneta!), quitclaims to Petrus et Johannes Gavaret her brothers, 31 aug 1520.

Katherina filia Johannis Phisican (=Fisican) junior de Corcellis uxor Petri Brocoz quitclaims to her father, 25 feb 1516 (millesimo quingentesimo decimo sexto, no abbreviation mark over the last word, which would turn it into septimo).

Georgius filius quondam Johannis Vuilliomet (Volliomet) with approval of ...? his brother Johannes, and Anna filia quondam Johannis Perriard with approval of her mother Glaudia, wife of Johannes Volliomet, marriage, 25 nov 1520, with marginal notation that this item was copied by Johannes Amedeus Probi.
