

## **ACV Dp 92 Attributed to Petrus Ruerat, Notary at Payerne, 1496-1516.**

“Secundum Registrum ... (initial is illegible due to stains) Ruerati”, incorrectly catalogued by the Family History Library (following an error in one of the inventories of the ACV?) as “Pierre Ruchat”. The cover is an old parchment, the recto of which was not included on the microfilm. Corners of some pages have water damage, but most of the text is legible. Similar to other registers of this period, the items are not recorded in exact chronological order. Rather, they seem to have been copied into the register at irregular intervals, with little or no preliminary sorting. The dates are so scattered, in fact, that we have to wonder if the notary devoted any significant time to his duties.

While studying other registers from the notaries of the period, we realized that the present register is far more likely to have been the work of Franciscus Ruerat. There are several reasons for this conclusion:

1. The small paraphe found at the end of most items in this register (three dots, followed by an N with a line through it) is also found with the signature and large paraphe of Franciscus Ruerat in the register of debts owed to Nicodus Mehandi (Dp 65).
2. A “minute” of the testament of Perroneta Bonet, widow of Berard Faulcon and wife of Aymo de Torculari, in the papers of the charitable hospital of Fribourg, to which she had made a bequest, has the signature and paraphe of Franciscus Ruerat. The original draft of this testament is at the end of the present register.
3. The testament of Aymo de Torculari, husband of Perroneta, is also in the present register. A later copy (about 1558) is found in the registers of Pierre Chuard (Dp 16), with notations indicating that the original was recorded by Franciscus Ruerat.
4. There does not seem to be any other mention of a notary Petrus Ruerat active at this period. However, there are many mentions of the notary Franciscus Ruerat during the interval covered by this register, 1496-1516.

Hugoninus Froment? de Visy owes Petrus Gindroz filius quondam Nycodi Gindroz parrochie Sancti Gervasii Gebennensis diocesis nunc morans ad Trey, 10 florins, relates to debt owed by Andrea, servant (ancilla) of Hugoninus ? and sister of the said Petrus Gindroz, 12 may 1513.

Petrus de laz Saugy barbithonsor Paterniaci sells to Glaudius filius quondam Petri Dauryer de Tornyer loz Grant, same date.

Petrus Guyniard burgensis Paterniaci sells to Perrissona relictam quondam Petri Bossonet de Paterniaco, 30 may 1513, with other provisions.

Fol. 79

Petrus Dodin de Paterniaco owes Johannes Grisso burgensis Paterniaci, 17 jul 1513.

Oddetus Vouchy filius Petri Vouchy de Paterniaco sells to Frater Georgius Banquetaz Mistralis procurator et procuratorio nomine venerabilis conventus abbacie monasterii Paterniaci, cense, 05 sep 1513, with other provisions.

Oddetus Vouchy filius Petri Vouchy de Paterniaci sells to Dompnus Vuilliermus Uldry tanquam procurator et procuratorio nomine venerabilis cleri capelle beate Marie Virginis Paterniaci, cense, same date, with other provisions.

Johannes filius Johannis Fisicans antenatus ? de Corcellies, and Johannes Ruerat dicti loci de Corcellis filius quondam Oliverii Ruerat nomine et ad opus \_\_\_\_\_ eius filie, marriage, 24 nov 1513 (the name of the bride is left blank wherever it appears in this contract).

Petrus Chavanton faber filius quondam Johannis Chavanton burgensis Paterniaci, and Oddetus Vouchy nomine Guillaume eius sororis, marriage, 20 jan 1513, with release by bride.

Glaudius de Cheriez alias Rolier de Dompnopetro Parvo sells to Jaquetus Rolinet dicti loci Dompnipetri Parvi, 03 feb 1513, with other provisions.

Guilliermus Jauliquyn ? de Villarsel l'Evesque owes Roletus Rolinet de Esy 6 florins for purchase of wheat, 24 apr 1514.

Johannes Chavanton clericus filius quondam Johannis Chavanton de Paterniaci sells to Anthonius Perrin residens Paterniaci, same date, with other provisions.

Franciscus de Montet alias Cosset de Paterniaco, and Johannes Grilliet filius Nycodi Grilliet de Ficignye nomine Magdalene eius sororis filie dicti Nycodi Grilliet, marriage, 11 may 1514.

Franciscus filius Johannis Gomaz de Ficitnye, and Humbertus de Montagniaco de Dompnopetro Parvo nomine Francescie eius filie, marriage, 26 may 1514, with release by bride.

Anthוניus Cormenbouf faber de Menyeres et Petrus Moret dicti loci de Menyeres sell to Petrus Bondu faber et burgensis Paterniaci, 10 aug 1514, with other provisions.

Bartholomeus Bondrard filius quondam Petri Bondrad de Villar Bramard parrochie Dompnipetri supra Lucens owes Johannes Grisso burgensis Paterniaci 4 livres for purchase of wheat, 05 apr 1515.

Petrus Guinyard de Paterniaci owes Georgius Maliardo de Granvaux 32 sols etc., cense, 23 apr 1515.

Ansoz Vellietez macellarius de Bevaz ? nunc residens Paterniaci owes Johannes Grisso burgensis Paterniaci 138 florins for purchase of sheep etc., 12 jun 1515.

Idem Ansoz Vellietez owes Guilliermus Bonfilz de Trey 30 florins for the same, 12 jul 1515.

Fol. 86

Johannes filius Petri Vouchy burgensis Paterniaci, and Girardus Pictet et Colletus Mollard de Ficignye nomine et ad opus Francesie Mollard, marriage, 28 oct 1516 (clear), with release by bride. Colletus Mollard is the brother of Francesia, but the role of Girardus Pictet does not seem to be explained.

Fol. 86v

Petrus Guinyard filius quondam Petri Guinyard burgensis Paterniaci sells to Marguereta filia quondam Petri Guinyard soror sua uxor Petri de Synarclens sartoris Paterniaci, various properties, 13 mar 1515 (clear), with other provisions.

Fol. 87

Glaudius Crostel burgensis Paterniaci, testament, burial in the cemetery of the Abbey, universal heirs his son Guiliermus Crostel, bequests for wife Clara, daughters Jaqua and Katherina, bequests ? to Johannes Mareschet filius quondam Girardi Mareschet and Glaudius Mareschet filius quondam Humberti Mareschet, mention of brother Petrus Crostel, bequests to church, guardians to be his wife Clara, his brother Petrus Crostel, Aymo de Torculari, and Petrus Gaschet, 01 apr 1513 (clear), with notation that Petrus Gachet made copies of this testament for the three children.

Fol. 88

Discretus Aymo de Torculari, testament, burial in the cemetery of St. Benedict ante capellam per ipsum fonatum, universal heirs Jaqua, Janna, et Claudia his daughters uxores ? Petri Gachet, Anthonius Oddet, et Claudius Fywaz, in equal portions, bequest to Jaqua his daughter, two parcels of vines at Granvaul that were purchased from the Mailliardo, bequest to Janna his daughter, vines at Expesses (or possibly Eppesses, modern Epesses) subtus villam, and another at Poudex, bequest to Claudia his daughter wife of Claudius Fywaz, vines at Expesses, bequests to Petrus Gachet, including a dîme (decima Sancti Marii, probably some part of the dîme of St. Maire), various possessions and clothing, similar bequests to Anthonius Oddet and Claudius Fywaz, bequest to Stephanus de Torculari frater suus, all title and claim he has to property held (jointly?) with him and Johannes de Torculari his brothers, requiring his heirs to turn over to the said Stephanus de Torculari all titles, obligations, and mortgages he holds against Johannes de Torculari for the sum of 800 florins ? , bequest to Jaqueta eius nutrita at the age when she is to marry, 100 florins, bequests to the church, bequest pro remedio anime Perronete quondam uxoris sue, 16 jul 1513. (The testament is in a different hand, heavily abbreviated, and difficult to read. At the end, there is the small paraphe of the present notary:



The text needs more analysis. As it stands, the testament looks like a rough draft.)

Glaudius Fywaz burgensis Paterniaci, and Discretus Aymo de Torculari clericus et burgensis predicti loci Paterniaci nomine et ad opus Glaudie eius filie et Perronete eius uxoris filie quondam Petri Bonet burgensis Paterniaci, marriage, in which Perroneta wife of Aymon de Torculari makes a donation, mention of Agnes filia Johannis Vuilliermyn, late wife of the said Glaudius Fywaz, 25 oct 1506. (The contract is very detailed, but the ink had bled through, making the text very difficult to read.)

Fol. 90

Petrus Gaschet clericus et burgensis Paterniaci filius quondam Francisci Gaschet, and Aymo de Torculari clericus et burgensis eiusdem loci Paterniaci burgensis nomine Jaque eius filie,

marriage, 24 mar 1503, with the same small paraphe noted above on fol. 88v. (The contract is very similar to the preceding item, but there is no problem with the paper, the other side of this folio being blank, and the text is thus quite legible.)

Fol. 91

Anthonium Rojoz de Corcellis owes Petrus Chavanton faber Paterniaci 13 florins for purchase of a horse, 08 jan 1516.

Nobilis Maria filia quondam Nobilis Johannis de Mont uxor Nobilis Girardi Mistralis approves ? sale by Johannes Dodin to Franciscus Donzel filius quondam Johannis Donzel textor telaris, same date, and another approval for a similar purchase by Johannes de Sarsens.

Fol. 91v

(The text appears to be a part of the testament of Glaudius Crostel, which already appears on fol. 87, above, and with the same date, 01 apr 1513. It is followed, inexplicably, by a notation that clearly refers to the testament of Perroneta Bonet, wife of Aymo de Torculari, on fol. 100, but in a different hand: )

“Sub tali condicione quod Jaqua, Janna, et Glaudia eius filie nec eius viros non tenantur nec deberant ... nec quamdem donacionem per dictam Perronetam testatricam eisdem filiabus ... factis in contractu matrimonii prout in predictam donacionem continentur sed tamen vult et ordinat quod sit cassa et nullius valoris.”

Fol. 92

Johannes Jam antenatus, Petrus et Glaudius Jam eius fratres filii quondam Johannis Jam et Johannes Jam junior filius quondam Hugueti Jam de Corcellis, Johannes Jam junior with approval of his mother Nycolleta and with approval of Johannes Hermengon, Dompnus Vuilliermus Uldry cappellanus, et Petrus Uldri de Paterniaci his friends, partage, 22 aug 1496, very long and detailed but difficult to read because of dark stains.

Fol. 99

Glaudius Crostel, testament, yet another copy of the testament that appears on fol. 87, but this one is incomplete. It may be that this sheet was originally continued onto the sheet that is now fol. 91v.

(Fol. 99v is blank.)

Fol. 100

(The upper right corner of the page is lost, and the whole page is stained.)

Perroneta [filia quondam ] Petri Bonet de Paterniaci uxor Discreti Aymonis de [Torculari] clerici et commissarii abbacie Paterniaci, testament, sepultarum suam eligit in ecclesia abbacie m[onasterii] Paterniaci in capella fondata per dictum Aymonem virum suum ad ho[noram] beate Marie Virginis loco dicto en Galileaz (this is apparently a reference to the narthex of the abbey ; the equivalent part of the old abbey of Cluny also bore this name), universal heirs Johannes et Petrus Faucon burgenses Friburgi, Clara et Anthonia eius sorores, liberi predictae Perronete testatricis et quondam Berardi Faucon quondam secretarii dicti loci Friburgi, ac eciam Jaqua, Janna, ac Glaudia eius filias et ac predicti Aymonis de Torculari eius viri burgensis Paterniaci in equal portions, sub tali conditione quod Jaqua, Janna, et Glaudia eius filie nec eius viros non ... (this is the same text as the misplaced notation at the bottom of fol. 91v ! ), various other bequests, 16 jun 1513, with notation that Petrus Chuard made a copy for the said Johannes Faulcon.

(The next folio, unnumbered, at first appears blank, but there is a very faint, almost ghostly image of a transaction in which someone owes Petrus Pigniolet burgensis Paterniaci a cense, dated in December, 1513. However, this image turns out to be from the next page, showing through the paper. On the reverse, at least two additional extremely faint items, one from 1513, but otherwise completely illegible.)

(The final "folio" is a small slip of paper: ) Jacobus Chevrolit ? macellarius residens Paterniaci owes Petrus Pigniolet burgensis Paterniaci 15 florins for purchase of sheep, 17 dec 1513.)
