

ACV Dp 94 Jean Savary, notary at Payerne, 1537-1547

Abstracts prepared by John W. McCoy (RealMac@aol.com) © 2014.

« Le premier registre de Discrept Joham Savari notaire de Payerne. »

There are two folios numbered 1, here designated fol. 1a and 1b. The first of these, in French, is apparently intended to replace the second, which begins in Latin. Fols. 2-16v, mainly in Latin, are followed (with a loss of at least one folio) by the same material in French, beginning at fol. 19, where the text begins with the last few lines of the transaction of 15 may 1537 that appears in Latin at the bottom of fol. 1b v.

The register is probably a fragment, since the dates skip from 1542 to 1546. Also, there is apparently some confusion about dates: the text frequently indicates style of the Nativity when order of the transactions suggests it should be read as style of the Annunciation. Also, the transactions originally (?) recorded in Latin are, with one exception, repeated in French in a different range of pages.

(A few words are in Latin, the rest in French) Johan Dodin bourgeois de Payerne owes Riedy Horner de Chetry 15 florins 8 gros for purchase of 2 horses, 02 may 1537.

Le devant nommé Johan Dodin owes Jacob de Rivaz bourgeois de Payerne 12 (*doses*) florins et dimiye for purchase of a horse, same date.

Humbert et Pierre Mogneys aultrement Page filz de jadix George Mogneys aultrement Page de Font owes Glaudoz filz de jadix George Banquetaz bourgeois de Payerne 5 florins for back censes, incomplete, no date. For the complete text (but in Latin), see fol. 1b v.

(In Latin) Glaudius Filliom burgensis Paterniaci ex una parte, et Johannes Margueron dicti loci ex altera partibus, contract, 13 apr 1537, with signature and paraphe of Johannes Savareti. This is the (original ?) Latin version of the transaction that appears in French on fol. 1a.

(In Latin) Johannes Dodin burgensis Paternaci owes Ryedy Horner ? de Chetry 15 florins 8 gros for purchase of 2 horses, 02 may 1537.

(In Latin) Johannes Dodin burgensis Paterniaci owes Jacobus de Rippa burgensis dicti loci Paternaci 12 florins for purchase of a horse, 14 may 1537.

(In Latin) Humbertus et Petrus monneys alias Page de Font fratre filii quondam Georgii Moneys alias Page owe Glaudius filius quondam Georgii Banqueta burgensis Paternaci 5 florins for back censes, and Williermus Olivey de Chebres is named as fidejussor, 15 may 1537. (Last lines of a French version of this transaction are at the top of fol. 19.)

Petrus Rossie de Villarsel owes Glaudius Grilliet de Fitignie 1 scutum, loan, 18 may 1537. (The French version of this transaction is on fol. 19.)

Prefatus Petrus Rossie owes Humbertus Rondallon burgensis Paternaci 13 gros for expenses incurred in the house of the said Rondallon, same date, with other provisions. (The French version of this transaction is on fol. 19.)

Riedy Horner de Chetry owes Glaudius Brossier antenatus de Corcellis 14 florins for purchase of wheat, 25 may 1537, with other provisions. (The French version of this transaction is on fol. 19v.)

Vuillanus Torchia burgensis Paternaci owes Jaqua reicta quondam Discreti Petri Gaschet notarii burgensis Paternaci, a sack of wheat, same date. (The French version of this transaction is on fol. 19v.)

Berthodus filius Johannis Bidaul burgensis Culiaci (=Cully) has received from his wife Ysabella filia quondam Georgii Banqueta burgensis Paternaci 100 florins, dowry, assignal, 09 jun 1537, and she quitclaims to her brothers Glaudius et Petrus for the same. Johannes Coset junior burgensis Paternaci has received from his wife Glaudia filia quondam Thome de Cleyry d'Orsin 80 florins, dowry, assignal, 13 mar 1537. (The French version of this transaction is on fol. 32v.)

Jacobus filius quondam Thome de Cleyry d'Orsin owes Johannes Coset junior burgensis Paternaci 80 florins for the above, same date. (The French version of this transaction is on fol. 32v.)

Glaudius filius quondam Johannis Guion burgensis Paterniaci, and Jacobus filius quondam Thome de Cleyry d'Orsin nomine et pro parte Pernete eius sororis, marriage, 13 mar 1537, with release by bride. (The French version of this transaction is on fol. 33a.)

(Fol. 16v is followed by fol. 19. It is evident that at least one folio has been lost. However, there is another discontinuity: the dates are apparently still in 1537, even though the last date in the section preceding the break, on fol. 16v, falls at the end of 1537 style of the Annunciation. All of the material on fols 19-33a consists of French versions of the transactions on fols. 1b v – 16v.)
