

ACV FF 32 bis: Prieuré de Lutry circa 1510 by Pierre Marchand

Abstracts prepared by John W. McCoy (RealMac@aol.com) © 2016.

The volume as it exists today is incomplete. It begins on fol. 23 and ends at fol. 319v. In addition, there are some irregularities in the foliation, possibly involving missing folios, or else folio numbers that are illegible. There is no index. Some of the pages have been defaced by what appear to be the pencil scribbles of a child (but on fol. 280, this had the effect of revealing a watermark in the paper), others have been torn out. Most of the property is at Chinaux, plus a few parcels at Champrenaux. Unfortunately, it is likely that the reconnaissances we most wanted to see in this terrier are among those lost! (See also Ff 34.)

Analysis:

23 Margareta filia quondam Anthonii Charvoz de Cremieres, parroche Sancti Simphoriani de Cheybre, uxoris Andree Grilliet (Grilleti) residens es Bouzcan parrochie Villette, 21 jun 1508. Previously recognized by her father Anthonius Charvoz in manibus quondam Johannes Vulieti pro tunc dicti prioratus Lustriaci commissarii, michi in assignatione dotis traditis ut constat lictera dicte assignationis recorded 27 apr 1480 by Petrus Cuyt notarius Culliaci. Margareta has a sister Johanneta.

25 Saturninus de Leyderrey (de Retro) filius quondam Nycodi de Leyderrey (de Retro) de Lazley parroche Villette, 30 dec 1507. Previously recognized by quondam Anthonium Dancys ? or Daveys ?

27 Petrus Bergier commorantes en Aran parrochie Villette, 28 nov 1502, previously recognized by quondam Jacobus Bergerii (J. Vuillieti).

28v Johannes Perrisod (Parisod) parrochie Villette, 28 nov 1502, previously from Johannes Regis de Espiney and then recognized by the said Johannes Parisod (commissaire Petrus Villencii), adjacent to property of **Petrimandi de Foucygnie de Fribourgi que fuit Nycodi de Planchia et eius uxorem, et pridem Nycodi Gavod.**

30 Magister Anthonius Guys alias de Putheo lathonius et burgensis Melduni nunc residens apud Grandvaux, also for his wife Coleta filia quondam Stephani Chauderet ? Property previously recognized by Uldrisodius Fornery et Roletus Excoffery de Chinaux, as well as Uldriseta filia quondam Johannis J... ? On fol. 30v, property adjacent to vineyards that were from Nycodus Gavol (=Gavod). On fol. 31v, the transaction appears to be coming to an close, but on the next folio, apparently 33, we seem to be launching into a different transaction. A folio is missing at this point.

[32v? Petrus filius Francisci Jacaux, 16 oct 1507. Folio missing.]

33?: reference to a previous document dated 24 may 1464 for property that has fallen to the present reconnaissant by legitimate succession. Whoever he is, the reconnaissant on fol. 35v

has a grandmother named Perrissona. Reference to property from this Perrissona continues on fol. 36. At the bottom of fol. 36, it is revealed that the father of the recognoissant is the late Franciscus Jacaux, patrem meum (this statement again at the bottom of fol. 36v). Finally, fol. 37v, the last section of the reconnaissance identifies him as Petrus Jacaux, and the date is found on fol. 38v, die festi Sancti Gally confessoris 1507 (=16 oct 1507).

39 Franciscus Borgonyon de Granvaux et Guillemeta filia quondam Aymonis Follat eiusdem Francisci uxor, 16 jun 1508, previously recognized by her father Aymonodus Follat (Nycolas Fulonis commissaire) et successive per quondam Anthonium Musygnin primum virum meum dicte Guillemete...

41v Nycodus Frachat alias Chastellan burgensis Melduni filius Rodulphi Frachat sutorum Meldini et Glaudie eius uxoris filie quondam Jaqueti de Aglerans, 03 may 1508, previously recognized by Johannes de Champrenaux (commissaire P. de Quercu) tailliabilis ad misericordiam et deinde affranchiatis ac manumissis by an affranchisement signed by Humbertus de Mediavilla, then commissaire for the priory. Purchased by Jaquetus Vegnerres ? alias de Aglerant avum meum maternum a heredibus dicti quondam Johannes de Champt Renaux senioris... to the reconnaissant by succession from his mother. Another alias: Jacobus de Champrenaulx alias de Crestaz.

44v Johannes Ramux residens apud Grantvaulx filius Vuilliermi Ramux de Ruex (=Riex), 25 mar 1510.

46v Johannes de Petragrossa de Jussy l'Esvesque diocesis Gebennensis nunc residens Villete, 20 sep 1508, de bonis dudum talliabilibus tam per quondam Jacobum Cavyn quam suos antecessores antecessoribus prelibati domini recognitis, which the reconnaissant acquired by public auction as they were vacant, mention adjacent property que quondam fuit **Nycodi Gavodi seu Nycodi de Planchia**, and another from the said Nycodus Gavod. Affranchissement relating to this property follows, on fol. 48, noting that it had been sold to the highest bidder, Johannes de Petragrossa, same date.

51 Johannes Chastellain de Ruex, 16 may 1508, previously recognized by Francisca uxor Girardi Croserens de Lausanna (Nycolay Folonis commissaire) et deinde by the said Francesca then widow of Girardus Croserens (J. Vulliet), adjacent to property from the Gavod.

52v Johannes Gauthey alias Gidey filius Vuilleme Gidey residens en Lalex parrochie Villete, die festi Sancti Clementis 1508 (= 23 nov 1508), based on affranchissement to his father 17 may 1464, adjacent properties had come from **Martinus de Planchia et per prius Johannis Gavod**, followed on fol. 55v by affranchissement to Johannes dated die festi Sancti Yllarii 1508 (14 jan 1508 Style of the Annunciation) as a result of his father Vuillieme Gidey alias Gautey purchasing the property at auction to the highest bidder.

57v Vuilliermi Gautey (Gauthey) alias Gidel de Chinaulx residens en Lalax filius quondam Petri Gautey alias Gidel, 31 oct 1507, previously recognized with his late brother Petrus, adjacent to property of the heirs of Johannes Reis (de Fribourgo) **que fuit Nicodi de Planchia et pridem Johannis Gavod, other property of the heirs of Johannes Reis that had come from**

Martinus de Planchia... Mention of an affranchisement dated 16 mar 1490. He has a son Johannes (presumably the subject of the previous reconnaissance). Followed on fol. 62v by affranchissement for his brother Petrus Gautey alias Gidel 16 may 1474, and on fol. 71v by affranchissement for Vuillermus himself, mentioning property held by **liberorum dicti Nicodi de Planchia, 17 may 1490.**

73v Honnestus juvenis Johannes Salix aetatis quindecim annorum et ultra clericus et burgensis Melduni filius quondam Johannis Salix, his guardian is Discretus vir Rodolphus Decimatoris clericus Melduni 25 may 1510, mention adjacent property of Johannes Reis que fuit **Gaspardi de Planchia.** This is an example of a person qualified to work as a notary who had not reached the age of majority.

77 Francesia filia quondam Johannis Piccatey de Culliez uxor Francisci Chablex de Chinaux and also for Johannis filii mei et dicti Francisci viri mei minoris etatis, die Sabbati post festum translacionis Sancti Benedicti (11 jul) 1510, jx Johannes Reys de Friburgo et Elesie eius sororis uxorisque discrete viri Petri Tavernery? clerici Friburgensis **que fuit Gaspardi et Martini de Planchia,** also property jx **liberorum quondam nobilis Peronete de Sancto Amore** que fuit Jaqueti Girodi.

81v Jacobus Branchyz (Branché) filius quondam Petrus Branchyz (Branché) de Granvaux parrochie Villete, die festi Sancte Lucie Virginus 1510 (=13 dec 1510).

85 Petrus filius quondam Glaudii Othonin burgensis Rotondomontis (=Romont), 23 apr 1509, possible mention of de Grangia family ?

88v Franciscus filius quondam Johannis Chablex de Chinaux, 04 ? dec 1510, property on fol. 89v, quondam domum ... sitam apud Chinaux juxta **vineam Johannis Reys et eius sororis que fuit liberorum Nicodi de la Planche et eius uxoris** ab oriente (thus giving the strong implication that Gaspard and Martin are the sons of Nicod de la Planche), Petrus Jacaux ex occidente. Also, fol. 89v, property de predictis bonis retro clausum de Chinaux, unum morsellum terre juxta terram dictorum Jacaux ab oriente, terram **liberorum Johannis de Torculari que fuit Petri de Sancto Amore.** On fol. 90, Item, unam peciam vinee sitam in territorio de Chinaux loco dicto retro Crosum sive retro Chinaux continentem dimidiam posam juxta vineam **Johannis Reys que fuit Martini et Garpardi de Planchia** ex oriente... On fol. 93v, another reconnaissance for the same Franciscus Chablex, 20 ... ? 1512. Also, fol. 95v, lictere accensactionis for the same, 03 nov 1512. Another accensation on fol. 100v, 13 feb 1512.

102v Francesia filia quondam Vuilliermi Cavyn uxor Nobilis Jacobi Cerjat de Melduno, 20 feb 1510, property, unum morsellum vinee continentem circa dimidiam posam vinee situm apud Chinaux loco dicto supra Turrim dicti loci de Chinaux juxta ortum **Johannis Reys et eius sororis de Friburgo que fuit Martini et Gaspardi de Planchia et pridem Jaqueti Gavoz** ex oriente, vineam illorum de Coster de Excertes ex borea, viam publicam inferius, et quondam aliam viam publicam ex occidente. Mention of a sale dated 10 feb 1498 by Humberta filia Bonifacii Bridel to the said Vuillermus Cavin, videlicet unum morsellum vinee continentem circa tres fosseratas vinee situm in territorio de Boussans loco dicto ou Frussaux juxta vineam que quondam fuit **Gaspardi et Martini de Planchia** quam tenent heredes Johannis Reis de

Friburgo superius, vineam Petri dou Bos sive eius uxoris que fuit heredum Claudii de Champrenaulx ex oriente, vineam Jacobi Monachy que fuit Bonifacii Bride et Petrum Roleti du Fort alias du Plex inferius et ex occidente. Another sale dated 30 may 1482. On fol. 105, another property that had been owned by Nicodus Gavod, but without mention of the de Planchia family.

106v Guiliermus Forel alias Magnin burgensis et veligatoris ? (=Banneret?) Culliacci, 22 oct 1509, de bonis alias pridem per quondam Roletum et Jaquetum Picot de Chinaux in manibus quondam Petri de Quercu commissarii sub talias recognitis et in dotem quondam matris mee per eodem Picto traditis michi ex legitima successione deventis, then affranchised,

Et primo, duos bonos fossererios vinee vel circa sitos in territorio de Chinaux loco dicto en Cloz juxta vineam **Johannis Reys de Friburgo et eius sororis que fuit Gaspardi et Martini de Planchia et pridem Johannis et Jaqueti Gavoz** ex oriente, vineam heredum Johannis de Moneta alias de Canturio ? civis Lausanne ex occidente, quondam semictam tendentem a villa de Chinaux versus vineis de Champalfon superius, et quondam aliam semictam ex lacu inferius, etc.

110v Nycodus Criblet et Perroneta eius uxor residentes in parochia Villette, 12 dec 1512, with accensation 11 dec 1512.

116 Jacobus de les Chaux et Johanneta eiux uxor relictaque quondam Uldrici du Boz (Bos) loci de Chinaux, 10 feb 1511, mention on fol. 117v of adjacent vineyard que quondam fuit **Martini et Gaspardi de Planchia** quam nunc tenet Dompnus Petrus Dionisii olim receptor dicti prioratus Lustriaci.

120 Petrus de Sancto Remigio et Johanneta eius uxor filia quondam Anthonius Charvoz de Curson (whose wife was Mermeta filia quondam Johannis Dancieres de Curson (Cursey, Corsier ?), 20 sep 1512. His sister is Margareta relictata Andree Grilliet.

123 Johannes Danchoz alias Joffrey burgensis et apothecarius Lausanne filius quondam Joffredi Danchoz, 05 sep 1509.

125v Johannes Gignilliacti senior clericus et burgensis Lausanne, 10 may 1511, de bonis et homagio alias per **quondam Jaquetum et Johannem Gavoz homines pro tunc talliabiles** ad misericordiam dicti prioratus in manibus quondam Domini Mycolay Fulonis et successive Petri Villiencii dicti prioratus quondma commissariorum sub homagio et feudo ligio per Aymonetum Chablex recognitis vigore affranchiamenti generalis probis hominibus de Chinaulx per antecessoros memorati domini commendatarii concessi et laudati prout constat instrumento recepto per Humbertum de Mediavilla notarium ... , videlicet res et possessiones sequentes michi per prefatum Aymonetum Chablex venditas precio septem viginti florenorum parviponderis recorded 08 mar 1497 by Discretus Johannes Perroudet quondam notarius Lausanne... ,

Planchia et pridem dicti Johannis Gavoz ex occidente et inferius, et etiam ex oriente. Other properties...

129 (Fols. 129 and 130 are either missing, or else were missed when the photocopies were made from the microfilm. On fol. 131, we find the end of this reconnaissance, dated 03 may 1511.)

131v Aymonetus Chablex de Chinaulx, 09 jan 1510, property on fol. 132: et primo, unum magnum casale dictum in ville de Chinaulx juxta iter publicum **superius casale heredum nobilis Perronete filie quondam nobilis Petri de Sancto Amore** quod tenere debent ? nobilis Rodolphus de Praromain de Friburgo et sui ? nepotes ac iter publicum inferius aliam viam publicam seu certum iter a parte occidentis.

This description could be read (depending on how the words here transcribed as “debent” and “et sui” are read) to say that Rodolphe de Praroman is a grandson of Pierre de Saintamour, or else of Perronete. The only possibility for Rodolphe in the de Praroman genealogy of Pierre de Zurich (*Annales Fribourgeoises* 45:23-94, 1962) is the son of Henri de Praroman and Guillemette vom Stein. If Guillemette was really the mother of Rudolphe, then the connection would have to be that Perronete was the mother of Guillemette. Or, if Henri de Praroman had married previously to someone else, then Rodolphe’s maternal grandfather could be Pierre de Saint-Amour. However, we think “et sui” is the more likely reading, which requires the verb to be debent. Rodolphe’s brother Antoine had died between 07 apr 1506 and 15 nov 1507, leaving two daughters Elizabeth and Anne, who would have shared any property that Rodolphe and his brother had held jointly. Rodolphe’s own children were then still living, and he apparently had no grandchildren. This still leave open the question of how the “big house” belonging to the heirs of Perronete came to be associated with the de Praroman family.

(In other words, Mermeta, wife of Nicodus de Planchia and daughter of Nicodus Gavoz, sold this property to Johannes and Aymonetus Chablex in 1471.)**

(Dancieres ?) quam de presenti tenent procuratores fabrice Beate Marie Virginis Lausanne ex oriente, vineam Discreti viri Johannis Ginilliacti clerici Lausanne que fuit dicti Aymoneti Chablex et per prius Francisci Magnin ex occidente, et vineam Johannis Reis que fuit **Gaspardi et Martini de Planchia** quadam semita intermedia superius, quiquidem morselli eidem Aymoneto Chablex extiterunt per eandem **Mermetam** (see above, Mermeta Gavoz, wife of Nicodus de Planchia) pridem traditi et largiti sine onere census ... quod ipse ... supportare posset census dicti furni ...

The reconnaissance is followed on fol. 138 by an accensation for Johannes du Crest (highest bidder on vacant property at Chinaux), 17 oct 1512.

140v Guilliermus Musard de Tuori de Peil domicellus, his mother was Hugonina, daughter of the late Johannes de Berchie, 19 nov 1509, de bonis que antiquitus fuerunt Jaqueti de Eschiens alias Jolaz talliabilis ad misericordiam ipsius prioratus Lustriaci, et successive per Johannem de Berchie in manibus quondam Petri de Quercu olim commissarii sub dicto feudo et homagio ligio vigore affranchiamenti per ipsum dominum priorum Lustraci et eius conventum antecessoribus meis facti recognitis, et etiam per Hugoninam filiam dicti quondam Johannis de Berchie matrem meam in manibus quondam Petri Villiencii sub simili feudo et homagio ligio recognitis, michi ex legitima successione dicte matris mee deventis,
