

# ACV Ff 34 Priory of Lutry, 1503, compiled by Petrus Marchiandi

The inventory of the ACV notes that the pages for Corsier and Belmont are missing, but the volume is otherwise in good condition, with 514 folios, but possibly not mentioning the apparent error in numbering the folios, see below. The index does not mention Corsier and Belmont, so possibly the gap in the foliation corresponds to the sections that are missing. A predecessor to this volume may be Ff 12, from about 1420, commissaire Petrus de Quercu.

Fols. 173v-184 have been copied from microfilm. Also a few additional pages: fols. 11-17v. The whole volume should be studied from better images.

Properties purchased by his father from others who had previously recognized them for various commissaires. On fol. 180, note property previously recognized by Nicodus Gavod and his wife Johanneta, that was then recognized (Johannes Vullieti) by Nicodus de Planchia and his wife, the mother of Gaspard (her name either not given or perhaps abbreviated incomprehensibly—from other records she was Mermета Gavod.)
