This volume is in poor condition, but enough of the introductory material and an old cover page remain to establish that it is from the hand of Petrus de Quercu, for the priory of Lutry. How it was intended to relate to the other terriers or registers of Petrus de Quercu for the same priory remains to be determined. Among other possibilities, it is simply another compilation of essentially the same reconnaissances, in a different order, that appear in Ff 33, Ff 34, etc. Of these, Ff 34 is by far the most carefully written, perhaps intended as the presentation copy, but the corresponding text in the others may offer insights, sources, or other evidence.

While the outer corners of the pages are badly eroded, no evidence seem to remain that the folios were originally numbered. However, a partial repertorium inserted after fol. 36 gives folio numbers for the remainder of the volume, indicating that folio numbers were once present. The folio numbers used here are those supplied by the ACV in preparation for the digitization project.

(The above reconnaissance occupies vols. 36v and 38. Fols. 37 and 37v appear to have been inserted here at an early date, containing a repertorium, apparently in the same hand as the rest of the volume, covering folios approximately 39 to 75, the folio numbers of the first four items lost due to fading and physical damage as noted above. However, those numbers do not correspond exactly with the present state of Ff 35. The first item in the repertorium that is clearly legible, a reconnaissance for Gulliermmeta uxor Petri Crostelli, fol. 43, is in fact found on fol. 44v of Ff 35 as it is presently numbered. In fact, if the present fols. 37 and 37v were left unnumbered, and if the next folio were therefore numbered 37 instead of 38, the folio numbers in the repertorium would line up well with the rest of Ff 35. Still to be explained, however, is why only half of Ff 35 was indexed. In the remaining abstracts, the old folio number from the repertorium is given in [square brackets]. It is also to be noted that the fading and physical damage become increasingly serious for the rest of the volume, to the extent that the names of some of the reconnaissants and sometimes other information as well are illegible or entirely lost.)
