

ACV Ff 58 Abbaye de Hautcrêt, commissaire Aymo Advocat, 1520-1522, reconnaissances copied after his death by Humbertus Balli.

The inventory of the ACV indicates this item consists of two separate pieces, which it labels as A and B. Both manuscripts are in the same hand, with the same signature and paraphe of Humbertus Balli, originally unnumbered. The numbers provided by the ACV for the terrier digitization project are used here. The reconnaissances concern mainly Chardonnay, in the parish of Corsier.



A1 Apud Chardonaz.

Johannes filius quondam Anthonii Brandonyer de Chardonaz prope Corsiaci, 26 jun 1521, Johannes filius quondam Anthonii de Meyerres (=Demierres) alias Brandonyer de Chardonaz parrochie Corsiaci, de bonis et nova recognitione Johannis Ronczoz alias Bastard de Chardonaz hominis liberi et ligii dicti reverendi domini abbatis et conventus eiusdem in manibus Providi viri Jacobi Crause quondam notarii et pro tunc huiusmodi extenttarum commissarii facta, ex empto per ipsum confitentem facto a dicto Johannes Ronczoz legitime per dictum dominum abbatem laudato. At the end, a subscription that explains something of the genesis of these reconnaissances: “Ego autem Humbertus Balli notarius publicus auctoritate apostolica prothocollorumque vitafuncti Aymonis Advocat quondam commissarii huiusmodi publicum instrumentum grossatum non tamen signatum, manu mea propria subscripsi ipsiusque prius collacione cum originali prothocolo debite facte signavi tradidi requisitus”, with signature and paraphe of Humbertus Balli. All of the reconnaissances in the A section of Ff 58 are signed in this manner.

A4v Johannes filius Claudii de Tavello alias Vacherand de Chardonaz parrochie Corsiaci, 08 oct 1521, de bonis et nova recognitione Anthonii filii quondam Martini Bastard alias Rouczoz in manibus Discreti quondam viri Jacobi Crause quondam notarii et huiusmodi extenarum sint recognitorum commissarii facta, ex empto per ipsum confitentem facto et Petro filio quondam Anthonii Bastard.

A8 Humbertus Tersier de Chardonaz, 09 oct 1521, de bonis et nova recognitione Anthonii Ronczoz alias Bastard in manibus cuiussupra quondam Jacobi Crause facta ex empto a Petro Ronczoz.

A10 (This item lined out) Johannes et Nycodus filii quondam Petri Brandonyer alias de Myerres (=Demierres) de Chardonaz, 09 oct 1521, incomplete. Apparently the same reconnaissance begins again on fol. 10v:

A11v Roletus Velet de Promasens, 23 nov 1521, de bonis et nova recognitione Anthonii Ronczoz alias Bastard hominis liberi et ligii quondam dicte abbacie ultimo in manibus quondam Jacobi Crause notarii et pro tunc huiusmodi extentarum commissarii facta, ex empto a Petro filio dicti Anthonii Ronczoz.

A13v Petrus Blanchard (Blanchard) de Chardonaz, 27 jan 1522, de bonis et nova recognitione Anthonii ~~Blanchard~~ Ronczoz alias Bastard in cuiussupra manibus quondam Notarii et huiusmodi extentarum commissarii Jacobi Crause facta, ex empto a Petro Ronczoz.

A14v (This item lined out, the introductory text is defective in the way the date is written, but the calendar is specified as Style of the Nativity) Nycodus Boccet de Chardonaz, only a few lines.

A15 Nycodus Bosset (note the different spelling from the previous item), 15 oct 1521, de bonis et nova recognitione Anthonii et Johannis Ronczoz alias Bastard per ipsos in manibus cuiussupra Jacobi Crause ultimo facta.

A16v Petrus Albi de Chardonaz, 15 oct 1521, de bonis sepenominati Anthonii Ronczoz alias Bastardi de Chardona obmissis ad recognoscendum in manibus quondam Jacobi Crause notarii et olim dictarum extentarum commissarii, ex empto per ipsum confitentem facto a Petro filio quondam dicti Anthonii Ronczoz alias Bastard.

A17v Cristinus Ramel de Chardonaz, 15 oct 1521, de bonis et nova recognitione Anthonii Ronczoz alias Bastard de Chardonaz in manibus Egregii Jacobi Crause quondam notarii et pro tunc dictarum extentarum commissarii ultimo facto, ex empto per ipsum confitentem facto a Perto Ronczoz.

B1 Petrus filius quondam Anthonii Ronczoz alias Bastard de Chardonaz parrochie Corsiaci, date incomplete (anno domini millesimo quingentesimo vigesimo ____ ; remainder of the year is blank, and there are blank spaces for the day and month as well), de bonis et nova recognitione dicti sui quondam patris alias per eundem patrem dicti confitentis in manibus predicti quondam Jacobi Crause pro tunc huiusmodi extentarum commissarii, no signature or paraphe.

B4 Colleta relicta Jacobi Berthod facto suo necnon ____ (blank space) suorum liberorum a dicto quondam Jacobo Berthod susceptorum, date incomplete as in the preceding item, and there is blank space in the text where the names of the children should be, de bonis et nova recognitione Johannis Ronczoz alias Bastard ex ____ (blank space where the remaining details of the origin of the properties and obligations should be), incomplete, amount of the cense and all the closing formalities are lacking, no signature or paraphe.

B6 Apud Culliez in valle Lustriaci.

Petrus filius quondam Petri filii quondam Nycodi des Favarges de Riex parrochie Villette, 18 feb 1522 Style of the Nativity, ad instanciam, postulacionem, et requisicionem mis dicti Aymonis Advocat notarii et prout supra commissarii, de quadam recognitione per quondam Nycodum de Favarges eius patrum a quo causam habet in hac parte Reverendo in Cristo Patri et Domino Domino Aymoni de Montefalcone commendatario perpetuo denoti monasterii Altecriste et conventui eiusdem facta in manibus Providi viri Jacobi Crause quondam notarii et pro tunc huiusmodi extentarum commissarii, cense, ex vendicione dudum facta dicto reverendo domino commendatario et conventui Altecriste per dictum quondam Nycodum de Favarges instrumento manu dicti quondam Jacobi Crause 08 nov 1490 recepto et signato precio sexdecim librarum bonarum Lausannensium..., with the same subscription found in the A section, with signature and paraphe of Humbertus Balli.

B7v Johannes filius quondam Ludovici Bidaulx de Culliez, 18 feb 1522, cense, et hoc vigore cuiusdam vendicionis per eundem confitentem dicto reverendo domino abbati et conventui eiusdem de presenti facta instrumento manu mis Paulo (but there is no Paulus mentioned elsewhere in the text !) ante istend recepto precio viginti octo librarum ... (complex history, also involving a rehemptio), with the same subscription found in the A section, with signature and paraphe of Humbertus Balli.
