

# **ACV Fg 243 “Extract” of reconnaissances for Mont-le-Vieux, commissaire Johannes de Sancto Ciriaco clericus imperialis, 20 mar 1356.**

There are two very old cover pages, the outer one with the faded inscription *Extractus recogniconum Montisveteris ad opus Nobilis et Potentis viri Amedei Domini Viriaci et Ducilaci (?)*, followed by a much smaller and very faded notation, *manuscriptis factis per Johannem de Sancto Ciriaco ? ...* (the rest too faded to read). The inner cover bears a similar but shorter title, even less legible, but the name of the commissaire is somewhat clearer (although abbreviated), *Johannes de Sancto Ciriaco*. The first folio also has a title, again too faded to read completely, followed by a short introductory text, but here the name of the commissaire appears to be instead *Johannes de Beato Ciriaco*, and there is mention of a paper scroll.

There is an inverted folio containing a summary of yearly rents (the year not specified) inserted before the repertorium (three folios), followed by the main text, which ends on fol. 39v. At fol. 40, we find a copy of the grant by Amedeus de Sabaudia to Guilliermus de Namur and his wife Catherina de Sabaudia of the fief of Mont-le-Vieux, and their “hommagium”, dated 04 jul 1359. This transaction should probably be regarded as a later addition that was not originally part of the reconnaissances compiled by Johannes de Sancto Ciriaco. The script appears to be in the same hand as the rest of the present “extractus”. Fol. 44 contains a transcript in French (more or less modern French) of a document dated *vi idus de juin* 1281 (08 jun 1281), in which Humbertus de Rosillions chevallier makes a reconnaissance for Johannes de Greillier, for various properties, surely also a later addition, but it, too, appears to be in the same hand.

There is some ambiguity inherent in the title. Was the original terrier compiled for Amedeus de Viriaco, or was the present extract made for the use of a *later* Amedeus de Viriaco? But the introductory paragraph, dated in 1356, mentions a Dominus Guilliermus, evidently Guilliermus de Namur, who, with his wife Catherine de Savoie-Vaud, in 1359 bestowed the fief of Mont-le-Vieux upon Guilliermus da la Baume. Following the chronology and references compiled by Olivier Dubuis (Le bourg et le château de Mont-le-Vieux, *Revue Historique Vaudoise* 58:49-68, 161-203, 1950), the fief of Mont-le-Vieux next devolved upon the death of Guilliermus de la Baume in 1360 or 1362 to his sister Luca de la Balma, who was at that point the widow of Amedeus de Viriaco I (he had died before his family had any claim to the fief). Luca died no earlier than 1383, after which her son Gallesius de Viriaco held the fief until his death in 1392-1393. A dispute arose between his sons Johannes and Amedeus II, resolved in favor of Amedeus II in 1402, and shortly thereafter, 1404, Amedeus II made a reconnaissance for the fief (AEF “Grosse Balay”). Amedeus II died about 1420, succeeded by his brother Jaquetus, who died around 1450. Jaquetus was succeeded by his son Amedeus III, who died about 1484. Amedeus III was succeeded by his son Amedeus IV, who died about 1519. Unfortunately, this chronology does not seem to provide any help in dating the extract; it could have been made for Amedeus II, III, or IV, at any point from about 1402 until 1420 or from about 1450 until 1519.

The script seems more typical of the later interval. One other clue still needs to be explored: the mention of Amedeus, Dominus Viriaci et *Ducilaci* in the title of the present manuscript. If the reference is to the seigneurie of Dusilly (Savoie) that was held for a long period by the Menthon family, was there ever a period when Amedeus II, III, or IV, or one of their wives, held this seigneurie, even in part? If not, what is the correct identification of *Ducilaci*? This question seems to be resolved, at least in part, by information reported by Olivier Dubuis, see above, that the wife of Amedeus IV was Hélène de Menthon. But it is not apparent why Amedeus IV would have had needed an extract of such an old terrier!

The individual entries contain brief but detailed descriptions of individual properties and rents, frequently indicating the source of those properties, and sometimes, that they had been the subject of an unidentified previous terrier. We leave the transcription of the individual items for the future, as the script is quite small and the available images are not sufficiently legible.

40 (Title at the top, faintly visible, appears to read, as suggested by the index, *Hommagium Domini Johannis de Mont*) Amedeus comes Sabaudie et dominus Vaudi, grant to Guilliermus de Balma as well as his father Galesius de Balma, and Guilliermus comes et Catherina de Sabaudia comitissa Namurcen, dated 19 jun 1359, followed without a break (fol. 42) by homagium to them from Johannes de Mont, dated 04 jul 1359. (Index shows Dominus Johannes dominus de Mont. This would be Johannes de Mont II, whose father and grandfather had sworn “homage-lige” to the Counts of Savoie, and who, as a result of the transfer of the seigneurie of Mont to Guilliermus de Balma and his wife, now swore the same allegiance to them for that portion of the seigneurie that concerned him.)
