

ACV Fg 244 Artificial register of diverse fragments, evidently pertaining to the Seigneurie of Rolle, 1345-1551.

Most of this small collection consists of isolated pages rather than complete transactions. However, in many cases there are clues as to the nature of the original documents, such as folio numbers, distinctive script, or recognizable subject matter.

The main sequence of folio numbers used here are those assigned (in pencil) by the ACV during the digitization of this register. We give other numbers or labels in parentheses if they are visible.

1 Fragment of a reconnaissance, in French, no folio number, with wide spaces between the lines, suggesting that this single folio comes from a copy of a terrier that was intended to serve as the basis for a later revision, after 1536. A cense was to be paid to the Noble Chalon by the unnamed reconnaissant, and part of the cense was to be paid by Clauda fillie de feu François Assonnarre femme de Jehan Osselet de B... ? Another parcel was held jointly with Jehan filz de George Joennin ? Other names (lieudits, adjacent tenants) include en Mossieres, Jaques filz de Jacquet Pacton, Claude et Pierre Loschard, and the heritiers de Jehan de Mex.

2 Fragment of a reconnaissance, in French, awkward script with considerable bleed-through, no folio numbers, many names, apparently those of reconnaissants from a prior terrier : Gaudin, François Manburier agissant en ceste partie comme administrateur de Thivent, Maurys, et Marye fille de feu Anthoyne de Lesel aultrement Christin, Collet Regnaud aultrement Bouffand ? agissant aussy tant à son nom que de Provide Claude Regnaud aultresfois prebrestre son oncle, et Claude Regnaud aultremant Bouffant ? tous de Saint Oyens de Rottyeres es mains de feu Egrege Jehan Pompus notaire. Current date evidently 26 feb 1551, and the prior reconnaissance was in favor of Michel de Viry...

4 (Fol. 553) Fragment of a reconnaissance, in French, clear, rapid script, mentions a noble confessant, and a tenementier called Claude, lieudits ou Ruttit ou soit ou Verney (Vernex) (Aultecour), ou Rippallex (Mont).

5 (Folio number probably present, but obscured by folds in the corner of the page) First folio of a reconnaissance for Nobles François et Jacques fils de feu Noble Pierre de Senarclens de Burssins et de Noble Rollette fillie de feu Noble Guillaume Mestral sa femme, 08 dec 1542 Style of the Nativity, wide spaces between the lines as if this is a fragment of a copy intended to serve as a basis for a later revision. Consistent with this notion are marginal notations giving the later history of the family in question : Ledit François est decédé et a laissé Lois, Claude, et George ses enfants. Ledit Loys est aussi decédé et a laissé Noble François son fils vivant. Lesdits Claude et George sont aussi decédés sans enfants ausquels ledit François a succédé. Ledit Jaques est aussi decédé et a laissé George et Claudine ses fils et fille. Ledit George est decédé et a esté faict discution de ses biens et sont ? dispersés ? Ladite Claudine a esté mariée à

Noble François donné de Militon ? et ont fait aussi discussion de biens tellement qu'ilz sont entierement disperséz.

6 Two folios containing reconnaissances or leases, unnumbered, badly faded, both mentioning the notary Petrus Mistralis de Germagnier, but the folios may not be in sequence, as the first item appears to be incomplete at the bottom of fol. 6v, and a new item begins at the top of fol. 7 :

6 06 oct 1438, transaction between Nobilis, Egregius, et Providus Amedeus filius viri Nobilis et Potentis viri Jacobi de Viriaco domini ipsius loci Viriaci et Montis Veteris militis, agens in hac parte nomine dicti eius patris ex una parte, et Henricus et Johannes Tissot de Gillier fratres filii Johannis ? Tissot habitatoris ? de Gillier suis propriis ac Johannis Tissot eorum patris nominibus ex altera partibus, property in the Clausum de Gillier.

7 Egregius Potens Amedeus de Viriaco filius viri Nobilis et Potentis Domini Jacobi de Viriaco..., lease to Anthonius filius quondam Perreti ? Fonjalaz de Brussins, property ceded to the said Noble Amedeus (in the name of his father Jacobus) this day by Johannes Magnin de Gillier, property in territorio de Visinchia juxta castaneriam Gladium Jalliet de Gillier ex parte boree...

8 Last folio of a reconnaissance, in Latin, large, wide script, mentions one parcel with cense : Dimydiam posam terre sitam en les Reyses juxta pratum Petri Baul a vento et lacu, curtile Guyonis Collon a juria, et terram Johannis Badel a borea, et pro ipsa dimidia [posa] terre debere confitetur dictus confitens pro se et suis predictis prefato domino et suis videlicet sex denarios census perpetue persolvendos, et quamquidem dimydiam posam terre tenet idem confitens titulo vendictionis sibi facte per Roletum Roncignodi notarium quondam precio septem florenorum parviponderis laudatum per prefatum dominum.

9 (Fol. 438) Reconnaissances, in Latin, a neat, flowing hand, evidently copied from the lost terrier of Aymonodus Roberti :

9 Last folio of a reconnaissance, several items : (a) in villa de Burtignye, cense 2 denarios Lausannenses, quod quidem morsellum terre fuit de bonis illorum de Visencyez. (b) unam seyuratam prati sitam in territorio de Provondavaulx, cense 12 denarios Lausannenses.

9v Reconnaissance by Johannes Merminodi alias Bolley de Bugnyou facta nomine suo et Claudii eius fratris, extractu Roberti antiquo B ? fol. 308, dimidiam posam vinee sitam subtus Bugnyou en Ryon Bosson de bonis in Mangie recognitis per Gladium ... ? (name obscured by a fold in the paper) ex empto facto a Claudio ... (illegible) precio decem florenorum constante instrumento per Stephanum Cuvit recepto laudat per dominum de Terraulx constante laudimio per Johannem Boleti, juxta vineam Johannis Roberti que fuit Reymonde uxoris Petri Loytiz a lacu... , sub censu novem denariorum Lausannensium in exonerationem census Petri de Crousaz bonatenentis dictorum Cortesii.

11 (Fols. 276, 289) Fragment of one or two reconnaissances, in Latin, two non-consecutive folios, neat script, widely spaced, and with various notations between the lines and

in the margins in a different, irregular hand, cense that the noble confessant declares that his noble wife (Jaquema ?) owes by virtue of a lease, various items : (Fol. 276) (a) Item, unam posam vinee sitam subtus Fontem de Tartignyn juxta vineam Petri Berthin quam tenet a Nobilibus de Gallera de Cletis a lacu, vineam dicte Nobilis Jaqueme a juria, quam vineam tenet Agatha filia Stephani Reymondi de Vinsel in assignationem dotis eius quondam matris. (b) Item, unum sestarium vini sibi annualiter debitum per Petrum Bertin super una pecia vinee sita in territorio de Pentloup loco dicto en Carmentrant ? juxta terrale a vento, vineam Petri Roberti et heredum Glaudii de Crosa a borea, vineam dictorum heredum de Crosa a lacu, et nemus commune a juria. (c) Item, quatuor solidos sibi nobili Jaqueme annualiter debitos per Ansermum Mugnerii de Tartignyns super quadam pecia prati sita in Pratis de Prengins juxta pratum [quod] fuit Martineti Montherod a borea et juria ? , et tactas communes a vento et lacu. (d) Item, super quadam pecia prati sita supra loz Roseys juxta pascua communia a vento et juria, et pratum quod fuit Johannis Reymond a lacu. (e) Item, de bonis et hereditate Berseti Prodon, res sequentes, (f) Et primo, tres solidos sibi annualiter debitos per Petrum Bertin super dimidia seycurata prati in ... (no more text, incomplete) (Fol. 289) (a) ... juxta pratum dicti confitentis a lacu et borea, carreriam publicam a juria, et pratum Nycodi et Michaelis de Torculari a vento, cense 2 denarios Gebennenses. (b) Item magis, tenere confitetur idem confitens in feudum a prefato domino causam habente a Domino Johanne de Saxo de recognitione Stephani de Torculari facta dicto Domino Johanni ex excambio cum dictis de Torculari, videlicet unum adossum vinee situm subtus Bougel quod alias fuit Loysie filie Petri Souvens ... , cense unam cupam vini seu musti ad mensuram de Germagniez ut supra persolvendum.

13 Two unnumbered folios, the bottom ¼ of each folio torn away, the end of a document concerning Nobilis Jaquema, domina Montismagni. The script is dark but not very neat, and some of the text has been eroded and lost. The notary appears to be Peronetus Foresii. Below the end of the transaction is a subscription, much of it torn away, concerning Venerabilis Dominus Johannes de Seyssello prior quondam prioratus Romanimonasterii nomini ipsius prioratus and Nobilis Altaudo ? de Mont dominus de Mont, for the augmentation of a fief.

15 Part of a settlement copied on 16 oct 1492 by Johannes Boleti, notary, for Nobilis Johannes nutritus Nobilis Johannis de Romanomonasterio quondam heredis Nobilis Johannis Baudi et Collete eius uxoris de Brussinel. The beginning of this settlement is lost, but the conclusions are presented in their entirety, concerning the rights of Richardus de Mont, dominus Moncium, particularly regarding fines and fees, confiscations, etc., and the other party was apparently Ludovicus de Sabaudia, datum apud Morgiam infra castrum nostrum presentibus testibus et rogatis Hugonino domino de Vufflens, Domino Petro curato de Gillier, et Johanne de Sarrata clerico Lausannensis 29 mar 1345 and copied by Petrus Balli de Gebennis and Johannes Fuserii habitator Gebennis clericus, notarii publici, on 23 jan 1393 Style of the Nativity. It was this copy of 1393 that Boleti copied in 1492.

20 Settlement involving Petrus Foresterii burgensis Rotuli ex una, and Petrus Merminodi alias Bolley de Exertines ex parte altera, decreed by Anthonius de Alpa domicellus, castellanus Montisveteris, Rotuli, et terre de Luyn, 24 feb 1527 Style of the Nativity, closely written in a fairly neat hand, but faded, incomplete.

31 Last page of a reconnaissance (mostly illegible) and the beginning of another dated 08 may 1437 ?, apparently from a terrier, because the second item ends with a citation of a reconnaissance dated 18 mar 1367 *in presenti extenta exhibita*. The second item, the beginning of a reconnaissance, is by Johannes filius quondam Perreti de Puteo de Glan, but the text is obscure due to imprecise script, fading, and physical damage. Names and lieudits mentioned include Perretus Symondi, Johannis Cristini, Guiliermus Balli, Johannes Perez, laz Lignere, Amedeus de Lucingio domicellus, en Medey, Johannes Vuilliermi de Serrauz, douz Bey or Bez, Guiliermus Grussignyon ?, Nycodus de Jonzie, cense 16 denarios Gebennenses, leased by Perretus de Visenciez domicellus in quadam lictera recepta et signata manu Johannis Ripo de Lugerno ? mencio continetur 18 mar 1367. There is a small paraphe, which we have been unable to decipher.

32 (Fols. 184-188v ?) Reconnaissances in several different hands, in Latin, the first with paraphe of (Mermetus ?) Cristine, at least a couple of the others with the same small paraphe found in the item on fol. 31.

32 Johannes ...set de Rotondamonte commorans apud Gillier, 29 jul anno et indicione quibus supra (perhaps 1434 ?), ex adquisito per ipsum facto ab Henrico filio quondam Girardi de Fraxino de Vinsie, various properties. The wife of the reconnaissant is Johanneta filia quondam Mermeti Pringini, reference to a previous transaction recorded by Guiliermus Fabri de Bignin notarius, also a cession dated 05 mar 1426 recorded by Petrus Bapchie de Luyns, and a purchase dated 13 oct 1428 recorded by Petrus Nycolay clericus.

33 Nobilis Petrus de Dulicio, 25 feb 1434, his late wife was Ysabella filia quondam Ansermeti de Brusinel, who had received a lease from Luca de Balma domina Montis Veteris dated 17 apr 1391 ? recorded by Vuilliermus Choetrerii, followed by possibly interesting subscription ? by Jacobus dominus Viriaci et Montis Veteris miles, apparently confirming lease of the same properties to Petrus even though the original lesee, Ysabella, had died without descendants.

34 Peroneta filia quondam Nycodi Bachou uxor Johannis Pro ? de Gland, 29 jan 1434.

Guiliermus Grusignyon filius Johannodi Grussignyon et Francesie filie quondam Thomasseti Primet de Gland quondam uxoris dicti Johannodi nomine suo et Petri ? eius fratris, 29 jan 1434 (anno, indicione, et die quibus supra).

35 Johannes Saubruz de Bignin suo et Glaudii eius fratris nominibus, 02 mar 1434.

36 Johannetus Carodi ? de Bignin, 02 mar 1434 ? (anno, indicione, die, et loco quibus supra).

36v Petrus Symon (=Symondi, Simondi), 28 nov 1434, incomplete.

37 (In the margin: No. 92) Four transactions, the first and last incomplete, notary Jaquerii. This might be a fragment of a notarial register.

37 Last page of a Quictacio ? by Johanneta with authority of her husband, his name not found in this fragment.

Cessio Petri Mathei de Rotuli sibi facta per Glaudium Advocat, 28 dec 1498 Style of the Nativity.

38 Recognicio Petri Richardi de Tertignin sibi facta per Johannem Joccerandi (Joccerandi) de Beria, 14 feb 1491.

38v Cessio Petri Richardi de Tertignin sib facta per Johannem Joccerandi de Beria de una posa vinee, 14 feb 1491, incomplete.

39 Part of the minutes of a judicial inquiry or “inquisition” in November, 1429, involving Petrus de Peseys ? clericus curie Alteville, inquisitor ? , contra Henricus Pipini de Champagnia, apparently involving Giradus et tota eius familia, mentions of notorious and ribald behavior, fist fight, nocturnal disturbances, etc. However, the script is vague, highly abbreviated, and faded, with some damage to the paper as well. It is far from clear precisely what happened.

47 First folio of a transaction, 03 nov 1478. Quod cum Nobiles Johannes, Claudius, et Matheus de Marchesio (fratres) acquisierunt casale de la Dollaz prope Gilly cum pertinenciis et appendiciis eiusdem ac certis aliis rebus et bonis sitis in territorio de la Dollaz se moventibus de feudo, directo dominio, et omnimoda jurisdictione Spectabilis Amedei Domini Vyraci, Montium, et Rotuli prout constat venditionis instrumento in de confectis ... , hinc est quod idem dominus Viriaci ... (script is extremely vague, but this may be a confirmation and infeudation of their purchase).

48 (Fol. 179) Marriage contract, 25 jan 1512 Style of the Nativity, notaries Stephanus de Ryva de Luyns and Stephanus Fillietaz de Gimel. The parties are Discretus Jacobus filius honesti Nycodi Bruneti de Brutignier, and Glaudia relicta quondam Stephani Vulliaudi filia quondam Johannis Vuyborg (elsewhere often Vuybort or Vuybor) de Luyns, with signature and paraphe of both notaries.

49 Copies of several settlements or transactions, with a cover sheet “Pro Domino Rotulum contra abbate Bonimontis et abbate Romanimonasterii”.

50 24 oct 1386, with confirming subscription by Amedeus de Sabaudia 15 jun 1400, establishing rights of the religious of Bonimontis at Gingins.

56 Transactio inter Dominum Michaellem de Sabaudia commendatorium Romanimonasterii ex una parte, et Nobilem et Potentem Michaellem baronem dominum Viriaci ex altera, 21 jun 1520, establishing their rights and jurisdictions, extracted from the protocols of feu Egrege Jehan Boulet (=Johannes Bouleti, who served as commissaire for the seigneuries of Rolle and Mont-le-Vieux at this period), the copy made June 26, but the year apparently not

given, at the request of Johann Steiger, Advoyer de Berne, Seigneur et Baron de Rolle, Mont-le-Vieux, et Mont-le-Grand.

59 Copia transactionis Domini Viriaci ex una et Nobilis Johannis Fabri de Bignino ex altera, 24 mar 1456, notary Petrus Mangie de Arcu Gebennensis diocesis, Nobilis et Potens Amedeus dominus Viriaci, Montisveteris, et Rotuli ex una, et Nobilis vir Johannes Fabri de Bignino filius quondam Glaudii Fabri de Bignino suo proprio et Johannis Fabri eius fratris junioris nominibus partibus ex altera, establishing their respective and very specific rights and jurisdictions over properties and tenants. At the bottom of the transaction (fol. 68), a faded notation, *Datum pro copia a suo proprio originali extracta facta...*, with a cramped paraphe that appears to be Johannes S... Followed by subscription and confirmation by Amedeus de Sabaudia principis Pedimontium etc., 21 apr 1463.

68v Copia protestacionis homagii Nobilis Sebastiani Fabri de Bignyn, 26 mar 1481, in domo Nobilis viri Hueti de Alladio domini douz Rossey in Rotulo, presentibus Nobili viro Jacobo Mistralis filio quondam Nobilis Michaelis Mistralis de Vincie et honesto viro Petro Arnaudi alias Bertrand de Tertignin testibus, constitutus personaliter Nobilis Sebastianus Fabri ... (the expected folio 69 is designated as “missing” by the ACV, then the next folio is numbered in pencil 70, suggesting that the folio was thought to have been lost after the folio numbers were added during the project of digitizing the terriers, or else the existence of the “missing” folio had been noted by some previous archivist).

70 Lictera transsactionis Domini Amedei Viriaci et Nobilis Johannis de Sovernier, 11 oct 1505, Nobilis et Potens vir Amedeus dominus Viriaci, Montisveteris, et Rotuli ex una parte, et Johannis de Sovernier filius quondam Nobilis Guilliermi de Sovernier ex parte altera, script is quite obscure, possible an abbergement, notary apparently not named. Notation at the end (fol. 71v), but lined out, indicates that the transaction has been confirmed.
