

tACV Fg 246 Extracts for the Hospital of Rolle 1348-1541, Compiled by Ludovicus Challeti around 1530-1541.

At the top of the first folio, but incompletely legible due to fading as well as damage to the edges, the title specifies that the extracts were made for Venerabilis vir Religiosus Franciscus Donzelli, current rector of the hospital of Rolle, by me, Ludovicus Challeti de Perruys, notarius. Many pages are damaged and faded.

Some of the “extracts” contain serious errors, including some erroneous dates. One way of identifying and possibly resolving some of the bad dates is to match them with the rectors of the hospital who are named in most of the records. Some of the questionable dates probably arose through the omission of one or more words or Roman numerals. There are glaring errors in a few names, too. In some cases, we cannot be certain whether the date is wrong, or if there may have been an earlier notary of the same name. However, it appears that Fg 246, errors and all, served as the working source for the final terrier compiled by the same Ludovicus Challet, Fg 263, and containing at least a few of these careless errors.

Among other information noted in these extracts, at the end of almost every one of them is the statement, “*a dorso signata per ...*”, followed by one or two words apparently having religious significance, such as *Misericordis*. When the various papers were arranged in the correct order, these single words would form a specific prayer, evidently in this case first the Lord’s Prayer, followed by several others, including the *Salve Regina* – a very medieval method of filing documents. However, the last few items that bear labels have words suggesting secular or perhaps astrological content, such as *Capricornus* and *Penelope*. One result of this method of labeling documents is that, with further study, we may be able to spot where a document is missing from the sequence, or has been misplaced, or inserted later. We show these key words in **red** at the end of each item where they occur and are legible.

6v Confessio Annexone relicte Petri de Plathea alias Pissonjat contra Johanne de Ruvina ? , 18 oct 1450, for a sum that had been owed by Roletus Bosson uncle of the said Petrus de Plathea, Petrus Mangie notarius. (Margin: Tenet Henrieta relicta Petri Reys.) (*Adveniat*)

7v Clausula testamenti ad opus eiusdem hospitalis contra Nycoletam uxorem Johannis Bertrandi filiam Mermeti Vuilliermi de Sarraul de uno quarterono frumenti census vel 20 solidis pro semel, 22 dec 1431, lictera recepta per Petrum Nycolay notarium, signata per Petrum Mangie de Arcu Gebennensis dyocesis. 9v Lictera vendicionis donacionis ad opus dicti hospitalis contra Stephanam relictam Johannis Carraz de Altacuria de una cupa vini seu musti ad mensuram de Germagnie, 04 apr 1377, the cense comes from a bequest by Mayoneta uxor quondam Johanneti [Carraz] her son, notary Mermetus de Leytreviens ? (possibly =de Leytravers ?) de Germagnier. (*Sicut* – this word occurs twice in the Pater Noster, and at this point in Fg 246, the sequence omits all of the intervening words, suggesting that at least 10 documents that should have been in this sequence have been lost.)

Rector Frater Johannes de Satigniac. (*Conditor* – this is the beginning of the Oratio Praeparatoria ad Confessionem Sacramentalem)

It would be very logical if the mysterious, illegible place name was somewhere in that same area, but we have been unable identify it.) (*Et Terre*)

(The date is far too early for Petrus Mangie and Petrus dou Marterey ! – **1449** is a distinct possibility. Fg 263 repeats this error, suggesting that Fg 246 was in fact used in the preparation of Fg 263, instead of using the original documents.) (*Me*)

On closer examination, it appears that the text originally continued from fol. 84av directly to fol. 85, without the two inserted, unnumbered folios. The text at the top of the first inserted folio, 84b, is the same as that on the lined out folio, 85, for several lines, but then 84b inserts several sections of additional text that were apparently omitted in error on 85, specifying additional provisions and conditions, and augmenting the original donation. Thus, the version that begins on 84b is apparently intended as the final, complete text, intended to replace the lined out text on 85. At the bottom of the last of the inserted folios, 84cv, the inserted text ends with *devesticentes etc.*, *promictens etc.* – indicating that the end of the transaction has been reached. However, the final added text found in the other items in this volume, indicating the notary and the additional label, is missing, unless the intention was to accept the last two lines of the item on fol. 85v. In view of the complex revisions of the text, we have come to believe that this item is a combination of an original donation recorded by Glaudius Samoen during the tenure of the rector Johannes Guillieti, probably 1452-1461, and later augmented by a further donation in 1493.)
