Extracts of reconnaissances for the priory of Biere 1488-1489, compiled by Stephanus Fillietaz de Gimel about 1520.

The extracts have been annotated in a way that suggests the volume was used in the preparation of a later terrier by Stephanus Fillietaz, noting the later owners of many of the properties mentioned (including properties noted as adjacent to those of each recognoissant).

In the margins at the beginning of each reconnaissance, there is a roman numeral that likely indicates either the page number where the original reconnaissance may be found in the terrier from which Fillietaz extracted this information, or page number in the new terrier that he was compiling. The source terrier may have been one compiled by Petrus Gos, as indicated in the first reconnaissance in Fg 38. These marginal numbers are listed below in **{curly brackets}**. These numbers appear in the first 80 folios of Fg 38. The inventory of the ACV does not appear to contain any terriers that could be identified either as the source from 1488, or as the new terrier presumably to be compiled by Fillietaz. Other terriers by this commissaire are from the 1520's.

The name that looks like Juhynns is also found in Fg 283, fol. 149 (circa 1555), where it is written "Johennyns aultrement Groz". In Fg 38, the name is usually written with a stroke over the last syllable, implying that letters have been omitted. One possible solution for the apparent abbreviation is something like Juhynnens. Similar names (perhaps Joannin, Jouennin, etc., but all rather uncertain because of the ambiguity of the script) are also found in early records from the area around Aubonne and Morges. In Fg 38, some of the marginal notations call this family Jenyn.

1 Claudius filius quondam Petri Merdens de Beria, 06 dec 1488. (=Meldem), originally recorded by Petrus Gos notarius Albone on behalf of Leodegarius Rolaz prior of the parish? of Beria. Margin: Tenet Petrus, Mermetus, et Jacobus fratres filii dictus Claudius Meldens. Many additional marginal notations, heavily abbreviated, and insertions. On fol. 2v: reference to property that was dowry of Margreta relictia Girardi Trippodi de Sancto Liberio, soror dicti confitentis (she is daughter of Petrus Merdens). Fol. 3, mention property from Mermetus Merdens, avum patrem dicti confitentem previously recognized Eg. Johannes Challeti. **{32}**

3v Margreta relictia Girardi Trippodi filiaque quondam Petri Merdens de Beria (=Meldem). Margin : apparently held by the same heirs of Claude Meldem as in the previous item. **{37}**

3v Stephanus filius quondam Reymondi Juhynns ? de Beria 06 dec 1488. **{39}**

6 Claudius filius quondam Stephani Juhynns de Beria, 16 dec 1488. Margin : tenet Georgius filius dicti Claudii... One property jx Stephaneta daughter of the late Johannes Juhynns wife of Nycolletus Monthoux, Stephanus Juhynns and Claudius son of Johannes Juhynns alias de Parys or de Parix. Mention Johannes Huguet and his wife, a previous owner. Also (fol. 8) mention Perretus Juhynns grandfather of Claudius son of Johannes Juhynns alias de Parix. **{45}**

9 Georgius filius Claudii filii quondam Stephani Juhynns de Beria, 16 dec 1488. **{51}**

11 Johanneta filia quondam Mermeti Baux (=Baud), 16 dec 1480 (possibly should be 1488, if "octavo" was accidentally omitted). **{56}**

Mention jx Claudius "Meccioux", presumably = Messioux. Fol.. 12v jx heredes Stephani Robert. **{58}**

15v Claudius filius quondam Nycodi Ansonarre de Berolaz, 24 nov 1488. Margin : long annotation, only partly legible, contains several dates in February, 1521. **{64}**

16 Claudius filius Johannes filii quondam Perreti Juhynns de Beria, 24 nov 1488. Margin, at top of page : apparently a later reconnaissance was made by Franciscus filius quondam Claudius Johenns alias Morel dated 24 apr 1512, rec. Petro Tripodi, also reference to 31 jan 1520. Margin, next to main entry: tenet Petrus Morel alias Johenns... **{66}**

18v Franciscus Advisa de Beria, 15 nov 1488. Margin, tenet liberi Francisci filii dicti quondam Francisci, by legitimate succession... Jx heredes Petri Robert de Albona. **{71}**

19 Johannes filius quondam Johannis de Crosa de Beria et Mermeta Commugny (or possibly Guiguin, Guignui, etc. ?) filia Johannete filie quondam Perreti Bugniouz uxoris quondam Vuilliermi Pillicier, 06 dec 1488. Fol. 24v, mention Guionis Robert, prior owner of adjacent property. Fol. 25v, jx heredes Mermeti Roberti. **{74}**

27 Vuilliermus Augier de Beria. 06 dec 1488. Margin : Tenet Aymoneta filia dicti Vuilliermi et Johannes ? V... ? **{86}**

28 Claudius filius quondam Johannis Meccioux (=Messioux) et Jaquete Commugny ? filiaque quondam Vuilliermi Pillicier, 29 dec 1488. Title likely in error, see reconnaissance on fol. 19. Implication in these transactions, however, is that Bougnioux became Commugny, or some similar name whose spelling is extremely ambiguous. Margin: note spelling Mexiouz. **{89}**

30v Petrus et Johannes Grivel de Sancto Liberio, 04 jan 1489. Margin: Tenet Johannes Grivel de Sancto Liberio perdictus cum liberis dicti Petri Grivel. **{96}**

[44b and c, inserted, not clearly legible, not yet analyzed, appear to contain additional reconnaissances highly abbreviated. Note fol. 44cv, date 22 feb 1522, and at bottom, notation about reconnaissance of Leodegarius filius quondam Petri Croysiez alias Guibat et Petrus filius quondam Stephani fratris dicti Leodegarii nomine suo et Claudii ac Johannis fratrum dicti Petri, 22 feb 1522.]
