


Romainmôtier, property subject to the priory and convent at Morges, Apples, Ballens, Mollens, Berolle, and other places, in two parts.

The first part was compiled by commissaires Mermetus Pippini of Morges and Petrus Vaunerii (Vannerii?) of Romainmôtier, 22 feb 1424.


The second part, numbered separately, was compiled by Noble Mermetus Cristine 08 apr 1439, and in some of the reconnaissances beginning at fol. 17v, by Guilliermus Gervasii clericus Morgie, subrogatus in hac parte a Nobili Mermeto Cristine Commissario. The reconnaissances in this part include very specific details about previous sales, inheritance, etc., including exact dates, relationships, and the names of the notaries or commissaries. As a curiosity, the name of the commissaire in the first part is clearly written Pippini on fol. 1:



... but the name of the commissaire in the second part is most often abbreviated as xpine. In the old script, the x looks very much like a p, creating the impression that the commissaire for the second part was the same Mermetus Pippin, his name abbreviated in some way!



However, the name of this second commissaire is spelled out in full in several places, so there can be no real confusion:



Index inserted later, not very legible. The individual reconnaissances are very neatly written.
