

# ACV Fh 10 Reconnaissances for Noble Jean (II) de Menthon, Commissaire Ludovicus Challeti, 1523-1534

The first 38 folios have been lost, and fol. 39-41 have been torn out, leaving only a few words at the inner edges of those pages. The intact text begins in the middle of a long reconnaissance on fol. 42. The rest of the volume appears largely intact, with clear script, concerning mainly Allaman, but the last surviving reconnaissance is incomplete, all material after fol. 454v having been lost. However, the inventory of the ACV indicates that the missing folios at the end were fol. 455-458v, possibly indicating that the remnants of four folios are still present.

42 Continuation of a reconnaissance, evidently concerning property of the Juens family of Allaman, for which Johannes de Cresto alias Choudet appears to be acting as guardian for Aymo his son, no date, with signature and paraphe of Ludovicus Challeti.

47 Johannes filius quondam Glaudii Collon de Alamand, 12 oct 1525 Style of the Nativity, previously recognized by the said Glaudius in a terrier compiled by Guilliermus Berardi de Romanomonasterio for Noble Glaudius de Menthone grandfather of the current condominus Albone and Alamand.

55v Aymo filius quondam Stephani de Nemore de Alamand, 17 oct 1525 Style of the Nativity, previously recognized (Berardi) by his father.

62 Aymo filius quondam Johannis Bergiers (Bergerii) alias d'Orbaz generis Petri Burgonion de Alamand, necnon Cristophori filii pupilli Johannis filii predicti Johannis Bergiers ipsiusque Aymonis nepotis, per eiusdem Aymonem facta ut infra, 02 nov 1526 Style of the Nativity, but the text describes the parties differently: Aymo Bergerii filius quondam Johannis Bergerii alias d'Orbaz generis Petri Borgonion de Alamand agens in hac parte nomine suo necnon Cristophori filii quondam Johannis filii predicti Johannis Bergiers predicti Petri Borgonion generis eiusdem Aymonis nepotis absentis et in pupillari et minoris estate existentis. A possible solution would be if Aymo and his brother Johannes (sons of the elder Johannes Bergier) had both married daughters of Petrus Borgonion. Previously recognized (Berardi) by the elder Johannes Bergerii. Followed by text of abergement by Nobilis Glaudius de Menthone dominus Ruppisfortis et condominus Albone, the tenement of Anthonius Andree and his wife Jaqueta filia quondam Johannodi de laz Planta de Alamand having become vacant, it is now leased to Johannes Bergier alias d'Orbaz morans apud Alamand, recorded by Guilliermus Berardi, 17 dec 1489.

85v Stephanus filius quondam Berthodi Cusini de Alamand, 02 nov 1526, previously recognized by his father (Berardi).

95 Suprannominatus Stephanus Cusini de Alamand, 02 nov 1526, previously recognized by Jacobus Margel de Authiez morans in dico loco (Berardi). Followed by text of abergement by Johannes de Menthone to the said Stephanus, recorded by Ludovicus Challeti, 02 nov 1526. Thus, this item includes both the lease and the corresponding reconnaissance made on the same day. However, the final page (fol. 108) has been torn out.

109a Continuation of a reconnaissance for Rodulphus et Jacobus filii quondam Johannis Regnaux mandamenti de Monthoux olym morantis apud Alamand, the date is lost, previously recognized by their father (Berardi).

118v Petrus et Jacobus filii quondam Nycodi Juyns alias Bullet de Alamand per ipsum Petrum facta ut infra, 25 nov 1526, based on an abergement to their father, recorded by Guillermus Berardi 16 dec 1495 and copied and signed by Egregius Mermetus Badelli from Berardi's protocols, the text of which follows this reconnaissance (the properties had previously been recognized (Berardi) by Petrus Borgonion).

132v Reymondus filius quondam Ansermi Rudel de Alamand, 03 dec 1526, previously recognized by his father (Berardi).

146 Janus, Petrus, anda Franciscus filii quondam Ansermi Rudel de Alamand fratres, per dictum Janus fact prout infra, 03 dec 1526, previously recognized by their father (Berardi).

160 Anthonia filia quondam Johannis Regnaudi ? relict Aymonis Chastel de Alamand, 09 jul 1527, previously recognized by her father (Berardi), and citing her marriage contract recorded by Discretus Stephanus Cortesii de Estuez 25 nov 1515.

164v Petrus et Johannes Bergerii filii quondam Perrodi filii quondam Guilliermi fillque quondam Johannis Bergerii de Alamand, 08 oct 1527, previously recognized by their father (Berardi).

182v Aymo filius quondam Petri Albbernardi de Cossenay habitator de Alamand, per Providum virum Johannem Duchat ? de Alamand eius tutoe facta prout infra, 16 jan 1528, previously recognized by Petrus Guyaz conjunctorio nomine Ludovice eius uxoris filieque quondam Glaudii de Nemore dicti loci de Alamand (Berardi), et tam ex legitima successione dicti Petri Albbernardi eiusdem Aymonis quondam patris heredis Guilliermete sue quondam uxoris filieque quondam dicty Petri Guaz, quam ex divisionibus et partagiis inter dictum quondam Petrum Albbernardi eiusdem Aymonis genitorum, necnon Anthonium Thoma et Anthoniem eius uxore, acque Glaudiam filiam quondam dicti Petri Guyaz ut asseritur factis.

188v Glaudia filia quondam Petri Guyaz de Alamand relictum Humberti Levret alias Fert et Stephani Levret eius filii, 16 jan 1528, previously recognized by dictus Petrus Guiaz eiusdem Glaudie pater conjunctorio nomine Ludovice eius uxoris filie quondam Glaudii de Nemore predicte Glaudie matris (Berardi).

194v Anthonius Thoma habitator de Alamand nomine suo necnon Anthonie eius uxoris filie quondam Noel Henriodi facta prout infra (according to the title; however, in the text, Anthonius is acting nomine suo necnon Anthonie eius uxoris filie quondam Noel Henriodi et Guilliermete conjugum filie quondam Petri Guyaz dicti loci de Alamand absentis), 01 feb 1528, previously recognized by the said Petrus Guyaz and his wife Ludovica filiaque quondam Glaudii de Nemore dicti loci de Alamand, and citing a partagium inter dictum Anthonius et eius uxorem necnon Glaudiam filiam quondam dicti Petri Guyaz ipsius Anthonie avunculum, acque Petrum Albibernardi eiusdem Guilliermete quondam primum virum ut asseritur factis.

200 Mermetus filius quondam Johannis filii quondam Guilliermi filiique quondam Johannis Bergerii de Alamand, 01 feb 1528, previously recognized by his grandfather Guilliermi Bergerii (Berardi).

222v Glaudia senior filie quondam Glaudii Juyns alias Bullet de Alamand, 15 feb 1531, previously recognized in the terrier of Berardi, but exactly who the reconnaissants were is not clearly stated, and with a citation of a partagium inter ipsam confitentem necnon Francesiam uxorem Johannis de Cresto alias Choudet, et Glaudiam filias quondam dicti Glaudii Juyns ipsius confitentis sororis ut asseritur factis.

228 Venerabilis vir Dominus Johannes Girardi cappellanus, curatus perpetiis, et rector ecclesie perrochialis Beati Johannis Baptiste de Alamand, 07 jul 1531, previously recognized per quondam Veneabilem Dominum Johannem Girardi alias ipsius predice ecclesie curatum de Alamand et rectorem (Berardi), but if this is correct, there would have been two rectors of the same name?

235 Nobilis et Potens Ludovicus filii quondam Nobilis et Potentis Francisci de Russino domini castri de Alamand, 10 oct 1531, previously recognized by his father (Berardi).

240v Glaudius filius pupillus Mermeti filii quondam Johannis Bergerii de Alamand per honestos viros Colletum de Torculari de Perrouys et Georgium Vizoz de Estuey eiusdem Glaudii tutores facta prout infra et infrascripta recognoverunt ultra omnia per ipsum quondam Mermetum Bergerii domino Ruppisfortis jam recognita, 05 jan 1534, previously recognized by Glaudius Juyns alias Bullet de Perrueys habitator de Alamand (Berardi), exque acquisito per dictum quondam Mermetum Bergerii a Johanne de Cresto alias Goudet causam habente dicti Glaudii Juyns.

Anthonius filius quondam Petri Moennat de Estuey, 23 jan 1526, previously recognized by Petrus Vidoz burbensis Albone (Berardi).

262v Johannes filius quondam Petri Moennat de Estuey, 03 dec 1526, previously recognized by Stephanus filius quondam Barthomei Cusin dicti loci de Alamand and by quondam Guilliermus Bergerii (Berardi).

269v Georgius Vidoz de Estuey, 03 dec 1526, previously recognized by Guilliermus Bergerii et Berthodus Cusini (Berardi).

276v Johannes filius quondam Emerici Rolaz de Crousaz habitator de Estuey, 17 dec 1526, text notes Johannes filius Emerici Rolaz habitator de Estuey etatis sexdecim annorum prout dixit, previously recognized by Girardus Baux et Ansermodus Rudel.

281v Petrus de Ponte d'Estuey et Anthonius Brizoz de eodem loco de Estuey, 25 apr 1527, previously recognized by Glaudius Juyns necnon Johannem filium quondam Johannis Challeti (Berardi).

288v Nobilis Bernardus Marquisii, 13 mar 1531, previously recognized by Glaudius Juyns (Berardi).

293 Peroneta relicita Reymondi Boverii ? de Estuey, 17 apr 1531, as the result of a sale to Peroneta...

298 Parrochia Albone ad causam de Alamand

Colletus filius quondam Jacobi Begoz sutor et burgensis Albone, 02 jun 1523, previously recognized by the said Jacobus Begoz and his ? brother Petrus Begoz (Berardi).

303v Stephanus filius quondam Petri filii Stephani Begoz sutoris (referring either to Petrus or to his father, the grammar is ambiguous) et burgensis Albone, 02 jun 1523, previously recognized by Petrus and Jacobus Begoz, brothers, sons of the elder Stephanus (Berardi).

309v Hospitale pauperii Sancti Spiritus ville Albone per Discretum Petrum Coinssini notarius et Jaquetum Challeti scindicos et gubernatores ville et communitatis Albone ipsiusque hospitalis facta prout infra, 10 sep 1524, with consent and authorization of Nobiles Franciscus Mistralis, Perrodus Marchiandi, Franciscus et Sebastianus de Sivirier, Jacobus Hugonini, Ansermus de Nanto, Discretus Johannes Fonjalleti notarii consultorum ipsius ville Albone ibidem presentium, previously recognized by Petrus Borgonion alias d'Orbaz (Berardi), with additional history, including accensation by Aymonetus Pollet.

313v **Petrus et Michael filii quondam Ludovici filii quondam Michaelis Roberti alias Fabri de Crousaz subtus Fechier per ipsum Petrum facta prout infra**, 10 sep 1524, Michael is absent, the property was previously recognized by the elder Michael Roberti their grandfather suo ac conjunctorio nomine Johannete eius matris filii Perrodi Gazelli (Berardi), there is a single property, videlicet quandam peciam prati continentem circa unam falcatam dudum per Jaquetum Breton et deinde dictum Perrodum Gazel dudum recognitam antecessoribus prefati condomini Albone, et super que liberi Nobilis Georgii Marchiandi annualiter precipiebant tres solidos bone monete Lausannensium, qui tres solidi fuerunt antecessoribus ipsorum fratum Roberti per Nobiles Stephanum et Georgium Marchiandi fratres venditi ut asseritur, sitam in Pratis subtus Marthereys juxta pratum Johannis Fonjalleti notarii a borea, pratum eiusdem Johannis Fonjalleti quod alias fuit Aymonete de Marthereys et deinde dictorum Gavit a vento, pratum dicti confitentis et Petri eius fratris a juria, et pascua communia a lacu, witnesses Colletus Begoz de Albona, Discretus Johannes Brasserii de Coinssins notarius, et Nycolaus de Fraxino de Albona.

317v Johannes et Glaudius (absent) filii quondam Johannis Chinaux (alias de Fonte) de Martherey per ipsum Johannem facta prout infra, 25 sep 1528, previously recognized by Stephanus de Nemore and their father Johannes Chinaux (Berardi).

322v Franciscus et Stephanus filii quondam Johannis du Martherey junioris per ipsum Franciscum prout infra facta, 15 sep 1528, previously recognized by Stephanus de Nemore and their father Johannes Chinaux (Berardi).

327v Venerabilis vir Dominus Percivalis Constantini cappellanus curatus et rector ecclesie parochialis Albone, 22 jan 1529, previously recognized by Venerabilis vir Dominus Johannes Militis cappellanus canonicus Mauriciencis curatus et rector et eo nomine predicte ecclesie parochialis Albone (Berardi).

331v Michael filius quondam Petri dou Sougeys morans subtus Fechier, 25 feb 1531, previously recognized by his father (Berardi).

336v Stephanus Challeti burgensis Albone, 06 mar 1531, previously recognized by Petrus Paccotti (Berardi).

341v Nobilis et Potens Franciscus de Sancto Simphoriano dominus ipsius loci, 13 jun 1531, previously by Nobilis Johannes de Monte antenatus de Albona morans in Paterniaco and his wife, Glaudia filia quondam Petrus de Siviryez et Nycolleta de Molleria conjuges (Berardi).

350 Apud Perruys

Glaudius Bocquini alias Gachet de Perruys nomine suo et Amedei Bocquini eius fratris facta prout infra, 05 nov 1526, previously recognized by Petrus Borgonion et Jacobus Marcel (Berardi).

355 Colletus filius quondam Stephani de Torculari de Perruys, 03 dec 1526, previously recognized by his father (Berardi).

363 Michael de Torculari necnon Johannes (absent) filii quondam Stephani de Torculari ipsius Michaelis consanguinei de Perruys per ipsum Michaelem facta prout infra, 07 mar 1527, previously recognized by the said Stephanus de Torculari (Berardi).

368v Jacobus et Roletus (absent) filii quondam Nicodi de Torculari fratres per ipsum Jacobum facta prout infra, 07 mar 1527, previously recognized by Stephanus de Torculari (Berardi).

373v Nobilis Amedeus Martine filii Nobilis Michaelis Martine de Perruys, 23 nov 1527, by succession from their father.

381v Bernardus, Jacobus, Johanes, et Johannes Guignieti fratres filiique Johannis filiique quondam Glaudii Guignyti de Perruys per ipsum Bernardum prout infra facta, 01 mar 1528, previously recognized by Girardus Guygniet filius Petri Guygniet brother of the said Glaudius (Berardi).

386v Bernardus Luysod muniserius ? habitator Albone suo et conjunctorio nominibus Loysie eius uxoris facta acque Johannes Bombardi de Perruys facta administratorio nomine Glaudii et Johannis Bombard eius filiorum per ipsum suceptorum in Colletam eius uxorem prout infra, 01 mar 1528, text describes the reconnaissants as Bernardus Luysod muniserius ? habitator Albone necnon Johannes filius quondam Gabrielis Bombardi de Perruys agentes in hac parte, scilicet ipse Bernardus suo ac conjunctorio nominibus Loysie eius uxoris filie quondam Hugonini Bocton ? et Stephanete sue uxoris filieque quondam Girardi Bessons, et ipse Johannes Lombardi (but this should be Bombardi, presumably) administratorio nomine Glaudii et Johannis eius liberorum et collete eius quondam uxoris filie dicti quondam Huttonini Bocton et Stephanete conjugum absentium, previously recognized by the said Stephaneta uxor dicti Hugonini Bocton (Berardi). Fol. 387v is followed by fol. 389 without a break in the text, a numbering error.

392 Altera recognitio Michaelis de Torculari de Perruys, 01 mar 1528, previously recognized by Johannes Guigniet (Berardi).

396 Alia recognitio Jacobi et Roleti filiorum quondam Nycodi de Torculari fratrum per ipsum Jacobum facta prout infra, 01 mar 1528, previously recognized by Johannes Guygniet (Berardi).

400v Franciscus Fabri burgensis et mercator Gebennis, 06 may 1533, previously recognized by Petrus de Plathea alias Pissinjaz, nephew of Petrus de Plathea de Perrueys (Berardi).

404v Alia recognitio honesti viri Colleti de Torculari de Perruys, 18 jan 1534, previously recognized by Petrus douz Sougey morans subtus Fechier (Berardi).

408v Nobilis Johannes Costabloz junior de Orba residens apud Perruys, 31 jul 1534, previously recognized by Nobilis Anthonius de Monestier de Bignyn suo et conjunctorio nominibus Nobilis Grabiele (=Gabriele!) filie quondam Nobilis Guilliermi de Bosco quondam duculis (=ducalis!) secretarii (Berardi).

414v Nobilis et Egregius Ludovicus Challeti de Perruys procurator fiscalis et commissarius generalis patrie Vuaudi acque ecitam commissarius et receptor extentarum et recognitionarum infrascripti domini in ipsius domini castellania et mandamento Albone acque de Alamand, 14 mar 1531, previously recognized by his father Johannes Challeti (Berardi?). This reconnaissance was recorded by the notary Roletus Canelli (=Canel) de Sancto Jorio in the diocese of Geneva, resident of Nyon (thus avoiding any conflict of interest), and bears his subscription and large paraphe. Fols. 430-430v are noted as missing, and this is likely not a numbering error, as the expected heading “Confitens” is not found; it should have occurred between the “Items” leading up to fol. 429v and the heading “Promictens” on fol. 431.

433v Anthonia uxor mis Ludovici Challeti commissarii infra nominati, 23 sep 1534, identified in the text as Anthonia filia Egregii Michaelis Quisardi burgensis Nyviduni quondam procuratoris fiscalis et commissarii generalis patrie Vuaudi – thus, Ludovicus Challeti married the daughter of his predecessor in this position, a very popular career move in that era – , previously recognized by Johannes Bergier (Berardi).

[Fols. 437 and 438-438v are noted as “blank” in the inventory of the ACV and fols. 437-438v are not included in the digital images on FamilySearch.org, but there is also a notation in the same inventory: “Au folio 437 verso, se trouve un dessin du notaire portant la mention: ‘Egrege Morsier Imago’ ”.]

#### 439 Pampignie, Coctens, et Cabane supra Veyronum

Johannes Auberti alias Gronsard de Pampignie, 12 mar 1526, previously recognized by Petrus Tardinat (clear, not Cardinat, but see the next item, where the text clearly shows Tardivat) (Berardi), and sold to the said Johannes Auberti for the price of 12 livres, recorded by Discretus Stephanus Cortesii notarius publicus de Estuey 16 dec 1506.

[Fols. 442-443v are noted as missing.]

444 Petrus Tardinat (but in the text clearly, and as far as we know, uniquely, Tardivat) de Pampigniez, 12 mar 1526, previously recognized by Franciscus Mosceys (or Mosteys?) (Berardi).

448 Petrus de Fontanna alias Chinaudi ? et Jaquema eius uxor filia quondam Francisci Mosceys ? acque Petrus Mosceys ?, 12 mar 1526, but several pages are missing (fols. 449-451v), so most of the information has been lost. Witnesses (fol. 452v) include Venerabilis vir Dominus Franciscus Fonjalleti cappelanus, curatus de Brutignier, in whose house (formerly the house of Nobilis Johannes Marchiandi de Cossenay) in Aubonne the document was signed.

[Fols. 449-451v are noted as missing.]

453v Petrus filius quondam Roleti Davidis de Cabanis supra Veronum notarius necncon Colletus Davidis eiusdem Petri frater, 26 may 1528, previously recognized by Petrus Mosteys (or Mosceys, the script is ambiguous, but in this instance more likely Mosteys) de Coctens (Berardi).

This reconnaissance ends before any of the properties are described, so the volume is incomplete and could have contained more reconnaissances.

[Fols. 455-458v are noted as missing, possibly evidenced by remnants of folios that were torn out.]
