

ACV Fh 102 Extracts, Hospitale Sancti Spiritus de Albona, 1300-1539.

Abstracts prepared by John W. McCoy (RealMac@aol.com) © 2015.

The text consists of summaries of documents relating to the hospital, the associated confratelia, and endowments for the Mass of Purgatory, clearly written but generally very brief. In effect, it is an “inventaire sommaire” of the documents in possession of the hospital in the early 16th Century. Fols. 1-48v appear to have been compiled by Petrus Cuynssins, whose signature and paraphe are found on fol. 48v. On fol. 49, the script changes, presumably to that of Egrège George Challet, who on 28 dec 1539 compiled a list of the documents formerly in possession of the late notary Stephanus Challet (George was his heir), procurator for the Purgatory Mass of Aubonne. Many notaries are mentioned in the text—from whom not one single register appears to have survived! The volume was previously known as N° 46 (on the cover), and later as 2 (in ink, on a white paper label pasted onto the cover).
