

ACV Fh 103 Confratia Sancti Spiritus de Albona, extracts of various donations, sales, and bequests.

Abstracts prepared by John W. McCoy (RealMac@aol.com) © 2016.

The inventory of the ACV indicates this volume dates from 1406-1407. That statement is certainly incorrect. While the first reconnaissance is dated in 1406, the rest of the dates are diverse, at least as late as 1431. From the details of the text, it is clear that this volume contains copies of various instruments that were in possession of the commissaire, possibly Jaquetus Gos, who signed a notation dated 17 apr 1431 at the bottom of fol. 26v, and whose handwriting and spelling in this notation are very similar to those found in the main text. There are also notations added much later, some signed by Petrus Gos. It seems likely that the main text was compiled by Jaquetus Gos, and that (his son?) Petrus Gos later had custody of it. This volume was previously known as N° 47 (written on the cover), and later as 3 (in ink on a white paper label pasted onto the cover).

1 Johannes Forchu faber burgensis Albone, 14 may 1406, origin of cense not given (simple debt?), recorded by Mermetus Bassins clericus.

1v Vuilliermus de Ponte burgensis Albone with approval of his wife Stephaneta, 21 may 1361, from a donation pro remedio animarum ipsius Vuilliermi et Stephanete, recorded by Jaquetus de Exertines morans Albone clericus.

1v Leona uxor Stephani Ruerrey ? burgensis Albone, donation to the confratia in her testament, recorded 09 may 1388 by Girardus de Ponte de Albona clericus, and a previous version ? 27 apr 1376.

2 Hudricus Barbier burgensls Albone, 19 feb 1373, donation pro remedio animarum fratrum suorum et animarum predecessorum suorum, recorded by Jaquetus de Exertines clericus morans Albone.

2v Martinus Golliardon sutor burgensis Albone, 13 jan 1401, testament, universal heir his son Johannodus Golliardon, recorded by Johannes Vinent ? morans Albone notarius, with reference to Perretus Golliardon on fol. 11, and to another item on fol. 12 at the sign ++.

3 Martinus de Abondancia ? de Albona, 20 may 1416, testament, universal heir his daughter ? Nycola ?, recorded by Johannes Mestralis de Albona clericus, with reference to another reconnaissance by Anthonius de Crousa maritus filie predicti Martini on fol. 12 at the sign #.

3 Perrodus filius Jaqueti Soubaroz ? de Albona, 07 oct 1350 ?, donation ? recorded by Perretus de Conier ? (This name occurs several times, but always abbreviated ȇier. We have not been able to verify the name. Could it be something longer, such as de Commugnier?)

3v Perrisonna filia quondam Francisci de la Barraz burgensis Morgie uxorque Perreti dicti Soubaroz faber burgensis Albone, 14 may 1384, with approval of her husband and of Hugardus her husband's brother (although a later passage mentions property in quibus *dicti fratres dicte Perrissone* tenentur pro dote dicte Perrissone assignatas per dictos fratres... – is it possible there were two sets of brothers involved, those of the husband and those of the wife?), donation pro remedio anime sue, recorded by Johannes Monrichier clericus.

4 Johannes de Yens domicellus, 08 oct 1390, testament recorded by Johannes de Sarrata de Albona clericus.

4 Mermetus Ansermet ? burgensis Albone, sale to Mermetus Levet and Humbertus Reymondi priors of the said confratelia, 20 jul 1412 ?, recorded by Jaquetus Planchy clericus.

4v (Extremely faded, name uncertain, probably a man and his wife Johanneta) ... , 07 dec 1394, sale recorded by Mermetus Bassins clericus.

4v Aymonetus Tresorer ? barilier burgensis Albone et Petrus eius filius, 28 may 1413, sale to Anthonius Bondralet and Stephanodus de Jolens ? burgenses Albone priors and rectors of the confratelia, possibly from a rehemption by Reymonda ? filia quondam Mermerii de Beria uxorque quondam Johannodi Chastellar de Bougier Sancti Martini, recorded by Jaquetus Pampignier de Albona clericus.

5 Bersetus Burit habitator Albone, 16 feb 1377, donation recorded by Mermetus de Monrichier clericus.

5v Agnelleta dicta Vigneta burgensis Albone, 13 may 1349, donation pro remedio anime sue et predecessorum suorum, recorded by Mermetus de Monrichier clericus.

6 Katerina ? uxor Vuilliermeti Planchy burgensis Albone, 17 ? (or 22 ?) jan 1376, pro remedio anime sue, anime Nicole Bouleta, et omnium predecessorum suorum, donation recorded by Mermetus de Monrichier, clericus.

6 Predictus Vuilliermetus Planchy, bequest pro remedio animarum predictorum, from his testament, which named as his universal heirs his daughters Nicola and Mermeta ?, 19 oct 1376, recorded by Mermetus de Monrichier, with notation in a later hand that Johannes de Fonte de Feschier will pay the cense, no date. (The dates of these two items imply a year reckoned either from December 25 or January 1, since the bequest from Katerina specifies that she is the “wife” rather than the “widow” of Vuilliermetus.)

6v Sencilliona relicta Johannodi de Sarrata quondam burgensis Albone, bequest from her testament, which named as her universal heir Johannes de Sarrata notarius Albone filius suus karissimus, 03 nov 1401, recorded by Jaquetus Gos de Albone clericus, with notation referring to folio 9 at the sign +++.

6v Mermetus filius quondam Jaqueti Magnin (Magnus ?) de Albona, testamentary donation, his universal heir being Franciscus frater suus karissimus and his successors, 13 feb 1349, recorded by Mermetus de Monrichier, notarius.

7 Mermetus Barillet burgensis Albone, donation pro remedio anime sue to Vuilliermetus Planchy (clear) and Perrodus Rosset burgenses Albone, priors and rectors of the said confratelia, 22 apr 1366, recorded by Jaquetus de Exertines clericus.

7v Roletus Mochet burgensis Albone, owes the confratelia for a bequest made by Girardus Coctet burgensis Albone pro remedio anime sue, 11 jun 1365, recorded by Johannes Monrichier clericus Albone.

7v Nicolaus Porterii de Albona, 06 may 1348, testamentary donation, his universal heir Vuilliermetus filius suus, and after the death of Vuilliermetus, Aymonodus dictus dou Cotor burgensis Albone consanguineus suus, recorded by Jaquetus de Exertines clericus.

8 Margareta uxor predicti Nicolay Porterii, 12 jun 1348, donation pro remedio anime sue, cense owed to her by Johannes Chautemps de Sancto Liberio and his brothers (or siblings), recorded by Perronetus Agricole clericus.

8v Stephanus filius Johannis de Saubra junioris ? burgensis Albone (it is not clearly stated to which man the epithet junior should apply), 06 dec 1350, donation pro remedio anime sue, recorded by Reymondus de Chavornay clericus. With notation dated 18 jun 1457, possibly indicating that this cense had been purchased or redeemed by Johannes filius Vuilliermi Bertier from Petrus Morelli burgensis Albone prior of the said confratelia.

8v Nobilis Dominus Johannes condominus Albone et miles et Dominum Johanneta eius uxor (and their son Humbertus, mentioned in the text), sell to Perrodus Robins et Perretus Guiar ? burgenses Albone, priors and rectors of the said confratelia, cense of 14 sols, 14 feb 1368, recorded by Mermetus de Monrichier notarius, with additional reference for a donation by the said Nobilis Humbertus on folio 15.

9 Johannes Morel de Albone, 07 oct 1349, donatio inter vivos pro remedio anime sue, recorded by Aymo Brusseti clericus.

9v Perrissona filia quondam Girardi Garit ? (Gavit ? Ganit ?) uxorque *predicti* Vuilliermi Fabri burgensis Albone, 17 oct 1401, testamentary donation, her universal heir Johannes Garit ? de Albona frater suus karissimus filius quondam *predicti* Girardi Garit ?, pro remedio anime sue, recorded by Johannes de Sarrata notarius.

10 Anthonius Bergeron de Trivillin burgensis Albone, mentions his brothers Johannes and Henricus Bergeron, 08 jul 1400, donation pro remedio anime sue, recorded by Petrus Bochu clericus.

10 Bisoncius Chivilier de Albona, 13 oct 1364, sale ? recorded by Johannes Monrichier clericus.

10v Perroneta ? Margencel de Albona, relictta Vuilliermi de Trivillins ? (or possibly Grivillins ?) de Albona quondam, 08 apr 1360, testamentary bequest, universal heir Peronetus Margencel and his successors, recorded by Mermetus de Monrichier.

11 Johannes Theobardi serrator ? burgensis Albone, 08 sep 1360, testamentary donation pro remedio anime sue, universal heirs Margareta, Mermetus, and Johannes his children, recorded by Mermetus de Montero notarius, with notation that a new reconnaissance was made by Mermetus ? Theobardi, and mention of Petrus ? Tyevaux ?

11 Johanneta filia quondam Girardi dicti Calla burgensis Morgie et Briseta relictta dicti Girardi uxorque Perrodi Soubaroz de Albona, 20 aug 1360, testamentary donation pro remedio anime sue et predecessorum suorum, universal heir Nicoleta soror sua and her successors, recorded by Mermetus de Montero notarius, with notation that a reconnaissance was made by Mermetus Theorbardi.

11v Briseta uxor Perreti Soubaroz (see previous item), 29 sep 1375, donation pro remedio anime sue, recorded by Jaquetus de Exertines clericus, with notation that a reconnaissance was made by predictus Mermetus who held the cense ad causam Nicole quondam uxoris sue.

11v Predictus Mermetus Theobardi, with approval of Perretus Guiar ? maritus Johannete matris ipsius Mermeti, 23 apr 1369, sale to Johannodus de Sarrata sutor and Roletus Culery ? burgensis Albone, priors and rectors of the confratria, recorded by Johannes Monrichier clericus.

12 Perretus filius Jaqueti Pampignier burgensis Albone, 14 feb 1349, donation recorded by Mermetus de Montero clericus, with notation that a new reconnaissance was made by Perretus Ansermi de Pampignier.

12v Jaquetus de Clarmont coudurerius morans in Ponte subtus villam Albone et Leona eius uxor, 14 oct 1382, sale to Richardus de Quercu burgensis Albone acting on behalf of the confratria, recorded by Nicodus de Gimel notarius, with notation, fiat recognione nova per Sencillionam filiam quondam predictorum conjugum.

12v Nicoletus filius quondam Mermeti Barillet clericus, 10 feb 1377, sale to Stephanetus de Avenay ? et Richardus douz Chanoz burgenses Albone on behalf of the confratria, recorded by Jaquetus de Exertines clericus, with notation that a new reconnaissance was made by the heirs of the said seller (per heredes dicti venditoris).

13v Johannes de Sancto Germano domicellus habitator de Martherey prope Feschier, 10 sep 1349, sale to Ansermus Vuillieti et Perrodo Marsonel de Albona nomine et ad opus predicte confratrie, fidejussor Jaquetus filius quondam Perreti filii quondam Petri Marchiant de Albona, recorded by Mermeti de Monthero clericus, with notation that a new reconnaissance was made by the heirs of Vuillermus Fabri.

14 Perretus Golliardon burgensis Albone et Clemencia eius uxor, 10 apr 1390, bequest from joint testament, pro remedio animarum suarum, universal heir Contessona filia sua carissima post decessum predicte Clemencie, recorded by Johannes de Sarrata de Albona clericus.

14v (This item marked with sign #.) Anthonius de Crousa sutor burgensis Albone et Nicoleta eius uxor filia quondam Martini de Abondancia quondam burgensis Albone, 13 nov 1416, sale to the confratelia, recorded by Aymonetus Challet notarius Albone.

14v Richardus Alamant burgensis Albone, 15 feb 1417, sale to the confratelia, recorded by Aymonetus Challet notarius.

15 (This item marked++) Johannes et Franciscus fratres filii quondam Roleti Bariliet quondam burgensis Albone, 02 mar 1417, sale to the confratelia, recorded by predictus Aymonetus Challet.

15v Mermetus Melleray antenatus burgensis Albone filius quondam Perreti Melleray, 12 mar 1417 (anno quo supra), sale to the confratelia, recorded by predictus Aymonetus Challeti.

15v Michael Cuvit burgensis Albone, 09 mar 1417, sale to the confratelia, recorded by Aymonetus Challet.

16 Petrus Bariliet de Albona burgensis Albone et Nicola eius uxor filia quondam Jaqueti ? ... ?, 07 aug 1418, sale to the confratelia recorded by the said Aymonetus Challet. With notation dated 12 mar 1430?

16 (Item marked +++) Johannes de Sarrata notarius et burgensis Albone, 07 sep 1421, sale to the confratelia recorded by Aymonetus Challet.

24 Roleta relictta Aymonis ? Morelli de Albona, die Martis ante festum Sancti Thome Apostoli 1348 (= 16 dec 1348), donation, recorded by Peronetus Agricole clericus.

24v Perretus Avoca (? = Advocat ?) de Monthero et Stephaneta eius uxor filiaque quondam Johannis de Birola quondam burgensis Albone, 22 aug 1360, joint testamentary donation pro remedio animarum suarum et predecessorum suorum, universal heirs Perrodus et Johanneta fratres quos suscepit dicta Stephaneta a Percivallo dicto Rendu de Gimel quondam viro dicte Stephanete in medietate bonorum ipsorum testatorum, et alias liberos ab ipsis conjugum legitime procreatis in alia medietate, recorded by Mermetus de Monthero notarius.

24v Perroneta relictia Vuilliermi Ginilliarez ? burgensis Albone, 15 nov 1348, donation pro remedio anime sue et predecessorum suorum, recorded by Mermetus de Monthero de Albona clericus.

25 Hudriodus Chevalle ? burgensis Albone, 22 aug 1377, testamentary donation, universal heir his sister Perreta and his niece Jaqueta in equal portions, pro remedio anime sue, cense owed to him by Perretus Barrat de Birola, recorded by Mermetus de Leyterner ? de Germagnier clericus.

25v Hugoneta uxor Mermeti Mugnerii de Trivillins, 18 oct 1360, testamentary donation, universal heir Hudriciodus filius quondam Girardi Gonallez ? de Albona, pro remedio anime sue, recorded by Jaquetus de Exterines de Albona clericus.

25v Mermeta filia quondam Vuilliermi dicti Magninat de Albona, die Veneris post festum Beati Martini Yemalis 1348 (= 14 nov 1348), donation pro remedio anime sue, mention her husband Stephanus filius quondam Johannis Sutoris de Albona, recorded by Perronetus Agricole clericus and copied after his death by Perretus Reymondi de Chavornay on 07 oct 1350 by commission.

26 Stephaneta relictia Jaquerii Girardi burgensis Albone filiaque quondam Girardi de la Baraz de Feschier, 09 jan 1394, donation pro remedio anime sue, recorded by Mermetus Bassins clericus.

26v Aymonetus Evolla burgensis Albone, 17 may 1401, donation pro remedio anime sue, recorded by Mermetus Bassins notarius.

26v Johannodus Lateron, 01 jan 1410, sale to Aymonetus Comply and Filiberto de Bagne ? priors of the confratria, recorded by Mermetus Bassins. Later notation: Anno domini m^o iiii^C xxxi^o die xvii mensis aprilis (17 apr 1431) Franciscus de Crousa de Saubra confitetur debere et solvere tam pro se et suis heredes tanquam possessor domus superius limitate videlicet predictam cupam frumenti census solvendum anno quilibet termino predicto sub condicione superius designatus ..., actum Albone presentibus Franciso de Ultralacum et Georgio Very de Albona, with signature and small paraphe of Jaquetus Gos.

27 Jaquetus filius quondam Jaquerii de Trivillins, 28 aug 1360, testamentary bequest, general heirs Johanneta, Perroneta, et Ysabella his sisters each for 1/3 part etc., pro remedio anime sue et predecessorum suorum, recorded by Mermetus de Monthero notarius.

27 Johanneta uxor Jacobi de Trivillin, viii kalendas februarii (25 jan) 1335, testamentary bequest, universal heir Hugonodus de Fesingio filius suus, recorded by Jacobus de Lavignier clericus.

27v Francesia filia quondam Johannerii Jordam ? burgensis Albone, die Veneris ante festum Beate Lucie Virginis 1348 (=12 dec 1348), donation pro remedio anime sue, recorded by Perronetus Agricole clericus, and copied after his death by Perretus Reymondi de Chavornay on 07 oct 1350.

27v Johannodus dictus Adam burgensis Albone et Alesia eius uxor, 17 jun 1364, sale to Aymonodus Leone et Vuilliermetus Planchy priors and rectors of the confratria, recorded by Jaquetus de Exertines clericus.

28 Jaquetus de Genollier burgensis Albone, Nicola eius uxor, et Johannodus dictorum conjugum filius, 15 mar 1390, sale to Johannodus Garin ? burgensis Albone prior of the confratria, recorded by Johannes de Sarrata clericus.

28v Petrus filius quondam Stephanodi Seschaux de Albona domicellus, 14 nov 1412, testamentary bequest, pro remedio anime sue, universal heir Aymoneta soror sua uxor Girardi Loguey ? de Chavene ? domicelli et suos, recorded by Mermetus Bassins notarius, with notation referring to fol. 11.

28v Anthonia filia quondam Michael Merdins ? (uncertain abbreviation of the first syllable) de Albona, die Jovis festum Accensionis Domini 1419 (= 25 may 1419), testamentary bequest, pro remedio anime sue, universal heirs Anthonius Bondralet de Albona avonculus suus carissimus, et post decessum dicti Anthonii liberos dicti Anthonii, recorded by Johannes Mestral de Albona clericus, with notation that a new reconnaissance was made by Anthonius Bondralet as heir of the said Anthonia, and referring also to fol. 23.

29 Communitas ville Albone, die festi Epiphanie 1352 (= 06 jan 1352), Johannetus Marchiant, Franciscus Bougnier ? (uncertain abbreviation, see below), et Roletus de Villar burgenses ... Albone, with approval of several citizens, sell to Stephanus Seschaux de Albona domicellus as prior and rector of the confratria, recorded by Perretus Reymondi de Chavornay.

29v Predicta communitas, 08 jul 1368, Perrodus Rosset et Johannodus Garulliat (=Garriliat) burgeneses Albone tanquam sindici et gubernatores communitatis predicte ville Albone with approval of Jaquetus Marchiant, Franciscus Bougnyer, and several other citizens of the city of Albona sell to Perrodus Robins et Perretus Guiar ? as priors and rectors of the said confratria, recorded by Dominus Petrus de Escleppens capellanus.

29v Predicta communitas, 16 aug 1370, Perrodus Rosset et Johannodus Garulliat tanquam sincidi et gubernatores dicte ville with approval of Johannes Vondesii ? et Jaquetus Marchiant and several others, sell to Perrodus Robins and Roletus Mochet as priors and rectors of the said confratria, recorded by Dominus Petrus de Escleppens capellanus.

(Fol. 29v is followed by fol. 40, apparently a numbering error.)

40 Martinus Chapat burgensis Albone, die tercio idus decembris (11 dec) 1332, donation pro remedio anime sue, recorded by Nicolas de Birola clericus.

40v Predictus Nicoletus Maliet de Cossenay ?, 15 oct 1355, debt ? recorded by Mermetus de Monthero notarius and copied after his death by Girardus de Ponte notarius ex commissione on 05 dec 1390. (On the previous page, there is a cryptic marginal notation Ny Maliet de Coss, but apparently no other indication that would result in calling him "predictus" in this reconnaissance.)

40v Parisia relictia Perrini de Hospitale ? de Jovia ? morans Albone, 09 mar 1391, testamentary bequest pro remedio anime sue, universal heir Jaqueta filia Renaudi ? Borgognon relictia Perrodi filii Johannodi dicti Lovat de Bougier Sancti Martini, with additional condition not clearly legible, recorded by Johannes de Sarrata clericus.

41 Nicoletus et Girodus fratres filii quondam Nicodi filii quondam Ansermi Vulliet de Albona, 25 may 1399, cense bequeathed to them by their late father, recorded by Johannes de Sarrata, with notation referring to fol. 23, and that a new reconnaissance was made by the heirs.

41v Reymondus de Sales alias Barbey burgensis Albone et Perrisonna eius uxor filia quondam Stephanodi de Yverduno, 01 feb 1396, sale to Stephanetus Barberii et Vuillermus Pampignier burgenses Albone as priors and rectors of the said confratelia, fidejussor Perronetus Bariaux ? de Monthero, recorded by Jaquetus Pampignier clericus.

42 Mermerius de Dysis ? burgensis Albone, 03 apr 1389, sale to Johannodus Garit ? burgensis Albone as prior and rector of the said confratelia, recorded by Johannes Tonssoris clericus, and copied after his death by Roletus Garit ? de Albona ex commissione on 26 apr 1391.

42 Nicoleta uxor Nicolay de Mollens domicelli, 09 may 1374, testamentary bequest pro remedio anime sue, universal heirs their children for 2 parts, and the other part for her children by Nicolaus Vuillieti her late husband, recorded by Mermetus de Monthero, and copied after his death by Girardus de Ponte notarius ex commissione on 01 aug 1383.

42v Caterina filia quondam Jaqueti Magnin ? de Albona relictaque Guilliermi Friant de Lausana, 24 aug 1369 ? (year is defective, m^o l^o ix^o) testamentary bequest pro remedio anime sue, universal heir Nicoleta filia sua carissima uxor Nicodi de Mollens de Albona domicelli et suos, recorded by Johannes Monrichier clericus, and copied after his death by Perrodus Suavis notarius ex commissione on 25 sep 1409.

43 Nicodus Escallier burgensis Albone with approval of his wife Roleta, 1378 (day and month left blank), donation pro remedio animarum dictorum conjugum et predecessorum suorum, recorded by Michael Coquoz de Albona clericus.

43 Johannodus filius Johannis Gavit ? (Garit ? Ganit ?) burgensis Albone et Leona eius uxor filiaque quondam Jaqueti Magninat burgensis Albone, 10 aug 1360, donation pro remedio animarum suarum, recorded by Jaquetus de Exertines clericus.

43v Predictus Johannes Gavit ? pater predicti Johannodi Gavit ?, 13 may 1374, donatio inter vivos, recorded by Johannes Monrichier clericus.

44 Girardus Gavit ? burgensis Albone, 05 aug 1394, testamentary bequest pro remedio anime sue, universal heir Johannes Gavit ? filius suus carissimus, recorded by Johannes de Sarrata clericus, with later (undated) notation that the cense is now being paid by Johannodus de Furno de Marchissier and his son as fidejussores, recorded by Johannes Fonjaleti.

44 Roletus Culery ? de Albona, 16 aug 1349, testamentary bequest pro remedio anime sue, universal heirs Roletus et Francesia siblings children of the late Janinus Culery ? nepotes ? sui ?, recorded by Mermetus de Monthero notarius.

44v Mermetus de Chiviliet ? (or Chiniliel ? ; all the i's are dotted) burgensis Albone, 29 aug 1360, testamentary bequest (or donation ?) pro remedio anime sue et predecessorum suorum, recorded by Mermetus de Monthero notarius.

44v Perretus filius quondam Stephani de Mont domicelli, 21 aug 1360 ? (date is defective, m^o sexag.) testamentary bequest pro remedio anime sue et Alesie quondam uxoris sue, universal heirs Anthonius, Hugo ?, Johannes, et Guillermus filii sui dilecti, recorded by Mermetus de Monthero.

45 Leona filia quondam Stephani de Mont domicelli, 03 apr 1372, testamentary bequest, pro remedio anime sue, universal heirs, Johannes filius quondam Perreti de Mont domicelli fratris quondam dicte Leone nepos suus carissimus, recorded by Mermetus de Monthero notarius, and copied after his death by Girardus de Ponte clericus on 31 aug 1380.

45 Mermetus Fabri de Cossenay morans apud Lausanam, 07 feb 1373 Style of the Nativity, donation pro remedio anime sue, recorded by Jaquetus de Exertines clericus.

45v Nicolaus filius quondam Johannis Guerici burgensis Albona et Johannes filius Johannis de Bougel burgensis Albone, cum ita sit quod Perretus Guerici quondam burgensis Albone avonculus predictorum Nicolay et Johannis sold to the priors of the said confratelia ... , hinc est quod predicti Nicolaus et Johannes owe the said cense, 08 kalendas septembris (25 aug) 1341, accensation recorded by Mermetus de Monthero clericus.

46 Petrus Guerici burgensis Albone et Briseta eius uxor, 14 kalendas maii (18 apr) 1329, donation pro remedio animarum suarum, recorded by Stephanus de Lavignier clericus.
