

## **ACV Fh 107      Extracts for the coseigneurié of Aubonne 1342-1438.**

The inventory of the ACV gives dates 1342, 1377, 1379, and 1442 for this volume, indicating it was compiled for Noble Jean (IV), coseigneur d'Aubonne, Noble Antoine, coseigneur d'Aubonne, et Nobles Henri et Marguerite de Montricher, à cause du fief dit de Rochefort et la coseigneurié d'Aubonne. What we find in the text is somewhat different.

There are several sections, suggesting that a number of different documents were simply bound together. If there is any explicit mention of the *fief dit de Rochefort*, we did not find it. The ACV has designated these sections as follows (with a summary of our analysis of each section, *in italics*) :

Section A, beginning with fol. 68 (*pencil ? notation at the top of the first folio, № 5*), ending on fol. 71v. *Contains several reconnaissances in favor of Nobilis Henricus dominus Montisrecherii et Margareta eius consor condomini Albone and their successors in the Château of Aubonne, dating from 1379. The reconnaissances appear to be copies, not signed, and with minor omissions replaced by « etc. » The name of the commissaire is found on fol. 71, but it is abbreviated and not very clear, possibly Petrus Crocti, and the preceding reconnaissances are not in the same hand or ink. Some of the text is lined out and there are signs of editing, as if the text was intended to be used in the preparation of another document. A Petrus Crocti is mentioned in Fh 101 as the person in charge of copying certain documents held at Chambrier for the Seigneur of Aubonne in 1426. The material that he copied included an extract by Johannes de Montricher of a terrier by Jacobus de Bissingio – these names figure in Fh 107 as well, suggesting that a comparison of these volumes might prove informative.*

Section B, beginning with an incomplete répertoire (two folios of the répertoire remain, but the first folio of the répertoire is lost; also, the répertoire ends prematurely with entries for fol. 27), then continuing with fol. 1-39v, of which fol. 32v-39v are blank. (*Apud Albonam: Per Jacobum de Bissingio clericu diocesis Gebennis et anno domini m<sup>o</sup> ccc xlii [1342] recepte fuerunt presentes recogniciones.*) *These appear to be extracts from a volume by Jacobus Rodulphus de Bissingio, all apparently in 1342. The volume by de Bissingio may be, or may be related to Fh 69, a fragment ? of a “rotulus” or scroll, compiled about 1344 for Noble Jean (IV), co-seigneur d'Aubonne, now too fragile and damaged to be examined. See below for mentions of a “rotulus” in other sections of Fh 107. Even more likely, there is a rotulus ACV P de Mestral I 1500, clearly identified on the first membrane as the work of Jacobus de Bissingio, for Johannes condoninus de Albona, dated in 1342, and including a later notation that at least some of it had been copied by Berard. However, what is now in section B does not match anything in P de Mestral I 1500.*

Section C, beginning with a répertoire (three folios, *Repertorium extenterum antiquarum per Johannem Monrichier receptarum*), then continuing with fols. 1-35v (*Johannes Monrichier recepti*). The first item is dated in 1377, in favor of Anthonius, *condominus Albone, in his own name*. Note that in Section E of this terrier, some of the reconnaissances are in favor of the same Anthonius, but under the guardianship of his mother, in 1370. By 1377, he had attained the age of majority. As is the case with the other sections, these are brief abstracts or paraphrases. The original terrier of Johannes de Monricher may have been Fh 113, compiled in 1377 for Noble Antoine, co-seigneur d'Aubonne, not yet examined. The repertorium at the beginning of Section F indexes later tenants listed in the margins of Section C.

Section D, beginning with a répertoire (one folio), then continuing with fols. 1-26v. This section is a continuation of Section A. The répertoire bears the folio number 72 (lxxii) centered in the top margin, and the entries in the répertoire are interrupted by a short entry that may belong with Section A, as explained below. Beginning on the next folio, there are two sets of folio numbers. The original set is probably the one centered in the top margin, folios 1-18, then a folio with 19 lined out and replaced by another 18, then folios 19-24, followed by a folio number 16 lined out, and then a folio 15. The second set of folio numbers was probably added later, on the left side of the top margin, running from 73 to 99. Thus, the second set of folio numbers continues the foliation from Section A, but the folio numbers are placed differently. Nevertheless, the dates in this section are in 1379, plausibly continuing the dates from Section A. The items in this section are in favor of "dictorum nobilium conjugum" Henricus de Monrichier and his wife Margareta, daughter and heir of Anthonius, co-seigneur d'Aubonne, and, as in the other sections, they are unsigned abstracts or paraphrases of the originals, now apparently lost. From the placement of the two sets of folio numbers, we surmise that Section D was originally a separate document (or two documents, since the last two folios duplicate the numbers 15 and 16), later adapted and placed after what is now Section A, but then rearranged by the interpolation of sections B and C.

Section E, beginning with a répertoire (one folio plus a blank folio), then continuing with fols. 100-140, first in favor of Humbertus, co-seigneur of Aubonne, dating from 1369-1370, and then a group of reconnaissances compiled in favor of Anthonius, co-seigneur d'Aubonne, from 1370. In effect, two new folios were inserted between fols. 99 and 100 to provide a répertoire for fols. 100-140. However, the contents are again extracts or paraphrases derived from earlier sources. Fols. 100-124 concern Humbertus, fol. 124v-140 concern his brother Anthonius. There is no indication of the name of the commissaire for fols. 100-124. Fols. 124v-140 are abstracted from reconnaissances compiled by Petrus d'Eclipens, Fh 110 (the text in Fh 110 is unsigned, but apparently complete).

Section F, beginning with a repertorium (nine folios), then continuing with nine unnumbered folios (or else the foliation was cut off when the volume was bound), although the associated repertorium has folio numbers as high as 36. Clearly the repertorium is not related to the pages that follow it. In fact, some of the entries mention a "rotulus" or scroll, as well as "papers". Eventually, we discovered that this

*repertorium, in part, indexes names of later tenants found in the margins of Section C! The remainder of Section F appears to consist of notations concerning petitions for “assignation”, by which properties were “assigned” to secure debts, and other legal procedures. The dates appear to be in 1438, and the notations suggest that these are actions before a court (note mentions of a “Locumtenens” or Lieutenant and the city council of Aubonne). While it is clear that some text has been lost at the tops of the pages by trimming for binding, possibly including folio numbers, we were unable to find any correspondence between the répertoire and the “main” pages in this section.*

We can now attempt to summarize the genesis of Fh 107. All of it was copied or abstracted from other sources. Sections A, D, and E appear to form a continuous sequence, but Section D originally stood alone and was renumbered when it was combined with Section A, which had been removed from some other volume. Fol. 72 from Section A, being nearly blank, was converted to serve as a répertoire for Section D. Later, the items that now form Section E (copied from Fh 110 and another, unknown source) were added after Section D, continuing with the next folio number. Two additional folios were then inserted to form provide a répertoire for Section E. Finally, Sections B, C, and F were added, apparently also from diverse sources, and with no attempt to continue the foliation of the earlier sections. The entire volume shows signs of use over an extended period, in the form of marginal notations indicating later tenants and sometimes other information.

But the planned repertorium for the contents of this scroll was never added.)

[Section C]

(Répertoire says *Repertorium extenterum antiquarum*, then in a different ink, *per Johannem Monrichier receptarum*. The entries appear to correspond with the contents of the pages that follow the répertoire. Some of the items specify allegiance to Anthonius, co-seigneur d'Aubonne.) (Notations in the margin correspond, more or less, to most of the entries in the repertorium designated as Section F, below. However, the notations are sometimes extremely faded, lost in the binding or trimmed off during binding, or so heavily edited that it is not possible to determine the correct reading. Among other issues, we strongly suspect that more annotations were added to Section C after the index in Section F was completed.)

Répertoire labeled Lavignyer, begins with Agneta relicta Perreti de Villa Nova on fol. 100. The répertoire, on both sides of one folio, continues with Estuey, Reveroulaz, Vaux, Ballens, and

Apples. It is followed by a blank folio. The whole section is heavily annotated, including many references to a “rotulus” or scroll.

The first reconnaissance, below, specifies allegiance to Nobilis Humbertus. However, the reconnaissances continue into 1370, clearly written, on fol. 119. This mystery is clarified on fol. 123v, where we find that Humbertus is the son of the late Johannes, co-seigneur d’Aubonne. This is Humbert (II), son of Jean (IV), coseigneur d’Aubonne, and Marguerite d’Oron. His testament was dated at Lavignier in 1377, and there is no indication that he married. He was succeeded by his younger brother Antoine.)

## [Section F]

The repertorium consists of 9 folios, but it does not relate at all to the “text” pages that were considered part of Section F by the ACV. Eventually, we discovered that this repertorium is, at least in part, an index to **Section C**, above, for the *later* tenants, or at least some of them, noted

in the margins there! However, both this repertorium and the marginal notations they reference are often heavily edited or illegible, so it has not been possible to make a detailed comparison of the two sections.

The repertorium also contains some references to items in a “rotulus” or scroll. These citations do not seem to be found in the present volume.

If there is any relationship between the unnumbered folios at the end of Section F and the rest of this volume, we have been unable to discover it. However, based on the dates, all in 1438, it appears that folio [3] belongs after folio [9]. It is not clear whether folio [1] or folio [2] belong in the same sequence, or whether one or both of these folios are perhaps from some other source.
