

ACV Fh 114 Properties subject to Nicodus and Rodulphus de Cerjat for their fief of Alamand, 1386, commissaires Anthoine Bruyvans and Johannes Serraceni.

A small volume, only 11 folios, designated “14” on the spine of the bound volume, but “13” on the first folio, concerning properties of the Cerjat brothers in Aubonne, Alamand, Féchy, and Marchissy. The folios were originally not numbered, but there is modern pagination 1-21. The ACV seems to have misread the signature of the second notary, it is definitely Serraceni, not Fracem!

Page 1: Extente Nichodi et Rodulphi Cerjat fratrum burgenses de Melduno super rebus et possessionibus quas habent in villa de Alamant et de Albone seu in territorio dictorum villarum, ac eciam in territorio de Flechier (=Féchy!) et de Marceseir (=Marchissy), recepte per Anthonium Bruyvanz clericum de Melduno, Anno Domini currente millesimo ccc^o octogesimo sexto (1386).

The first reconnaissance appears to be for properties held by someone named Perrodus, but the first few words are lost, 09 jan 1386.
