

## **ACV Fh 116 Properties subject to the hospital of Aubonne, 1425-1459, commissaires Jaquetus Gos and others.**

At least twice on the flyleaves, this volume is described as an “extract”. However, the short introduction at the top of fol. 1 describes the contents as reconnaissances for the benefit of the Hospitale Sancti Spritus Albone by Jaquetus Gos de Albone, at the request of Mermetus Morandi cappellanus Albone rector dicti hospitalis.

The script is generally clear, but there is some damage to the paper, as well as various stains and similar minor damage. As noted below, some of the later items bear the signature of other notaries, especially Petrus Gos.
